AHPRA and the Medical Board

How Regulatory Capture Endangers Public Health

Australia's medical regulator AHPRA [Australian Health Practitioner Regulation Agency] and the Medical Board have become not just failed watchdogs, but an active threat to public health through its ruthless enforcement of government policy over scientific evidence. The organisation's transformation from public protector to political enforcer represents one of the most dangerous developments in Australian medical history, made even more egregious by its continued defence of unsafe Covid vaccines despite mounting evidence of harm.

The Queensland Supreme Court's ruling in the Dr William Bay case exposed AHPRA and the Medical Board's methods as fundamentally unlawful, finding they denied basic procedural fairness, demonstrated apprehended bias, and failed to identify actual breaches of professional standards. Instead of protecting the public, AHPRA has become a tool for enforcing political compliance through regulatory terror.

Dr Fraiman's rigorous reanalysis of Pfizer and Moderna's original trials revealed that serious adverse events occurred in one out of every 800 recipients - a staggering safety signal that

should have triggered immediate suspension of the program. Yet AHPRA continued to persecute doctors who raised these legitimate concerns about safety, especially considering that Pfizer appears to have concealed deaths prior to Emergency Use Authorisation and substantial DNA contamination has been detected in the *process 2* manufactured global vaccine rollout, which was never properly tested. Dr Jay Bhattacharya, Trump's pick to lead the National



Institutes of Health (NIH), appears correct in his assessment of the Covid response being 'the biggest public health mistake we've ever made ... the harm to people is catastrophic'.

The human cost is in fact devastating. The Australian Medical Professionals' (AMPS) recent 'Human Cost of AHPRA' survey of health practitioners shows over half of medical practitioners have faced AHPRA notifications, with nearly 80 per cent reporting unfair treatment. Multiple practitioners have committed suicide while under investigation. Many more report depression, anxiety, and suicidal ideation - not from clinical misconduct, but from AHPRA and the Board's persecution of those who dare question official guidelines, political narratives and the government's response to Covid.

The consequences extend far beyond individual practitioners. When AHPRA shut down Professor Dr Reece's Brisbane practice serving 1,100 drug-dependent patients, the results were calamitous, patient deaths, hundreds re-incarcerated, widespread return to illicit drug use, and a 17 per cent spike in local crime rates. Similar devastation followed AHPRA's action against Melbourne's Dr Taylor and his 1,360 vulnerable patients.

AHPRA and the National Board's March 2021 directive effectively criminalised medical opinions that questioned government Covid policies.

The unprecedented level of government information control and regulatory overreach created an environment where critical safety data was withheld from doctors and the public, while practitioners' careers were threatened if they raised any concerns. The government's suppression of scientific debate combined with AHPRA and the Board's attack on clinical independence forced doctors into an impossible position - most lacked access to crucial safety information, yet faced career destruction for even questioning the official narrative. The result has been catastrophic: systematic suppression of emerging safety signals, destruction of informed consent, undermining of ethical evidence-based medicine, and the creation of a climate of fear where many physicians dare not speak out even when confronted with clear evidence of patient harm.

As the Hope Accord petition now argues, the apparent emergency that justified rushed vaccine approval 'no longer exists'. Yet AHPRA and the Board continue to enforce compliance with a failed policy that emerging evidence suggests is 'contributing to an alarming rise in disability and excess deaths.' The

regulatory capture is complete - rather than protecting the public, AHPRA and the Medical Board refuse to meet with independent researchers to exchange critical safety information, seemingly actively suppressing evidence of harm to maintain political narratives and corporate profits.

The current situation is untenable. AHPRA and the Board's conduct has created a healthcare system where fear replaces evidence, where compliance trumps conscience, and where bureaucrats dictate clinical decisions, many that cause more harm than good. They continue to defend policies that have resulted in monumental social and economic harm and destruction of trust in our institutions from the enforcement of unscientific secret health advice that was in total contravention of our 2019 Pandemic Plans. At the same time, they refuse to acknowledge the mounting safety signals that demand immediate suspension of these experimental gene-based mRNA products. British Cardiologist Dr Aseem Malhotra has stated, 'These experimental injections should never have been approved for use in a single human being.'

The path forward requires more than reform. It demands a complete overhaul of medical regulation in Australia. The alternative - a permanently cowed and gagged

medical profession serving as mere enforcers of government policy while ignorant or ignoring clear evidence of public harm - represents an existential threat to both public health and democratic society. We must remember: when AMPS keeps asking for scientific exchange, for discussion, for scientific evidence, the authorities keep ignoring the questions.

AHPRA's and the Medical Board's transformation from regulator to enforcer will be remembered as one of the darkest chapters in Australian medical history. We have here a cautionary tale of how institutions meant to protect the public can become instruments of harm when captured by political and corporate interests. The cost of continued silence is measured not just in ruined careers but in preventable deaths and injuries. Reform is no longer optional; it is a moral imperative for anyone who believes in public health and medical ethics.

Senator Ralph Babet Speaking on Excess Deaths

Australian Parliament 23 March 2023

The fact that Australia is right now experiencing its highest mortality rate in over 80 years must be cause for concern and it must be a priority for everyone in this place. It should be front-page news. According to Actuaries Institute figures released earlier this month, Australia experienced an 11 per cent increase in excess deaths in 2022, the greatest number since World War II. It's not all Covid. Only around a third of nearly 23,000 excess deaths, according to the most recent ABS report, have been attributed to COVID-19. The remainder, a truly significant amount of excess mortality, is not recorded as Covid related; in fact, it is largely unexplained. What's more alarming is that the Actuaries Institute states that excess mortality was a significant percentage in all age groups in 2022. So, we're seeing significant excess mortality across all age groups, even among young people.

We Have Won – Will We Win (Again)?

■ *Dr. William Bay, a GP registrar, had his medical license suspended 2.5 years ago for criticising the COVID-19 vaccines and the government.*

On 13 December 2024 the Queensland Supreme Court handed down an emphatic victory for me as a suspended medical practitioner in this country. The judge, Justice Bradley, ruled that my 2-and-a-half-year suspension, my investigation, and my tribunal hearing were all overturned. (Full details can be found at www.qpp.life/legal).

The Australian Health Practitioner Regulation Agency's (AHPRA) conduct was found to be 'profoundly less than satisfactory', and that they had acted with procedural unfairness, bias, and 'animus' towards me. During my public protests, I had always told AHPRA they were on trial, not me; so this ruling was especially gratifying. I am so glad that my political outspokenness was vindicated as I feel that I had never left the medical profession but most of the medical profession had left me! The right to informed consent and an ability to (vocally) warn patients of important medical risks is a hill worth dying on in my humble opinion.

But thankfully, because of

the grossly unlawful actions of AHPRA and the Board, that hill did not become my career grave but my legacy, because the judge ordered that my suspension was not just stopped but set aside retrospectively from the 17 August 2022. This gave much hope and encouragement to health professionals and lawyers around the country and means that I am now able to sue AHPRA and the Medical Board of Australia for compensation! All glory to God for helping and guiding me to this win. Praise Jesus.

But this was not just a win for God and for me, this was a win for all health practitioners, and not just doctors either. Importantly, the judge found that I had not breached the code of conduct, nor any legislation or rules that AHPRA had made baseless allegations against me about. So, this means that there are implications for other practising health practitioners in Australia.

Prior to my win practitioners were afraid to speak out publicly, attend protests or even use social media because of AHPRA's intimidation and bullying. Medical Defence Organisations (MDO), like Avant, would put it to their AHPRA-attacked clients that you "can't win against AHPRA" and that you must shut up and take a deal, acknowledge failings, show "insight" and

submit to "re-education". But now, Avant says you just can't be free in ALL circumstances as one isn't permitted "carte blanche" freedom as a doctor to speak. Ok – great – so what's changed here is that MDO's have gone from saying you can't win ANY of the time to now: you can't win all the time! This is a fantastic change of mindset and will hopefully result in more health practitioners being less afraid of the bullying bureaucracy and enable them to put their patients first.

I want a new health system that focusses on caring for patients, not the feelings of the health bureaucracy. Our laws currently don't support this, and this needs to change so that medical sanity can be returned to this country.

So, to all the young doctors starting their careers this year: I am living proof that you too can speak out. You can attend public protests, and you can use social media, and you do NOT need to vaccinate yourself against your will for COVID-19! The matter of Bay v AHPRA 2024 shows that guarding your patient's ethics first begins with guarding your own, and you, like me, can and will win if you stand strong, trust in God, and the right to speak for yourself and all human beings.

Decentralised Medicine in El Salvador

A model of decentralised medicine in El Salvador can rejuvenate our medical profession by enshrining the sanctity of the doctor-patient relationship and reinforcing the principle of informed consent. A related move to decentralised agriculture in the small Central American republic is exciting regenerative farming enthusiasts.

The key medical reform began when El Salvador's President Nayib Bukele contacted American neurosurgeon Jack Kruse over his concerns about the Covid shots. Dr Kruse outlined the need for a specific constitutional amendment to protect the health of El Salvador's people in the long term. Australian doctor Max Gulhane attended the health summit in El Salvador where Dr Kruse announced the constitutional amendment and was excited by this new dimension in medicine.

Speaking in an interview with

Logan Duvall, Dr Gulhane saw the potential for El Salvador to become a place where cutting edge medicine is practised. He referred to the Covid experience when the prescription of repurposed medicines such as Ivermectin was blocked by centralised entities. Dr Kruse put it bluntly: "Everything centralised is about money."

The measures Dr Kruse wrote to safeguard the health of El Salvador's people are now with Bobby Kennedy Junior who pledged alongside President Trump to make America healthy again. The question for Americans is whether Kennedy will dissipate his force in squabbles over the cooking oil used by McDonalds to fry hamburgers and succumb to Big Pharma's big bucks or whether he and Trump will make a real difference.

In Australia the focus is on the dismal performance of our doctors. People of my age can remember when doctors were proud of their profession to the point of arrogance. Now their profession is under the thumb of an organisation



called AHPRA (Australian Health Practitioner Regulation Agency) that is not at all professional. Can our doctors regain their professionalism? We can't do it for them.

Eighteenth century statesmen could be forgiven for failing to foresee the villainy of Big Pharma and the treachery of 21st century governments but the problem was indeed identified by the father of psychiatry, Benjamin Rush, and was taken seriously by America's founding fathers. Dr Kruse related the story in one of his many interviews: "There is no provision

in the U.S. Constitution for medical tyranny at all. In fact, when it was brought up when they were doing the Declaration of Independence, the Bill of Rights and writing the Constitution, James Madison and Thomas Jefferson found no incidents in 5,000 years of human history where medical tyranny was used to overthrow anyone politically, so they thought it was superfluous." In highly charged correspondence, Jefferson wrote to Benjamin Rush on 23 September 1800: "... For I have sworn upon the altar of God eternal hostility against every form

of tyranny over the mind of man."

The worst countries for 21st century medical tyranny are Australia, New Zealand and Canada. In a recent speech Dr Robert Malone said the reason for the extreme behaviour of governments in the three countries was their membership of the Five Eyes intelligence network along with Britain and USA.

In my view the explanation is more straightforward. Our three countries are major producers of vital resources – food, fibre, minerals and energy. The globalists want our resources, but they don't want us. What they don't want most of all – what they detest and fear – is an independent frame of mind which we Australians like to think is a national characteristic. We call it the Anzac spirit. The globalists want a weak, compliant, docile population. To our shame we gave them what they wanted. Our challenge now is to throw out the Covid project, take up the Australia project and get our country back.

Cancelling Candace Owens

At the time of writing this article, the game of free speech between the Aussies and Kiwis remains in play with New Zealand taking the lead by allowing Candace Owens to enter their country. On 27 October 2024 the Australian Immigration Minister, Tony Burke stopped Candace's

tour of Australia and New Zealand by denying her a visa. New Zealand initially followed suit but (sensibly) reversed this attack on free speech in December 2024. After all, Candace Owens is a US citizen and a globally recognised podcaster with over 20 million followers. One of the reasons given for her Australian ban by Minister Burke is Candace's alleged "capacity to incite discord". While tour promoters

launched a High Court challenge to her visa ban, unfortunately government censorship has experienced a global escalation. Another famous podcaster Joe Rogan recently aired an interview with Facebook CEO Mark Zuckerberg who described the Biden administration's methods at forcing Facebook to censor "truth" during the Covid pandemic. Zuckerberg stated, "these people from the Biden administration

would call up our team and scream at them and curse." Zuckerberg has since publicly apologised for censoring Facebook and vowed to curb censorship on his platforms. In Australia 'freedom of speech' faces an uncertain future as the Australian Labor Government intends to actually ban under-16-year-olds from using social media like Facebook. The methods for enforcing this ban are unclear, but the Albanese government may be

the first to bring facial recognition or mandatory internet licenses to the so-called *Lucky Country*.

Battle Over Australian DNA Contamination

US Food and Drug Administration (FDA) Weighs In

The modified RNA (mRNA) contamination controversy continues to escalate in Australia as regulatory agencies and independent studies battle it out over whether COVID-19 vaccines were contaminated. It all began when a council from a coastal mining town in Western Australia, Port Hedland launched an initiative in October 2024 to expose residual DNA contamination in the COVID-19 jabs. The council's findings included testing in four independent labs from four countries – Canada, Germany, France and the US all resulting in findings that residual DNA contamination levels in Pfizer and Moderna COVID-19 vaccines were between 7 and 145 times above the legal level. The initiative was a world first calling for an immediate suspension of these drugs and backed by a Federal Member of Parliament, Hon. Russell

between July 2019 and July 2024 the TGA received (in accordance with their published fees) over \$45 million (AUD) from Pfizer, Moderna and AstraZeneca. In May 2024 the AstraZeneca COVID-19 vaccine was officially withdrawn from the global market and one of the earlier deaths from AstraZeneca was BBC presenter Lisa Shaw (age 44) who died in May 2021. In the US, Attorney Generals from Texas and Kansas have commenced lawsuits against Pfizer concerning fraud, side effects and deaths. The lawsuits are likely to escalate globally in 2025 and health issues could be catastrophic with oncology Professor Angus Dalglish from the University of London describing this vaccine contamination rollout as the "the greatest crime of the century".

Broadbent. Mr. Broadbent went 'public' sending warning letters to the Australian Prime Minister, Anthony Albanese. At the time of writing this article, the Prime Minister has yet to respond, and the consequences are potentially deadly as the Australian government pushed millions of doses of these experimental drugs on the Australian public.

The Australian Therapeutic Goods Administration (TGA) rejected the council's findings soon after claiming their contamination reports were 'misinformation'. However, in a recent blow to the TGA's counterclaim a peer reviewed study published in the Journal of High School Science in December 2024 confirmed such contamination levels. Conducted in the US Food

and Drug Administration's (FDA) White Oak Campus in Maryland the study confirmed contamination levels exceeded regulation limits by 6 to 470 times. Then in response, as reported by journalist Maryanne Demasi PhD in January 2025 – the FDA tried to distance itself from this study despite it being conducted in their own labs and under their own supervision. It should be noted that

A Growing Movement at The Local Government Level

In recent months, there's been a surge in community members stepping forward to engage with local government processes to spark debate and foster change.

At the Town of Port Hedland Council's special meeting on 11 October 2024, a motion passed 5-2 calling for the suspension of Pfizer and Moderna COVID-19 products due to DNA contamination. In addition, the motion passed included other points:

■ the council agreed to send letters to Prime Minister, Anthony Albanese, all registered health practitioners and medical clinics in the Port

Hedland Local Government Area, and all other Australian Local Government Councils.

■ each letter would include Canadian Virologist and Molecular Epidemiologist, Dr. David Speicher's report on the DNA contamination and MP Russell Broadbent's letters to the Prime Minister.

Dr. Speicher's report revealed DNA contamination in Pfizer and Moderna COVID-19 products showing levels up to 145 times higher than the limit set by Australia's Therapeutic Goods Administration. The presence of SV40 promoter-enhancer sequences was detected in the Pfizer products. These discoveries sparked worries regarding long-term health effects, such as the integration into the genome and risks of cancer. MP Broadbent's letters to the Prime

Minister, co-signed by 52 professors, scientists and legal experts, detailed the DNA contamination, as reported by Dr. Speicher. They advocated for an immediate suspension of the products and requested an independent inquiry into the potential health risks.

Several councils across Australia have passed motions like Port

Hedland. These motions reflect a unified effort to address shared health challenges and ensure safety. Some of these councils include West Tamar Council in Tasmania, Ceduna Council, Adelaide Hills Council, and Streaky Bay Council in South Australia, and Port Macquarie-Hastings Council in New South Wales.

Community members are increasingly advocating for health and greater transparency, demonstrating the power of grassroots movements in shaping the future. Though many other councils across Australia voted against similar motions, the efforts of elected officials and community members bringing forth motions to address public health concerns are commendable.

In 2025, anticipate another surge of activity within councils, where both elected local officials and community members are poised to introduce motions. This burgeoning grassroots movement may give rise to a transformative year in community politics across Australia.

The Future of Right-Wing Minor Parties

Western politics moves in cycles between left and right. Some cycles are longer than others. A cycle comes to an end when the leadership of the dominant political outlook goes too far. The right ran the West from the election of Margaret Thatcher in 1979 until the US mid-terms in 2006. During that period even nominally left of centre governments such as Bob Hawke's and Bill Clinton's were firmly right-wing compared to administrations of their parties in the past. It came to an end when the right cheered on the disaster regime change wars across the Middle East and the middle shifted firmly left. Again, even when the period since has had right of centre governments (like Malcolm Turnbull's and Scott Morrison's) they were firmly left-wing compared to previous Liberal Party governments.

It feels like the cycle is swinging back to the right. If so, it is because the left has gone too far with all their woke garbage and the middle has shifted right. What is interesting with this swing is in many places it is bypassing the traditional parties on the right and going to new entrants on the right.

All around the Western world we are witnessing an erosion in the support of centre-right parties that have over the past several decades often formed governments. Sometimes this erosion is slow and sometimes it is abrupt. Sometimes the traditional party of government on the right remains the most

viable party on the right to form government... but they are doing so on a reduced primary vote and dependent on others. Minor parties on the right are hopeful of becoming major parties on the right. This trend is in its early stages in Australia so buckle up the next decade should be interesting.

The United Kingdom held an election last July. The Conservative Party won 23.7% of the vote. Nigel Farage's Reform Party won 14.3% but only a handful of seats thanks to their First Past the Post voting system. Since that election there have been ten national opinion polls... and in the last two Reform was polling higher than Conservatives.

Germany is holding its federal election this February. I had been foolish enough to believe what the mainstream media had told me for several years that Alternative for Germany (AfD) is borderline Nazi sympathetic. It didn't take too much digging to see that AfD is an impressive party with an impressive leader, Alice Weidel. She was recently interviewed by Elon Musk who had publicly endorsed her a week earlier. At

the 2021 federal election AfD won 10.4% of the vote. Recent polling has AfD at 21% and 22%. The Musk endorsement should help further.

The traditional right of centre party of government in France is the now named Republicans... and they have collapsed and are on the endangered species list. Marine Le Pen's National Rally party is now easily the dominant party on the right.

It's a similar story across Europe. Giorgia Meloni's Brothers of Italy replaced the old right, and she is now PM. The Swedish Democrats too are surging. At the 2021 general election they won 17.5% of the voting (third place) and are in coalition government.

Donald Trump performed an internal coup by permanently banishing the Bushes, Cheneys and Romneys. Likewise in Canada, a membership ballot of 700,000 rank and file party members elected Pierre Poilievre as their opposition leader. He would have never won a ballot amongst his fellow MPs and his platform is firmly right-wing.

In Argentina, Javier Milei has not only performed a political miracle in being elected president

from a minor party but is now demonstrating to the world the upsides of a radically libertarian government.

In New Zealand the libertarian ACT Party won 1 seat out of 120 in 2017. In 2020 the traditional centre right party, The Nationals, went along with Jacinda Ardern's COVID-19 hysteria but ACT did not... and they won 10 seats. At the 2023 NZ election ACT won 11 and are a particularly positive influence in a coalition government with The Nationals.

At the last federal election in Australia the Liberals and Nationals won 35.7% of the primary vote and a motley crew of minor right parties won just over 12%. Australia's voting system has two features that the US and UK do not – preferential voting and proportional representation. Both makes the pathway easier for a minor party on the right to become more significant. Preferential voting allows a voter to effectively vote twice. They can 'Vote 1' for their very favourite party and if that party doesn't win then they can make a list of their preferred parties thereafter. This more accurately captures the democratic will of the voters. It also gives voters confidence that

they are not wasting their vote by voting for their favourite party who may not be likely to win.

Proportional representation in our senate and state upper houses is also helpful for minor parties... and again fairer. Take the NSW Legislative Council and its 42 members. Each four years, half (i.e. 21) are elected and the electorate is the entire state. If a party can secure around 3% of the statewide voter, they are quite likely to win a seat. This means that 3% of the state gets a voice in parliament but 3% in the UK or US does not.

So, all the ingredients are on the table for a minor right party to become a force of national significance. The Labor Party doesn't like the Greens, but Labor has been smart enough to accept that there will always be a 10-15% vote on the minor left and have helped curate their rise via preferences etc. The Liberal Party has however failed to recognise the significance of the even larger minor right vote. The Liberal Party seems to consider the minor right a nuisance. I expect that to soon change. Australia has a congested field of minor right parties jostling for the breakthrough. This cannot continue and the Libertarian Party has an outstretched hand of collaboration.

The Legacy Media Is Dead

The 2024 US presidential election has highlighted a seismic shift in how people consume news, a shift that resonates with media trends in Australia. As reported by The Australian [newspaper], traditional media - once the self-appointed 'gatekeeper' of political discourse - is quickly losing ground to new platforms like podcasts, TikTok, and independent online creators.

In America, figures like Joe Rogan, whose podcast featuring Donald Trump drew over 45 million views, exemplify this change. Legacy media channels, such as CNN, have seen dramatic declines in viewership, with election night ratings dropping by nearly half

compared to 2020. Meanwhile, platforms like TikTok and X (formerly Twitter) are flourishing, offering alternative narratives and a direct connection to audiences.

Australia mirrors this fragmentation. Like their American counterparts, younger Australians are turning away from traditional outlets like 9News and ABC (Australians Broadcasting Communism) in favour of podcasts, YouTube, and TikTok for news and political commentary. This decentralisation offers more diverse viewpoints coming into the market, which should send a shiver down the spine of the legacy media.

As The Australian notes, the

implications are profound. For politicians, reaching voters now requires engaging across this splintered landscape, from social media influencers to citizen journalists. For media, it's a wake-up call to adapt or risk irrelevance in a rapidly evolving digital age. The lesson for Australia? The way we consume, and trust news is changing. The legacy media is dying, or dead.

Fluoride in the Water

Politico reports that RFK Jr. [Robert F. Kennedy Jr.] plans to ban fluoridation, and the work is already underway. Multiple news outlets repeated this story, yet none of them checked the evidence. According to the CDC [U.S. Centers for Disease Control and Prevention], adding fluoridation to water supplies was among the 20th century's top ten public health achievements. "A cornerstone strategy for prevention of cavities in the US. It is a practical, cost-effective, and equitable way for communities to improve their residents' oral health regardless of age, education, or income."



The CDC states that fluoridated water keeps teeth strong and reduces cavities by about 25% in children and adults. To validate this statement, the CDC refers to two studies. The first is a meta-analysis of 20 studies. Eleven studies examined the effectiveness of self or clinically applied fluoride, and of the nine that examined the effectiveness of water fluoridation none were RCTs, [randomised controlled trials] and all were cross-sectional

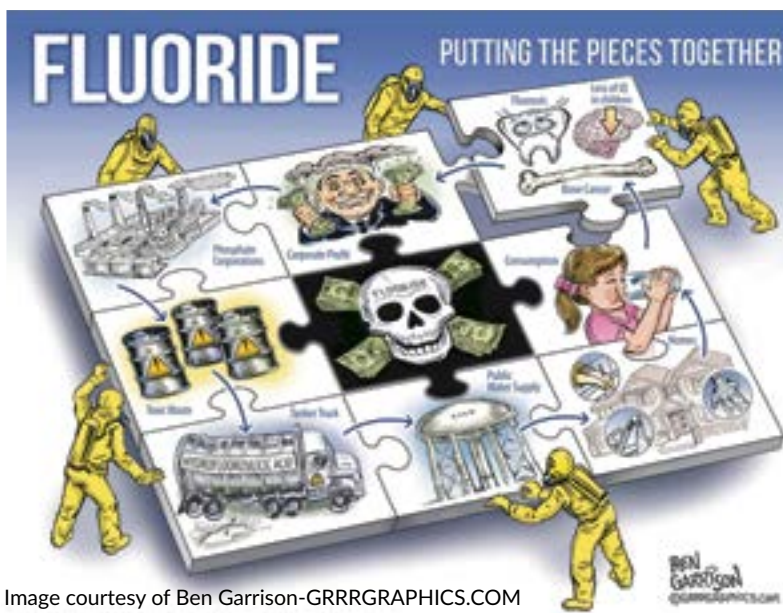

studies. Also, the review, which wasn't systematic, included adults and no children. The conclusion was limited to suggesting fluoride effectively prevents caries [tooth decay] of all ages.

The second study was a Cochrane review. Notably, most studies (71%) were conducted before 1975, when fluoride toothpaste was widely introduced. The review concludes that little contemporary evidence evaluates the effectiveness of water fluoridation in preventing caries. The observational nature of the studies, the high risk of bias, and the lack of generalisability to current lifestyles limit confidence in the size of the effect estimates. The review goes on to say that

insufficient information exists to determine whether initiating a water fluoridation programme changes caries levels across socioeconomic status. No studies that met the review's inclusion criteria investigated the effectiveness of water fluoridation in preventing caries in adults. RFK, Jr., says he would advise the water districts using fluoridation that a lot of science still says safety studies still need to be done. RFK, Jr., considers fluoride an

industrial waste. He also thinks a federal court ruling could speed up the end of fluoridation in the US.

A judge ordered the US Environmental Protection Agency (EPA) to undertake a risk assessment. Judge Edward Chen found fluoridation could cause developmental damage and lower IQ in children at the levels found in drinking water. Following this judgment, four water systems, including Salt Lake City's provider, have stopped or suspended fluoridation due to the ruling. At the TTE [Trust The Evidence] office, we searched for updated evidence published in the last decade, including 32 reviews. A word of caution: the overworked staff at the TTE office is currently unable to assess the evidence fully.

Dental Caries

A 2021 review of ten studies on Brazilian populations reported that water fluoridation effectively prevents dental caries [tooth decay] in children younger than 13 years, even with the widespread use of fluoridated toothpaste. A further review of fluoride for under-fives reports that the evidence supporting oral fluoride supplementation for caries prevention is limited and inconsistent. The WHO [World Health Organization] reports fluoride intake has both beneficial effects – in reducing the incidence of dental caries – and negative effects – in causing tooth enamel and skeletal fluorosis following prolonged high exposure.

Potential Harms

Reviews include an assessment of dental fluorosis, which affects

individuals of all ages, with the highest prevalence below age 11. A further review reported that in 6 – 18-year-olds, at a water fluoride level of less than 0.7 parts per million, dental fluorosis occurred in 13% (95% CI: 7.5 – 18%) of the children. Above two parts per million dental fluorosis prevalence rose to 98% (95% CI: 96 – 100%). In some regions, the amount of fluoride in the water represents a public health problem as it exceeds national and international regulation levels. Reviews also assessed an association with hypothyroidism and children's intelligence. Regarding neurological disorders, the evidence was inconclusive, and the authors call for epidemiological studies to provide further evidence regarding the possible association. A call for evidence that is repeated for establishing whether there is an association with hip fracture risk. Reviews have also assessed the potential correlation with increased blood pressure, association with chronic kidney disease, and risk of fluoride contamination in groundwater and its impact on the safety and productivity of food and feed crops.

The Impact of Stopping Fluoride

A systematic review, including six cross-sectional design studies, indicated that fluorosis [a disorder caused by ingestion of excessive fluoride] significantly decreased following either a reduction in fluoride concentration or the cessation of adding fluoride to the water supply. A systematic review of 15 studies identified methodological considerations for designing community water

fluoridation cessation studies.

These studies would permit an assessment of the effects of cessation on dental caries and the impact on reducing harm.

Where Does This Leave RFK, Jr.?

Beware of the swift condemnation of anyone who asks questions. Experts will espouse that fluoride is well-tested, it definitively or significantly decreases caries, and it has no association with any harm – all without reference to the evidence. Furthermore, the argument is lost when an individual who puts forward questions about healthcare exposure is referred to as a denier. RFK, Jr. rightly asks questions about an intervention based on evidence going back to the 1930s. In the meantime, there have been growing concerns about harm and little contemporary evidence evaluating the effectiveness of water fluoridation in preventing caries. So, stopping fluoride in the context of epidemiological evaluations isn't far off the mark.

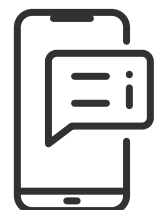

The Bell Is Tolling for Trans Activism

More and more countries are waking up to the dangers posed to children by extremist trans activism and gender ideology, leaving the Albanese government increasingly isolated in its enthusiastic support for the hideous movement.

It began in the United Kingdom, at the Tavistock gender clinic in London. Its practices and treatment of children presenting with ‘gender identity’ issues prompted a groundbreaking inquiry – the Cass Review – commissioned by the country’s National Health Service in 2020.

In 2011, the Tavistock clinic had 250 kids seeking treatment. In 2021, this number had risen to more than 5000. The Cass Review recommended an end to the ‘gender affirmation’ approach to these kids, and the NHS issued clinical guidelines requiring more holistic, comprehensive assessments and approaches to treating children with gender issues. The review found:

- there was no simple explanation for the increase in the numbers of predominantly young people and young adults who have a trans or gender diverse identity, but there is broad agreement that it is a result of a complex interplay between biological, psychological and social factors;
- there were conflicting views about the clinical approach, with expectations of care at times being far from usual clinical practice – this has made some clinicians fearful of working with gender-questioning young people, despite their presentation being similar to many children and young people presenting to other NHS services;
- an appraisal of international guidelines for care and treatment of children and young people with gender incongruence found that that no single guideline could be applied in its entirety;
- while a considerable amount of research has been published in this field, systematic evidence reviews demonstrated the poor quality of the published studies, meaning there is not a reliable evidence base upon which to make clinical decisions, or for



children and their families to make informed choices;

- the strengths and weaknesses of the evidence base on the care of children and young people are often misrepresented and overstated, both in scientific publications and social debate;
- the rationale for early puberty suppression remains unclear, with weak evidence regarding the impact on gender dysphoria, mental or psychosocial health;
- the effect on cognitive and psychosexual development of puberty suppression remains unknown;
- the use of masculinising/ feminising hormones in those under the age of 18 also presents many unknowns, despite their longstanding use in the adult transgender population;
- clinicians are unable to determine with any certainty which children and young people will go on to have an enduring trans identity; and
- for the majority of young people, a medical pathway may not be the best way to manage their gender-related distress. For those young people for whom a medical pathway is clinically indicated, it is not enough to provide this without also addressing wider mental health and/or psychosocially challenging problems.

The new UK Labour government has since banned the use of puberty blockers for children under 18 indefinitely, based on a targeted review by the UK Commission on Human Medicines which found they posed an “unacceptable safety risk”.

Other countries have followed the UK’s example, including

Belgium, Finland, Turkey and Canada. November 2024 saw New Zealand join the growing number of countries now requiring holistic treatments instead of automatically putting kids on life-altering puberty-suppression drugs as a prelude to gender re-assignment surgery.

On the back of New Zealand’s about-turn, I again moved for a Senate inquiry into the use of puberty blockers and yet again Labor and the Greens – along with cross bench senators Pocock, Thorpe and Tyrrell – blocked it. For the fifth time!

Australia has also experienced a massive rise in children presenting with gender dysphoria, a 10-fold increase between 2014 and

2021, and a 100-fold increase in adolescents being treated with puberty blockers at public clinics in Australia in the same period. We don’t know the numbers for private gender clinics, but it’s a very safe bet the total number is much higher.

For the life of me I do not understand why lawmakers will not support an inquiry that examines the causes of this exponential rise in Australian children with gender identity issues. If it had been any other condition affecting children which had suddenly exploded in numbers there would be national outrage, demands for inquiries and answers, and demands for funding and support programs.

But not this one. Labor and the Greens categorically refuse to bring this issue into the light. They want it – and us – kept in the dark. They scream “trans rights are human rights” as if an inquiry into the matter will somehow contravene those rights. All they have is a slogan and – obviously – something to hide from the rest of us.

My response is a little more honest: children’s rights are human rights too, and Australian children are clearly being impacted by a condition that has exploded in Australia. We need and deserve to know why so we can make informed decisions that are in the best interests of these kids. Other countries are taking these steps, so it’s clear they can have inquiries without impacting “trans rights”.

We know from overseas that many children who go through these treatments later regret it, or find they are no happier than before their ‘transition’. Some seek to have their ‘transition’ reversed. They must remain on cross-sex hormone treatments forever. The effects of cross-sex hormones and puberty blockers are not reversible as many activists claim. There is evidence they cause a loss of sexual function and libido and increase the risk of osteoporosis. There are indicators they increase the risk of developing heart conditions and diabetes.

Trans activists just don’t care about the damage this is doing. The role they have played in the explosion of gender dysphoria in Australian children by promoting their hateful, intolerant and exclusionary ideology should also be the subject of an inquiry.

The bell, however, is tolling for trans activism. Their excesses – including death threats against women seeking to preserve the rights and exclusive spaces they fought for over generations – are opening eyes in other countries while Labor and the Greens remain blind to the harms they’re inflicting on our most vulnerable Australians.

The Turning Point that Shattered

In just one month, three explosive new (FOI) request have shattered the notice

For the climate change zealots and their profiteering masters, October 2024 may go down as one of the most damaging months in the movement's history. A series of bombshell studies, published in their own 'bibles of truth,' completely dismantled the so-called 'climate change scientific consensus'. Unsurprisingly, it was crickets from the mainstream media. But behind the scenes, it's becoming evident that the 'climate boiling' narrative is quietly being retired to the scrap heap of non-existent global emergencies, joining the ranks of acid rain, the new ice age, and the hole in the ozone layer.

The most devastating narrative-buster was published in Nature on October 16th:

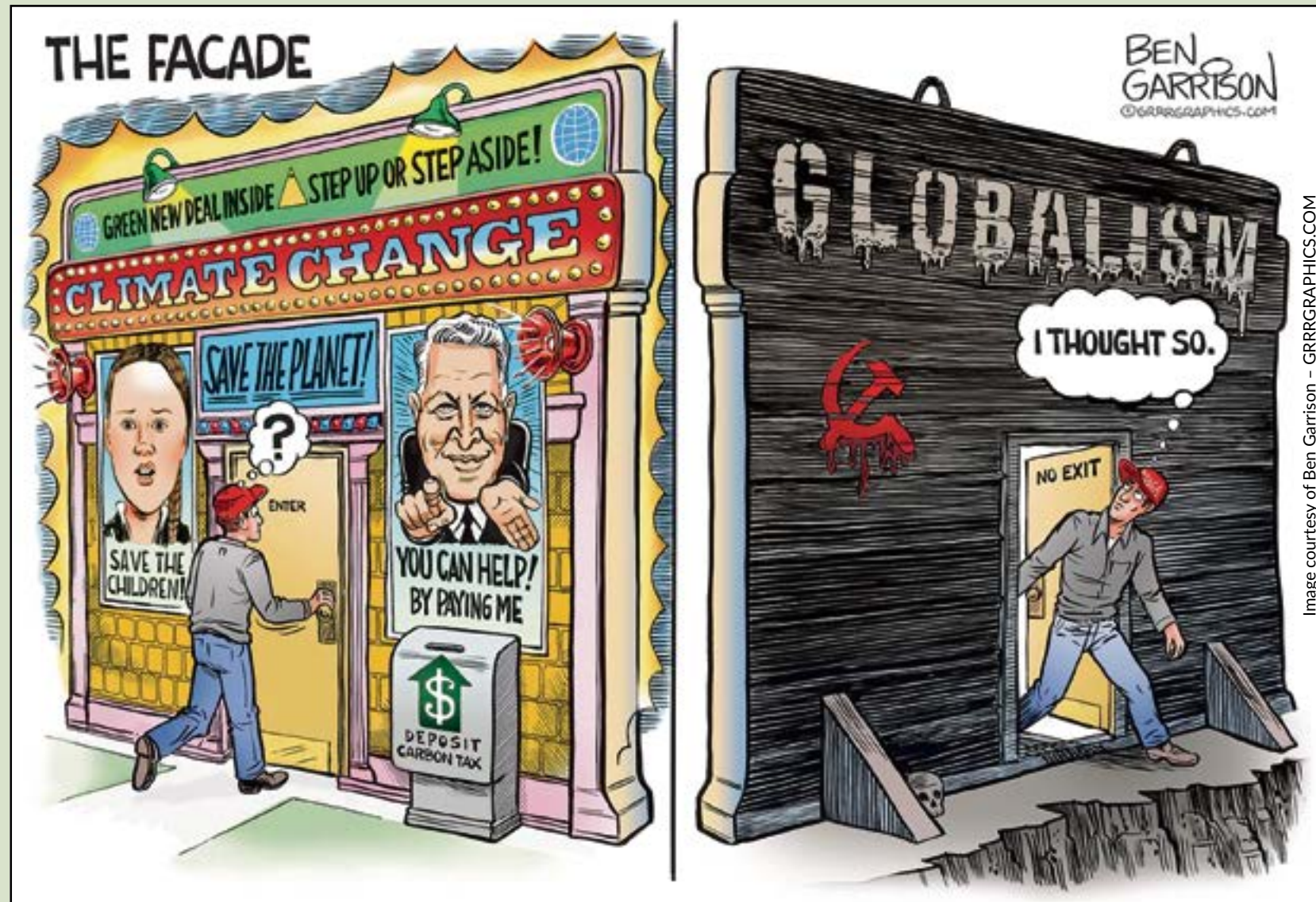
"Terrestrial photosynthesis inferred from plant carbonyl sulphide uptake." This study found that plants absorb roughly 31% more CO₂ than previously thought. The significance of this discovery cannot be overstated.

Particularly in light of a second study published in Nature the following week, on October 25th,

"Enhanced ocean CO₂ uptake due to near-surface temperature gradients." This study revealed that Earth's oceans, in this case, the Atlantic, absorb 7% more CO₂ than earlier models suggested. According to SciTech Daily, ...when [these results are] applied across all oceans, this additional carbon absorption is equivalent to one and half times the carbon captured by annual forest growth in the Amazon rainforest.

A small error of, say, 4% might be embarrassing, but an error margin of 38% could render current climate models useless, raising serious questions about future emissions scenarios and the legitimacy of Global Net Zero policies. These findings add to the growing evidence that the natural world is remarkably efficient at managing carbon. For example, NASA's study "CO₂ is making Earth greener for now" revealed that Earth has actually become greener over the past three decades. This aligns with the theories of 'cancelled' astrophysicist Ferenc Miskolczi, who argued that Earth's atmosphere is self-regulating, naturally adapting to balance gases like CO₂, methane, and other vapours.

The third October study, published in The Proceedings



of the National Academy of Sciences (PNAS), "Rapid shift in methane carbon isotopes suggests microbial emissions drove record high atmospheric methane growth in 2020–2022," found that up to 90% of the surge in atmospheric methane from 2020 to 2022 came from microbial activity, not cows. Despite this, over 150 countries, including Australia, the United Kingdom (UK), and the United States (US), have signed the Global Methane Pledge to cut methane emissions by 30% by 2030. In response, some nations have started culling cattle and adding supplements like Bovaer to livestock feed without first determining whether the methane emissions were linked to human activity, such as farming or natural. This knee-jerk response has led to farmer suicides, land seizures, and further destabilisation of fragile food chains.

Adding to the revelations, an FOI request to the UK's Meteorological Office (Met Office) delivered another blow to the global warming narrative. Ray Sanders' October 31st report revealed that of the 302 sites listed as collecting climate data

across the UK, 103 did not exist. So, the Met Office has effectively been using data from phantom sites. Official documentation lists figures from the closed sites as 'estimated'. Unsurprisingly, the Met Office was not forthcoming on how these estimated figures were calculated. Even worse, some sites have been reporting figures for over 14 years. A less charitable interpretation is that the Met Office fabricated this temperature data. The FOI request also revealed that many rural sites had been closed in favour of urban-based ones. Given the well documented Urban Heat Island Effect, which can make cities up to 7°C warmer than surrounding rural areas, it's not hard to see how data could be skewed to support alarmist rhetoric. Worse still was the location of some of these temperature sites: they were placed in car parks, on beaches, near water treatment plants, surrounded by solar farms, or - straight out of a Monty Python sketch - between a Royal Air Force runway and a sewage treatment tank. As a result, nearly 85% of Met Office sites were deemed UNACCEPTABLE for climate data reporting by

the World Meteorological Organisation and the International Standards Organisation. This matters because Met Office figures feed into global datasets the United Nations uses to 'prove' global warming. These same datasets justify expensive and damaging policies imposed on citizens worldwide through coercion and taxation.

Indeed, most climate policies are cloaked in the rhetoric of fear, shame and guilt, reinforced by threats of social disgrace, fines, or even imprisonment. Brutally deployed during the pandemic, these psychological tactics remain potent tools for enforcing compliance, even when such compliance undermines individual well-being. Once internalised, these 'mechanisms of control' are so powerful they can evoke feelings of guilt and shame even when we're alone and even when a behaviour or action is entirely innocent. To sustain this psychological grip, the narrative requires constant reinforcement that subtly and progressively escalates over time. This peaked in the climate change discourse with Greta Thunberg's 2019 "How dare you" speech at the UN

Climate Action Summit in New York, which famously included the phrase, "You have stolen my dreams and my childhood with your empty words".

This was followed a year later by David Attenborough's documentary, "A Life On Our Planet" in which Attenborough articulated the following timeline of events based on questionable climate models:

- In the 2030s, the Amazon Rainforest will degrade into a dry savannah, causing catastrophic species loss and altering the global water cycle. In the summer, the Arctic will become ice-free.
- By the 2050s, the ocean will continue to heat and thus become more acidic, killing all coral reefs and most fish life.
- Thus, by the 2100s, large parts of the Earth will become uninhabitable, leading to a sixth mass extinction event.

That's a lot for just 75 years... These methods of psychological manipulation are cruel and disproportionately punish those least responsible for the so-called 'emergency'. Never mind that 80% of global CO₂ emissions come from just 57 companies.

studies and a Freedom of Information Act that ‘the climate science is settled.’

Presenting a very easy ‘fix’ if that was the actual goal of this agenda. Moreover, much of the climate narrative is rooted in the school of attribution science. This is a little-known fact because this relatively new field of scientific inquiry is based almost entirely on computing modelling, in other words, predictions. The integrity of these models depends on the quality of input data and the biases of researchers, many of whom are incentivised by funding, recognition, and career advancement (i.e., good old fame and fortune).

These ‘best in practice’ algorithms and techniques are similar to those used by Neil Ferguson and his team at Imperial College London, who predicted that the Bird Flu Pandemic of

the early 2000s would kill over 150,000,000 people when the actual death toll was closer to 470... worldwide. The arrogance of the people conducting this modelling, who believe that they can arrive at a consensus or ‘truth,’ disrespects and runs counter to the scientific method and the advice of arguably two of the greatest scientific minds. Albert Einstein championed humility in science, warning, “...all our science, measured against reality, is primitive and childlike...”. Carl Sagan similarly decried science masquerading as truth, labelling any such claims pseudoscience, evident when “practitioners are defensive and wary” and where “sceptical scrutiny is opposed.”

Sound familiar? Yet, despite two decades of relentless climate

‘fear porn,’ cracks in the narrative are showing. Scepticism will only grow as climate ‘milestone years’ continue to pass without the predicted catastrophes. Even in Australia, once a bastion of climate alarmism, public concern is waning. What the weather may or may not be doing one hundred years from now is of little concern when you’re struggling to put food on the table and keep a roof over your head. The latest Melbourne Institute’s *Taking the Pulse of the Nation Poll* shows that the number of Australians listing climate change as one of their most critical election issues has slipped from 59% in 2022 to 42% this year. Support has declined most among Labor voters, 79.2% to 58.6%, and The Greens voters, 90.4% to 79%. These two-year

drops are enormous. It will be interesting to see how the teal party pivots in the 2025 election, given that their 2022 campaign was almost entirely focused on climate change and heavily funded by one of Australia’s richest and most outspoken climate activists. These developments, including the fact that these narrative-shattering studies were ‘allowed’ to be published, particularly in those journals, make me nervous. It signals that the pervasive ‘end-of-the-world’ narrative is about to shift, and recent history warns that with each new global ‘emergency,’ the fear, shame, guilt, alarmism, and costs to citizens have grown exponentially. This reminds me of the infamous quote from the Club of Rome’s 1994 book *The First*

Global Revolution:

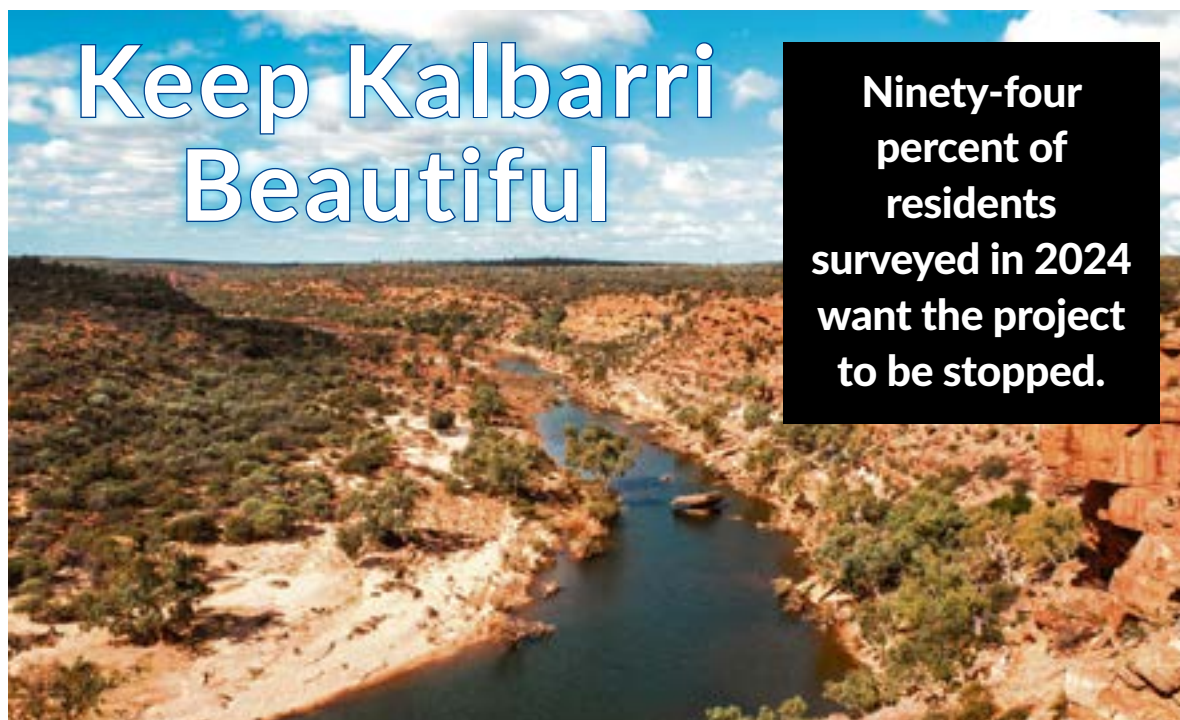

Holiday makers and locals enjoy surfing, whale watching, hiking and camping. Deservedly, in 2024, it received the WA Tiny Tourism Award. Kalbarri is famous for its bountiful recreational fishing with numerous endemic species to the area and is also home to the vital WA rock lobster industry.

Mining and industrial exploitation across prime agricultural land and our oceans is finding its way to Australia's isolated communities just like Kalbarri. Until now, Kalbarri has managed to retain its natural beauty with the community preserving its charm by blending everyday living, eco-tourism and indigenous culture in harmony with its surrounds. Locals are passionate about preserving it for future generations.

The Keep Kalbarri Beautiful Facebook group was formed by the community and has been battling Danish corporation Copenhagen Infrastructure Partners (CIP) in an effort to prevent their subsidiary Murchison Green Hydrogen

THE VENTURE WILL COMPRISE OF:

- **200** offshore wind turbines - this part of the project is absent from the Environmental Protection Agency's (EPA) website but was stated to be built by another foreign company for CIP/ MGH plant usage

- Offshore mooring for liquified green hydrogen/ammonia international exportation - up to **5km** offshore in **30+m** depth
- Desalination plant, hydrogen/ammonia production facility, holding tanks and workers camp taking up **50-100 hectares**

(MGH) from industrialising their town. MGH is one of six companies shortlisted for a grant from Australian Renewable Energy

Agency's (ARENA) Hydrogen Headstart Program worth \$2 billion, to create a Green Hydrogen Hub in Kalbarri. Ninety-four percent of

residents surveyed in 2024 want the project to be stopped.

MGH claims, "This project will significantly contribute to

the decarbonisation of the world and help to reduce the impacts of climate change by producing a green, clean, and viable alternative energy source for global use." However, liquified green hydrogen/ammonia is known to be toxic to humans and aquatic systems, taking only 1 part per million to kill aquatic systems. The proposed site is only 20 kilometers north of Kalbarri and will be transformed into an industrialised zone that potentially will be seen, heard and smelt by residents and visitors.

The Environmental Protection Agency approval requires 'Inland Water' assessments. Such a requirement has revealed that there is 'no available groundwater' on the entire site for use in the construction of roads, concrete for the wind turbine bases and site establishment. Massive volumes of water for construction will be required long before a desalination plant can be built.

Notably, a Native Title Agreement has 'not been' agreed to with the Nanda People, especially considering much of the proposed industrial sites for wind turbines and solar array contain possible burial and cultural sites.

Given that blasting and significant substrate modification will be necessary to make any of the above feasible, it appears CIP/ MGH are pursuing an unattainable goal and perhaps is yet another money grab akin to numerous other green renewable projects.

Nuclear Energy: Cheap, Clean & Recyclable

"The cost of living doesn't affect us – we only care about climate change." This is what a teal volunteer told me during the Sydney electorate of Pittwater by-election in October [2024]. It indicated the mentality of teal supporters. After all, why would anyone care about the cost of living when the Earth is gripped by 'global boiling'? Teal volunteers are disciplined in their approach, loaded with talking points to tackle their Liberal opponents. Leader of the Opposition, Peter Dutton



was public enemy number one, as the teals declared that Dutton was "holding the Liberal Party back" by embracing nuclear energy.

The teal volunteer then asked if I had seen the recent ABC

Four Corners report [Nuclear Gamble 7 October 2024] which argued against nuclear power. To him, it was proof that nuclear energy was a pipe dream. He then proclaimed that nuclear energy would not work in Australia, citing the recent GenCost report by the Commonwealth Scientific and Industrial Research Organisation (CSIRO) and Australian Energy Market Operator (AEMO). However, when I asked why France sources most of its electricity from nuclear, the teal admitted he had never heard that before and said he would 'look into it'.

Two weeks later, I interviewed Charles-Henri Gallois, Chairman of French political party, 'Reprenons le Controle' (Let's Take Back

Control). I did not hesitate in asking him to confirm France's reliance on nuclear. "80% of electricity production is done by nuclear (in France)" he explained. "Actually, we could have 100%, but we have, let's say, 'renewables' imposed by the EU." "I think nuclear energy has two main advantages," he added. "It's cheap... and then you don't have emissions."

Better yet, a French company, Orano, has been recycling nuclear materials for 60 years. The Orano website states, "Following recycling operations, 96% of spent nuclear fuel (95% uranium + 1% plutonium) can be reused to manufacture new fuel, which will then supply more electricity in turn".

Interestingly, Orano currently has recycling contracts with

several countries, including Australia. Yes, Australia already recycles its nuclear fuel. Back in 2005, former Prime Minister Bob Hawke argued that Australia should accept the world's nuclear waste "as an act of economic sanity... and environmental responsibility". "We'd get an enormous flow of stable income which would be to the benefit of the world," he added. Not only could Australia take the world's waste, but we could recycle it, potentially negating the need to dig another ounce of uranium out of the ground. If France proves that nuclear is cheap, clean and recyclable, why are the teals, and Australia, not on board?

The Roots of World War III

The American diplomat and historian George F. Kennan called the First World War the “seminal catastrophe” of the 20th century, and he wrote two lengthy books on the events that led to the outbreak of that war: *The Decline of Bismarck’s European Order* and *The Fateful Alliance*. He also included one of his lectures on the First World War in his book *American Diplomacy*. Reading these works of history gives one a better sense of the root causes of that war, which included policies, decisions, and events that occurred decades before June-August 1914.

When the war began in the Balkans after the assassination of the Austrian archduke and his wife in Sarajevo on June 28, 1914, few foresaw that the conflict would eventually engulf most of Europe and parts of Asia, Africa, and the Middle East, and result in the toppling of four empires (Romanov, Hohenzollern, Hapsburg, and Ottoman), the deaths of more than 10 million combatants, the aerial bombing of cities, the use of poison gas, the carving-up of territories in the Middle East that would engender conflicts that continue to this day, the creation of revolutionary secular ideologies that led to an even more destructive war and a Cold War that followed it. When Kennan reviewed the major diplomatic and international events in the rest of the century, he remarked that “all the lines of inquiry” led back to World War I.

Today, with wars in Eastern Europe and the Middle East, and a gathering storm in the Western Pacific, there is concern that the world is lurching toward another world war. All three conflicts involve at least one nuclear armed power. Some respected strategists and observers believe that an “axis” of autocracies (Russia, China, Iran, and perhaps North Korea) are collaborating to undermine the global order produced by the end of the Cold War, and are urging the United States and its allies to become more deeply involved in these conflicts. Some have even urged the formulation of a “grand strategy” for winning the

Third World War. The “lessons of Munich” have been invoked along with Churchillian-like warnings about the need to confront aggressors now to deter future aggression. Those who counsel prudence or restraint, or who promote diplomatic solutions to these conflicts are often labeled “appeasers” or worse.

In *The Decline of Bismarck’s European Order*, Kennan wrote that the origins of World War I could be traced to at least 1875, when the future Franco-Russian alliance first germinated in the minds of the statesmen of both countries. A hallmark of German Chancellor Otto von Bismarck’s diplomacy was to prevent an alliance between France and Russia. When Bismarck left the scene in 1890 – forced into retirement by the brash Kaiser Wilhelm II – his alliance structure gradually fell apart. During the next two decades, France and Russia grew closer, eventually entering into what Kennan called the “fateful alliance” in 1894. Germany, meanwhile, allowed the Reinsurance Treaty with Russia to lapse, grew closer to Austria-Hungary, while simultaneously scaring Great Britain by challenging it at sea. Yet,

almost to the very day in August 1914, that Germany declared war on Russia, and the alliance system quickly brought other great powers into the war, few believed that the regional war between Austria-Hungary and Serbia would spread across Europe, into Asia, the Middle East, and Africa, and draw into the maelstrom of conflict combatants from Australia, North America, and elsewhere.

In *The Fateful Alliance*, Kennan explained what he characterised as a “whole series of... aberrations, misunderstandings, and bewilderments that have played so tragic and fateful a part in the development of Western civilization over the subsequent decades.” He continued:

One sees how the unjustified assumption of war’s likelihood could become the cause of its final inevitability. One sees the growth of military-technological capabilities to levels that exceed man’s capacity for making any rational and intelligent use of them. One sees how the myopia induced by indulgence in the mass emotional compulsions of modern nationalism destroys the power to form any coherent, realistic view

of true national interest. One sees, finally, the inability of otherwise intelligent men to perceive the inherent self-destructive quality of warfare among the great industrial powers of the modern age.

Kennan worried that in the nuclear age, these developments could result in “a catastrophe from which there can be no recovery and no return.”

In his seminal history of World War II, *The Second World Wars*, Victor Davis Hanson described how a series of smaller, regional wars – an Italian-Ethiopian war, a German/Soviet-Polish war, a German-Norwegian war, a German-Danish war, a German/Italian-French/British war, a German-Yugoslav war, a German-Greek war, a German-Soviet War, a Japanese-Chinese War, a U.S./Britain-Japan War – expanded into a global conflict of unprecedented proportions and destruction.

Today, the wars between Russia-Ukraine/NATO/US, Israel/US-Hamas/Hezbollah/Iran, and the China-Taiwan/U.S. dispute are regional conflicts that if not limited and resolved may expand into a global conflict among nuclear powers – a Third World War, which, to paraphrase George Kennan, would be a catastrophe from which there would be no recovery and no return. Yet, the United States under the [former] Biden administration seems intent on continuing and escalating its involvement in Ukraine, even as it sends mixed signals about our intentions in the Middle East and

the western Pacific. Adding to the danger is a growing perception both here and abroad that the American president is cognitively unfit for the job of commander-in-chief and chief diplomat.

Should, God forbid, World War III evolve out of these regional conflicts, historians of Kennan’s depth and insight may trace its roots to the early post-Cold War years when successive administrations expanded NATO and positioned the alliance on Russia’s European borders despite vigorous protests from successive Russian leaders (Gorbachev, Yeltsin, Putin), and prophetic warnings from Kennan and several other experts on Russia and international affairs (including Richard Pipes, Edward Luttwak, Jack Matlock, Jr, Paul Nitze, Fred Ikle, Sam Nunn, Marshall Shulman) that NATO enlargement would produce an aggressive Russian reaction.

Those same historians may also cite the foolish and failed post-Cold War engagement of China which helped facilitate the rise of our next peer competitor even as it drove Russia into the arms of that peer competitor while we were distracted fighting peripheral wars in Afghanistan and Iraq, and clearing the way for greater Iranian influence in the Middle East in our quest to remake that region in our own image (the so-called “Arab Spring”).

Now, some in the West are calling on the U.S. and its allies to invite Ukraine to become a member of NATO even as Ukraine’s war with Russia gives no sign of ending. This caused more than 60 foreign policy specialists and scholars to pen an open letter to NATO leaders urging them not to invite Ukraine into the alliance. “Moving Ukraine toward membership in the alliance,” the letter states, “could make the problem worse, turning Ukraine into the site of a prolonged showdown between the world’s two leading nuclear powers and playing into Vladimir Putin’s narrative that he is fighting the west in Ukraine rather than the people of Ukraine.” Such a move, the signers contend, “would reduce the security of the United States and NATO allies, at considerable risk to all.” Let us hope that a future George Kennan will not describe a U.S.-NATO-Ukraine Treaty as a “fateful alliance.”

Homeschooling on the Rise

Rejecting Indoctrination, Embracing Education

We live in an age where mainstream education is often packed tight with irrelevant social engineering and is taught impersonally. External forces, including the teachers' political opinions, increasingly influence, pressure and distract students. As a result, Australia witnessed a 111 per cent increase in homeschooling in just five years, from 2018 to 2023. In 2018, homeschool registrations were 20,260, compared with 2023's 43,892. Queensland has the highest increase, 210 per cent, tripling. The second highest is New South Wales, at 127 per cent, followed by Victoria, South Australia, Western Australia, and Tasmania.

Homeschooling presents an excellent alternative for many families, providing an academic setting that prioritises children's welfare and provides more holistic development. Anecdotally, during Covid school lockdowns, many parents were absolutely horrified to see how far mainstream schools had deviated from solid education, and they pulled their children out of school, preferring homeschool. Educating children at home means avoiding public institutions' involvement in their raising while nurturing strong family bonds. In traditional school settings, children spend most of their day away from home, leaving little room for connecting with family members. In contrast, homeschooling can not only facilitate academic growth but foster emotional stability and the family's core values.

One of the biggest misconceptions about homeschooling is that it does not allow interaction with other children, which is needed for developing social skills. On the contrary, parents can choose a variety of social experiences in which the

child can engage, such as community groups, sports, homeschooling co-ops, and visits to live community events and businesses. In this way, parents can guide such interactions, avoid influences not aligned with the family's values, avoid negative influences and ensure the development of healthy relationships.

Furthermore, socialisation takes place every day within the family unit, and the bonds created in interactions throughout every day are incredibly beneficial for the child's mental and emotional wellbeing. Home education allows the development of trust among family members through shared experiences, activities and discussions. Ultimately, the presence of a supportive family is an invaluable asset in children's lives, especially during developmental stages.

A notable benefit of home education is the program, which can be personalised and delivered

in a way that suits the children's learning styles and interests in ways not possible in traditional, overcrowded classrooms. Homeschooling's flexibility ensures a stress-free learning environment and allows enough free time for extracurricular activities and personal interests, employing an allistic development approach.

As said earlier, in the five years from 2018 to 2023, homeschooling more than doubled across Australia, with rates in Queensland more than tripling. This trend reflects parents' distrust of educational institutions. Several social and political factors drive this growing distrust, leaving parents increasingly feeling uneasy and concluding that traditional schooling is no longer the best environment for their children's academic, moral, emotional, physical, spiritual and social development. Research on homeschooling shows

that the reasons parents take a step towards home education include the elements of dissatisfaction with the government, with conventional schools and with the curriculum.

Educational institutions are perceived as increasingly ideologically driven. To put it bluntly, they're woke. Their purpose is to indoctrinate, not educate, and to create serfs who cannot think critically. As John Rockefeller said, these are factory fodder for his business empire, which is now global. Cross-cultural priorities of race and sustainability are integrated into the curriculum along with other aggressive narratives of gender and identity. Children are being taught about gender identity and pronouns and in some cases are made to apologise for the sins of their forebears, encouraged in the abrasive gender and transgender ideology. Meanwhile, imposing welcome to country chants and calls to pay respect to the custodians of the land loses people. Children are in fear daily with climate fraud and lies saying we have only five years to live unless we stop driving cars, which will stop the global boiling. Unfounded guilt damages children. All this builds distrust in children and disrespect for woke teachers. Parents and increasingly people across society have had a gutful.

Meanwhile, between 2003 and 2015, the Australian academic

landscape has been in steady decline. One in three students failed reading proficiency. Fifty per cent of students failed science literacy tests. Half are scientifically illiterate. No wonder the climate fraud and climate fear have taken hold! The average in mathematics declined 26.7 points. All these factors accounted for, taking back the lead on their own children's education makes sense for parents. This sentiment was clear when Queensland Labor's education minister put forward legislation enforcing the national curriculum in home education. Through the public pushback, with 900 submissions and a petition of almost 22,000 signatures, parents have made their feelings about education clear. Parents are unhappy with public educational institutions and with the national curriculum. Every parent's top job is raising their family's children. One of our nation's most important tasks is educating children. We must support homeschooling, reform education and give parents choice.

Gillard's Parting Gift: Self ID

Many of you would by now have heard that former Prime Minister, Julia Gillard amended the Sex Discrimination Act in 2013 to also include gender identity, sexual orientation, and intersex conditions (disorders of sexual development). The initial purpose of the Act

was to create a fairer society for women by addressing sex-based discrimination, but now it has paved the way for Self ID.

A simple and obvious example of sex-based discrimination for instance was access to toilets. In the past there were often only public toilets for men but not for women. This led to the expression "urinary leash" being coined, referring to the fact that women could only be away from home for as long as they could hold their bladder. By including gender identity as something that could be discriminated against, we have watered down the sex-

based provisions aimed at keeping women safe.

Both biological sex and intersex conditions are rooted in reality. There are clear parameters that identify sex and disorders of sexual development. None of that, however, relates to gender identity. Gender identity is based on feelings only. There are no objective diagnostic criteria except for someone stating they feel like a woman or a man. Literally any man can self-identify as a woman and the current Act does not provide us with any recourse to dispute that. This means that a feeling carries greater weight than reality.

The obvious implication here is that any man can now access women's spaces and sports. If we are serious about the safety of women and girls, we absolutely need to have the definition of women reinstated, so the original purpose of the Act can be fulfilled. I am not a woman because I feel like one, I am a woman because I am an adult human female. Thanks to Labor, the urinary leash is making a return.

Revisiting the Past to Find Our Future

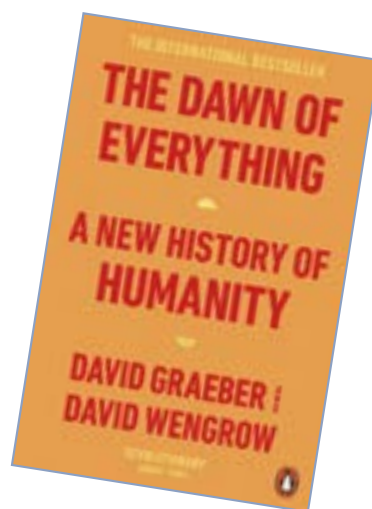
In *The Dawn of Everything* authors David Graeber and David Wengrow delve into thousands of years of history and find the story is more complicated, interesting and hopeful than generations of students have been led to believe. The authors worked together for 10 years to create this major academic work of 527 pages in the Penguin paperback with 83 pages of notes. David Graeber died three weeks after completing the book. His other big historical work – *Debt, the First 5,000 Years* – is also on this reviewer's shelf.

Graeber was a professor of anthropology at the London School of Economics. Wengrow is a professor of comparative archaeology at the Institute of Archaeology, University College, London. The two men used advances made in the last 50 years in the techniques of their

disciplines to re-examine ancient societies all around the world and made a detailed analysis of the indigenous people of the North American Eastern Woodlands both before and after the arrival of the French and British. There are some fascinating insights, including a possibility that the native American disdain for French class distinctions may have influenced French revolutionary thinking.

The authors take issue with the linear view of human development that has dominated the social sciences since Turgot and the young Adam Smith defined the four stages of hunter-gatherers, pastoralists, farmers and today's commercial world. Detailed study shows that some hunter-gatherers tried farming then went back to foraging. Others did a bit of both. Of special importance to today's Western society is research into ancient cities known as megasites discovered in Ukraine dating back to 4,000 years BC.

"There was ample potential



for some to lord it over others or battle for the spoils but over eight centuries we find little evidence for warfare or the rise of social elites."

"Careful analysis by archaeologists shows how the apparent uniformity of the Ukrainian megasites arose from the bottom up through processes of local decision-making."

"Highly egalitarian organisation has been possible on an urban scale."

(Earlier in the text) "The mere fact of urban life does not necessarily involve any particular form of political organisation and never did."

The writers ask how societies such as ours in the contemporary West become "stuck" in our hierarchies, social and economic divisions and they explore the nature of freedom.

"We are not talking about freedom as an abstract or formal principle (as in liberty, equality, fraternity). We have instead talked about basic forms of social liberty which one might actually put into practice. (1) The freedom to move away or relocate from one's surroundings. (2) The freedom to ignore or disobey commands issued by others and (3) the freedom to shape entirely new social realities or shift back and forth between different ones."

"The three basic freedoms have gradually receded to the point where a majority of people living today barely comprehend what it might be like to live in a social

order based on them."

The situation has deteriorated since the authors finished their magnum opus to the point where politicians like the Australian Premiers have forced millions of people to be injected with experimental gene therapies in order to hang on to their jobs. Many of the victims went along with this terror and are yet to wake up. Addressing the question of how we become "unstuck" the authors describe the present as a time when real change is possible.

"Societies around the world appear to be cascading towards such a point... In developing the scientific means to know our own past we have exposed the mythical structure of our 'social science.'"

"What is the purpose of this new knowledge if not to reshape our conception of who we are and what we might yet become? If not, in other words, to rediscover the meaning of our third basic freedom, the freedom to create new and different forms of social reality?"
