





Finding mRNA in breast milk typifies how Covid-19 vaccine safety was oversold

On the 24th September 2021, when CDC director Rochelle Walensky was asked if it was safe to receive a Covid-19 vaccine while breastfeeding, her reply was unwavering:

“THERE is no bad time to get vaccinated,” said Walensky.

“Get vaccinated while you’re thinking about having a baby, before you’re thinking about having a baby, while you’re pregnant with your baby or after you’ve delivered your baby.”

But Walensky’s advice was not based on science. The safety studies had not been done.

It has been over a year since her comment, and a study published in JAMA found trace amounts of mRNA in the breast milk of mothers who’d received the Pfizer or Moderna Covid-19 vaccine.

The researchers speculated that lipid nanoparticles containing mRNA, once injected into the arm, are transported via the lymphatic system to the mammary glands and expressed into breast milk.

Yes, it was a small study, and the mRNA was only detected in expressed breast milk for up to two

days, but the authors stated:

Caution is warranted about breastfeeding children younger than 6 months in the first 48 hours after maternal vaccination **until more safety studies are conducted.**

Caution is warranted?

Aaron Kheriaty, psychiatrist and director of the Bioethics and American Democracy Program at the Ethics and Public Policy, Washington DC, has been critical of the “jab first, ask questions later” approach.

He says Walensky’s insistence about the safety of mRNA vaccines in breastfeeding women was “completely reckless” in the absence of adequate safety data.

“We don’t have evidence that it’s harmful, but we also don’t have sufficient evidence that it is safe for your baby, so that’s the first thing that needs to be said when there’s an absence of evidence,” says Kheriaty.

There are still many unknowns. Oral ingestion of mRNA bound to lipid nanoparticles has no demonstrated safety, and the pegylated product (a design of the mRNA vaccines) when ingested, can be rapidly absorbed through the gut lining.

“The safety studies should’ve been done right out of the gate. Until you actually do the studies, you cannot, at the same time, come out and say, don’t worry, this is safe. We have to inform people of the state of the science, we should tell them that the evidence is not clear,” he adds.

Public health authorities argued that pregnant women and their babies would face a greater risk of harm from Covid-19 than from the vaccine, but Kheriaty says it was guesswork.

“We didn’t know any of that. It

was a theoretical risk. Childbearing women were excluded from the clinical trials, so we did not have that data.”

Childbearing women were coerced

Adam Urato, a maternal-foetal medicine specialist at MetroWest Medical Centre, Massachusetts, says vaccines have an important role to play in medicine, but admits that many of his patients have legitimate concerns about the unknown impact of Covid-19 vaccines on pregnancy and breastfeeding.

“These women make good points. They should be listened to, and their judgement and decisions respected,” says Urato.

“After all, these vaccines are synthetic chemical structures. They are made in chemical manufacturing facilities. They aren’t ‘all natural’ substances. And, honestly, we just don’t know what all of the effects are going to be from using these vaccines during pregnancy and during breastfeeding,” he adds.

Urato rejects the media narrative that childbearing women are “victims of misinformation” if they have concerns about Covid-19 vaccine safety.

“My patients are intelligent, they have good instincts and I think their concerns are valid. The idea that all of these women are misled, and uninformed ‘victims of misinformation’ is an insult to them,” he says.

When vaccine mandates were imposed across the globe, many pregnant and breastfeeding women were forced to get vaccinated under penalty of losing their jobs and those who declined, were accused of being anti-vaxxers.

“Pregnant women should be allowed to make personal health choices and decide what gets injected into their body, and the decision should be free from coercion,” says Urato.

Instead, doctors are being coached on ways to handle vaccine hesitancy. In Canada, for example, the College of Physicians and Surgeons of Ontario encouraged doctors to prescribe medication to manage anxieties about the vaccine or to recommend psychotherapy.

The precautionary principle

A recent article by British sociologist Robert Dingwall reminds us of the underlying principle of clinicians *primum non nocere*; the first duty of a doctor is to do no harm.

Dingwall writes that safety cannot be “assumed” but must be demonstrated. He says, “doing stuff just in case” or because “it might help,” is not sufficient.

“Emergency conditions do not justify the abandonment of the precautionary principle. If action is urgent, but benefits and harms are uncertain, then the actions or innovations must be temporary, provisional, and closely monitored with a view to withdrawing or halting them if their benefits are not proportionate to their harms.

Pandemic policies would have looked very different if the precautionary principle had been applied correctly.”

Urato agrees. He says that we will look back with regret at how public health authorities treated pregnant women.

“Vaccine mandates were a really cruel, uncompassionate, and inhumane way to treat pregnant women. The community needs to



really learn from this awful episode and make sure nothing like this happens again.”

Italian nurses and doctors who refused Covid-19 jab reinstated

Government U-Turn on health strategy

THOUSANDS of unvaccinated healthcare staff in Italy who courageously stood firm against government over-reach have had their jobs rightfully restored.

New Health Minister, Orazio Schillaci, announced that, due

to a shortage in healthcare staff, suspended staff can now return to healthcare settings. He said: “A measure is being finalised that will allow the reintegration into service of health staff subject to suspension proceedings for non-compliance with compulsory vaccination, before the expiry date of the suspension.”

The Italian Health Ministry added in a statement: “Six months after the suspension of the state of emergency and given the level of Covid-19 contagion, health minister Orazio Schillaci considers it necessary to initiate a progressive return to normality in activity and behaviour, based on criteria of

responsibility and respect for the law in force.”

New Italian Prime Minister, Giorgia Meloni, accused her predecessors Mario Draghi and Giuseppe Conte of taking an ‘ideological’ approach to handling Covid-19. She said: “The previous governments took a host of measures that had no scientific evidence.”

According to an *Epoch Times* report, under previous Prime Minister, Mario Draghi, whose government imploded in the midst of an energy crisis and a worsening economic outlook, all public and private sector workers had to get a Covid-19 ‘green pass’ before they

could go to work.

The report continued: ‘Italians who ignore the order and go to work without proof of vaccination or a negative test or recovery from the virus are suspended on no pay and fined up to 1,500 euros.’

Earlier this year, former Italian health minister, Roberto Speranza, is said to have told reporters: “We are making these choices in order to restrict the unvaccinated as much as possible, as this is what is causing the burden on our hospital system.”

On October 25, in her first speech at parliament, new Italian leader Meloni said: “Something clearly didn’t work there. That’s

why I want to say that in no way will we imitate this model.”

Reinstating their jobs is a good first step, but does not go far enough. Compensation and grovelling apologies are also required, and questions need to be answered by authorities that promoted medical apartheid.



Democracy under World Economic Forum an illusion

Pfizer knew their vaccine would kill

Own data show shocking number of fatalities and side effects now officially associated with Covid-19 shots

THE documents were first leaked in a cyber attack on the European Medicines Agency website. More than 40 megabytes of classified information from the agency's review were published on the dark web, and several journalists including those at the British Medical Journal were sent copies of the leak.

In the U.S., the Food and Drug Administration had previously agreed to withhold the documents and their jaw-dropping revelations from the public for 75 years, until Texas District Judge Mark Pittman ordered their release within eight months, stating it was 'of paramount public importance'.

Most alarmingly of all, the documents show that in the trials there were at least 1,223 deaths reported in the first 28 days after injection.

The NHS, media and the government continually state that the vaccines are 'safe and effective' while those that report vaccine-related injuries via the Yellow Card scheme are often accused of making false correlations or imagining their symptoms.

However, the Pfizer documents paint a very different picture, listing thousands of side effects that occurred at an alarming rate, which were as a direct result of taking the experimental genetic injection.

According to their report, Pfizer hired 600 extra staff to handle the sheer number of adverse reactions from its Covid-19 shot, and said it had planned to hire 1,800 in total.

Serious side effects included, but were not limited to: auto-immune disorders; blindness; diabetes; herpes; heart problems such as myocarditis; thyroid disorders; neurological conditions such as multiple sclerosis; seizures; epilepsy; narcolepsy and Guillain-Barré Syndrome.

Non-fatal conditions such as eczema, blisters, asthma, fertility problems, inflammatory bowel disease, deafness and even tongue biting are also listed among the side effects by Pfizer.

While it has been approved for use in pregnant women, it is also known to cause pregnancy complications, including many spontaneous abortions. One of the many issues it causes is anaphylactoid syndrome of pregnancy or ASP for short.

ASP is a fatal disease for mothers and is among the leading causes of maternal mortality. Symptoms include severe bleeding, confusion, shortness of breath and anxiety. There is therefore a high risk for pregnant women taking the Covid-19 'vaccine'.

The Pfizer document also lists various blood disorders, Crohn's disease and liver failure as side effects. Blood clotting was another issue reported from the trials.

One of the most telling side effects listed is...Covid-19. Proponents often



argue that despite the possible side effects associated with some of the Covid-19 shots, they at least prevent people from dying from Covid-19.

The problem is that the 'vaccine' actually causes people to develop the disease, and so it is contributing to the number of cases, listing Covid-19-associated pneumonia as a side effect.

Some may argue that these problems are only associated with the Pfizer shot, but death and serious injuries have been present and publicly acknowledged with all of the manufacturers' injections.

Research developed by Edinburgh University showed that almost 350 Britons have been struck down with a rare clotting disorder after getting the AstraZeneca vaccine.

These blood clots cause minor bruising around the body and can leave some with a purple-dotted rash.

The Moderna vaccine has been associated with heart problems such as myocarditis and pericarditis. Their list of adverse reactions also

includes inflammation, fainting and breathing difficulties.

Data from the UK Health Security Agency (UKHSA) in the table has also revealed that both Covid-19 deaths and cases were worse in vaccinated people, particularly those over the age of 18. The official data is clear: the chances of developing Covid-19 increases significantly following subsequent 'booster' jabs.

This is broadly in line with the information contained in the Pfizer document, which states that the shots cause Covid-19 and respiratory illnesses.

Coupled with the fact that ONS data recently revealed that Covid-19 deaths were much lower than previously thought, the risks of taking the vaccine seem to greatly outweigh the risks of not doing so.

G20 commit to vaccine passports and Agenda 2030 in Bali declaration

REPRESENTATIVES of the Group of Twenty (G20) countries met in Bali on 15-16 November 2022, and issued a declaration that again exposes collective intent to control all the world's people, at the expense of our health, autonomy, and fundamental freedoms.

These are not empty words; these are the leaders of the world's major countries, and they are going to act upon their statements. Paragraph 5 of the declaration reads: 'It is essential that the G20 undertakes tangible, precise, swift and necessary actions, using all available policy tools, to address common challenges, including through international

macro policy cooperation and concrete collaborations.'

It is alarming by itself, of course, but these intended policies are an exact match to the stated agenda of the World Economic Forum, a private body no one has elected to govern.

When the people find out their freedoms are being removed, they will not want it, which is why corporate media have been complicitly silent about this declaration.

The G20 are still committed to the fake war on weather, de-industrialisation and creating energy crises: paragraph 17 reiterates the intention to implement COP26 commitments, the Paris Agreement and the push for 'net zero' by any means available, phasing out traditional fuels.

Perhaps the most alarming is the commitment to a world

health dictatorship and towards an international pandemic treaty, as stated in paragraph 19.

Ignoring vaccine damage and continuing to make sure they are pushed to everyone, paragraph 22 declares: 'Covid-19 immunisation is a global public good and we will advance our effort to ensure timely, equitable and universal access to safe, affordable, quality and effective vaccines, therapeutics and diagnostics (VTDs). We remain committed to enhancing global surveillance, including genomic surveillance, in order to detect pathogens and antimicrobial resistance (AMR) that may threaten human health.'

World Council of Health's Tess Lawrie, wrote in response: 'Mounting evidence of regulatory body corruption, and real-world data of harms associated with the Covid-19 injection program do not

support this statement. The World Council for Health invites members of the G20 to take responsibility for the serious failings of the Covid-19 injection program and stand accountable for the extensive harm wreaked on men, women, and children during the Covid-19 crisis.'

Vaccine passports are also back on the menu, despite being soundly rejected by even the vaccinated in most countries. The Health Minister of Indonesia, Budi Gunadi Sadikin, advocated for them, saying, "Let's have a digital health certificate acknowledged by WHO. If you have been vaccinated or tested properly, then you can move around."

This is reflected in paragraph 23: 'recognising digital solutions and non-digital solutions, including proof of vaccinations.'

Continuing to move life online where it can be completely controlled

and censored, the G20 want 'a resilient, safe and secure online environment to enhance confidence and trust in the digital economy. We acknowledge the importance to counter disinformation campaigns, cyber threats, online abuse, and ensuring security in connectivity infrastructure.'

Serious questions as to the nature of the problems they are trying to solve should arise from this G20 declaration, especially as it has been unreported in the world's media.

Amnesty? Before forgiveness comes repentance

Call for Covid-19 amnesty met with astonishment

THERE have been many responses to the recent proposal by Professor of Economics Emily Oster for an ‘amnesty’ and a moving-on from all the schisms that have typified the Covid-19 era.

And we couldn’t even get to our loved ones to say goodbye to them - the elderly, our aunts and uncles, our mothers, our fathers.

“Instead, we were left outside, and they were left to die alone. We couldn’t even go to a funeral. And how about all the suicides that took place, and the child abuse and domestic abuse and drug abuse? Or turning our children into hypochondriacs?

“How about denying people transplants because they didn’t want an experimental ‘vaccine’? And what about the police brutality, attacking those people who were standing in the truth; who wanted to watch their child playing in a sports event without wearing a mask - because

If you said any of the things that have now proved to be true, like this vaccine doesn’t work or [Covid-19] has a very low death rate, or maybe you should try ivermectin or hydroxychloroquine - you can lose your licence.

“Or in the case of the most renowned heart doctor in the world, Dr Peter McCullough, he has now had his licence, which made him a world-renowned cardiologist, taken away.

“Why? Because he’s been quoting the science from around the world on blood clots, on

thrombocytopenia, on myocarditis (the swelling of the heart) - something he knew about more than anyone else. So in the very moment when Dr McCullough’s licence is being taken away and he’s under attack, we’re supposed to give amnesty right now?

“And what is it I’m supposed to forgive you for? Because there’s a word that goes along with forgiveness, if we’re to look at the biblical spiritual nature of this. That word is ‘repent’. Assange verdict: British courts and media **GUILTY!**

THE months-long extradition hearings of Julian Assange, a trial that will forever define modern journalism, have been shamelessly whitewashed by British media. Too few news agencies reported on the utter abrogation of judicial due process and the rule of law exhibited in a British courtroom against an innocent fellow journalist.

This sham trial exposed a fundamental British truth: that the UK courts and its press are really America's concubines, willing to promote any US interest on command.

With the number of courtroom seats set at only sixteen, the few in attendance at Westminster Magistrates' Court provided the only reporting from the trial to the world. Former UK ambassador to Uzbekistan, Craig Murray, reported daily on the courtroom torture of Julian Assange. However, the world's media quashed the story!

Murray wrote in outrage: "I simply cannot believe the blatant abuse of process that is unfolding before my eyes in this courtroom... A complicit mainstream media has ensured those of us who know what is happening are very few."

Extradition effectively began after Assange was dragged from the Ecuadorian Embassy on April 11, 2019, and sentenced on May 1 to fifty weeks in jail for jumping bail for the safety offered by then-president Rafael Correa. The bell tolled when incoming president Lenin Moreno rescinded his asylum due to U.S. pressure.

The judge for the extradition was Vanessa Baraitser, who was selected by Chief Magistrate, Lady Arbuthnot. It has been claimed her husband, Lord James Arbuthnot, had substantial interests with UK and U.S. defence and security contractors and had condemned Assange publicly. Baraitser denied bail, and ordered Assange to be placed each day in a plexiglass box, with one bailiff



on each side of him at the back of the courtroom, where he could not communicate with his attorneys. Baraitser's order brought defence councils QC Edward Fitzgerald and QC Mark Summers together with prosecutor QC James Lewis in stipulating to allow Assange to sit, as normal, with his council. Baraitser denied the request.

Assange was punished before and during the hearings. Always handcuffed, he was moved between five isolation cells on his way to his plastic box. In Belmarsh prison, he has not been allowed proper medical attention, denied his books, writing supplies, and access to his court documents, while being kept in solitary confinement.

When Trump became U.S. president his Attorney General Jeff Sessions stated that it was suddenly "a priority for the Justice Department" to arrest Julian Assange. Later, William Barr, as AG, issued a new superseding indictment in May 2019 - sealed and ignored since 2013 - that added seventeen counts related to the 1917 Espionage Act. This had been an abandoned attempt by Obama's AG, Eric Holder, who refused to indict Assange using the Espionage Act. Yet the allegations were the same in 2018 as they had been in 2013.

Assange's fate may have been sealed, however, when in the last weeks of the Trump/Clinton presidential campaign, Wikileaks provided to the American voter documentary emails that showed that the Democratic National Committee (DNC), led by Donna Brazile, John Podesta, and Amy Wasserman Schultz,

were not promoting democracy at all, but instead a two-year conspiracy to elect only Hillary Clinton, regardless of rising national support for Bernie Sanders. Days later, Hillary lost.

Abuse of process by the prosecution could have given many reasons for an impartial judge to summarily dismiss

extradition treaty provided a specific exemption for political prisoners. A separate UK treaty, not specific to the U.S./UK treaty however, did not contain this prohibition. Baraitser ultimately favoured the prosecution.

The defence produced experts with working knowledge of Alexandria

After many weeks in court, Judge Baraitser ignored virtually the entire defence and ruled that the U.S./UK treaty prohibition did not apply

the extradition request. But the court ignored the wiretap of Assange's embassy office, and of his privileged conversations with his attorneys, the U.S. discussion of his assassination by poison, and that much of the evidence produced by the prosecution was false.

QC Lewis spoke for the American interests while a team of four unknown Americans sat behind him each day passing him notes. The prosecution's case hung on four main points: Assange was not a journalist nor protected by free speech or political prisoner statutes; Assange had committed crimes when he allegedly helped Chelsea Manning obtain a password for her leaked classified material; that Wikileaks put lives at risk by failing to redact important names when publishing the 2010 leak; and that Assange would certainly receive fair treatment in a U.S. gulag after being found guilty.

For testimony, the prosecution relied substantially on the written affidavit of U.S. Assistant Attorney Gordon Kromberg, who was the man who crafted the 2018 U.S. superseding indictment against Assange. Kromberg provided many assurances of Assange's guilt.

For the defence, QC Fitzgerald and QC Summers countered every allegation using expert witnesses with impeccable credentials. The court is said to have restricted the defence by not allowing more than thirty minutes to introduce each expert and their statements to the court.

The very legality of the U.S. extradition request was first in question because the 2004 U.S./UK

City Jail, and the Florence, Colorado SuperMax prison - Assange's fate. Twenty-three hours a day in isolation with one hour of exercise while shackled, two phone calls and one family visit a month, and restricted access to his attorneys. Gordon Kromberg, by affidavit, 'assured' the court that Assange would not likely suffer these conditions.

With the hearing already under way, on June 20, 2020, the prosecution suddenly announced that it was introducing a brand new subsequent indictment. Evidence showed that the U.S. prosecution had planned this move for months despite the defence's preparations. No matter. Baraitser gave the defence six weeks to prepare to challenge the new allegations that the U.S. had kept secret from the court and the defence for months.

Regarding the allegations of Assange helping Manning gain a password for access to classified information, the defence and its witnesses showed that no password was required to gain access; that a journalist aiding a source is constitutionally protected; that Assange had gone to great lengths to redact sensitive information, and that Wikileaks had worked directly with U.S. officials to do so.

As to the Manning leak becoming public, the defence claimed it was two journalists from The Guardian newspaper, Luke Harding and David Leigh, who published the security code in their tell-all book, Wikileaks: Inside Julian Assange's war on secrecy. The code created by Wikileaks was to keep the Manning tranche safe while redacting. The prosecution claimed

that when Assange got word of the situation he alerted U.S. officials. Leigh is said to have dismissed these allegations to the Associated Press, according to a report from CBS News in 2011 (<https://www.cbsnews.com/news/wikileaks-breach-made-all-cables-public/>).

On June 26, 2021, the man the FBI used as its main informant in Iceland regarding Assange helping Manning break the non-existent password, Sigurdur Ingi Thordarson, recanted his testimony, saying it was coerced. His claim is bolstered by Iceland's expulsion of the FBI, because it was fostering Thordarson to frame Assange.

After many weeks, the court ruled that the U.S./UK treaty prohibition did not apply, Assange was not a journalist, nor a political refugee; he did help Manning access a code that did not exist, and he had not redacted national security information.

Unfathomably, Baraitser next ruled that Assange could not be extradited, since incarceration American-style would likely force his eventual suicide.

Any celebration was momentary. Baraitser remanded Assange back into custody, pending a U.S. appeal. In appeals, the UK High Court on Dec 10, 2021, ruled that renewed American "assurances" regarding Assange's treatment in U.S. prison could legally negate Baraitser's inconvenient decision.

Assange next appealed to the UK Supreme Court, but they refused him standing, leaving Home Secretary Priti Patel to twist the knife and approve Assange's extradition on June 16.

The extradition, a kangaroo court twelve years in the making, will now return before the High Court in a last desperate appeal for abuse of process. But first, the Union Jack will be dutifully lowered again from sight... in favour of the Stars and Stripes.

Governments beholden to money power

Dark truths too upsetting for public to accept

IN a representative democracy, we are ruled by a government elected by the people. If we don't like the current administration, we have an opportunity to remove it at the polling booth.


The rhetoric may change, but in practice the differences between mainstream political parties are insignificant. Aside from electoral comings and goings, there is a long-term trend towards state interference in our daily lives. Despite any appearance of progress and prosperity, the people are more controlled than ever. But who is doing the controlling, and why?

Viewed from multiple perspectives, it becomes clear that governments are beholden to the global money system. Any national leaders who resist the globalist agenda are likely to be denounced as anti-democratic or 'far right' (e.g. Viktor Orban in Hungary and Jair Bolsonaro in Brazil); or they may be targeted for 'regime change' (after a long series of Middle-Eastern and Latin-American leaders, the pantomime ogre is now Vladimir Putin). Regime change operations in the 20th century included the destruction of Tsarist Russia by the Bolshevik Revolution, and of Imperial China under Mao Zedong.

The ravaging of Europe in two world wars spawned the supranational entities of the European Union and United Nations. The dismantling of Yugoslavia in the final decade of the millennium was a foretaste of a 'new world order'.

International bodies are conduits of financial power, some more obviously than others (e.g. the Bank of International Settlements, World Bank and International Monetary Fund). Similarly, non-governmental organisations are controlled by embedded money interests; for example, the World Wildlife Fund is backed by the Rockefeller Foundation, whose wealth derives from the hydrocarbon industry (i.e. oil).

Various Rockefeller-backed institutions are at the forefront of the fraudulent climate crisis narrative that vilifies the oil industry. This paradox requires a lot of unpacking, but, in short, the 'net zero' imperative is not about reducing



pollution, but reducing population.

Why is public perception of power structures so far from the reality? Organisations spend vast sums on public relations, which is really manipulation. Propaganda has existed for as long as institutional hierarchy. When the Roman Church was the dominant institution, congregations were told many lies to reinforce the wealth and power of priests and bishops. However, exploiting mass media took shape as a science in the early 20th century, coinciding with the publication of the book *Propaganda* by Edward Bernays (Sigmund Freud's nephew) in 1928.

Since then, the sophistication and ubiquity of psychological manipulation techniques to manage the attitudes and behaviour of the masses has evolved to a level that is awe-inspiring and all-encompassing.

Propaganda is everywhere to see, for those who care to look. But the majority of the people are malleable to messaging by the powers-that-

be, oblivious to the motive of the messenger. This reality has become clear to anyone who has explored how the world works, and whose discoveries are met with disbelief.

The question often asked is - why? To the average man and woman, the answer is simply not credible, because they cannot accept that something so diabolical can possibly exist outside the fiction of dystopian novels or films. If a lie is big enough, people will more easily believe it. Surely the demolition of the Twin Towers wasn't an inside job?

The output of Hollywood and mainstream media 'news' is controlled by the same network that controls all other levers of power. So while people watch Shakespeare or modern drama portraying the diabolical misdeeds of monarchs and cliché contemporary despots, most seem incapable of attributing the same characteristics to supposedly liberal leaders such as Justin Trudeau or Ursula von der Leyen.

A common flaw of lesser mortals

is a belief that such men and women have the same human cares and concerns as their own. They neither understand the psychopathy of power and the type of person drawn to it, nor do they relate the Machiavellian plots and manifestation of evil in the latest TV series or movies to real life. Truth is indeed stranger than fiction.

The internet is a double-edged sword. It is undoubtedly used as an instrument of control, but it also has exposed, to those sufficiently curious, the dark underbelly of power in the world. For now at least, researchers and analysts can obtain information and share their findings with others similarly motivated to understand power and its manifestations.

There is a growing awareness that in co-existence with a web of international policy shops, such as the Bilderberg Group and Trilateral Commission, are secret societies such as the Bavarian Illuminati, which have infiltrated Freemasonry

and conduits of state, Church and corporate power. Thus, we find connections between many of these societies such as Skull & Bones, and the financing and leadership of revolutions and regime change agents. These secret societies indulge in bizarre practices that are so alien to most people that they dare not take them seriously, though the exposure of Jeffery Epstein and Ghislain Maxwell gives a glimpse into this world.

Tjeerd Andringa of the University of Groningen appears to have been silenced since going public in 2015 on his theory of how the kakistocracy (rule by the worst) uses child abuse to perpetuate their control, both over the victims of that abuse and its perpetrators. His interview with James Corbett of the Corbett Report is enlightening on how those in power are seduced into depravity, and why the majority refuse to believe it. Child abuse and other crimes aren't the source of power, but symptoms of the structure that has evolved over two-and-a-half thousand years.

However, even those at the apex should worry about losing control of the evolving 'machine'. The technology of artificial intelligence and digital control, taken to its logical conclusion, would result in the collective suicide of our species. More optimistically for humanity, the misapplied occult techniques and money matrix will culminate in the misanthropic structure's demise. Evil sows the seeds of its own destruction.

Trump and the timing of Covid-19

IN *States of Emergency*, Dutch author Kees Van Der Pijl links the timing of the Covid-19 project to Establishment concerns that Donald Trump would win a second term as President of the United States, commencing in 2020. Trump was and remains a populist candidate with money, who cannot be controlled by the ruling oligarchs. The continued persecution of Trump to this day supports the author's conjecture.

Van Der Pijl's central thesis is that the Establishment – especially after the 2008 financial crash – feared a repeat of 1848, Europe's year of revolution, when Marx and Engels launched *The Communist Manifesto*.

How then to frighten a restless population into submission when terrorism has gone past its use-by date? A health scare looked a likely prospect to provide cover for the imposition of authoritarian governance. Here Van Der Pijl introduces a name that was new to me in the Covid-19 saga.

French social scientist Patrick Zylberman was a key figure paving the way for the radical policies such as lockdowns, taken by governments during Covid-19. His study of the social-psychological consequences of measures used during the SARS-1 epidemic of 2002-2003, were taken up by the Rockefeller machine to produce the blueprint for today's medical pseudo-scientific police state.

Zylberman worked as a visiting researcher at the University of Toronto, the city where SARS-1 had the greatest impact outside China. Van Der Pijl writes: "The measures taken in China and Toronto, such as quarantine for people without symptoms and the tracing of contact

histories, according to one WHO expert, were 'medieval' but, as it turned out, the large majority accepted them all." Zylberman was surprised to find that only 15 percent of the population resisted the measures. He calculated that 50 – 68 percent obeyed.

His work was incorporated in a joint report of the Rockefeller Foundation and the Global Business Network (GBN), a subsidiary of Deloitte. Van Der Pijl notes: "It is almost unbelievable to read in great detail in a document compiled 10 years ago, the scenario for what is happening now."

He quotes the *Rockefeller Foundation and Global Business Network Scenarios for the Future of Technology and International Development* report, that describes an imaginary influenza epidemic hitting China in 2012.

"Citizens were tolerant and even eager for top-down direction and oversight and the national leaders had often unexpected latitude to impose order in ways they saw fit. In developed countries, this heightened oversight took many forms: Biometric IDs for all citizens were among them."

The report predicted that people would not reject the authoritarian measures until 2025 – 13 years after the fictitious disaster year of 2012 – and then it would be too late.

In Perth, the Government of Western Australia is operating on the Zylberman/Rockefeller timetable, pushing through our insipid Parliament *The Emergency Management (Temporary Covid-19 Provisions) Bill 2022*, a diabolical piece of police state legislation, that would embarrass Adolph Hitler and bring a flush to the rosy cheeks of Heinrich Himmler.

In preparation for this dark day in our parliamentary history, the Government installed former Police Commissioner Chris Dawson in Government House on St Georges Terrace. Dawson commenced his


duties in July (2022) following the retirement of former Governor Kim Beazley. The appointment of a policeman to this high office is unprecedented in our history, even in convict times, yet among the complacent West Australian public this sinister chain of events has ruffled scarcely a feather.

States of Emergency is a big-picture companion to Bobby Kennedy's masterpiece of medical reporting, *The Real Anthony Fauci*, and Judy Wilyman's *Vaccination – Australia's Loss of Health Freedom*. The first Covid-19 book I read, preceding the vaccination campaign, was *The Great Hysteria and the Broken State* by Sanjeev Sabhlok, who was so outraged by the Andrews Government's measures, that he resigned from his position as a senior economist in the Department of Treasury and Finance Victoria.

Economist Paul Frijters teamed up with Gigi Foster and Michael Baker to write *The Great Covid Panic*. When he was a Professor of Economics in Brisbane, Paul Frijters, and Cameron Murray, wrote a book on Australian politics called *Game of Mates* that went to the heart of the matter. The technical term is regulatory capture. Agencies established to supervise key industries are invaded and taken over by those very same industries. There is no umpire on the football field. The fox is in charge of the chook yard. When this happens to banking, the results are disastrous. Now it has happened to medical practice and science and the consequences are fatal.

For people who do not like reading, there are thousands of hours of podcasts, interviews, panel discussions and lectures on the internet. There is room for more research on the ins and outs of the Covid-19 project but there is no excuse for ignorance.

Students of neoliberal ideology trace the road to today's horror



show from Switzerland's Mont Pelerin in 1947 to the abandonment of social democracy by political parties such as Australian Labor. Massive privatisations split politics away from the economy. Without Big Daddy Commonwealth looking on, the banks and big business, treat employees and customers with equal disdain. Small business trembles and anybody who isn't worried is not paying attention.

Van Der Pijl ends on a note of utopian hope, advising us to beat the bad guys by informing ourselves through independent media which, after all, is the reason for the existence of this newspaper.

UNESCO launches war on 'conspiracy theories'

UNESCO is training and recruiting teachers as a key part of its worldwide effort to combat what it considers problematic information and ideas

The United Nations Educational, Scientific and Cultural Organization, better known by its acronym, UNESCO, is escalating its war on ideas and information it considers to be 'misinformation' and 'conspiracy theories'.

According to the Paris-based UN education agency, which released a major report on the subject for educators this summer, conspiracy theories cause 'significant harm' and form 'the backbone of many

populist movements'.

Among other concerns, conspiracy theories "foster and reinforce harmful thinking patterns and exclusive worldviews," the report said.

They also 'reduce trust in public institutions' and 'scientific institutions', which can drive people to violence or decrease their desire to 'reduce their carbon footprint', UN officials argued in the document.

While 'all conspiratorial thinking threatens human rights values', the document says without elaborating, some conspiracy theories are more dangerous than others.

In some cases, teachers are even encouraged to report their students to authorities.

Examples of conspiracy

theories cited in the report include everything from widely held and respectable beliefs such as climate change denial and manipulation of federal elections in the United States, to more far-fetched notions such as the earth is flat or Michelle Obama is actually a lizard'.

"There are plenty of crazy thoughts on the Internet, many of which are patently false," explained Citizens for Free Speech Director Patrick Wood. "The only thoughts being 'corrected' are those contrary to the globalist narrative. This proves that the focus is on protecting their own narratives and nothing else."

"UNESCO joins a censorship cartel that now includes the European Union, the U.S. government, the World Economic

Forum, social media giants like Facebook and Twitter, and notably, Google," Wood told *The Epoch Times*. "Anyone who does not parrot the globalist narrative is by default considered to be a conspiracy theorist."

At the heart of the worldwide program to combat these ideas and theories are teachers and schools, according to the UN agency. Also central is the battle online and in the media, UNESCO documents explain.

The latest strategy was unveiled at UNESCO's International Symposium on Addressing Conspiracy Theories through Education. Held in late June in Brussels, the summit brought together academia, governments, civil society, and the private sector

to promote joint action against conspiracy theories and those who believe or spread them.

The plan includes strategies to prevent people from believing in conspiracy theories in the first place, as well as tools for dealing with those who already believe them.

Several experts on propaganda and free speech, however, warned that the UN effort represents a dangerous escalation in what they portrayed as a war on free speech, free expression, questioning official narratives, and dissent more broadly.

David Icke's one simple word to stop tyranny: No!

What happened with the Amsterdam protest? The Dutch authorities banned you from speaking?

The authorities are so myopic and arrogant that the old ways of demonising and lying about people are no longer working, and the Dutch authorities are finding this out.

When people talk about Nazi Germany and the Holocaust, it's incredibly emotionally charged, and that's where they want you - this is how the manipulators of perception work. They don't want you thinking, they want you reacting emotionally all the time, leading to very different behaviour. So if they can tag someone and demonise them in the public mind with the anti-Semitism/Holocaust denier label, that highly charged negative emotion will then be connected to the person they're trying to demonise.

But what's happened in the Netherlands is they haven't got the reaction they thought. I've been all over the Dutch media for the last seven days; they have completely demonised me, and not one of them has contacted me to respond. After a week of this, a newspaper started a poll on whether I should be allowed in - the last I heard, it was 84% in favour, so it was backfiring.

[Despite this popular vote in favour of freedom of speech, Icke has since been banned from the EU Schengen area for two years, citing prevention of public disturbance, and so the official protest in Amsterdam on November 6 was cancelled in response. We continue on censorship.]

What is dawning on people is that the world is controlled by a network, one I call the global cult. It's fiercely compartmentalised, so most who are in it only know their little part of it. They don't know what it's all about; but at the core, the spider at the centre of the web, they absolutely know what the game is.

The plan all along was to first create the internet, then bring the giants of the internet that dominate communication and retail. You need to control the perceptions of the population so they behave as you want them to, so you have to control communication. It's a simple process: information equals perception equals behaviour.

The censorship is to make sure that people don't hear anything that's

not approved by the authorities, so all they're getting is the official narrative and the official perception. The information we're putting out is challenging their narrative - and their narrative is so ludicrous, so full of holes - they know that if there was an open debate and a free flow of information, they would lose overwhelmingly. So they have to defend their lies by keeping them from being exposed.

I'd like to talk about some of the bigger questions: do you think you were fed the reptilian stuff early on to discredit the verifiable truths that you were revealing?

This is the difficulty: the idea of suppressing information is to suppress the sense of the possible, so people wave their hands and say 'that's ridiculous!' when you're actually articulating the truth.

When the internet began in the 1990s, I put in the search terms reptilian, extraterrestrial and so on, and 33 pages came up; you put it in now... so more and more people are opening their minds to these big concepts, not least because they look at the world, and they see it's an anti-human agenda. They are targeting every area that humans need to survive - the atmosphere, the human body, food, water, energy and many other areas; it's anti-human. Connecting the brain to Artificial Intelligence (AI) is an anti-human agenda.

So is it such a stretch that an anti-human agenda might be driven by a non-human force?

A lot of people have thought about these things, but obviously there's a lack of actual evidence?

You have read my books, right? There's no lack of evidence there.

Okay, but given what we know about governments' ability to manipulate information and perception, isn't it possible that it's just these bankster families doing the old Sun Tzu's Art of War, making themselves appear far more powerful and unassailable than they really are, by saying 'we're in league with Lucifer, aliens are in charge', etc.?

All you've got to do, as I have over the decades, is look at the ancient world, look at all the ancient cultures that have appeared over the years, no matter what continent, and their religions too; there is a common theme between all of them, and that

is of a non-human force manipulating human society.

What happens if those ancient rulers were just pulling the same deception? 'Don't blame us, blame the devil, gods, aliens, the sun, etc.'

But hold on a second - I'm connecting all of them. I'm not saying that the people directly doing this stuff - the Gates, Schwabs, Rothschilds, Rockefellers et al - can be forgiven because some other force greater than them is making them do it.

All these different levels are expressed through the same force. There's the force that drives it - what I call the spider - and the force that plays it out, which is this global cult running human society.

If people want to believe something else, then they should believe something else. I've spent 32 years full-time researching this. I'm not a kamikaze pilot; I'm someone who is interested in the truth. When the evidence crosses my line of 'this is real', then I put it out there. I do have an extraordinary record of predicting what's coming for over 32 years. I'm not predicting the future, I'm predicting the plan.

There are many different levels to research and explore. If you're just looking at the level of the globalists; well okay, how long do they live? Maybe 90 or 100 years. So why have they spent their lives pushing to create a world which they're not going to be in when the endgame arrives? Why have they been doing it, not only in modern society, but way back? What's the common theme? Why did David Rockefeller spend his entire life trying to create something that he knew he wouldn't be around to see?

Well he certainly enjoyed his life while he was making it though, didn't he? It's not too shabby down



at Waddesdon Manor either, is it?

I can understand that they would be ruthless in business for their own benefit while they're alive, but that's not what they were working towards. You say 'no'! A classic example was the mandated NHS job. They'd done it with the care workers before. As the date got closer, they saw the numbers of NHS workers who were not injected and would have to be fired was huge, and reversed their policy.

People ask, 'what's the solution?' - it's staring us in the face. Get a calculator and work it out. There are three types of people - those that follow without question, those that don't want to follow but do so out of fear, and these two groups have been responsible for every tyranny in history. The third group has been responsible for ending every tyranny, because that group says 'I'm going to look at what you're telling me, see that you're lying for reasons of control, and I'm not complying - I'm not doing what you tell me to do. Because I have the self-respect not to be told by a moron how to live my life'. At that point, if enough people do it, the game is over.

This a time for people to open their eyes and see what's happening around them. To stiffen the backbone, look this in the eye and then we'll realise at long last where the power really lies in this world; and it's not with the few, it's with the many. The fact that people have not had the guts to act upon that, is why the entirety of known human history is a story of the few controlling the many. We have the opportunity to break that cycle now, but only if people open their eyes and minds, and stiffen their backbone. If they do those things, then this house of cards will come down.

I'm 70 years of age. I could walk away from all this. The worst of it I'm not going to see, but I keep going every day because I do not want my worst enemy to experience what's coming, if we don't sort this out. And I certainly don't want my children and grandchildren to experience it - that's what drives me on.

One of The Australian Furniture Directory's recent creations is this Jarrah cabinet that was custom-made for the RAAF to display the Number 2 Flying Training School Governor-General's Banner.

The cabinet was specially designed to house the banner that is made of blue silk and features the Governor-General's pennant in the top left corner, wattle sprays in the other corners, and the Unit Badge surrounded by the Southern Cross in the centre. The banner is fringed and tasselled in blue and gold and is hung from a staff with an eagle aloft.

Historically, military units would have a Banner or 'Colours', which were taken into battle and commonly positioned at the centre of a battle line alongside a Unit Commander. Carried at the centre of the front rank of a formation, they could easily be seen and recognised, thus being used as a rallying point for troops. As the 'Colours' were invaluable to a unit, they are often assigned escorts to protect them. Still to this today, when Number 2 Flying Training School march in ANZAC Day parades, the banner is accompanied by an armed escort to protect it.


