# Misinfo bill signals regression to Soviet-era censorship

THE Australian government's proposed new laws to crack down on misinformation and disinformation have drawn intense criticism for their potential to restrict free expression and political dissent, paving the way for a digital censorship regime reminiscent of Soviet Lysenkoism.

Under the draft legislation, the Australian Communications and Media Authority (ACMA) will gain considerable expanded regulatory powers to "combat misinformation and disinformation", which ACMA says poses a "threat to the safety and wellbeing of Australians, as well as to our democracy, society and economy."

Digital platforms will be required to share information with ACMA on demand and implement stronger systems and processes for handling of misinformation and disinformation.

ACMA will be empowered to devise and enforce digital codes with a "graduated set of tools" including civil penalties, with fines of up to \$550,000 (individuals) and \$2.75 million (corporations). Criminal penalties, including imprisonment, may apply in extreme cases.

Controversially, the government will be exempt from the proposed laws, as will professional news outlets, meaning that ACMA will not require platforms to police misinformation and disinformation disseminated by official government or news sources.

Faced with the threat of penalty, digital platforms will play it safe. This means that for the purposes of content moderation, platforms will treat the official position as the 'true' position, and contradictory information as 'misinformation.'

Some platforms already do this. For example, YouTube recently removed a video of MP John Ruddick's maiden speech to the New South Wales parliament on the grounds that it contained 'medical misinformation', which YouTube defines as any information that, "contradicts local health authorities' or the World Health Organization's (WHO) medical information about Covid-19." Under ACMA's proposed laws digital platforms will be compelled to take a similar line.

The potential for this circular definition of misinformation to escalate the censorship of true information and valid expression on digital platforms is obvious.

Free expression has traditionally been considered essential to the functioning of liberal democratic societies, in which claims to truth are argued out in the public square. Under ACMA's bill, the adjudication of what is (and is not) misinformation and disinformation will fall to 'fact-checkers', AI and other moderation tools employed by digital platforms.

But the assumption that such tools are capable of correctly adjudicating claims to truth is misguided. 'Fact-checkers' routinely make false claims and rely on logical fallacies in lieu of parsing evidence. In US court proceedings, 'factchecker' claims are protected under the First Amendment, confirming that the edicts of 'fact-checkers' are just opinion.

Recent reporting on the gaming of social media moderation tools, most notably from the Twitter Files and the Facebook Files, shows that they comprise a powerful apparatus for promoting false

narratives and suppressing true information, with significant realworld impacts.

ACMA seeks to curtail expression under the proposition that misinformation and disinformation can cause 'harm', but the scope is extraordinarily broad. A shopping list of potential harms includes: identitybased hatred; disruption of public order or society; harm to democratic processes; harm



financial harm to Australians or to the economy

The overly broad definition of harm makes enforcement of the proposed laws inherently subjective and likely to result in a litany of court cases - to the benefit of lawyers and the institutionally

latitude where the law allows it. In the past, extreme censorship has led to mass casualty events, such as the Soviet famine of the 1930s brought on by Lysenkoism. Biologist Trofim Lysenko's unscientific agrarian policies were treated as gospel by Stalin's censorious Communist regime. It is reported that thousands of dissenting scientists were dismissed, imprisoned, or executed for their efforts to challenge Lysenko's policies. Up to 10 million lives were lost in the resultant famine - lives that



# WA Aboriginal Cultural Heritage laws to be repealed: but for how long?

The Western
Australian
Aboriginal Cultural
Heritage Act went
into effect on
July 1st 2023.

HOWEVER, on August 8th 2023, 39 days later, on the steps of the WA Parliament, the Aboriginal Affairs minister, Tony Buti, announced that his government would immediately write new legislation to repeal the Act.

"Put simply, the laws went too far, were too prescriptive, too complicated, and placed unnecessary burdens on everyday Western Australian property owners," Premier Roger Cook confessed.

This official announcement was made after about 2 months of intense pressure from the state's farming, mining and pastoralist industries over concerns the new laws were confusing and difficult to implement. Both the premier, Roger Cook, and Tony Buti, apologised to the many farmers and business owners gathered there to protest the onerous laws. In reality, these laws would effectively drive many farmers off the land.

The decision to repeal these laws will make it the fastest any parliamentary Act has ever been repealed in the history of state politics in Australia. This might sound like a victory for the people of Western Australia, and in the short term it is, but we suspect

that that is not the whole story. Arguably, Labor found it impossible to manage the outcry caused by such an oppressive intervention on the property rights of landowners. The WA government has suffered a significant 22.5% swing against them in the "safe" Labor seat of the former premier Mark McGowan in the July 29th by-election.

A few days ago, one of us was speaking to an agricultural supply agent who said he had had 16 years dealing with farmers on the land. The farmers had expressed concerns that the backflip on the state laws is because of two reasons.

Firstly, the federal government has recognised that the WA Indigenous cultural heritage laws were the main cause of people waking up to the damage that will be inflicted on the nation if the soon-coming referendum on the "Voice to Parliament" is successful. The NO vote has been gaining momentum in every state and now eclipses the YES vote.

In other words, not only were these laws threatening the return of the Labor Party in the next state election, but they were also too prescriptive, too complicated, and placed unnecessary burdens on everyday Western Australian property owners,"

Premier Roger Cook confessed.

"Put simply, the laws went too far, were

undermining the prospects of the "Voice to Parliament" referendum being successful. Many reasonably fear that these laws would be just a glimpse of what "The Voice to Parliament" might enshrine in the Australian Constitution.

Secondly, the federal Labor government, led by Prime Minister Anthony Albanese, has its own federal Indigenous laws that it wants to pass, but only after a successful vote on the "Voice" referendum. These new federal laws would replace the state Indigenous law anyway. Thus, the repeal of the controversial legislation in WA is just political manoeuvring.

These indigenous cultural laws essentially create an apartheid state

with "rent" paid to the Indigenous landowners, ostensibly. According to Tony Seabrook, president of the Pastoralists and Grazers Association in Western Australia, the WA Aboriginal Cultural Heritage Act "was really starting to stir up racial divisions. It should never have happened."

Curiously, both the WA
Liberals and the National Party
failed their rural members by
initially supporting Labor in this
outrageous legislation. To make
it worse, on April 5th, the WA
Liberal leader, Libby Mettam,
challenged the federal Liberal
position to the Voice to Parliament
by saying she would vote 'YES'.
She now says she regrets to have

supported the Voice, but one must wonder how incompetent a leader might be to support a proposal that would radically change the egalitarian nature of the Constitution.

Australians are led to believe institutionalising inequality will promote equality and that constitutionally enshrining separateness will reinforce national unity. But let's not be fooled here. As Senator Jacinta Nampijinpa Price correctly points out, this is about entrenching racial separatism and "the idea that Aboriginal people are perpetual victims forever in the need of special measures."

Don't think our Indigenous peoples will benefit from a "Voice" to Parliament. They will be as much pawns in this manoeuvring as anyone else in Australia. The reality is that constitutionally enshrining "the Indigenous Voice" reaffirms difference at the very moment when we should be trying to establish equality, and leads, in the name of alleged anti-racism, back to the old commitments connected with race or ethnicity.

To conclude, politicians who engineer these divisive laws are leading us down that dark corridor on the basis of race – thus prolonging the sorry history of racial difference. The ultimate goal is to divide our country into lines of culture, origin and ethnicity, which obviously facilitates the attainment of more power and control by the ruling classes. We can only guess the level of hatred and division that the so-called "Voice to Parliament" will generate, if passed.

# Access to cash must be preserved in the Constitution

AUSTRIANS are fearful of living without cash in their pocket. Cash to transact daily purchases. Cash to ensure anonymity in those transactions. They understand that physical cash, issued by the government's treasury department is essential to freedom. It is the people's money, non-interest bearing and not created by a bank in a bank loan, thus not interest bearing.

Two weeks ago, the Chancellor of Austria, Karl Nehammer, said "More and more people are worried that cash could be restricted as a means of payment in Austria." He went on to say "In Austria alone, €47 billion (nearly [USD] \$52 billion) is withdrawn from ATMs every year and, on average, every Austrian carries €102 in cash."

He also pointed out that, in
Austria, 67% of payments under €20
(about US \$22) are made with cash.
He has proposed that the



country must enshrine the use of cash in its national constitution, otherwise citizens may lose the right to use paper money and coins.

Nehammer also said "Cash is elementary as a means of payment. It is important that we create an unambiguous legal framework in order to secure it."

He appointed Finance Minister Magnus Brunner to work on implementing the plan. Additionally, a roundtable assembling relevant ministries, industry representatives and the national bank will be held in September to determine the best way to make it happen.

European states, including Austria and Germany in particular, remain suspicious of using credit and debit cards and are still using cash much more than other nations, particularly for smaller, everyday items.

## Undone science and the vaccine racket

During the Cold War, protesters fearful of nuclear annihilation marched with Ban the Bomb placards.

UNFORTUNATELY, powerful nations are unlikely to stop making bombs, just as they are equally unlikely to shut down laboratories where scientists play with gain-offunction research and biological weaponry.

What then is a realistic baseline goal for a world population that is oppressed by authoritarian governments and medical professionals who are under the thumb of a cartel known as Big Pharma?

Dr Judy Wilyman answers this question in the last words of the final appendix to her remarkable book, Vaccination - Australia's Loss of Health Freedom – A Critical Analysis of the Australian Government's Rationale for its Vaccination Policy:


"The health of Australians can only be protected by maintaining our right to bodily autonomy and having choice in all health interventions. It cannot be protected by giving that right to the government and losing the right to decide what is injected into our bodies and those of our children."

Judy Wilyman's book was published in 2015, years before the Covid-19 project. The author calmly traces the erosion of medical ethics, scientific standards and political transparency that has turned Australia's health system into a ruthless racket.

The work was originally written as a successful PhD thesis, an academic badge that is small reward for such a massive work of scholarship. It is a frightening book for readers, including this reviewer, who were ignorant of the appalling corruption and prostitution of corporate medicine and science, until the tragedy of the Covid injection mandates woke us up.

Chapters are devoted to detailed case studies of jabs for HPV (Human Papillomavirus) and the so-called Swine Flu of 2009, noting that it would not have been possible to declare a "pandemic" if the definition of that word had not been changed. Thus, the book provided one of many ominous foretastes of what lay ahead regarding the world's Covid hysteria.

Central to the mounting catastrophe of contemporary public health is the inexcusable failure to follow basic rules that can be summarised in two words – undone



science, which is defined by Dr Wilyman as "research that is not conducted because institutionalised barriers are constructed in the political process to prevent it from being done."

Lay readers will find the guide to the abbreviations used in the book handy. One that caught my eye was GAVI – The Global Alliance for Vaccines Initiative. A turning point Dr Wilyman identifies was the 1978 Conference of Alma-Ata in Kazakhstan, where the World Health Organisation tried to promote a general lifting of clean water supplies, nutrition and community involvement, but was outmanoeuvred by the Rockefeller Foundation's focus on vaccination programmes for economic efficiency.

"Ultimately the price that is paid for adopting public-private sponsorship of global health policies and the academic-industry model for research institutions is an increased risk to the health of populations because the profit motive contaminates the search for knowledge. This health model is a faith-based system and not an evidence-based system because it is dependent on trade secrets and political decisions that are based on biases that are not transparent to the public," Dr Wilyman writes.

Judy (aka Dr Wilyman) has the ability to speak both to the lay reader, like this reviewer, and the specialist scientist. For example: "Modern science has progressed by selecting some causes and ignoring others ... Reductionist theories over-simplify and encourage the lay person to believe in 'magic bullets' as cures or preventions for disease

"The political, epistemological and economic conditions of the time influence which theories about infectious disease control are adopted in public policy and the relationship between the individual and the State."

The standard history curriculum for high school students of my vintage was the British 19th century parliamentary model, taking us from Wilberforce and the abolition of slavery to Grey's electoral reform, and on to Lord Shaftsbury's sponsorship of improved working conditions and public health.

Dr Wilyman's historical perspective looks at the 20th century in two halves. "The Australian government's public health policy up to 1950 was a holistic approach that emphasised prevention through nutrition and environmental changes."

She notes the increasing influence on Australian policy from the 1970s via the World Health Organisation (WHO) and United Nations Children's Fund (UNICEF), and the basic clash of logic when the Australian government stepped up its national vaccination programme in the 1990s, even though most Australian children were not at serious risk of any infectious diseases.

Today, Dr Wilyman continues her tireless campaign around the country and educates us on the need for integrity in science and medical practice. There is an urgency in her timetable because the International Health Regulations promoted by the United Nations through the WHO currently threaten to bring us all under a global medical tyranny.

## Why 'anti-vaxxer' shuts down debate

'When one's only tool is a syringe, the world becomes a pin-cushion.' (with apologies to Abraham Maslow)

THAT impeccable paragon of scientifically objective, non-politicised and vested-interest-free medical information, the World Health Organisation, has called the 'anti-vaxxer' movement 'one of the top ten threats to global health'.

This view is presumably based on their claim that vaccines are a hugely successful public-health intervention, and that their much-vaunted 'Decade of the Vaccine' will be a beneficent good for our health.

It's time to subject the 'antivaxxer' trope to analytical scrutiny. Its etymological origins are unclear, so perhaps a more productive approach is to work backwards from the effects of this squalid term, and thence deduce some possible reasons for its cultural deployment.

Having been repeatedly subjected to this offensive term in my street campaigning, and having thought deeply how (if at all) to respond, it's clear that the term is deeply connected to hate and victimhood, and to the closing-down of thinking.

In Kleinian psychoanalytic terms, hate is a pervasive phenomenon to which we're all subject; it's one that's ripe for psychological projection onto a 'hate-object', whose identity can easily be manipulated into existence when fear and death anxiety are skilfully deployed.

anxiety are skilfully deployed.

The powerful dynamics
of blaming are also deeply
implicated in the 'anti-vaxxer'
trope. In terms of the archetypal
'Drama Triangle' of Persecutor—
Victim—Rescuer from Humanistic
Psychology, the incessant
mainstream propaganda narrative
has cleverly created huge numbers
of unwitting Victims of the
'deadly', 'Persecutory' virus;



and once Victims have been thus manufactured, they will likely rage descriptor. at anyone who threatens the raison d-etre of their potentially lifesaving Rescuer - the 'vaccine'. When it's experienced as literally a matter of life and death, the very first casualty will be the capacity to think. Anyone who's been subjected to anti-vaxxer 'othering' and demonisation will have observed how the use of the term seems to render its deployers incapable of thinking beyond the trope's confines – and therefore also incapable of even discussing

its legitimacy and origins as a descriptor.

Tempting as it might be simply to call them 'vaxxers' back, sinking to their level isn't very useful. It is helpful to realise, though, that 'anti-vaxx' can only exist as a notion because of 'vaxx' itself. That is, it is those who believe that Russian Roulette techno-medical intrusions are a good idea – thus waging a war against nature – who have themselves created the 'anti-vaxx' phenomenon, not those who believe in natural living and

natural immunity.

What is perhaps most concerning, however, is the way in which a kind of uncritical 'vaccine-consciousness' seems to have completely colonised the psyches of so many people (including scientists and politicians) - and often, people who by any measure would be seen as 'intelligent'. Big Pharma and their criminal accomplices have been working away at this colonisation of the psyche for decades, with their zombiescience lies about the beneficence of vaccines, and their control of the mainstream narrative, laced as it is with fear and victimmanufacturing propaganda. This explains why their clever programming of the 'anti-vaxxer' trope into so many people's psyches has, to date, been so effective.

It is in the naming of these dynamics and encouraging people with any capacity left for openmindedness to think about them, that the cultural defusing of this obnoxious name-calling trope offers most hope.

# Impending disaster in the global aviation industry

Mandating Covid-19 injectables for pilots and the aviation industry at large was a massive mistake.

**COERCING** aircrews to take the dangerous Covid-19 jabs or lose their jobs has placed the global aviation industry on the precipice of disaster.

I am a victim of the world's airlines mandated "vaccination" policies, having been terminated for "serious misconduct" due to not being injected.

My expertise in aviation safety and decades spent piloting commercial flights has given me a clear view of what has happened to this industry since 2020 - and what will happen if we do not take urgent remedial action.

Let's start by looking at a model of accident causation that most in the aviation industry will be familiar with: "James Reason's Model of Accident Causation". This simple model likens human systems in aviation to multiple slices of Swiss cheese, stacked side by side, so risks are mitigated by defences that are "layered" behind each other.

Aviation is now poised for disaster because holes in six slices of the industry's "Swiss cheese" have aligned:

Slice #1: Mandated mRNA jabs, globally introduced, with little data.

Slice #2: Complicit regulators and authorities, wilfully blind to the risks

**Slice #3:** Airlines incentivised by government inducements to comply.

Slice #4: Incompetent regulators who ignore the danger signals.

Slice #5: Aircrew coerced to take jabs by "no jab, no job" rules.

Slice #6: Adverse reactions or deaths from the jabs amongst


It is no longer a matter of if but when these aligned holes will lead to disaster. Each mitigator has been breached. A catastrophe is inevitable. The failure to observe safety mechanisms since 2020 means the legal liabilities will be huge. All who have been complicit must be held to account.

Three sets of data substantiate this claim. The data, when correlated, prove there is a problem that will lead to disasters. Investigators know there are always missing pieces of the puzzle. In aviation, the missing piece of evidence is proof that the Covid-19 jabs are causing the harms.


Data point 1: After the introduction of mRNA jabs for




2 Complicit 3 Airlines Mandated mRNA

there was an increase of 272% in 7700 squawks. In the first three months of 2023, the increase was 386% - a staggering and unprecedented increase. **Data point 3:** The Civil Aviation

Safety Authority (CASA) administers medical certification and licensing for all pilots in Australia. CASA can endorse a Pilot Licence with a limitation to restrict operations to a

multi-crew environment only. This happens to pilots when their medical status shows a possibility that they may become incapacitated whilst piloting. The data shows a substantial increase in licence limitations from FY21/22 to FY22/23 of over 200% a massively significant increase.

It is extremely late in the day to stave off what is coming, but there is one last opportunity, in my view.

Insurers who are the greatest at risk financially can mitigate their risks by amending their underwriting contracts with the stipulation that at least one pilot in every airline cockpit must be unvaccinated. This will help prevent financial and human losses from an airliner crash.

However, flight crews who may unknowingly have subclinical medical issues could be at risk of a serious adverse reaction at any time. A shocking number of pilots have 'suddenly' lost their lives or their health since receiving the injections. If they are not subject to adequate medical screening, they will remain an unknown risk to their own lives and the lives of passengers and citizens on the ground.

The ICAO booklet on aviation medicine discusses "new medicines to market," and states that pilots should not take any new medicines on the market, unless they have been fully approved and available in the free market for 12 months. It is deeply perplexing to me that CASA in Australia has chosen to let pilots be injected with unapproved medications.

I demand that there be a cessation of the Covid-19 shots and a high-level investigation into the jab itself, plus the mandates, and then create appropriate compensation structures for all jab-injured pilots. Furthermore, extensive medical testing that accurately identifies both clinical and sub-clinical adverse reactions in pilots needs to be implemented immediately. The cost of these tests must be borne by the employers that mandated their employees get jabbed.

If my demands are not met urgently, disasters will occur and both aircrew and the travelling public will die unnecessarily.

Legal hearing will challenge global media censorship


IN March 2020, the BBC launched an industry partnership with other media groups to stifle independent news sites.

The sites were providing increasing amounts of alternative content to a broadening readership.

And so the Trusted News
Initiative (TNI) was born
to combat this and, along
with the BBC, includes The
Associated Press (AP), AgenceFrance Press (AFP), Reuters,
Canadian Broadcasting Corp
(CBC), Australian Broadcasting
Corporation (ABC), European
Broadcasting Union, Facebook,
Financial Times, Google/YouTube,
Microsoft, Twitter and The
Washington Post.

The TNI's aim, as stated in memos seen by Children's Health Defense (CHD), was to destroy independent voices by labelling any stories which departed from the 'trusted news' narratives as 'misinformation' - and to deny them access to the social media sites essential to their functioning.

Its reason was that competition from independent news outlets posed a direct threat to the members' commercial interests,



and was undermining trust in the larger networks.

The stratagem was an 'early warning system' that identified individuals and outlets disseminating information that the TNI did not approve of, with immediate notification to all partners. Partners would then act in concert to discredit the material, while Big Tech removed such voices and opinions from their platforms.

Otherwise known as a cartel, this practice is prohibited in the U.S. under antitrust laws.

Thus, in January, CHD filed a case in Texas on behalf of a group of plaintiffs that includes Robert F. Kennedy Jr., alleging violation of The Sherman Antitrust Act, and of the First Amendment of the Constitution, although the First Amendment does not ensure private entities are under the same obligation as the state to uphold free speech.

The lead attorney for the plaintiffs, Jed Rubenfeld, explained that the first major hurdle to overcome would likely be a motion to dismiss the case. Powerful defendants can hire teams of lawyers to outspend and exhaust plaintiffs to prevent a case from ever coming to court, and this tactic would have to be meticulously and painstakingly fought because, if a motion to dismiss fails, the case proceeds to the discovery phase, when documentary trails of communications and secret

agreements are prised into the light.

In fact, the defendants moved to have the case transferred to a different forum, and on May 12, Judge Matthew J. Kacsmaryk mistakenly transferred the case prematurely, before the June 18 deadline for the plaintiffs to submit their objections to the transfer.

As a result, CHD withdrew the case, and on May 31 filed it in Louisiana. Kennedy is no longer a plaintiff in the case but he is acting as volunteer legal counsel.

So why is this an important development?

- The case is now before U.S.

  District Judge Terry Doughty,
  who is already examining three
  key free speech cases, all of which
  raise similar issues of censorship,
  and means he is well versed in
  the subject matter and equipped
  to preside over a case against
  several of the world's largest news
  organisations.
- The somewhat aptly-named Judge Doughty will be the arbiter of whether to grant any new request to have the case transferred to another forum, and will determine whether the case has the merits to proceed or not.
- The plaintiffs have requested a trial by jury, as the magnitude of censorship and resulting harm to the populace at large demands that The People themselves decide the case, the outcome of which will not easily be censored.

## No evidence that depression is caused by a chemical imbalance

RESEARCHERS from University College London (UCL) have published eyeopening findings that may create a seismic shift in how we view and treat depression.

Joanna Moncrieff, lead author of the study, and professor of psychiatry at University College London, said: "It is always difficult to prove a negative, but I think we can safely say that after a vast amount of research conducted over several decades, there is no convincing evidence that depression is caused by serotonin abnormalities, particularly by lower levels or reduced activity of serotonin.

"The popularity of the 'chemical imbalance' theory of depression has coincided with a huge increase in the use of

antidepressants.

"Thousands of people suffer from side-effects of antidepressants, including the severe withdrawal effects that can occur when people try to stop them, yet prescription rates continue to rise."

Co-author of the research, Dr Mark Horowitz, reacted to their findings by saying: "I had been taught that depression was caused by low serotonin in my psychiatry training, and had even taught this to students in my own lectures. Being involved in this research was eye-opening and feels like everything I thought I knew has been flipped upside down. It is high time to inform the public that this belief is not grounded in science."

The UCL team also highlighted that many studies found that precipitating external factors, such as stressful life events, can increase the likelihood of depressive features. More

pluralistic treatment options, such as psychotherapy, alongside practices such as exercise, self-care, and mindfulness, or addressing underlying perpetuating factors such as poverty, stress and loneliness, can greatly help with low mood, said the researchers.

Dr Horowitz said: "One interesting aspect in the studies we examined was how strong an effect life events played in depression, suggesting low mood is a response to people's lives, and cannot be boiled down to a simple chemical equation. We believe the situation has been driven partly by the false belief that depression is due to a chemical imbalance."

The ground-breaking umbrella peer-review meticulously examined all relevant studies and research published on depression and serotonin. The detailed review can be found in the scientific journal Molecular Psychiatry, under the title: 'The serotonin theory of depression: a systematic umbrella review of evidence'.

The professor and consultant psychiatrist, Moncrieff, also questioned the efficacy of antidepressants by stating: "Our view is that patients should not be told that depression is caused by low serotonin or by a chemical imbalance, and they should not be led to believe that antidepressants work by targeting these unproven abnormalities. We do not understand what antidepressants are doing to the brain exactly, and giving people this sort of misinformation prevents them from making an informed decision about whether to take antidepressants or not.'

Irving Kirsch, an American psychologist, researcher and academic, discussed the efficacy of antidepressants in his 2009 book called: The Emperor's New Drugs - Exploding the Antidepressant

Myth. He argued that the chemical imbalance theory of depression is wrong, and that antidepressants have minimal therapeutic effect on depression, but because of their common or serious side-effects, antidepressants can be powerful active placebos.

Antidepressant drugs rank third in pharmaceutical sales worldwide. According to a report from Fortune Business Insights, the market is projected to reach U.S. \$18.29 billion by 2027.

It is high time that enlightened health professionals and service users questioned the psychiatric and Big Pharma industry over its inaccuracies, pseudoscience, and reliance on popping pills.

'Still III', a 1984 song by the band The Smiths, asked the curious question that we should all be asking: "Does the body rule the mind, or does the mind rule the body?"

## Misinformation war over 5G risks

'Captured agencies' are forcing wireless radiation on the public

ALLEGEDLY, any concerns or claims about the risks of 5G technology are 'misinformation'.

But just what is misinformation? And have the government, health and regulatory services that are meant to keep us safe ever failed us before? Have they ever peddled information that subsequently was proved not only to be false, but dangerous?

The harmful effects of asbestos were first identified 100 years before it was banned. There are a litany of other examples, from tower block 'fireproof' cladding to our sewage-soaked seas - the list goes on and on. It is difficult to argue that we live in a climate where health checks are more important than profit.

Sometimes, we need to remind ourselves that not all truths are hidden behind a veil of secrecy; some are there in plain sight. Who could conclude that safety procedures and regulatory supervision operate smoothly and effectively with honesty, integrity and accountability? Who in their right mind would conclude there is no corruption, and there are are no lapses, or vested interests that care little for our collective health, beyond weasel words and platitudes?

Enquiring minds continue to be deterred from investigating

risks, lest they be targeted by an apparently socially engineered stigma of ridicule. Consider the mainstream disdain for even questioning the issue of 5G and wireless radiation - an issue that literally and figuratively slowly wraps around us all.

Kent Chamberlin PhD, touring the UK from the U.S., knows more than most. Before rising to be Professor & Chair of the Dept. of Electrical & Computer Engineering at University of New Hampshire, he was taught as a young faculty member to prioritise designs that were faster and used less power - but never urged to consider less radiation.

His 2021 New Hampshire Commission has proven a goto source of peer-reviewed scientific information for those fighting 5G masts and antennas in their local communities. The Commission included experts from the fields of physics, toxicology, electromagnetics, epidemiology, biostatistics, occupational health medicine, public health policy, business and law. They relied upon peer-reviewed papers and the regulatory agencies' own information, and they concluded that wireless telecommunication antennas needed to be placed at least 500m from residences, parks, playgrounds, hospitals, nursing homes, day care centres and schools.

It is a familiar story of modern times. Local Republicans and Democrats sensed an issue more important than their old tribal divisions, and the New Hampshire Commission initially secured bipartisan support. The Commission also ruffled feathers, as top experts were discussing inconvenient possibilities.

Corporate interests mobilised, allegedly 'captured agencies' did their thing and the continuation of the unabated roll-out of wireless technology was ensured.

Following the New Hampshire Commission guidelines is an even more forlorn hope here in the UK -5G antennas are frequently allowed in close proximity to primary schools and nurseries, sometimes not even requiring planning permission from the local council.

Kent described to UK audiences the potted history of the issue, how international standards set in the 1980s, and informed by a behavioural study on just 8 rats and 5 monkeys that lasted less than one hour, have been used to inform radiation exposure limits for a society that now has virtually 24/7 exposure.

The talks set out how international agencies apply mast and antenna guidelines designed for adults as the default, while evidence has shown variations in tolerance, with children, the elderly and the chronically ill appearing more vulnerable to its effects.

Meanwhile, the tide of 'progress' and public demand for must-have gadgets and devices continues inexorably. Yet, since 2015, Lloyd's has declined to provide insurance cover for illnesses caused by

continuous long-term non-ionising radiation exposure.

We can also speculate that ever more powerful antennas may also be crucial to the future delivery of technology such as driverless cars, and to wider agendas that will exert more control and monitoring over our everyday lives.

Many are now waking up to the sense of an on-running information war, a propaganda war, a spiritual war, even - one being fought on many fronts. And there are not many fronts less immediately rewarding than this.

Many campaigners sit alone in dark rooms, poring over the intricacies of legal statutes, planning regulations and electromagnetic frequency readings. Some have poured thousands of their own life savings into costly legal battles against a hostile establishment that appears to hold all the cards. It is a sobering reality of our times.

Yet, one of the features of the last few years has been the great awakening; the mobilisation of people power, often across international borders. The American Professor began his tour in the small Sussex town of Bexhill, a town and county that have consistently punched above their weight in the struggles of the last few years.

He was originally invited to the UK to address a Vodafone meeting - a window-dressing PR exercise perhaps, but either way it presented a valuable opportunity to take his message around the UK at the same time.

The first night was standing room only. Slowly but surely, there are signs that the persistence and dedication of him and others are being rewarded and their message is getting through.

People power has already had its victories with inappropriately sited masts and antennas being refused after public objections. Many more will have a part to play, if the same momentum is to be continued.

## How to have more rational conversations

Having successful conversations with people unaware of the issues we face today is complex and difficult, but can be done with practice and patience

## WHY do people shut down when asked a simple question, or lash out at a stated fact?

I spent over 20 years, prior to the first lockdown, studying perception, communication and behaviour. Yet nothing had prepared me for the level of influence that could be exerted over intelligent people who suddenly became completely irrational and abusive, doctors who dismissed valid questions, and a collective media that continues to demonise anyone daring to ask questions, or who refused to comply with rules and mandates.

Reaching people that have been conditioned with a false narrative is difficult, and at times can seem impossible. There are ways to reach people but it takes practice, understanding of the issues, as well as self-control, to even begin to have small successes at having rational conversations. It's an obstacle course we must navigate.

It is fair to say there are many pitfalls in having conversations with loved ones. Much of how to reach people begins with a number of things we must avoid; if these pitfalls are not navigated successfully, it really doesn't matter how many facts you have, or convincing an argument you present; you will likely be shut down with one of the many scripted responses, such as 'you're a conspiracy theorist' or 'have you joined a cult?'.

What has happened when someone turns into King Kong and gets angry? Metaphorically speaking, we stepped on a landmine. Human beings have in-built (and cultivated) safety alarms, or cognitive dissonance, that to some extent help us function in the world.

While the behavioural sciences have in recent times made startling discoveries about how we come to make decisions, and what drives our behaviour, these sciences are also now used by corporations and authorities in what is known as 'nudging' (influencing). For example, in repeated slogans such as 'hands, face, space'.

If these insights were understood by the public on the

other hand, we could solve so many problems. This gives me great hope, and communicating these insights to help people understand their own and other's behaviours and beliefs is one of my missions in establishing reachingpeople.net.

'Science advances one funeral at a time' - Max Plank

Max's quote describes the resistance that we humans have when our beliefs are challenged. Usually the first information in, sets the belief, so education and the media have a huge responsibility, and they have failed us so miserably, for so long.

First, however, we will have to let go of negative emotions we have towards unaware people.

Trying to have a conversation in a heightened state - angry, anxious, etc. - will invariably not work. The anger, the injustice, the bitterness are all justified; but the problem is, in practical terms, they disconnect us from those we need to reach.

The greatest manipulation of all is of our emotions, and by resolving negative ones, we do not let the perpetrators off the hook; we just stop experiencing those emotions. You don't want to feel bad when looking at a picture of a maniac such as Bill Gates. He isn't worth an ounce of energy.

So, finding a way to let go will really help conversations. Some of the ways I have found powerful are a) The Sedona Method; b) Emotional Freedom Technique (EFT or 'tapping'), and c) any process that assists in letting go of unresolved emotion.

Jerome Bruner showed that a fact presented in a story will land over 20 times more effectively than the fact presented in its raw form. We find that metaphor is also useful at reaching people, along with questions used artfully. See boxes on the right.

## Key concepts in successful communication

#### 1. First impressions are everything

Most people make up their minds whether someone is a threat (physical or ego) within the first second. If we are seen as a threat, the other person will shut down immediately, likely attack us verbally, or exit the conversation quickly.

Seeing the unaware person as having wrong ideas, rather than see them in a derogatory light, will greatly help us not trigger this shutdown. If we unconsciously view people as stupid, we will treat them as such, and they will sense this and shut down. We have to be understanding that people have been subjected to the greatest psychological operation in history. Letting go of negative emotions we have towards unaware people is key.

## 2. Overcome division and find common ground

Studies clearly show if we see people as on the opposite side, we will mostly dismiss everything that person has to say. This is why media propaganda focuses on divisive group identities such as 'anti-vax', 'conspiracy theorist' and many others.

Overcoming this is critical. If we find a subject where we and the other person agree, we will have a great platform to introduce ideas they need to be aware of. A quick way to find common ground is to establish that you both want people to be healthy and happy. Example: 'we are effectively on the same side'.

#### 3. Pace, pace, pace

One of the quickest ways to shut down someone to new ideas is to introduce too many subjects and complex problems too early. This is like a pushy salesman, or evangelical preacher - it shuts people down.

Share information at a pace that the other person can digest. Think about where they are and what they can acknowledge, such as corruption.

## 4. Share information in a way that the other person can hear

Much of the propaganda is aimed at reaching the unconscious mind. It is largely pointless to present a fact to someone in its raw form such as 'lockdowns don't work', if they believe the opposite. Starting with 'how effective were lockdowns?', then telling a story using metaphors or questions is a more powerful way to do so.

It is also worth avoiding asking the question "Why?" regarding the person's decisions. They get defensive, and will rationalise and justify. Asking questions to have them explain themselves, in a polite and gentle way, helps them understand their thinking, or lack of it. Be supportive as they hit discomfort in their minds. You're not trying to 'win', only help people realise where their beliefs come from. Asking questions about things such as 'are the public aware it doesn't stop transmission?' etc, when you have a good rapport going, can also be very effective.

# 15 minute cities: 30 years in the making

UN's climate narrative reveals disturbing goals

CLIMATE change has been visible in government policy and in the media, to a greater or lesser degree, for around the last three decades.

WHILE 1876 was the year that the Swedish chemist Svante Arrhenius first proposed a human-influenced greenhouse gas effect on the earth, it was almost a century later that a growing environmental movement sparked the United Nations Conference on the Human Environment in 1972.

It was the first of a series of UN gatherings aimed at protecting the global commons from the environmental impacts of industrialization. Here, acid rain performed 'a dress rehearsal for global warming'.

Coincidentally, 1972 also saw the appearance of the Club of Rome-authored Limits to Growth - a report which made a direct link between resource depletion and degradation of the earth's carrying capacity and projected global population increases.

It was at the Rio Earth Summit in 1992 where climate change was first outlined as a distinct environmental threat. To these ends, participants at the Rio summit first outlined a political and economic framework through which: a) national governments could develop their own indigenous policies and b) begin a collaborative process through which countries could coordinate and mainstream sustainability objectives at a global level.

Central to these efforts was the emergence of Agenda 21 – a four-phase, long-term action plan by which the UN would play a central role in coordinating global, national, and local level sustainability endeavours post 1992.

Local Agenda 21: Community Planning and Neighbourhood Renewal then became the finer level of detail on the role of local authorities, communities,

and citizens in organising and delivering 'bottom up' environmental interventions.

In the UK for instance, transport policy has been increasingly delivered via local government delivery mechanisms, ranging from traffic calming; an increase in cycle lanes; car-free town and city centres; congestion charging and low-speed zones.

The momentum behind all of this was given further impetus by the world's first Climate Change Act in 2008, where the stated aim of the UK Government was to coordinate and oversee the reduction of carbon emissions from three main sectors: energy, transport and households.

Despite these endeavours, the UK's climate programme up to now has been inconsistent at best, and an outright failure at worst - particularly when compared to countries such as Germany, Denmark and the Netherlands, who have all reorganised around renewables and more energy-efficient economies in a more significant way than the UK.

However, the year 2020 witnessed a huge shot in the arm to the UN's climate change programme, where it has dovetailed nicely with the reshaping of society through the Covid-19 restrictions.

Indeed, the World Economic Forum has made no secret that the period from the beginning of the decade had provided a window of opportunity to 'build back better' in all nations – including the UK.

The '15-minute city' is set to become the cornerstone upon which the principles of Agenda 21 (now Agenda 30) can finally be delivered after three decades of planning.

Transport has been the sector that the UK Government has long sought to intervene in more directly, but dissuaded by a reluctant public and the power of the transport lobby.

Transport accounts for a quarter of UK carbon emissions. Net Zero is a clear ramping up of the UK's climate agenda from setting unrealistic, unaccountable targets. Net Zero means exactly what it

says on the tin - a zero carbon society.

Oxford City Council is already set to unveil the first 15-minute city in the UK this year, and the expected countrywide rollout of them will embed an ongoing and increasingly restrictive set of infrastructural and geographical boundaries through which it will be possible to enforce, limit or completely curtail mobility for UK citizens.

Cities will be divided up into a series of districts or zones.

No longer will people have to travel far to schools, parks, shops, gyms or for health care.

Neighbourhoods will now be organised so that all these places will be a short walk or bike ride from any location. A central plank in this will be that petrol and diesel cars will be gradually outlawed.

This 'new urbanism' will also force citizens to take responsibility for their role in saving the planet from the impending climate crisis.

This geographic, cultural, and demographic revision of modern life will be coordinated by a new suite of smart technologies, not least the impending 5G rollout and ongoing camera surveillance systems.

Given that the UK Government has been understandably vague about all of this, it must be assumed that much like a Russian Doll, the nested layers of what is being planned will include a central role for the CBDC and the appearance of a carbon credit system.

The overall policy framework is likely to be the forthcoming World Health Organisation treaty, supplemented by the WEF's My Carbon: An Approach for Inclusive and Sustainable cities, prioritising the twin control mechanisms of public health and the environment.

Understanding the three-decade evolution of the UN sustainability agenda rests upon a comprehension of the more sinister, underlying narratives which guide policy makers: a) climate change (and other environmental impacts) are man-made and b) environmental degradation and resource depletion are directly related to population growth and associated per capita consumption.

The UN scientific community has even given a name to the geological period of the planet characterised by man's so called direct impact on the Earth's ecosystems – the 'Anthropocene'. All UN climate science broadly supports this supposition, and any challenges are swiftly discredited or shut down.

Highlighting the alleged responsibility and profligacy of citizens, UN rhetoric ultimately points the finger at individuals, whose lack of responsibility for unsustainable transport routines, inefficient energy habits in households, and for the carbon embedded in goods and services (out-of-season fruit and veg for example) and 'unsustainable' purchasing decisions that they make every day.

To these ends, 15-minute cities are a means by which these 'unsustainable' options can be curtailed or taken away from the irresponsible citizens and choices instead made by an unaccountable, technocratic elite who claim a 360-degree vision which is inclusive of the entire world.

# The great famine reset: you will own nothing and you will be starving

Renowned primatologist Jane Goodall said, at the World Economic Forum (WEF) in 2020: "All these [environmental] things we talk about wouldn't be a problem if the world was the size of the population that there was 500 years ago."

In 1600, the world population is estimated to have been 500 to 580 million. That means 94 per cent less humans in the world! Massive depopulation has historically occurred through

engineered wars. In the First World War 21.5 million died, of which 13 million were civilians. The civilian deaths were largely caused by starvation, exposure, disease, military encounters and massacres. In the Second World War, 40 to 50 million died, the largest of any war. Then there were the massacres by the communists. For example, Joseph Stalin's Bolsheviks (1929-53) killed 40 to 60 million in the former Soviet Union, and Mao Zedong's communist regime (1946-76) killed 65 to 78 million in China

The war in Ukraine, coupled with the West's economic sanctions, has put the world's food security at tremendous risk. These sanctions are supposedly meant to punish Russia for its invasion of Ukraine. However, they are seriously endangering the world's ability to feed itself.

We are experiencing an asymmetric war, some kinetic (NATO/Ukraine vs. Russia) but primarily a silent war where food shortages are engineered. This is achieved by driving farmers from the land, banning live animal exports, and disrupting

supply lines like we saw in the "pandemic" years.

The greatest driver of famine is none of the above, but the supply of currency and credit. Control the food supply and you control the people. Control the money supply and you control the whole world.

Since 2008, the world-dominating US Federal Reserve has been "printing money" like never before. Currently, the amount is already 2.3 times larger (in the same dollar terms) than was "printed" during and after World War II — and there is no stopping. Since the US dollar is the global reserve currency, either hyperinflation will result and/or a total global economic collapse will ensue. Either way, global famine will accelerate.

We must resist all efforts to impose the dystopian objectives on us. Stop the wasteful kinetic wars and stop the war on citizens by insane fiat currency printing. We must also stop the woke depopulation attempts and put an end to the WEF's ungodly neofascist agenda before it is too late. Otherwise, paraphrasing WEF's statement, "you will own nothing and you will be starving!"

## Café Locked Out: in search of humanity

THE past four years have given us much to grapple with. Did everyone in Australia have the same experiences? Are things really 'back to normal', or are we just not asking enough questions?

The real history of these extraordinary times will be recorded by those willing to go out and actively listen.

Michael Gray Griffith, a playwright from Victoria, has spent the past two years on the road doing just that. Before lockdowns began in March 2020, a play he had written was touring Australian Army bases, having been chosen for its effective messaging on suicide prevention. When lockdowns eased, lockouts began, and a 'green tick' COVID pass was required to enter most public venues including gyms, cafes, sports venues — and theatres, "It came out that they were going to segregate audiences – and I couldn't do it," Michael recounts.

When he publicly questioned how all of this was about health, Michael was encouraged by industry colleagues to "keep quiet" for the sake of his career.

Instead, Michael created a social media account specifically to talk about what was going on. He was concerned that "free speech was under attack" and purposefully made the account, Café Locked Down, into a platform for reporting on



events, news and personal tragedies that were being ignored by the mainstream media.

Café Locked Down became Café Locked Out, and Michael created a podcast of the same name, co-hosted with Damien Richardson, which incorporated interviewing people about their experiences.

"We just got anyone on who would speak," Michael says.

Michael witnessed local protests where, he says: "There were no reporters here. No one was recording who these people were. So, I started recording them [asking] who are you, what are you doing here? That's what

started all this."

Michael travelled to Canberra to document the February 2022 protest events as hundreds of thousands of Australians were gathering. During the journey home, he recalls that in one town "there were all these people waiting, wanting to tell their stories. And when we got to the next town, it was the same. I said to Kret [who travelled with Michael at the time] there's a whole country out there. Why don't we tour the country town to town until we run out of money and just document what's happening?"

So, what began as a social

media page has become a full-time, on-the-road commitment to free speech. Café Locked Out travels the country in a coaster bus nicknamed 'Florence', stopping at any and every town possible, ready to listen to anyone who wants to talk – and no topic is off limits.

Michael's interviews, videos, photographs and blogs are all published online and feature astounding stories of courage. Some are reminders of the contradictory measures taken in the name of public health, like firefighters stood down for 'non-compliance' during the height of summer, and military

veterans excluded from ANZAC Day commemorations. Others are messages of resilience and hope, such as the health practitioner who created a community-run wellness centre in her small country town.

The Café Locked Out platform is also used to collaborate with independent citizen journalists, raise awareness of social issues and support community initiatives. It is a collaborative effort – and that doesn't just include the remarkable people who have given of their time and shared Michael's journey (and the driving). Everyone who donates towards fuel costs, offers their front yards for camping or shares their story is part of the 'new media' movement.

Global audiences can be reached online, but in the face of nearconstant censorship and bans, connecting in-person is a vitally important pastime to engage in.

With upwards of sixty thousand kilometres travelled so far, and an estimated 1,400 interviews recorded, Michael says: "It is an honour to be on this journey. I didn't see this coming and I don't know where it will end. We are attempting to capture a history they are already trying to erase."

- 5. With the hindsight of the pandemic, what alterations would you introduce in preparation for a potential recurrence?

## The long walk for justice

Matthew Lawson completes epic walk for Australia's vaccine injured.

"HEY, everyone, hope you're well!"

For almost three months, Matthew Lawson's catchery beamed from The Newell Highway as he journeyed on foot from Victoria to Queensland to raise awareness for Jab Injuries Australia.

Matthew, 45, set off from his Melbourne home on Monday, July 17, with a backpack and an unflappable mindset to share his message. A dedicated support crew followed.

His commitment to speak up for basic human rights over the past three years has been life changing. When Victorians faced the world's longest COVID lockdowns – and the rest of Australia lined up alongside them for mandated "vaccinations" – Matthew actively sought to encourage peace and connection in our increasingly dystopian world.

For his efforts, his home was raided, he was strip searched, handcuffed, hit with a baton, pepper sprayed and shot with a rubber bullet (for which he required corrective surgery).



"It's fair to say I copped every bit of abuse possible from the government ... but I'd do it again in a heartbeat," Matthew said as he left Victoria.

With a heavily censored online presence, Matthew hit the road to be as visible as possible on his mission: The Long Walk for Covid Jab Injury Awareness.

"Whether mainstream media reported on it or not, I had a feeling the Bush Telegraph would get a hold of it quickly."

Matthew was right. News spread faster than it took to walk an average 30km a day. Groups welcomed Matthew to their towns, while others kept him company for short stretches. Forests of the Fallen were erected to signal Matthew's arrival, local newspapers ran stories and independent journalists interviewed him.

Carmen Bartley, 36, from New South Wales, followed Matthew's journey closely. The single mother of three children said she had no choice but to be vaccinated – and her life changed irrevocably after getting her first and only Pfizer jab in 2021.

"I needed to be able to go out of the house, and I had no help at all at home," she said.

"(Afterwards) I started getting extreme fatigue, and headaches," she recollected. "I was sleeping up to 20 hours a day and totally exhausted."

Blood tests revealed Carmen's cortisol levels were three times higher than normal. She was referred to The Garvin Institute of Medical Research. However, she was refused treatment until she received her second shot.

"I was treated like a leper because I wasn't fully vaccinated," she said. "Then, I was told I had a mental health, not a physical issue." Carmen was finally diagnosed with Cushing's disease and underwent brain surgery to remove a tumour on her pituitary gland.

Carmen said she hoped Matthew's "selfless" walk would open people's eyes.

"It is hard enough being this sick without people and doctors calling you out as a tinfoil hatter, too," she said. "Some doctors and nurses have confirmed my suspicions, but only ever off the record."

Matthew said he was always aware the vaccines could do damage, but he never imagined making such a trek for the cause. His aim was for people, like Carmen, to get recognition and compensation for their suffering.

"These people are being shunned," he said. "They are stuck in limbo and can't get the compensation they need, to keep living. In many cases, they have lost their jobs and, I am sure, many have lost their lives."

Matthew has no plans to put his feet up when he returns to Melbourne.

"I will just keep advocating for human rights," he said.

## Open letter from Clintel to the UN Secretary-General António Guterres

## Fake meat sales plummet amid falling demand

'It's less digestible than real meat, and certainly less nutritious'

FAKE meat giant Beyond Meat's revenue plunged over 30% for the second quarter compared to last year as consumers turn to real meat.

The California-based company also slashed its annual sales forecast from \$375m—\$415m to \$360m—\$380m "in light of greater than expected consumer and category headwinds and their anticipated impact on net revenues," according to The Telegraph. Last year, the company was forced to cut a fifth of its workforce as its stock dropped nearly 80%.

Beyond Meat, founded in 2009 to "fight climate change," counts globalist billionaire Bill Gates as one of its investors. It has since supplied its plant-based fake meat to McDonalds, Dunkin' Donuts, Taco Bell, Walmart and PepsiCo. In 2013, the People for the Ethical Treatment of Animals (PETA) named Beyond Meat "Company of the Year" and the company has been endorsed by

several Hollywood celebrities.

Frontline News reported last year that Beyond Meat was distributing its fake Beyond Burger to 1,600 supermarkets throughout Germany as the country moves to reduce livestock to "fight climate change."

Beyond Meat is not the only player in the fake meat industry. It primarily competes with Impossible Foods, which also provides plant-based meat, and Upside Foods, which provides lab-grown meat. All three companies are backed by Gates, who has clarified that

government regulation may be needed to force people to transition to fake meat.

"I don't think the poorest 80 countries will be eating synthetic meat," Gates told the MIT
Technology Review. "I do think all rich countries should move to 100% synthetic beef. You can get used to the taste difference, and the claim is they're going to make it taste even better over time. Eventually, that green premium is modest enough that you can sort of change the [behaviour of] people or use regulation to totally shift the demand."

But nutrition experts have been warning against fake meat. Nutritionist and Sacred Cow: The Case for (Better Meat) author Diana Rodgers says lab-grown meat, such as that sold by Upside Foods, is still not as healthy as McDonalds.

"I'd rather eat my shoe than labgrown meat," Rodgers stated.

British investigative food journalist Joanna Blythman warns against even plant-based meat, which she says sometimes contain up to 30 artificial ingredients.

"Artificial plant-based proteins tend to be loaded with 'anti-nutrients' - compounds that make it harder for our guts to absorb beneficial macro and micronutrients," Blythman wrote in an article for the Daily Mail. "Essentially, it's less digestible than real meat, and certainly less nutritious."

While Gates and his World Economic Forum (WEF) colleagues hope to significantly reduce meat consumption by 2030 and, ideally, phase it out completely by 2050, Blythman says the global real meat industry is forecasted to rise up to 7% annually.

There are also significant concerns about fake meat's purported contribution to the climate. Plants require fertilizer, processing and shipping, too, and

lab-grown meat is also expected to be environmentally taxing.

A preprint study published in April by University of California, Davis researchers found that if fake meat becomes as widely accepted as globalists would like, it could be extremely harmful to the climate.

The researchers found that the production process for fake meat emits 246 to 1,508 kg of carbon dioxide per kilogram of fake meat, while retail meat production produces only about 60 kg of CO2 per kilogram. According to the scientists' estimates, producing fake meat is 4 to 25 times worse for the climate than real beef.

"Currently, animal cell-based meat products are being produced at a small scale and at an economic loss, however companies are intending to industrialize and scale-up production," the scientists opine in the study.

"Results indicate that the environmental impact of near-term animal cell-based meat production is likely to be orders of magnitude higher than median beef production if a highly refined growth medium is utilised," they concluded.

## Playbook for GMO 2.0 going exactly to plan

IF you are eating 'animalfree' dairy or meat products that taste nearly identical to a traditional animal product, you should be asking plenty of questions.

And more often than not, what you will discover is that these foods are anything but natural.

Aware of what consumers may find out and not wanting to make the same PR mistake twice, the GMO industry has intentionally introduced sophisticated and deceptive names such as synthetic biology, cultured meat, gene editing, precision fermentation and cellular-based seafood.

Further muddying the waters is that these companies have been funded not just by the likes of Bayer and BASF, but by Silicon Valley heavyweight investors

who have bankrolled some of the largest technology companies in the world, giving these start-ups instant credibility and a certain degree of protection from criticism.

Even more, the organic community is being aggressively courted.

They are enlisting people like acclaimed farm-to-table chef Dan Barber and are purchasing booths at Natural Products Expo West, a show that most attendees believe is only for natural products. And these booths are interspersed throughout the show, sharing aisles with USDA organic and natural product companies.

During 'The State of Organic & Natural' keynote presentation at this year's Expo West, we were told that "The only way we are going to meet demand, as a planet, is through cultured meat." Cultured meat is meat produced from cells,

without having to raise or kill animals. This is synthetic biology.

As these GMO 2.0 companies have raised billions of dollars, with Silicon Valley salivating over the prospect of owning a piece of the patent-protected food supply, their marketing tactics have been an unmitigated success at manipulating the public.

"Companies call these things 'synthetic biology' and 'fermentation technology', but these foods are all just GMOs," said Michael Hansen, PhD, Senior Staff Scientist at Consumer Reports. "They are using terms people do not understand, so that people will not realise these are GMO ingredients.

"These are often highly processed foods, which are associated with increased calorie intake and weight gain, according to a study from the National Institute of Health.

And while these companies may be perceived as tech start-ups, the products they produce are designed to fit into an industrial food system, and society is clearly moving against this trend and toward a more agroecological-based food system. Additionally, they are introducing novel, geneticallyengineered proteins into the food supply that will have unknown potential impacts on the human microbiome and the environment, and these companies are selfaffirming GRAS status with the FDA, a voluntary process that is incredibly problematic and falls very, very short of protecting the consumer," said Michael Hansen.

In recent years, 'animal-free' dairy proteins have found their way into everything from ice cream to cream cheese to snack bars, but many shoppers, food

manufacturers and retailers are unaware that these are actually unlabeled and unregulated GMOs. Further compounding the problem is that consumers may be misled into thinking that these products are 'natural', which could potentially take market share away from the organic industry.

The introduction of synthetic biology products will seemingly only continue to accelerate, and according to the biotech industry's Good Food Institute, nearly \$2 billion has been invested in developing 'precision fermented' products like synbio dairy in the past year alone.

How is so much money being directed into this category despite consumers increasingly moving away from GMOs?


