## What's in the shots? A 'shocking' discovery

#### By REBEKAH BARNETT

Early in 2023 genomics scientist Kevin McKernan made an accidental discovery.

WHILE running an experiment in his Boston lab, McKernan used some vials of mRNA Pfizer and Moderna covid vaccines as controls. He was 'shocked' to find that they were contaminated with tiny fragments of plasmid DNA.

McKernan, who previously managed R&D on the Human

regulatory agencies around the world have specifically said is not possible with the mRNA vaccines.

> McKernan raised the alarm, posting his findings to Twitter

(now X) and Substack with a callout to other scientists to see if

they could replicate his findings. Other scientists soon confirmed McKernan's findings, though the amount of DNA contamination was variable, suggesting inconsistency of vial contents depending on

batch lots. One of these scientists was cancer genomics expert Dr Phillip Buckhaults, who is a proponent of the mRNA platform and has received the Pfizer covid vaccine himself. Continued page 2

Genome Project, ran the experiment again, confirming that the vials contained up to 18-70 times more DNA contamination than the legal limits allowed by the European Medicines Agency (EMA) and the Food and Drug Administration (FDA).

In particular McKernan was concerned to find the presence of an SV40 promoter in the Pfizer vaccine vials. This is a sequence that is "used to drive DNA into the nucleus, especially in gene therapies", McKernan explains. This is something that



In September of this year, Buckhaults shared his findings in a South Carolina senate hearing, stating that he was "kind of alarmed about this DNA being in the vaccine".

"There is a very real hazard", he told those present, "that the contaminant DNA fragments will integrate with a person's genome and become a 'permanent fixture of the cell', leading to autoimmune problems and cancers in some people who have had the vaccinations". He also noted that these genome changes can "last for generations".

Buckhaults said that the presence of high levels of contaminant DNA in the mRNA vaccines, "may be causing some of the rare but serious side effects, like death from cardiac arrest". He added, "I think this is a real serious regulatory oversight that happened at the federal level".

Both Buckhaults and McKernan shared their findings with the FDA, but at the time of writing, neither scientist had received a response.

In Australia, a spokesperson for the Therapeutic Goods Administration (TGA) maintained that covid vaccines cannot alter a person's DNA, and stated that, "all batches of COVID-19 vaccines distributed to Australians have been tested for the presence of contaminants including residual DNA template levels".

However, Buckhaults suggested that the current regulations around allowable DNA contamination limits are not suitable for this new type of vaccine. The difference lies in the distinction between whether the DNA contamination is 'naked' (as in traditional vaccines), or 'packaged' in lipid nanoparticle casing (as in new mRNA vaccines).

A bit of naked DNA contamination is not a problem, Buckhaults explained, because it gets, "chewed up immediately upon vaccination, and there's no real mechanism for it to get inside the cells".

But with the introduction of the mRNA vaccines, the regulators, "inappropriately applied that regulatory limit to this new kind of vaccine where everything is encapsulated in this lipid nanoparticle... able to dump its content into a cell," said Buckhaults.

In recent months, more and more scientists from around the world have come forward to confirm the presence of plasmid DNA contamination in the mRNA vaccines, which is thought to be a by-product of the upscaled production method.

The process used for mass manufacture of the mRNA vaccines involves using E. coli bacteria to make copies of DNA plasmids to create the vaccine mRNA, and it is fragments of these bacterial DNA plasmids that have since been found in the mRNA vaccines.

Now, McKernan, Buckhaults and other scientists are calling for urgent research to test whether the DNA contamination is lingering in the cells of mRNA vaccinated people, and whether the human genome has in fact been altered by mRNA covid vaccines.

## Australian GP sues over unapproved **GMOs in mRNA covid vaccines**

A Victorian doctor and pharmacist is seeking an injunction from the Federal **Court of Australia to stop** Pfizer and Moderna from distributing their mRNA covid vaccines. Dr Julian Fidge alleges that both the monovalent and bivalent vaccines contain genetically modified organisms (GMOs), for which Pfizer and Moderna did not obtain the appropriate licence.

It is a serious criminal offence under Australian law to sell or distribute GMO products without approval from the Office of the Gene Technology Regulator (OGTR). However, Pfizer and Moderna only sought approvals for their covid vaccine products from the Therapeutic Goods Administration (TGA), which is not authorised to approve GMO products in Australia.

The case alleges that there are not one, but two, GMO components in the mRNA covid vaccines.

The first is the mRNA itself, which is actually modified RNA wrapped in lipid nanoparticles (LNPs). The second alleged GMO component is synthetic DNA contamination, which an increasing number of scientists claim to have discovered in both the Pfizer and Moderna monovalent and bivalent mRNA covid vaccines at dangerously high levels (see front page).



Genomics scientist Kevin McKernan, who made the breakthrough discovery of DNA contamination in the covid vaccines, provided expert advice on the case. He agrees that the DNA contamination in the mRNA vaccines fits the Australian legal definition of a GMO.

Potential risks associated with the alleged presence of GMOs in the covid mRNA vaccines include autoimmune issues, cancers, cardiac arrests and sudden death. Should the LNP-mod-RNA complexes or contaminant DNA enter the cell nucleus of vaccinated people, there is also the theoretical risk that these components will integrate with the genome, permanently altering the vaccinated person's DNA.

McKernan is one of several

scientists to have publicly stated this theoretical risk in association with the contaminant DNA.

As for the LNP-mod-RNA complexes, a peer-reviewed scientific paper published last year demonstrated that the Pfizer covid vaccine mod-RNA can enter the human liver cell line and reverse transcribe into DNA in vitro (meaning in a lab dish).

Other studies cited in the case materials show the presence of spike protein mRNA in the nucleus of human cells, and evidence that acquired immune traits pass down to the offspring of mice pre-exposed to the covid vaccine LNP-mod-RNA platform. This is suggestive that, once in the nucleus, the vaccine mRNA can be transferred and integrated with

chromosomal DNA.

The TGA strongly refutes that any components of the mRNA covid vaccines can enter the cell nucleus, or alter a person's DNA. A spokesperson for the TGA stated, "The mRNA in the vaccines does not enter the nucleus of cells and is not integrated into the human genome. Thus, the mRNA does not cause genetic damage or affect the offspring of vaccinated individuals."

They also said that "All batches of COVID-19 vaccines distributed to Australians have been tested for the presence of contaminants including residual DNA template levels."

However, the TGA did not provide scientific evidence in support of its claims, linking only to fact pages (with no studies referenced), a fact checker post and one commentary article published

in a scientific journal, which merely suggested that more research is required before the theoretical 'in vitro' risks can be assumed to be occurring at large in the population.

Indeed, McKernan and other scientists who have confirmed his DNA contamination findings are now calling for urgent research into whether this genomic integration risk has occurred in mRNA vaccinated people or not.

But the GMO case argues that this should have been done before mass administration of the mRNA products to the public.

Lawyer Julian Gillespie, who developed the case theory says, "It has always been the mandate of the regulator to establish that the vaccine mRNA and spike protein do not enter the nucleus. They have never done that, so therefore, it is not well established."

Taking both the LNP-mod-RNA complexes and the recently discovered DNA contamination present in the mRNA covid vaccines, acting solicitor on the case, Katie Ashby-Koppens says, "Every single person who has been injected with these products has received a GMO that has not been through the expert regulatory process in this country." She adds, "The human genome could be changed permanently and no one was informed."

Nuremberg war crimes trials. ## How much energy will the world need?

We're headed toward an exciting all-renewable energy future. Wind and solar will power the world of tomorrow. And tomorrow isn't far off!

### IT'S time to wake up. You're having a dream. Here's the reality.

Oil, natural gas, and coal provide 84% of all the world's energy. That's down just two percentage points from twenty years ago. And oil still powers nearly 97% of all global transportation.

Contrary to headlines claiming that we're rapidly transitioning away from fossil fuels, it's just not happening. Two decades and five trillion dollars of governments "investing" in green energy and we've barely moved the needle.

This was supposed to be easy. Why is it so hard?

In a word: rocks. To get the same amount of energy from solar and wind that we now get from fossil fuels, we're going to have to massively increase mining. By more than 1000%. This isn't speculation. This is physics. Copper, iron ore, silicon, nickel, chromium, zinc, cobalt, lithium, graphite, and rare earth metals like neodymium. We need them all.

And then those metals and materials have to be turned into motors, turbine blades, solar

panels, batteries, and hundreds of other industrial components. That also takes lots of energy, which requires even more mining.

As a World Bank study put it, these green "technologies... are in fact significantly more material intensive" than our current energy mix. That may be the understatement of the century: raw materials account for 50–70% of the costs to manufacture both solar panels and batteries.

Until now it hasn't really mattered that much because wind and solar still account for only a few percentage points of the global energy supply. They're an applause line for environmentalists – not a major energy player. And it's unlikely they will be in the foreseeable future.

But for the sake of argument, let's say we sharply ramp up mining. Where would these new mines be located? Well, for one, China. That country is today the single largest source for most of our critical energy materials. The United States is not only a minor player but is dependent on imports for 100% of 17 critical minerals. Do we want to give China more political and economic leverage? Europe has made itself dependent on Russia for 40% of its natural gas. How well has that worked out?

Ironically, we have all the minerals we need right here in North America. But good luck trying to get them out of the ground. Proposals to build mines in the United States and, increasingly almost everywhere else, meet fierce opposition if not outright bans. To give just one example, in 2022 the Biden Administration cancelled a proposed copper and nickel mine in northern Minnesota. This was after years of delays, navigating a maze of environmental regulations.

Yes, the same environmentalists and green-leaning politicians who tout all the benefits of electric cars are the same people who make mining the materials essential to build those cars – like copper and nickel – all but impossible. Try to square that circle.

So far, we've only talked about today's energy needs. What about tomorrow's? Future energy demand will be far greater than today's. That's been true for the entire history of civilization. The future will not only have more people but also more innovations. And entrepreneurs have always been better at inventing new ways to use energy than to produce it. It's obvious but worth stating: before the invention of automobiles, airplanes, pharmaceuticals, or computers, there was no energy needed to power them. And as more people become more prosperous, they'll want the things others already have - from better medical care to vacations to cars.

In America, there are about 80 cars for every 100 citizens. In most of the world, it's about five per hundred citizens.

Over 80% of air travel is for personal purposes. That's two billion barrels of oil a year. Hospitals use 250% more energy per square foot than an average commercial building. And the global information infrastructure – the Cloud – already uses twice as much electricity as the entire country of Japan, the world's thirdlargest economy. The massive data centres at the heart of the Cloud alone consume almost 10 times more electricity than the world's 10 million electric cars.

E-commerce has taken off and is propelling record growth in warehouses, increasingly filled with energy-hungry robots. America's truck freight index more than doubled in the past decade to deliver the goods to and from those warehouses.

These are today's known trends. While we can't predict the future, we can predict there'll be more innovation – in robotics, drones, quantum computing, biotechnology. And new industries not yet imagined. All of it will require more energy – a lot more. Fossil fuels, nuclear energy, and yes, renewables will be required.

But if you think we can get it all from wind and solar, dream on.

### Cuba's cashless measures backfire on businesses

'Right now the effect... is like paralysis. **NEW anti-cash restrictions** set by Cuba's government are backfiring on businesses, says a Reuters report. Earlier this month the Diaz-Canel administration announced new measures to transition the country to a cashless system, including a 5,000 peso (\$20) daily cash withdrawal limit. This has proved disastrous for Cuban businesses who rely on goods and services from abroad, particularly developing entrepreneurs.

the opposite effect of what was intended: companies are insisting on transacting in cash to avoid losing access to paper money, which is now scarcer than before. Now small business owners

Now small business owners like Pilares Construccion founder Yulieta Hernandez find themselves being asked by their suppliers to be paid in cash and being told by the government they cannot do so. (CBDC). A CBDC is a digital currency issued and governed by a central bank, allowing the government to keep records of all taxpayers' transactions.

Nigeria's central bank debuted Africa's first CBDC in late 2021 but the digital currency was given a cold reception as less than 0.5% of Nigerians used it. To try coaxing citizens into adopting CBDC the Nigerian government removed restrictions that required bank accounts to use CBDC. When that didn't work the government offered discounts on cab fares if riders used CBDC to pay. When neither of those worked the Nigerian government launched a war on cash and restricted cash withdrawals to 100,000 naira (\$225) per week for individuals and 500,000 naira (\$1,123) for

businesses. At the same time, the government also decided to redesign the currency, which limited banks' cash reserves while they waited for the newly designed currency.

Nigerians erupted in protest over the cash restrictions, but the government is doubling to control how taxpayers spend their money and ultimately phase out cash altogether, allowing only digital payments.

"The Law for the Reduction in the Use of Cash was designed to change the public's consumption habits and encourage a switch to digital means of payment, with a view to almost complete replacement of the use of cash in the future," reported Globes. In Australia, banks such as Commonwealth and ANZ are phasing out cash at their branches. More than a billion notes in cash have disappeared from circulation in Australia over the past twelve months, reports Sky News.

But the new rule has also had

"Right now the effect... is like paralysis," Hernandez said. "People are waiting to see... if a solution is found for the problems [the rules] have created." She added that many businesses are already freezing investments.

Cuba's cash restrictions follow similar decisions by other countries like Nigeria, which has been trying to force its citizens to use central bank digital currency down. Central Bank of Nigeria Governor Godwin Emefiele said: "The destination, as far as I am concerned, is to achieve a 100% cashless economy in Nigeria." Israel is also trying to phase out cash, even restricting the amount of cash an Israeli taxpayer can keep at home.

While the State of Israel mentions money laundering and tax evasion as justifications for these laws, they are not the only factors. The government also aims

## Children's Health Defense Australia: where the adults are standing up

FEW would disagree that the health of the children today foreshadows the health of the population tomorrow. With that in mind, the past three years of pandemic fear and dystopia have upset any preconceived ideas that the health of the people is on solid ground. In a worldwide response that saw nations lockdown, mask up and mass vaccinate – 'to protect grandma' – it seems scant regard was paid to the cost incurred on the future generation.

Australia was ground zero for many of the more tyrannical restrictions of freedom and it didn't go unnoticed. "The whole world is alarmed by what's happening in Australia", says Robert F. Kennedy Jnr, founder of Children's Health Defense USA. With many states enforcing closed schools, masking of children, social distancing and mandates, it will be years before the full impact of these actions is known.

As early data emerges on the impact on education, health and social development it seems those who might pay the greatest price are the next generation. It is timely then that the Australian Chapter of the Children's Health Defense was officially launched on 26 August 2023.

With a board packed with expertise from the likes of

Professor Robyn Cosford, Emeritus Professor Ramesh Thakur, lawyers Julian Gillespie and Peter Fam, Dr Astrid Lefringhausen, registered nurse Kara Thomas, and medical freedom advocate Cloi Geddes, Children's Health Defense (CHD) Australia is well placed to bring light to, and fight back against, the incursions on children's health over the covid years. But the story doesn't begin there. The covid response may simply be the catalyst, in Australia at least, for a light to be shone on the deterioration in the health of children over several decades.

"What we're seeing in our children now... is an epidemic of chronic disease", explains Professor Cosford. "The sorts of things that we used to be seeing in older adults, in our grandparents, and our great aunts and uncles. We don't expect to be seeing them in our children. We're seeing an epidemic of immunological disorders where nearly half of the children have some kind of allergic-type disease, and we have autoimmune diseases occurring in our children which never have been seen before... We have an epidemic of mental health ...

(with) some 40% (suffering) with depression, anxiety, OCD, panic disorders and so on.

"And then there's a big epidemic we're seeing of neurodevelopmental disorders... one in 10 diagnosed with ADHD, one in five with learning disorders (and) one in 36 with autism. These (figures) have increased dramatically over the last 20–30 years and were unheard of before now."

With a mission to 'end childhood health epidemics' it seems the team has their work cut out for them. These alarming trends in the health of our children have been brewing for years and now may well have been exacerbated by the additional insult inflicted by the covid response.

"A major study recently concluded that lockdowns harmed the emotional development of almost half of all British children", reports Professor Thakur in his CHD launch presentation entitled 'Children as human shields'. "I ask as a grandparent: why did we use children and adolescents as human shields to protect the supposed grown-ups and elderly?"

More concerning and downright disturbing, information was delivered during the launch by fellow presenters including the adverse effects of the covid injections, censorship of free speech in science and medicine, DNA contamination in the Pfizer covid injections and legal cases in process which aim to protect our future generations.

The rap sheet is long and the stakes are high. It seems CHD Australia has formed at just the right time. But the strength of the organisation will depend not only on the expertise at the helm but on those who hear the call and take a stand. Will you be one of them?

The Real Anthony Fauci

Big Pharma's Global War on Democracy, Humanity and Public Health

BOBBY Kennedy's masterpiece of medical reporting, The Real Anthony Fauci, was published in 2021. The facts were all there in this big, best-selling book. The sub-title to Kennedy's contemporary classic is Bill Gates, Big Pharma and the Global War on Democracy and Public Health. Several chapters of the Kennedy book are devoted to analysis of the AIDS saga where HIV tests on healthy patients were used to market dangerous pharmaceutical products.

Author Rebecca Culshaw is quoted, writing about the HIV scandal and unknowingly predicting the fraudulent Covid-19 tests and injections. She describes "a climate of fear, discrimination and terror that has been waged aggressively by a powerful group of people whose sole motivation was and is behavior control".

capital quickly and become more financially stable. Banking stability is crucial to a civil society. Therefore, they are a threat to shareholder owned banks. And the big shareholder owned banks are trying to buy up these community owned banks to eliminate their competition. Find a community owned bank and use them (Beware: some shareholder owned banks call themselves 'community banks' in their promotional material).

- 4. Choose cooperative education: Our young adults have been poorly educated. They have been taught what to think, how to accept guidelines, to accept official narratives – NOT how to think. ## Have the UN and WHO gone rogue?

#### By SENATOR MALCOLM ROBERTS

FOR many years the United Nations (UN) and the World Health Organisation (WHO) have been considered trusted organisations. That confidence has suffered in recent years as a result of their muddled and financially compromised COVID response.

I am pleased a growing number of Australians are seeing through the 'façade of worthy' that has been spun around these international political organisations. It is time to stop forming an opinion on the UN and WHO based on feelings. When viewed objectively on the data these organisations are a clear threat to freedom and the pursuit of abundance for all.

The constitution of the WHO should have alerted us to their intention from the start. From the preamble: "Member States declare... health is a state of complete physical, mental and social well-being and not merely the absence of disease or infirmity".

WHO's remit has always been to act not only against a real disease outbreak, but also to pursue an agenda based on social well-being. That could of course be anything.



Their constitution does limit the power of the WHO. Article 2(c) allows the WHO to "assist Governments, <u>upon request</u>, in strengthening health services". The Review Committee investigating the proposed changes to the International Health Regulations (IHR) found this was the overarching clause which should prevent the addition of compulsive powers.

Article 19 requires that any changes to the IHR or a new

pandemic 'accord' must be passed by a two-thirds majority of member states in the World Health Assembly (WHA) and will not be binding until ratified by that state. In Australia this means passing through both houses of parliament.

This is poor comfort for Australians. The tentacles of the predatory billionaires who bought out the WHO under the leadership of known terrorist Tedros Ghebreyesus also extend across Australia's body politic and bureaucracy. Approval of the IHR/accord is a foregone conclusion with only One Nation likely to oppose.

All is not lost. Article 21 of the WHO constitution only gives the WHA power to pass regulation on "Sanitary and quarantine requirements and other procedures designed to prevent the international spread of the disease". This is the full statement of the assembly's power to enact regulation as it relates to the provisions of the IHR/accord.

It is clear the WHA does not have the power to pass the IHR/ accord because it does not have the power to ratify the new heinous powers relating to domestic affairs of nations. The accord, for instance, calls for forced vaccination, arbitrary business closures, internal quarantine zones, lockdowns and arrest of dissenters.

It is clear the IHR/accord breaches the WHO constitution and the WHA does not have the power to even consider such matters.

The UN, however, could alter the WHO constitution to include powers of compulsion. The UN considered this issue on the 20th of September 2023 in the inaugural 'High-Level Meeting (HLM) for international coordination to improve Pandemic Prevention, Preparedness and Response' (PPPR).

HEALTH

This session did not result in a clear outcome so a communique was signed by session chair Dennis Francis without a vote. This 'political declaration' called on the WHO to advance the IHR/ accord but did not grant powers of compulsion necessary to support the IHR/accord.

This communique has provided nothing but propaganda 'aircover' for the WHO to introduce the IHR/ accord despite having no legal basis to debate or exercise such power.

Corporate pharmaceutical interests who fund the WHO in return for mandates in favour of their products, and gutless politicians desperate to dodge accountability for this or future pandemic measures, have won the day.

The UN and World Health Organisation have gone rogue by ignoring their own constitution and processes to achieve an illegitimate, political outcome. As voters and citizens of this beautiful country it is time to contact your local MP and Senators to stop the WHO.

## We are feeding an industry that profits from our ill health

NOWADAYS our bodies are overwhelmed with an onslaught of chemicals not only from our outdoor environment, but from everyday indoor products that most of us use without a second thought. Indoor air pollution is many times more toxic than outdoor pollution – but rarely mentioned.

The solution to household pollution is an easy one, but is not publicised or is simply dismissed, because it would dent the profits of those manufacturing toxic products.

The simple removal of harmful indoor chemicals costs you next to nothing and pays you back with improved health, supports you and your loved ones, builds stronger immunity and genuinely helps the environment at the same time.

These chemicals, many of them untested for safety, can combine with others to make a toxic invisible soup and can accumulate, overwhelm and be hard for our bodies to deal with.

Breathing issues such as asthma, or persistent coughs, rashes, runny nose, itchy watery eyes, migraine and headaches have improved dramatically or been resolved completely, simply by avoiding fragranced products and replacing them with less harmful substitutes.

A strong immune system is critical for good health and although there are countless dietary and other changes we can make, some of the simplest, quickest and most effective methods are literally right under our nose.

Like Big Pharma, the chemical industry is very lucrative. Over the past 80 years there have been 100,000 synthetic chemicals added into our world.

Unless you are taking conscious steps to avoid these products, you are likely living in a toxic soup of chemically 'fragrant' air.

Fragrance or parfum is not only found in the beautiful aspirational bottles of perfume and aftershave so glamorously marketed, but it also



A splash of fragranced deodorant, perhaps some cosmetics which can also have fragrance added, perhaps some perfume and some fragranced hairspray or hair gel, then off into a freshly 'cleaned ' fragrant car or taxi, complete with the constant release of chemical air freshener (just in case we managed to sneak in a molecule of actual fresh air!)

I think you can see where I'm going with this... a constant steady, discreet drip of fragrance into our everyday lives, so subtle, and in so many everyday items, has been, over time – normalised. We now all pay for the privilege of breathing in this toxic mix unaware of what, and how harmful, the ingredients are.

Is it any wonder our bodies have succumbed to allergies, diseases and chronic illness when even our attempts to detoxify at night are thwarted by our heavily-fragranced bedsheets and nightclothes?

Why are we inhaling and absorbing so many artificial chemicals via so many of our everyday items?

From dishes, cleaning sprays, bin liners to toilet paper, 'air fresheners' baby wipes... the list goes on and on and there seems to be new additions to the list constantly - now even including the pet market. But what exactly is wrong with fragrance and is it really causing serious health issues? Fragrance or parfum sounds comparatively safe on the ingredients list, especially compared to the other long scientific, unpronounceable, names listed. Fragrance sounds familiar and comfortingly reassuring ... what clever marketing!

e.g., from rose petals or flowers. Fragrances in household products are usually a mixture of many synthetic chemicals.

These chemicals are untested for safety, some are known to be harmful and thus are only allowed in small restricted amounts and many do not have to be revealed at all and remain secret and undisclosed to the customer 'for proprietary reasons'.

So this accumulative chemical soup we choose to breathe in daily – whilst we sleep, exercise, eat, work and play – is our choice – yes, but with this heavily funded industry, mass marketing and the misleading minimum disclosure – is it truly a fully informed one?

We are lured and manipulated into purchasing these everyday products without considering that they may contain ingredients which could have short – or long-term harmful consequences for our health.

Since some of the fragrance ingredients are not divulged by manufacturers, we aren't able to research the possible negative effects of those ingredients on our health.

If we don't know exactly what's in our body lotion or air freshener how can we make an informed decision about whether we would like to continue inhaling or absorbing? do not experience immediate negative health effects, they fail to understand the risk of long-term effects, which can be much worse.

People can continue to use products for years, allowing the toxic chemicals to accumulate in their body tissues, which can then be a contributing causal factor in serious diseases such as cancer and Parkinson's.

Is it any wonder our children are born today with hundreds of toxic chemicals in their umbilical cords and that toxic chemicals have been found in the breast milk of the mothers of newborns?

A study was done by EWG in 2004, testing the cord blood of newborn babies in U.S. hospitals for toxicants.

*The results came back with an average of 287 chemicals:* 180 of them known to cause

cancer. 117 are toxic to the brain and

nervous system. 208 are known to cause birth

defects or – abnormal development. This is a reflection of the number of chemicals that you may have inside you right now.

Allergies are the norm now – but when did it become 'normal' to have huge bags of inhalers at school

linked air fresheners to diarrhoea, ear aches and headaches suffered by their mothers.

Many harmful indoor chemicals can exasperate or be the cause of many chronic conditions. The elderly, babies, children, those who are pregnant, and nursing mothers should be particularly careful.

Children today are bombarded with artificial chemicals before their immune system has even been formed. Adults can change this toxic environment for them.

Teens spray on their chemical products with one hand and puff away on steroid inhalers with the other.

Convenience sells, we like it, we buy it, we want to continue to benefit from it, but there's a price – it could contribute to irreversible damage.

Should we really continue to feed an industry that profits from our pain?

Fragrance-free products are readily available and many products which accomplish the same goal have no fragrance added at all. Their raw ingredients smell fine and there is no need to mask them with 'fragrance'.

The human body can perform miracles in detoxifying itself, but it has to work a lot harder when faced with all the chemical poisons it is subjected to on a daily basis.

Chronic conditions can all be worsened by toxic indoor air pollution. The great thing is, the reverse is also true. Clean indoor air allows the body to detoxify and repair, particularly as we sleep and heal.

Avoidance of 'fragrance' can especially help a host of neurological issues from autism to dementia.

Our children, the elderly, babies,

surrounds us invisibly daily, coming from a multitude of surprising places.

Some people sense straight away that certain products are toxic and unhealthy and stop using them. However, because many receptions? Medication often can lower our natural immunity which is the last thing we all need. There are always side effects.

If you or anyone in your household has any autoimmune issues like asthma, allergies or neurological issues like ADHD, autism, anxiety or depression, it's really worth removing these products even temporarily and assessing the difference – it could be the easiest and most effective move you make.



## Could cyber attack bring in digital slavery?

#### Cashless society threat is a nightmare we must wake up to

#### WILL a cyber attack lead to us waking up to a cashless society powered by Central Bank Digital Currencies (CBDCs) and a digital ID?

This might sound like the plot of a dystopian science fiction movie – but it could be our reality and the climax of 'the great reset'.

Let's back up a bit here and set the scene. Fiat currencies (government-issued currency that is not backed by a commodity such as gold) start life with a backing to give them value.

The dollar was backed by gold until President Richard Nixon took it off the gold standard in 1971. And the great British pound was originally backed by 11b of sterling silver, hence pound sterling.

Fast forward to today, and these fiat currencies are backed by nothing more than a promise from the banks. They are designed to keep people poor via inflation. And they do so because central banks print money (create it out of thin air), slowly devaluing the currencies over time.

The primary reason they do this is to make their debt more serviceable. But what happens after years of monetary debasement? And what happens when central banks lose control of their 2% annual inflation target? The answer is simple: fiat currencies by design tend towards zero until they eventually reach zero (think Zimbabwe, Venezuela, and the Weimar Republic).

Worse still, with a backdrop of double-digit inflation, the Bank of England and the Bank of Japan continue to print exponentially more money to try to save their rapidly imploding bond markets, pensions and dying economies. History tells us that all currencies first collapse into the world reserve currency (that would be the dollar this time around), before the world reserve collapses and the whole system requires resetting. Usually a new country claims

the world reserve status, backing the new reserve against gold to ensure value, stability and public trust, before the whole pony show starts over again. But what if this time, central banks decided to utilise technology to control this reset and implement a totalitarian takeover? That's where the CBDCs and digital IDs come in.

CBDCs are digital fiat currencies issued by central banks. In practice, the daily user experience would be very similar to using a debit card or paying contactless with a smartphone. Beep the merchant terminal to pay and off you go.

But CBDCs have a sinister iteration that should make you want to resist them at all costs. First, CBDCs are a direct line from central bank to the people, with no requirement for any intermediary banks. CBDCs operate on a blockchain which is an immutable ledger, meaning the record of transactions can never be changed. By using CBDCs, a record of everything you ever purchased will be kept forever. Everywhere you went, every prescription, everything you ate, wore, or watched will be on a public blockchain forever. Worse still, CBDCs are programmable money. This means CBDCs can come with stipulations, e.g. you can only spend money if you have met injection requirements. They can be product-restricted, so that they only allow you to purchase pre-approved items. And they can even come with expiry dates e.g. spend within two weeks or two years, or lose it.

These are not speculations; these are part of the design, and stated inside the white papers for each of the CBDCs. As if that's not bad enough, expect to pay negative interest rates (yes, really, they want you to pay the bank to keep your money there).

So how exactly are these to be rolled out? No one will accept CBDCs unless there is no other choice. Central banks will continue to debase their currencies until the cost of living increases so much that the public will beg the government for a solution. That solution will be a monetary reset, with the roll-out of CBDCs, heading towards a cashless society and worst of all, digital ID and social credit scores. But all of this will leave the people angry at the government and central banks. And the intermediary banks will still be operational. Hence, the World Economic Forum tells us to 'prepare for a cyber-pandemic'.

CBDCs are being tested right now; countries including Australia, India, Hong Kong, China, Japan, Korea and even the UK all have their CBDCs developed, tested and ready to go. The U.S. Federal Reserve launched its CBDC for testing last month.

Digital IDs are closer than most realise too. The Prime Minister, Rishi Sunak, has ties to the WEF, and his father-in-law, Narayana Murthy, is the founder of software giant Infosys – which has developed a digital ID system similar to the one used in China.

Could a cyber-attack be used to bring in these new cashless systems? Could an internet blackout be the climax to this financial reset that sees us waking up to a new digital, cashless economy, full of totalitarian systems like CBDCs, digital IDs and social credit scores like they have in China?

## Aviators take to the air waves

TWO programmes that went to air in September on Club Grubbery showed what is possible with technology in media and what is at risk from Australia's turn to Soviet-era censorship in our government's proposed misinformation and disinformation legislation.

On September 21 Graham and Michelle Hood were half-way to Perth, their caravan perched on the edge of the Nullarbor Plain, a few metres from the Great Australian Bight. Graham's media co-host, John Larter, was home at Tumut in the foothills of the Snowy Mountains.

Their guests, Squadron Leader Derek Fox and Ben Morgan, were in Victoria and NSW. 'Foxy' is a former chief pilot of Tigerair. Ben is CEO of the Aircraft Owners and Pilots' Association (AOPA). John Larter is a paramedic of 25 years' service who holds commercial pilots' licences for fixed wing aircraft and helicopters. 'Hoody' was a long-serving Qantas captain until the covid mandates grounded him.

Audiences nationwide and overseas via internet technology watched these four men with vast experience and knowledge speaking freely for two hours about the crisis facing a vital industry. This is exactly

what we need from the media.

Graham Hood introduced the first session with the solemn statement that the spotlight on Qantas exposed "ineptitude across every sector of aviation in this country".

At the end of the second session, Hoody's message conveyed an air of urgency and a lack of patience with people failing to take a stand.

"If you love your country, lace up your boots and do something about it. The world is being run by cartoon characters. There needs to be a global tribunal to hold these puppets to account".

Club Grubbery and all the new media who have arisen from the covid project, including this newspaper, share a common origin. We stopped waiting for our moribund mainstream media to do their jobs and we set out to tell the uncensored story.

Our target audience is the same general public to whom preachers have directed their energies throughout history – the mass of people in the middle who are sitting on the fence, some of them blissfully ignorant of the dangers, others reluctant to speak up.

I asked Graham and John the central question: Are people waking up?

"It is hard to gauge", said John. "It would be good to see some more data. It appears that the number of people taking boosters has declined".

John was disappointed by the turn-out at September 23 rallies around Australia and detected "a level of complacency creeping in". The government retained an ability to cover up the story, for example, by calling vaccine injuries 'long covid'.

However, the marketing of vaccines generally, including injections for babies, indicated a concern in official circles about the loss of consumer confidence.

He sees the 'watered-down' covid inquiry as a mistake by Prime Minister Albanese. "Because it is so ridiculous, the Liberal Party is now forced to take a position and the Human Rights Commissioner is speaking up".

John Larter came to the covid controversy with a background in politics, both in local government and as a NSW delegate to the federal executive of the Liberal Party when Tony Abbott was opposition leader.

His fights over covid mandates for NSW health workers went public on social media while Graham Hood's quarrels with Qantas went down the same path and the two critics began to appear together at protest meetings.

They were told they resembled the satirists 'Roy and H.G.' whose satirical show was known as Club Buggery. Hence the Club Grubbery name. The pilot and paramedic still try their hand at satire but their message is deadly serious.

In his concluding comments to the September 21 aviation programme, Graham Hood said: "When people wake up, they don't go back to sleep and more people are waking up every day".

Coming from a company that uses 'the spirit of Australia' as a marketing slogan, he mourned the loss of freedom in the three Commonwealth countries.

"If anything went south in the world, people wanted to go to Canada, Australia or New Zealand. Now we have become the pariahs of the free world. In fact, we are not a free world any more.

"It all rests with you", Graham Hood said as he addressed the camera and the audience. "What we are talking about is just a minute speck in the dustpan of what is going on in this country.

"You either get part of the solution or you are part of the problem".

## The climate cultists want to decarbonise the planet of humans

Climate alarmists want to hijack tax dollars to inject carbon dioxide into the ground, removing the lifegiving gas from the atmosphere.

#### THESE schemes include burying trees and paying millions of tax dollars to mining corporations to pump the carbon underground into deep wells for storage.

The process is called Carbon Capture and Storage (CCS) and it is becoming a haven for lunatic plans that will drain Australia's tax base of money that would otherwise go to hospitals, roads and schools.

Australia's national science agency the CSIRO wrote in September that there are 18 CCS projects in Australia forecast to sequester 20 million tonnes of carbon dioxide (C02) per year by 2035.


Worldwide there are 30 projects in operation, 11 under construction and 153 planned according to the Global Carbon Capture and Storage Institute.

The world's largest project in Texas, USA, is a US\$1 billion project called Stratos that aims to remove 500,000 tons (453,592 tonnes) of CO2 from the atmosphere a year once fully operational in 2025.

The Guardian reported on the project in September, describing it as: "a quest that has been lauded as essential to help avert climate catastrophe".

There is no "climate catastrophe", it's a total fraud. Carbon dioxide is not poisonous or a pollutant. It is a vital trace

gas necessary for life that plants absorb during photosynthesis, enabling them to grow and produce the oxygen and food vital for animal life.

If you take away the C02, all life on Earth will die.

Earth's atmosphere is 0.04% C02, 78% nitrogen, 21% oxygen. Other gases including Argon make up the remaining 0.96%.

The lie beneath the climate change movement is that there is excess carbon dioxide in the atmosphere. Who says and by what definition?

There are four essential

ingredients for plants to grow and produce oxygen and sugars (food). Those four essential ingredients are sunlight, carbon dioxide, water and minerals such as nitrogen and magnesium.

Sunlight, carbon dioxide, and water are all demonised as greenhouse gases. In addition, nitrogen, an essential plant fertiliser, is also now considered pollution.

Carbon dioxide is taken into green plants and through a chemical process called the Calvin cycle converted into sugars (glucose) in a biomolecular factory using an energy molecule called "ATP".

Adenosine triphosphate (ATP) is an energy-carrying molecule known as "the fuel of life", because it's a universal energy source for living cells. Every living organism has cells that contain thousands of ATP-producing rotary motors supplying the energy of the cell. The rotary motor is proton powered. Where does the cell get protons from to power these motors? From water (H2O), also demonised as a greenhouse gas.

Plants operate under two different conditions. With sunlight and without sunlight. Under sunlight carbon dioxide (CO2) is absorbed and net oxygen (O2) is produced. Water (H2O) is required at this stage. Under these conditions photosynthesis results in energy being transferred to ATP using photons from sunlight.

Sunlight is required to activate molecules in green leafy plants. A single photon of absorbed sunlight is used to drive the thermodynamically uphill process of converting adenosine diphosphate (ADP) to ATP. Without ATP all life dies.

When there is no sunlight, ATP is consumed by the plant to keep it alive. During that time (usually at night) the plant consumes oxygen and emits carbon dioxide.

Plants are essential to our existence and green life depends on carbon dioxide, oxygen

and water, along with certain minerals. Nitrogen, phosphorus, and potassium, which are used in artificial fertilizers, are also needed.

Due to modern industrial farming methods, minerals are not taken up by plants as readily due to a lack of soil microbes, so farmers need artificial fertilizers. These fertilizers are manufactured with natural gas to produce nitrogenbearing molecules.

The global warming lunatics want to shut down natural gas production and thus fertilizer production. We saw what happened in the Netherlands, Sri Lanka and Brazil.

The fanatics also want to shut down sunlight. Research is underway to block out the sun using upper atmospheric aerosol injection techniques.

CNBC reported last year that the White House Office of Science and Technology Policy was coordinating a five-year research plan to modify sunlight "to temper the effects of global warming".


"Some of the techniques, such as spraying sulphur dioxide into the atmosphere, are known to have harmful effects on the environment and human health," CNBC reported.

"Climate leaders", however, want to "balance these risks against a possibly catastrophic rise in the Earth's temperature".

Other methods include dumping millions of tonnes of toxic chemicals like Barium, Strontium, Aluminium, etc into the upper atmosphere with tanker aircraft. It is called geoengineering.

Shut down all the inputs to photosynthesis and you shut down all oxygen and sugar production. That is a mass extinction event. If these lunatics succeed what follows will make the extinction of the dinosaurs a footnote.

## **Timber industry in shock as governments impose unrealistic closure dates**

THE Victorian and WA state governments have reneged on previous agreements by forcing the timber industry to shut down by the end of this year.

First, they came for the fishing industry. Australia is the world's largest island with 34,000 kilometres of coastline and more than 4,000 species of fish and yet we import 75% of our seafood. Let that sink in.

The farming industry is under severe threat from impossible green overlays, incredible numbers of solar panels, wind turbines and transmission lines closing down productive farming land and a rising wall of unreasonable Indigenous demands.

And in the same manner of madness, both Western Australia and Victoria's hardwood timber industries are being forced to close by the end of this year, despite both having agreements with their state governments that they would support logging until 2030. The industry accepted that date in good faith and mills and the harvesting and timber transport industries have spent millions of dollars in new equipment. Those industries are in shock.

The Andrews government assured the industry before the last election that it would support



logging until 2030 and abruptly reneged on that agreement almost immediately after they won another term. There was no consultation. The same cruel blow was dealt by the McGowan government.

The McGowan government gallantly offered \$350M to develop the softwood industry. Worthy perhaps, but WA will still need hardwood so where will that come from? The Andrews government launched a fund to help the industry and the fund is titled 'The Sawmill Voluntary Transition Package'. Voluntary! Really! This is how governments spin truth to the point that perhaps bureaucrats believe it themselves.

hardwood industry but only if enough time is allowed to replace it with sufficient plantation hardwood and that is a sixty-year cycle. Close it down at the end of this year and that timber will be replaced from countries to our north – among others – who have far less stringent logging practices and are far less regulated and monitored.

It is not as if this hasn't been discussed in full over successive governments. Federal Member for Monash, Russell Broadbent, announced in federal parliament; "This is a kick in the guts for regional Australia. This is a real kick in the guts for my community and it's immoral." Broadbent said various federal governments have addressed the issue. "We spent political blood and millions of dollars to get these regional forestry agreements up with the states and those agreements are now shattered."

Federal member for Gippsland Darren Chester announced in parliament, "It is dangerous to live around forests that are unmanaged. People and wildlife die in poorly managed forests and Victorian Premier Dan Andrews' plan to shut down the native timber industry in 2024 is a plan to kill country towns, kill wildlife and kill Australian jobs. It is a Dan-made disaster." Recently Gippsland Water cancelled a longstanding agreement with the Country Fire Authority for forest management which is a loss of important income to the volunteer firefighters, but also leads to an increased risk of fire and this just as we enter an El Nino dry weather period.

In WA, Shadow Minister for Forestry Steve Martin lambasted the government over the loss of yet another milling operation.

"Whiteland Milling is the third timber mill to close within the last month as a direct result of the McGowan Labor Government's attack on regional jobs. Thanks to Labor's unscientific and cynical decision to shut down a sustainable regional Western Australian industry, dozens of workers in Busselton are now looking for a job." Mills in WA have advised that they can't get logs even though the government suggests there is no issue. At the coalface it is a different story, with mills unable to source logs which essentially means the industry is shutting down well ahead of the January 1 deadline.

WA Forestry Industry Association CEO Adele Farina said that five months from the cut-off the government contacted mills across southern WA and advised them that no more logs were available and any statement to the contrary by the government is a blatant lie.

To add insult to injury, logs selected for logging are being selected for firewood according to WA's Forest Industry Association.

Perhaps the final word goes to WA forestry consultant John Clark who said he has seen clear evidence that sawmill-quality timber was still being harvested but it was not going to mills and instead was being stockpiled for firewood. "One of my suspicions is that the minister, The Honourable Jackie Jarvis, is really concerned there will be firewood shortages next year."

## **Bill Gates and the uncertain prospects for food security**

As we approach a winter of discontent and food systems go from bad to worse, there is trouble in paradise.

AT the root of these problems, government responses to covid have contributed to a sixfold increase in famine-like conditions as global supply chains collapse and field trials for gene-edited crops and farm animals restart in the UK.

Against the backdrop of this perfect storm, the UN's World Food System Summit convened last month [September 2021], with member states joining the private sector, civil society groups and researchers to bring about "tangible, positive changes" to the world's food systems, and as the story goes, "drive recovery from covid-19".

But even if we could solve our problems using the same logic that created them, there are deeper institutional problems undermining the integrity of the Summit. Specifically, its corporate capture by one man, whose vision of the future of food security places the interests of civil society and farming communities in a different universe to the corporations he is beholden to.

A household name on the world stage of disaster capitalism, there is more to Bill Gates than doomsayer-general terrorising the world's population into a permanent state of suspended animation, and it typically involves the future of food security.

In less than a decade, Gates has become America's largest private farmland owner, acquiring more than 269,000 acres of prime farmland in the US, including the 100 Circles Farm where fast food giant McDonalds' potatoes are grown. Gates effectively owns McDonalds' fries, his commitment Gates owns 7.8% of Warren Buffet's investment vehicle, Berkshire Hathaway, which controls 39% of the largest Subway fast food franchise and 9.3% of The Coca-Cola Company. That's in addition to the Gates Foundation's 16.8% stake in the largest Coca-Cola bottling franchise in the world, named for the fourth consecutive year as the world's biggest plastic polluter.

But Gates' environmental effrontery is only part of the problem. He also backs multiple ventures blurring the lines between food and tech, and if, indeed, Gates has his way, the food of the future will little resemble what grows out of the ground.

That's because his centre of gravity is GMOs. He owns 500,000 Monsanto shares worth a modest \$23 billion, making him, by implication, the sworn enemy of everything natural, organic and sustainable. There's the Gatesfunded Impossible Burger, made from genetically engineered soy and yeast, with its manufacturer, Impossible Foods, owning 25 patents on artificially replicated cheese, beef and chicken.

Another Gates-backed start-up is Ginkgo Bioworks. According



is of little importance to Gates are the social and environmental costs of his ventures. Or at least, he promotes one set of values, and invests in another.

For example, Gates accepts that agriculture accounts for 24% of 'greenhouse gas' emissions, but thanks to the 100 Circles transaction, Gates is now the largest farming real estate holder in the U.S. This despite, as we are told by the likes of Gates, that agriculture makes up as much as

If, indeed, the agrifoodtech ventures Gates is bringing to market continue to flourish, traditional diets will soon be replaced by lab-cultivated meat and other Frankenstein foods.

to their mission statement, Gingko will produce custom organisms using cell programming technology to genetically engineer flavours and create ingredients for ultra-processed foods. Their plan is to license more than 20,000 engineered cell programmes to the food industry.

If, indeed, the agrifoodtech ventures Gates is bringing to market continue to flourish, traditional diets will soon be replaced by lab-cultivated meat and other Frankenstein foods. Like Rockefeller before 70% of fresh water usage globally, leads to greater soil erosion, deforestation, and, you guessed it, climate change.

Gates flouts the very values of low carbon and sustainability which he himself helped to popularise. From the carbon footprint of his farmland holding, to \$1.4 billion invested in the world's biggest oil companies, Gates backs all the largest corporate perpetrators on the list of the European Commission's top five causes of 'climate change'. When it comes to unsustainable scientific interventions, however, nothing quite hits the mark like synthetic fertilisers, which Gates describes as the "magical innovation that's responsible for saving millions of lives from hunger and lifting millions more out of poverty".

world's largest carbon sink - the soil – exhaust the soil's natural nitrogen deposits, deplete the soil's microbial biomass, and, according to the Intergovernmental Panel on Climate Change, are one of the key drivers of 'climate change'.

Taking no notice of these facts, synthetic fertilisers are central to Gates's master plan for the future of food security. He's under the spell of Europe's biggest fertiliser producer, Yara, which is not only causing climate catastrophe, but also had their top executives sent to prison in one of Norway's biggest corruption scandals. There's also the small matter of his 14.4% ownership of Canadian National Railways – one of the most important fertiliser supply chain operations in North America.

On the one hand Mr Gates uses his influence to transform public policy towards high input farming interventions; on the other, he directly profits from their deployment. What is of little importance is whether these interventions are fit for purpose.

Marking a broader takeover of the farming commons, fertilisers were once solely derived from natural and organic farming practices, including compost, animal manure and crop rotation – which have been shown to be more robust, sustainable, and profitable to farmers.

That was until the arrival of the Rockefeller Foundations' 'Green Revolution' in the 1950's, which galvanised an industry-wide overhaul to chemical interventions, large scale, technology-driven monoculture and hybridised seeds. Modernisation that heralded the arrival of mega corporations into farming and the reliance of small-scale farmers on their products and services. But that's only half the story. A generation before the Green Revolution, John D. Rockefeller (the first) belonged to a group of prominent industrialists at the turn of the century, including the Carnegie and Harriman families, who were committed to facing off a threat presented to America's Anglo-Saxon ruling elites by inferior genes, such as they were considered.

That culminated in the adoption of eugenics programmes across the U.S., which set out to eradicate the poor, feeble-minded and ethnic minorities from the gene pool through the forced sterilisation of 80,000 so-called defectives. That was until the Nazis' race purification programmes were revealed to be imported from America's flourishing eugenics movement, which, to say the least, proved to be a public relations disaster for eugenics.

The solution was to distance the pseudo-science from the holocaust by transmuting eugenics into the morally acceptable fields of 'birth control' and 'genetics' (with the reconstruction generously funded by the Rockefeller and Ford foundations), and with many of the original eugenics institutions morphing into today's medical genetics organisations.

Fast forward a generation and many of the principles of eugenics were put to work in the Green Revolution of the 1950s when John D. Rockefeller Jr brought the gene revolution and its hybridised seeds to India. He was signalling man's conquest over nature and the principle that only the strong amongst plants and animals should thrive and survive.

Half a century later, Gates would come to inherit this legacy through his foundation's programmes in Africa. As is often noted, Gates's father was the head of Planned Parenthood, one of the birth control descendants of the original eugenics movement, founded by prominent American eugenicist, Margaret Sanger.

This explains why the Gates Foundation is today active across the barometers essential for life itself – birth, health and food, and why no other organisation is so deeply embedded in medical genetics, from GM seeds and farm animals to the mRNA gene-based vaccine to the myriad birth control organisations funded by Mr. Gates, these principles are central to his philosophical worldview, which like Rockefeller before him, involves the aberration of man meddling with natural laws to rein in a subordinate nature. If, indeed, Gates has a maxim, then it is science over nature, man above God.

to public health aside.

On the one hand Mr Gates is the most influential player in global public health, following in the footsteps of his spiritual leader, John D. Rockefeller. On the other, he backs a confederacy of fast food brands that are killing more people than tobacco, and driving those who survive towards the very pharmaceuticals which he also wheels and deals to half of all Americans suffering from chronic health disorders.

When it comes to fast food,

him, Gates is transforming our relationship with food, only he's weaving climate change and the mantra of 'following the science' into his worldview.

This typically involves genetics, agrochemicals, and a shedload of automation, with his foundations industry partners operating Herculean monopolies over services and supply chains. What




