Keep cash alive: use it or lose it

Physical cash is a voting machine that can be used every day. Bankers hate cash.

WHY do bankers hate physical cash? They have to collect it, secure it, account for it, distribute it and manage the recall of old cash. All of this activity generates no revenue for them. Thus it generates no profits. In fact, it is a cost centre for the entire banking sector. So it's not hard to understand that bankers see cash as their enemy.

The benefits of physical cash:

- Cash protects privacy and personal data.
- Cash is anonymous no tracking by big brother.
- Cash contributes to personal freedom and independence.
- Cash supports democracy.
- Cash is the people's money.
- Cash does not require electricity or electrical devices.
- Cash is sovereign money.
- Cash is non-interest bearing at origin.
- Cash is fungible.
- Cash is non-electronic.

■ Cash supply is immediately responsive to increased demand from the people.

 Cash provides an excellent buffer against excess creation of interest-bearing credit money.

■ Cash is free of charge.

■ Merchant may offer discounts for cash.

In most advanced economies of the world, the supply of fresh new money created as a bank loan is now around 97-98% of the total. Thus physical cash is only 2-3% of the supply of fresh new money.

The 'buffering' effect of cash to dampen excess credit creation is important. But it has declined dramatically since the 1960s when the ratio of credit money to cash in the money supply was much more favourable to physical cash.

The supply of cash is determined by its demand:

Perhaps the most important aspect of physical cash is that its supply is determined by its demand. In other words, if the people use more of it in their transactions, then the supply has to be increased. In effect, this takes the power of increasing the money supply away from the bankers and transfers it to the people.

Cash is increasing in many nations simultaneously:

There are firm reports of increased use of physical cash in Switzerland, Spain, Germany, Nigeria, Slovakia, Austria and India. Austria and Slovakia have



enshrined the use of cash

in their national constitutions which enraged the European Commission whose head is the un-elected Ursula von der Leyen.

Power to the people:

Money is a public good that emanates from the desire to exchange promises in a trustworthy manner. Understanding that is critical. The people are actually at the centre of money demand and supply, not the bankers and not the government.

Drug regulators - the revolving door keeps revolving

EIGHT months after leaving his position as head of Australia's Therapeutic Goods Administration (TGA), John Skerritt has been appointed to the board of Medicines Australia, the peak body that represents the nation's pharmaceutical industry.

In a recent interview with *Medical Republic*, Skerritt talked about his new position as an independent director on the board, saying that he was "looking forward to working closely with the industry".

Reflecting on his time at the TGA, Skerritt said he was most proud of the way he was able to "totally rework" the regulatory framework by speeding up drug approvals. "Now we have priority, provisional, other pathways that can get those medicines to patients much earlier", said Skerritt.

Since leaving the TGA, Skerritt also said he was "doing an awful lot of stuff on building the messenger RNA framework in Australia, both therapeutics and vaccines", the very industry he was charged with regulating during the pandemic.

This has reignited concerns about the 'revolving door' of drug regulators, whereby agency officials end up working for (or advising) the same industries they once regulated. The TGA was approached for comment. In a statement the agency said it "has no restrictions applied to what employment employees can take when they leave the department".

Medicines Australia did not respond to my request for Skerritt's disclosure statement (which board members are usually required to submit), and it is not a matter of public record if Skerritt has a financial interest in mRNA technology.

Tony Nikolic, director at law firm Ashley, Francina, Leonard & Associates, said whether or not Skerritt is remunerated for his new role he is still in a position to influence regulatory and policy decisions. "Medicines Australia



officials at the US Food and Drug Administration (FDA), who oversaw the approval of Moderna's 'Spikevax' Covid-19 vaccine, took jobs at Moderna within months of leaving the agency.

"Public service isn't just any job – you are being entrusted by the public to serve in the public interest. Revolving in and out between the FDA and industry violates that trust. It raises suspicions – suspicions that could very well be valid," said Doshi.

"How can one ever be sure that the decisions they're making while in the public sector were actually in the public interest? If an FDA official is eyeing a lucrative industry job, how tough is he going to be on his potential future employer? The public needs a regulator it can trust to always make regulatory decisions with the public interest in mind - not someone's private interest," he added.

Some have argued that the revolving door can be an asset that takes advantage of unique expertise and knowledge, but Doshi said this argument is flawed and blurs the line between expertise and commitment.

"Expertise is great. But it's possible that an expert working as a public servant doesn't have a commitment to the public interest and is also considering personal gain, or helping one's network. That's why some people propose a cooling off period before allowing staff to accept roles with the industries they once regulated," said Doshi.

TGA under the microscope

During senate hearings, TGA staff members were criticised for downplaying safety concerns related to mRNA vaccines and for failing to monitor adverse events. At a senate hearing on 3 August 2023, South Australian Senator Alex Antic asked the TGA about its financially conflicted operations model.

Antic cited my BMJ investigation that reported the TGA had the highest proportion of its budget funded by the drug industry (96%) compared to five other international regulators.

"Does the TGA accept that it is horribly conflicted by virtue of that industry-funded model?" asked Senator Antic. "No", responded the TGA abruptly.

Under the Therapeutic Goods Act 1989 the TGA said there was no requirement to disclose the names of individuals involved in the Covid-19 vaccine approval process, nor did any of its employees consent to having their names disclosed.

In a statement, the TGA said:
"Staff have received threats (including several dozen death threats) from individuals opposed to vaccination and, in particular, vaccination with the Covid-19 vaccines. In these circumstances, and having regard to the Australian Government's safety obligations to its staff, it is inappropriate to release the names of those involved in the Covid-19 vaccine approval process."

The agency said I could submit a freedom of information request, but that authorities would likely regard the information as being 'exempt having regard to the safety obligations around government staff and other public interest factors'.

is still a lobby group and can influence the decisions made by the TGA and the advisory group ATAGI [Australian Technical Advisory Group on Immunisation] to favour certain research. In this case Skerritt admits he's interested in pushing mRNA technology through the pipeline", said Nikolic.

He says certain organisations in Australia have argued for better rules to prevent the 'revolving door' and ensure that public officials act with integrity by enforcing a 'cooling off' period once they leave public office. "There should be a higher emphasis on ensuring there's a cooling off period of no less than five years between appointments", said Nikolic. "Skerritt's recent statements only underscore the need for proper legislative and regulatory oversight to manage and prevent potential abuses and conflicts of interest."

Peter Doshi, professor at the University of Maryland School

of Pharmacy said the expedited pathways mentioned by Skerritt (that speed up drug approvals) come at a cost. "Swift approvals are a fine goal, but not if it means that standards are being sacrificed – that defeats the whole purpose of having a regulator", said Doshi. "The US has more than two decades of experience now speeding drugs to market and the costs of rushing are substantial."

"Officials often argue that they don't cut corners, but we know that speeding up drug approvals means drugs can get onto the market without substantial evidence that they improve patient outcomes", added Doshi. "And research shows that such drugs are more likely to be subsequently labelled with additional safety warnings and more likely to be withdrawn due to safety issues."

Doshi's recent investigation for The BMJ [British Medical Journal] highlighted the ongoing issue of the 'revolving door' of regulatory agencies.

He reported that two senior

of My Place is based on the same realistic assessment that has propelled the growth of other enterprises including this newspaper – The Light Australia.

Electromagnetic fields and miscarriage

Are you pregnant or planning for pregnancy?

THEN here's a good reason to reduce your exposure to electromagnetic fields (EMFs).

In a study published late last year, researchers found that pregnant women who were exposed to high levels of EMFs had a higher-than-normal risk of miscarriage.

The authors reviewed previous studies that were conducted on miscarriage and exposure to mobile phones and magnetic fields of the sorts emitted by power lines and wiring.

'The present meta-analysis

study showed that the risk of miscarriage in pregnant women who were exposed to EMF was 1.69 times higher than the risk for women who were not exposed,' they concluded.

They found that miscarriage risks were affected by:

the mother's distance from the wireless source and the frequency of its signal the length of the exposure the strength of the exposure (double the risk was found at a magnetic field of 16 milligauss) daily time spent using a mobile phone and where the phone was positioned on the body the period of pregnancy (risks were higher in early pregnancy).

EMFs could also damage the growth and health of the foetus,

the study found.

The authors suggested a number of ways in which EMFs could cause miscarriages.

"... EMF may affect chemical

interactions in cell membranes; they may decrease the permeability of cell membranes, which results in decreased cell connections; they may increase the number of free radicals in the body; they can impair mitotic divisions; and EMF may damage cell proteins and cause cell severance. Another theory is that the depth of penetration by EMF into tissues increases when fluids are low.'

The authors say their findings could be used to help prevent miscarriages in the future. 'It is hoped that the results of this study will increase awareness of healthcare providers, such as gynaecologists and midwives, about the adverse effects of electromagnetic waves on pregnancy and the risk of miscarriage. In this way, pregnant women will be encouraged to

protect themselves from exposure to electromagnetic waves. Prepregnancy and early pregnancy counseling on the proper way to limit exposure to electromagnetic waves from electrical appliances and devices, mobile phones and the internet may reduce the risk of spontaneous abortions,' they

The Controligarchs

CONTROLIGARCHS is a name that investigative journalist Seamus Bruner invented to describe a group of super-rich people who have an indecent obsession with the way the rest of us lead our lives.

The leader of the pack is Bill Gates who followed the example of John D Rockefeller and rebuilt his public image from ugly corporate cannibal to benevolent philanthropist.

The author begins his story in May 2009 in the president's house at Rockefeller University in New York where three major-league moneybags – Gates, David Rockefeller and Warren Buffet – convened a meeting of the rich and famous to plan a public relations stunt called the Giving Pledge – philanthropy on a grand scale.

According to reports leaked to The Times of London and some European newspapers, guests at the meeting included George Soros, Michael Bloomberg, the heads of Cisco, Blackstone Group, Tiger Management and media hotshots Ted Turner and Oprah Winfrey.

The 2008 financial crash revealed such incompetence and greed in the governing institutions that global elites were concerned about a loss of control. Bruner uses the expression – peasants' revolt.

Kees Van Der Pijl in States of Emergency (reviewed in Issue 3 of The Light Australia) made a similar analysis referring to the establishment's fear of another 1848 European year of revolution when Marx and Engels published The Communist Manifesto. Biologist Bret Weinstein adopted the same hypothesis when he explained the covid project on his 6 January interview with Tucker Carlson.

Disregarding the origin and authenticity of the disease, an organised and coordinated network was ready to use the covid panic to impose obscenely harsh measures such as lockdowns leading to the massive crime against humanity of mandated injections with an experimental gene therapy, the consequences of which are now evident in what statisticians call all-cause mortality.

These are sick puppies and this is adults-only reading. Bruner quotes a report on a Gates-funded technology to track children's vaccination status published in the December 2019 issue of Scientific American – just weeks before we heard about SARS CoV 2.

"Along with the vaccine, a child would be injected with a bit of dye that is invisible to the naked eye but is easily seen with a special cell phone filter combined with an app that shines near infrared light on to the skin. The dye would be expected to last up to 5 years

according to tests on pig and rat skin and human skin in a dish."

Not content with their grasp on the government-medical-scientificpharmaceutical complex and their constant propaganda bombardment via mainstream media, social media and headphones, the Controligarchs want to get inside our heads – literally.

We read of a monkey in so much pain after having a hole drilled into his skull and microchip inserted into his brain that he vomited continuously and had to euthanised. Another monkey to meet the same fate chewed his fingers off.

According to a Reuters investigation this field of research has killed 1,500 animals including pigs, sheep and monkeys. Yet a Pew Research poll found that nearly six out of 10 Americans would consider having a microchip inserted into their brains if they could switch it off.

The obsession of Bill Gates, the Rockefellers and the Controligarchs generally with population control is well documented. Seamus Bruner takes it back to John D Rockefeller Jr engaging with pro-eugenics feminist Margaret Sanger. A popular slogan at the time was, 'Your body, Rockefeller's choice'.

what to do about it. Economic historian and presidential adviser WW (Walt) Rostow wrote the big book on world population and his detailed statistical analysis is confirmed by everyday observation.

As countries develop more sophisticated economies and women take up careers people have fewer children. Without immigration the population of Australia and North America

would be declining.

A mass injection campaign with covid death shots is unnecessary. A more civilised population control method is to foster in other countries the policies that our countries used to develop economically.

The tragedy of mass covid injections proves the prescience of Ivan Ilich who wrote Limits to Medicine in 1976. "When the intensity of biomedical

intervention crosses a certain threshold, clinical iatrogenesis (medically introduced death and disease) turns from error, accident or fault into an incurable perversion of medical practice.

"That society which can reduce professional intervention to the minimum will provide the best conditions for health."

Bruner's diligence following the money trail does us a service. He is a young man and we look forward to his continuing research. The breadth of his inquiry is reflected in the chapter headings – The War on Farming, the Great Reset, The Open Society Scheme, Mainstream Mind Control.

Like Van Der Pijl, who devoted a chapter to the subject, Bruner ponders the relationship between the USA and China. It is a thorny issue for Australia with China a major export market.

The author examines the Controligarchs and China with subheadings such as – Wall Street and the CCP, the Naked Communists and Zero Covid: Communism through the Back Door.

His conclusion pulls no punches: "Using conservative figures, the Controligarchs have pumped staggering amounts – more than \$50 billion – into increasingly terrifying and borderline hellish technologies.

They are creating a dystopia, right before our eyes.

"Worse, they are doing so while aligned with America's greatest adversary, China. The end game, it seems, is to achieve total control by exporting American wealth and jobs to China while importing a form of communism and corruption that spells doom for the rest of the world."

For baby-boomers like this reviewer, the headlong rush of our Western countries into totalitarianism is hard to take. We were born into the Cold War and taught from the cradle that the difference between our societies and the Soviet and Chinese Communist world was our respect for individual freedom.

Australia and America now copy the worst aspect of Chinese governance – high tech control of individuals – while ignoring the best aspect – the brilliant railway engineering. After his recent exhibition in London was shut down, Chinese artist Ai WeiWei said the West was now experiencing a cultural revolution like Mao's China. People were too timid to question and argue.

The superstars of the Controligarch team include philosopher king Klaus Schwab, social media prince Mark Zuckerberg and Amazon chief Jeff Bezos.

The author includes George Soros in the group because of his political activities. The Hungarian is more complex, interesting and intelligent than the rest of this lot. His Open Society foundation is named in honour of Austrian philosopher Karl Popper's bestknown book – The Open Society and its Enemies.

Roadmap to global governance

Covid marked an acceleration of the globalist agenda; a mad dash to the finish line that seems to have lost momentum short of victory – but the race is still going.


THE goal has not changed, even if the years since may have seen the agenda retreat slightly back into the shadows.

We know what they want conceptually, but what does that mean practically?

What does a potential global government actually look like? First off, let's talk about what we're NOT going to see.

- 1. They are not going to declare themselves. There will almost certainly never be an official 'world government', at least not for a long time yet. That's a lesson they learned from covid putting a name and a face on globalism only foments collective resistance to it.
- 2. They're not going to abolish nationhood. You can be sure Klaus Schwab (or whoever) isn't ever going to appear simulcast on every television in the world announcing that we're all 'citizens of ze vurld now' and that nation-states no longer exist. In part, because that is likely to focus resistance, but mainly because tribalism and nationalism are just too useful to all would-be manipulators of public opinion. And, of course, the continuing existence of nation-states in no way precludes the existence of a supranational control system.
- 3. There will never be an overt declaration of a change of system. We will not be told we are united under a new model. Instead, the illusion of regionality and superficial variance will camouflage a lack of real choice across the political landscape. A thin polysystemic skin stretched tight over a monosystemic skeleton. Capitalism, communism, socialism, democracy, tyranny, monarchy – these words will steadily dilute in meaning, even more than they have already, but

they will not be abandoned.

What globalism will bring us, I suggest, is a collection of nation-states in name only, operating superficially different systems of government, all built on the same underpinning assumptions, and all answering to an unelected and undeclared higher authority.

And if that sounds familiar, it's because it's essentially what we have already.

The only major aspects missing are the mechanisms by which this rough model can be transformed into a flowing network, where all corners are eroded, and all genuine sovereign powers become entirely vestigial:

1. Digital money

Over 90 per cent of the nations of the world are currently in the process of introducing a digital currency issued by their central bank.

Simply put, entirely digital money enables total surveillance of every transaction. If the currency is programmable, it would also allow control of every transaction.

CBDCs are a potentially dystopian nightmare which will infringe the rights of anyone forced to use them; but how are they a building block of global government?

The answer to that is 'interoperability'. While the world's national CBDCs will notionally be separate from one another, the majority are being coded to recognise and interact with each other. They are almost all being developed along guidelines produced by the Bank of International Settlements and other globalist financial institutions.

2. Digital identity

The global push for mandatory digital identities is even older than the digital currency agenda, dating back to the turn of the century and national identity cards.

Terrorism? Digital identity will keep you safe. Illegal immigration? Digital identity will secure the harder.

Pandemic? Digital identity will keep track of who is vaccinated and who is not.

AI? Digital identity will prove who's human.

Poverty? Digital identity will 'promote financial inclusion', apparently.

Clearly, just as with CBDCs, a far-reaching digital identity service is a threat to freedom. And, just as

with CBDCs, if you interconnect national digital identity platforms, you can build a global system.

Again, it's all about interoperability. They use the exact same language.

How does this global government hand down policy and legislation without giving away its existence?

Climate change, that's how.

3. Climate action

Climate change has been at the forefront of the globalist agenda for years. It is the Trojan horse of the anti-human technocrat.

As long ago as 2010, noted climate change 'experts' were suggesting that 'humans are not evolved enough' to combat climate change and that 'it may be necessary to put democracy on hold for a while'.

More recently, in 2019, Bloomberg was publishing articles with headlines like 'Climate Change Will Kill National Sovereignty As We Know It'.

For years, climate change has been sold as the reason we might be forced to abandon democracy and sovereignty.

We're being told that international trade needs to be climate conscious.

We're being told by the World Bank that education reform will help the fight against climate change.

We're being told by the IMF that every country in the world should tax carbon, and, in a recent cross-over episode, that CBDCs can be good for the environment.

See how it works?

Agriculture and food, public health, energy and transport, trade, fiscal and taxation policy, even education; almost every area of government is now potentially covered by the climate change umbrella.

They no longer need a oneworld government, they just need a single panel of impartial international climate change experts working to save the Earth.

Through the lens of climate change, these experts are empowered to dictate – sorry, recommend – government policy in almost every area of life to every nation. Local councils and city mayors are also a big part of this power structure.

Do you see it yet?

This is global government in the modern world: not centralised, but distributed. Cloud computing. A supranational corporate-technocrat hive mind. With no official existence or authority, and therefore no accountability, and funnelling all their policy decisions through one filter – climate change.

There won't be a single global currency, there will be dozens and dozens of interoperable digital currencies creating a 'harmonious payment ecosystem'.

There won't be a single global digital identity service, there will be a series of interconnected identity networks engaged in the 'free flow of data to promote security'.

There won't be a global government, there will be international panels of 'impartial experts', appointed by the UN who make 'policy recommendations' carried out by local councils.

All of the countries of the world will follow most or all of the recommendations, but anyone who calls these panels global governments will be fact-checked by Snopes or Politifact, highlighting that 'UN expert panels do NOT constitute a global government because they have no legislative power'.

This, I suggest, is how global government will take shape in 2024 and beyond.

Government censorship threatens health, safety and scientific freedom

SKY News Australia reported that doctors demand an overhaul of Australia's medical ethics guidelines over the new 'woke' set of codes, arguing for a return to the Hippocratic Oath.

Medical regulation now appears designed to control the thoughts and speech of Australia's 850,000 health professionals.

Doctors are disciplined for offering opinions that do not align with approved government messaging on gender, culture, public health and politics. Practitioners have lost careers and lives through suicide as a result of the actions of health authorities and national boards.

Daring to have an opinion on topics like the morality of abortion, gender transitioning of children, covid vaccine safety and efficacy and the Israel-Gaza conflict's humanitarian effects risks regulatory disciplinary action. Voicing politically incorrect opinions may cost a practitioner a lifetime's work, with regulators prioritising subjective issues over the Hippocratic Oath's principle of 'first, do no harm'.

The pervasive threat posed by government censorship and woke ideology enforcement through regulatory threats has reached alarming levels, jeopardising scientific and intellectual freedom, time-honoured medical ethics and public safety. The infiltration of political correctness, identity

politics and cultural relativism into medicine, at the expense of objective scientific evidence, is alarming and it poses a serious threat to public safety.

Recent events highlight government regulatory authorities silencing public discussion and undermining the scientific method. An article in the medical magazine AusDoc titled 'De-sexing' of medical language is harming patients, [NHMRC warned], asserted that "de-sexing' of medical language is perpetuating anti-women bias in research and putting transgender patients' safety at greater risk'.

The Sydney Morning Herald reported doctors are being targeted by regulators for opinions on the Israel-Palestine conflict; doctors again have said the regulatory process is being weaponised. Most recently the FDA's final rule on January 22 allows exceptions to informed consent requirements in clinical investigations, potentially risking human subject safety.

Many doctors expressing concerns about covid mRNA vaccine safety and efficacy faced severe punishment for causing vaccine hesitancy and undermining government public health messaging. Despite evidence vindicating their concerns the Medical Board declined discussion, focusing solely on requiring practitioners to avoid contradicting the government.

Evidence-based medicine, informed consent, the sanctity of the doctor-patient relationship, medical ethics and the freedom



of political communication have been sacrificed at the altar of woke and the pharma-industrial complex. An element of religiosity has been introduced. In the name of increasing the belief in the benefit of public policy for the collective, the manufactured trust in government policy has been elevated to the level of sacred.

Valid genuinely scientific covid mRNA vaccine safety and efficacy concerns, supported by evidence documented in the government's own reports, were deemed serious professional misconduct.

As doctors spoke up in accordance with their ethical principles, they were threatened with disciplinary action or immediate suspension as the state deemed them a threat to public health and safety. It continues. There are legal actions globally, including in Texas, where Republican Attorney-General Ken

Paxton is taking action against pharma giant Pfizer:

'We are pursuing justice for the people of Texas, many of whom were coerced by tyrannical vaccine mandates to take a defective product sold by lies.'

Doctors who dissent from the government's manufactured and then enforced consensus pay a high price. It doesn't take many heads on spikes in the town square to mute the majority and coerce compliance. But as Brett Weinstein said in a recent interview with Tucker Carlson, these are the people we need and they will change history, echoing RFK Jr's sentiment that there are a lot worse things than dying and living like a slave is one of those.

The western world, once a bastion of free thought, now trends toward totalitarianism, suppressing dissent and dismantling the scientific method in favour of activist political profit-driven guideline-based medicine.

Whoever has the power and money influences the research outcomes and the articles published. They fund the lobbyists who shape the guidelines and treatment protocols. It is easy to see who benefits the most from vaccine mandates, the increasing numbers of children on puberty blockers and cross-sex hormones, the mental health crisis and the diabetes epidemic.

If we want to find 'the science', we follow the money.

The influence of the multinational drug companies extends to the producers of 'the

science' very efficiently and it blocks the independents' criticism and fact-checking.

A 2022 paper titled Censorship and Suppression of Covid Heterodoxy: Tactics and Counter-Tactics analysed worldwide doctor and scientist experiences, revealing censorship, suppression and career damage regardless of standing. Exclusion, derogatory labelling, hostile comments, threats, dismissals, inquiries, licence revocations, lawsuits and paper retractions threaten healthcare integrity globally.

The coordinated targeting of dissenting voices and corruption of ethical evidence-based medicine poses a grave threat to healthcare systems, patient wellbeing and personal liberty. It necessitates vigilant defence of scientific inquiry, medical ethics and freedom of expression.

No matter the personal cost, both health professionals and the public at large who are interested in their own welfare must stand together to protect the people from vested interests, weak or corrupt leaders and malignant, incompetent and woke regulators.

To begin with, they need to work against the censorship currently being applied to ethical doctors by public servants and governments and for a return to the Hippocratic Oath.

U-turn on 'woke' education

New Zealand government to reverse Ardern policies

THE Prime Minister of New Zealand, Chris Luxon, has said he wants a well-defined sex education curriculum, agreed by experts to be 'age appropriate'.

Luxon wants parents to be informed about sexual content being taught in schools, and for parents to have the right to withdraw their children from the curriculum if concerns arise.

The coalition government, consisting of the National party, ACT party, and the NZ First party is planning to 'refocus the curriculum on academic achievement and not on

ideology'; including the removal and replacement of the gender, sexuality, and relationship-based education guidelines.

New Zealand First Leader, Winston Peters, believes parents have a right to know what their children are being taught regarding sexuality and gender. New changes and guidelines to the curriculum should be based on transparency, said Peters.

Prime Minister Luxon has been critical of the previous Labour government under the reign of Jacinda Ardern, calling their record on education 'absolutely shameful' and 'startling'.

Truancy levels rose during Ardern's leadership, with 40 per cent of children not attending school for five days or more each term in 2022.

National Party spokeswoman for Education, MP Erica Stanford, believes that: 'Labour has failed a generation of children with its misguided approach to education that has seen achievement in the basics plummet, in addition to abysmally low attendance.'

Only half of 15-year-olds in
New Zealand passed a standard test
on numeracy and literacy recently,
according to results from the
Progress in International Reading
Literacy Study (PIRLS). Stanford
expressed concern about the results,
adding that it 'means they are
not able to go on and live the life
that they want with those basic
standards that they need.'

Family First, a family-focused New Zealand charity, described the educational curriculum under Ardern's leadership as a dangerous ideology that put 'schools at risk of becoming ideological and indoctrinatory spaces'.

The centre-right coalition is planning to change the failed education policies under Ardern with a strong focus instead on 'regular assessment', and a curriculum that is knowledge-based, with a specific emphasis on reading, writing and mathematics. The tri-party government is aiming to get children back to mastering the basics under an education plan called 'Teaching the Basics Brilliantly'.

They hope to ensure that 'every

child has the skills they need in reading, writing, mathematics, and sciences to set them up for further success.'

Since Ardern walked away from politics, because she didn't have the 'tank' to carry on and possibly due to her growing unpopularity, she has been appointed a trustee of Prince William's environmental Earthshot Prize, a multi-million World Economic Forum (WEF) approved trust that aims to 'save the planet' through new ideas.

In 2022, the 'Queen of Woke' was given an honorary doctorate by Harvard University for globalist contributions that 'shape the

WHO runs the World?

In the wake of the covid pandemic, the World Health Organisation (WHO) is placing great emphasis on preparing for the next pandemic.

SPEAKING at a summit on 12 February 2024, the Director-General of the WHO, Dr Tedros Adhanom Ghebreyesus warned, "Although some progress has been made... the world is not prepared for a pandemic".

"And there will be a next time. History teaches us that the next pandemic is a matter of when, not if."

This is why there are two proposed reforms currently being considered by WHO Member States. One is a pandemic preparedness treaty, which the Director-General described as a "legally-binding pact" between countries to "work together to keep themselves and each other safe".

The other reform is a collection of over 300 amendments to the 2005 International Health Regulations (IHRs), to which Australia is already bound in their present form.

Both reforms are to be voted upon in May this year by the 194 Member States of the WHO, of which Australia is one.

Speaking about the pandemic treaty specifically (not the IHR amendments) Dr Tedros stated the importance of the treaty as a tool to "strengthen the world's defences" against health threats by becoming exceedingly well-prepared and co-ordinated.

Under the WHO's One Health approach, health threats could include a broad range of global concerns, from pathogens to the climate, which Dr Tedros described as a 'health crisis'.

However, Dr Tedros cautioned that misinformation about the pandemic treaty poses a 'major barrier' to its resolution. Conspiracy theorists are spreading lies about the treaty, claiming that, "it will cede sovereignty to WHO", that "it will give WHO power to impose lockdowns or vaccine mandates on countries" or that "it's a power grab by the WHO".

"These claims are utterly, completely, categorically false", said Dr Tedros.

He went on, "Let me be clear: WHO did not impose anything on anyone during the covid-19 pandemic. Not lockdowns, not

mask mandates, not vaccine mandates."

"We don't have the power to do that, we don't want it, and we're not trying to get it. Our job is to support governments with evidence-based guidance, advice and, when needed, supplies, to help them protect their people. But the decisions are theirs. And so is the pandemic agreement."

Here, the Director-General of the WHO explains how the global managerial gambit works. The WHO gives advice. Nation states (like Australia) dutifully implement it. It's a bureaucratic partnership that allows the WHO to say, 'we didn't make you do anything' and allows national leaders to say, 'we were just following advice'.

In an article titled 'The WHO's Managerial Gambit,' published by the Brownstone Institute, Canadian law Professor Bruce Pardy explains further.

"Under the [pandemic treaty and 300+ IHR] proposals, the WHO will become the directing mind and will of global health. It will have authority to declare public health emergencies.

"National governments will promise to do as the WHO directs. Countries will "undertake to follow WHO's recommendations" ... the idea is to persuade the public that their governments must obey the WHO.

"Binding recommendations legitimise the heavy hands of domestic governments. Local officials will be able to justify restrictions by citing global duties.

"They will say that WHO

directives leave them no choice. 'The WHO has called for lockdowns, so we must order you to stay in your home. Sorry, but it's not our call.'"

Of course, this is already the state of play, as we have seen in the political effort to bounce responsibility all the way up the bureaucratic conga line over the covid response, and the WHO's readiness to volley the responsibility back onto individual nation states.

However, this is not to say that the managerial gambit excludes the possibility that the WHO reforms will in fact result in Member States ceding sovereignty to the global health body.

That's because, "that is what is written in black and white in

the documents, and there's no other way rationally to interpret it", says Dr David Bell, a public health physician and former WHO Medical Officer who has written extensively on the WHO reforms and the globalisation of public health more broadly.

"It is very specific in the IHR that countries will undertake to do what a single person, the Director General of the WHO recommends, and it's repeatedly stated in these amendments."

Dr Bell is referring to proposed articles such as 13A of the amendments to the IHRs, which states that countries 'undertake to follow WHO's recommendations in their international public health response,' and Article 42, which requires that the WHO's

recommendations 'shall be initiated and completed without delay.'

What kind of binding recommendations might be put forward by the WHO? These are detailed in Article 18, which states that the WHO advise countries to:

- Require medical examinations;Review proof of vaccination or
- other prophylaxis;
- Place suspect persons under public health observation;
- Implement quarantine or other health measures for suspect persons;
- Implement isolation and treatment where necessary of affected persons;
- Implement tracing of contacts of suspects or affected persons;
- Refuse entry of suspect and affected persons; and,
- Implement exit screening and/ or restrictions on persons from affected areas.

It is noteworthy that Dr Bell references the IHR amendments as the primary source for the claim that the WHO will supersede national sovereignty, while the Director-General's assurance that this is not the case was made in reference to the proposed treaty.

Indeed, the WHO Director-General's tendency to publicly discuss the proposed pandemic treaty and IHR amendments in isolation from each other gives the appearance of a semantic sleight of hand, as it is the combination of the two reforms that promise to make the global managerial gambit watertight.

In May 2024 representatives from the Australian government will decide whether they agree, on behalf of the Australian people, to the pandemic treaty and IHR amendments. It is anticipated that they will vote yes.

As the time for voting nears, opposition to the WHO reforms is building within the Australian community. A group of member organisations and media influencers reaching nearly a million Australians has come together under the banner of the Aligned Council of Australia to educate, organise and campaign for Australia to vote no to the WHO.

A Royal Commission to save us from our health authorities

RECENTLY I was successful in having the Senate Community Affairs Committee hold an inquiry to produce appropriate terms of reference for a Royal Commission into COVID-19. The inquiry has clarified for me anyway, what really went on during the covid years.

During covid, drugs were rushed through that would never have been approved on safety and efficacy grounds - such as Molnupiravir and Remdesivir. Last year, these two inhuman pharmaceuticals cost taxpayers a billion dollars. Alternative tried and tested drugs such as Ivermectin could have been used for a fraction of the price because they were out of patent.

Our health authorities demonised Ivermectin as horse paste despite being a Nobel Prize winning antiviral and common treatment for early-stage coronavirus. As a result, the novel mRNA vaccines became the saviour of public health, a debate about the dangers of mRNA technology was avoided and the public became guinea pigs for an entire new class of drugs.

How many died from the side effects of mRNA technology? This was technology that was not tested in Australia and not tested off the production line. The method of

production was changed after it was tested, the trials were partially faked, fraudulent and criminally negligent.

Why would our health authorities behave in a manner that serves the interests of pharmaceutical companies and harms the interests of everyday Australians?

The answer is a thing called the patent cliff. Pharmaceutical companies are profitable because they develop a new drug and then get a patent allowing exclusive sale of the drug for 25 years.

Drug companies can afford the approval process because once approved they add the approval cost to the selling price. The system of drug patents has created a two trillion-dollar industry whose tentacles of influence extend worldwide.

Once-respected global organisations are now captured by vested interests in the pharmaceutical industry with deep pockets and shallow morals. These include the World Health Organisation, the United Nations and the World Economic Forum, whose young global leaders influence Australia's health administration, to their eternal shame

Not surprisingly this has produced intolerable conflict of interest. As an example, Professor Skerrit, former head of the Therapeutic Goods Administration is now on the board of the pharmaceutical industry lobby group Medicines Australia only eight months after leaving the job. This is something a Royal Commission may choose to have a look at.

The patent cliff is upon us now. There is increasing urgency and desperation in the measures being rammed through government. Two thirds of the revenue from drugs being sold to you are out of patent now or will go out of patent over the next five years.

Where are the new patents going to come from? mRNA, of course. Four hundred new mRNA vaccines and drugs are currently under development. Two manufacturing plants are being built in Australia; such is the expected volume of these things.

Our health authorities decided to press ahead with mRNA technology to save the pharmaceutical status quo: the pharmaceutical industries' gouging of people to extract exorbitant profits.

Patient harm apparently no longer matters. Only last week a study of 99 million covid jab users, including in NSW and Victoria, found the injections were not safe. The study was published by the world's leading scientific publisher and data analytics company for more than 140 years, Elsevier.

The study found serious health conditions were appearing well above baseline in vaccinated persons – brain and spinal cord



swelling up 380%, blood clots up 320%, Guillain Barre syndrome up 250%, myocarditis up 610% and pericarditis up 690%.

I warned Australians the covid products were not tested, were experimental and forcing them on the general population was an insane, inhuman abuse of government power. The evidence showing the truth of this position is now obvious and grows every day.

The hearings into appropriate terms of reference for a Royal Commission into COVID-19 will shortly hear this evidence, adding to the mountain of submissions already received, all of which demonstrates overwhelming consensus for a Royal Commission.

Witnesses to the inquiry also criticised the prime minister's cover-up review of our covid response using two bureaucrats and one academic who were all on record promoting the covid response. Nobody believes this desktop review is legitimate.

I am encouraged that public opinion has moved strongly towards a Royal Commission and the prime minister has no choice but to ask the governor general to issue a letters patent as soon as the committee completes the terms of reference.

The war on Ivermectin

BEFORE the pandemic Dr Pierre Kory, an intensive care specialist in New York, was no stranger to fighting the system for better patient care. When a German intern told Dr Kory and his superior Dr Mayo that ultrasound could be used at the bedside to help doctors make more accurate diagnoses, they listened. Dr Mayo set up an 'ultrasound club' where keen doctors learnt how to use this tool.


With ultrasound equipment doctors could get detailed information within minutes and start appropriate treatment quickly. For critically ill patients it could be lifesaving. The idea was strongly resisted by radiologists who had a monopoly on this tool. Ultimately Dr Kory and his colleagues were able to convince hospital administrators to purchase ultrasound equipment by reminding them of the threat of litigation due to incorrect or delayed diagnoses. Dr Kory and others then taught this diagnostic skill to doctors worldwide with their POCUS (point-of-care ultrasonography) program.

When covid struck, Dr Kory and his friend and mentor Dr Paul Marik were convinced it could be treated with repurposed drugs. But they were in the minority. Heart specialist Dr McCullough estimates that across the USA there were only 500 doctors advocating early treatment.

Dr Kory and Dr Marik started the FLCCC (Frontline Covid Critical Care Alliance), to provide guidance on prevention and treatment for covid. Little did the doctors know the powers they were up against. Their public stance was to cost them jobs, income and reputation over the next few years. But they built an international network of doctors and supporters and spread the word about prevention and early treatment. Their contribution to saving lives has been immeasurable.

This book challenges the dominance of randomised control trials, RCTs, as the only valid way to determine the effectiveness of a treatment. Dr Kory calls it the 'Church of RCT Fundamentalism'. There are many things wrong with RCTs. First up, in an emergency situation, it is unethical to give someone a placebo. Two, RCTs are very expensive to run which means it's usually pharmaceutical companies that fund them. This leads to conflicts of interest. Thirdly, RCTs remove power from everyday doctors who have been trained to diagnose, prescribe, assess treatment, build cumulative knowledge and make professional judgements. Finally, randomised control trials can be faulty, or as Dr Kory found, even fraudulent. Dr Kory asserts that the over-reliance on RCTs during the pandemic led to the most catastrophic mortality rates of ICU patients in history.

The war on Ivermectin shows



the extremes Big Pharma and its captured health agencies will go to to protect their interests. Early studies of Ivermectin both with patients and in the lab proved promising against covid. As background, Dr Kory points out that Ivermectin is an antiparasitic drug that virtually eliminated river blindness and elephantiasis, two of the world's most disfiguring and devastating diseases. It is listed as an essential drug by the World Health

Organisation (WHO) and had won its discoverers Nobel Prizes. But as an out-of-patent drug no-one was going to make any money out of it. So, the battle began. Hit pieces, ridicule, talk of horse medicine, you name it, the media did its worst.

Dr Kory calls this one of the most damaging and coordinated propaganda campaigns in history. At the time this book was written, there were 95 studies showing Ivermectin was effective against covid. It works

as a preventative, in early phases and for very sick patients, too. Yet the government health agencies, the WHO and the medical journals ignored its life-saving ability.

Disinformation was clearly at play. One strategy was to conduct studies of Ivermectin that were 'designed to fail' then write these up in the medical journals. This was done by limiting the dosage or the timing of the drug or simply fudging the results.

Journal editors blocked articles that showed positive results for Ivermectin. They often used a delay strategy. They held an article for several months which meant it could not be offered to another journal and then rejected it.

With Ivermectin and the maligned hydroxychloroquine, the pandemic could have been over within months. But Big Pharma, or Big Harma as Dr Kory calls it, did not want that. These repurposed drugs threatened their income from vaccines, remdesivir and other covid 'treatments'.

This book takes you through the covid years in sequence through Dr Kory's eyes. It's an important and very readable document that may one day be the diary Dr Kory takes to court when it's time to see justice served.

Former Greens candidate now warns wind turbines are lunacy and a scam

He said the bulk of the wind farm projects have already slipped through while everyone was sleepwalking.

Nowakowski is shocked at the scale of the industrial wind plants being planned for Queensland. For months Nowakowski has been trying to warn about the proliferation of wind farms in Queensland and the impacts the developments are having on the environment.

"Every high elevation ridge-line outside of national parks and state forests will have a turbine on it between Gladstone and Rockhampton along the Great Dividing Range", Nowakowski claims.

"It now seems over 60,000 ha of remnant forest to be cleared across Queensland for proposed projects with approximately 4600 km of new haulage roads pushed into remote and wild forests along ridge lines and mountain tops", he said. On the Chalumbin wind farm he says, "It blows my mind".

On his YouTube channel [see link below, Kaban wind farm lunacy], Nowakowski says it's lunacy and a scam: "We will look back at the lunacy of our folly in

years to come. There is already so much cleared and degraded land in Australia and here we are destroying some of the best high biodiverse remnant bits left.

"Clearing and fragmenting some of the best habitat left in Australia for wind farm industrial estates is a delusional act that won't save the climate. Real climate action is placing renewable energy projects in a planned and proper manner in appropriate locations that will lead to a net loss of carbon emissions and a net gain in increased biodiversity. The environmental offsets given to these wind farm projects in high biodiverse locations are a scam.

"There are more of these inappropriately placed projects in the pipeline including the Chalumbin wind farm, Upper Burdekin wind farm and the completely ridiculous Mount Fox energy park which is almost entirely contained in some of the best remnant wet sclerophyll forests outside of the protected estate".

Thankfully, Nowakowski is not the only environmentalist waking up. McCarthy mentions the Wildlife Preservation Society of Queensland which he says has also changed position due to the large amount of land being cleared for wind turbines. Then there is Apple, which has pulled out of a wind farm near Burdekin because of environmental concerns. Even the group building the Chalumbin wind farm has scaled it back from 200 turbines to 86 (and it has been renamed Wooroora - presumably for PR's sake?).

Moah Creek wind farm video [see below] is remarkably like ones made by skeptics for the last ten years (nearly). He's now supporting nuclear power. It would have been better if he'd realised this ten years ago, but he's doing a great job now. Wait until I tell him about the corruption in science.

One day he will realise climate-skeptics were the real environmentalists all along.

Green energy anything but green

ONE of the most remarkable aspects of green energy is how non-renewable and environmentally dirty it actually is.

Almost no attention goes to the staggering environmental costs that go into making the mammoth wind towers, solar panels and EV lithium-ion batteries. That grave omission is deliberate.

Solar panels and giant windpower arrays require huge amounts of raw materials. A standard engineering evaluation between 'renewable' solar and wind versus present nuclear, gas or coal electricity production would begin by comparing bulk materials used such as concrete, steel, aluminium, copper consumed per production of TeraWatt hour (TWh) of electricity.

Wind consumes 5,931 tons

of bulk material per TWh, and solar 2,441 tons, both many times higher than coal, gas or nuclear. Building a single wind turbine requires 900 tons of steel, 2,500 tons of concrete and 45 tons of non-recyclable plastic. Solar power farms require even more cement, steel and glass – not to mention other metals. Keep in mind the energy efficiency of wind and solar is dramatically lower than for conventional electricity.

A recent study by the Institute for Sustainable Futures details the impossible demands of mining for not only EV vehicles but also solar and wind farms. The report notes that the raw materials to make solar PV panels or windmills are concentrated in a small number of countries – China, Australia, DR Congo, Chile, Bolivia and Argentina.

The report says: 'China is the

largest producer of metals used in solar PV and wind technologies, with the largest share of production for aluminium, cadmium, gallium, indium, rare earths, selenium and tellurium.

'In addition, China also has a large influence over the market for cobalt and lithium for batteries. While Australia is the largest producer of lithium... the largest lithium mine, Greenbushes in Western Australia, is majority owned by a Chinese company.'

Not so good when the West is escalating confrontation with China

The report notes that the DR Congo mines more than half of the world's cobalt. The mining there has led to 'heavy metal contamination of air, water and soil... to severe health impacts for miners and surrounding communities in DR Congo, and

the cobalt mining area is one of the top ten most polluted places in the world. Around 20 per cent of cobalt from DR Congo is from artisanal and small-scale miners who work in dangerous conditions in hand-dug mines and there is extensive child labour.'

Rare earth metals mining and refining is essential for the 'zero carbon' transition in batteries, windmills and solar panels.

According to one report by energy specialist Paul Driessen: 'Most of the world's rare earth ores are extracted near Baotou, Inner Mongolia, by pumping acid into the ground, then processed using more acids and chemicals.

'Producing one ton of rare earth metals releases up to 420,000 cubic feet of toxic gases, 2,600 cubic feet of acidic waste-water, and a ton of radioactive waste.

'The resulting black sludge is

piped into a foul, lifeless lake. Numerous local people suffer from severe skin and respiratory diseases, children are born with soft bones, and cancer rates have soared.'

The USA also sends most of its rare earth ores to China for processing since it shut down domestic processing during the Clinton presidency.

Because they are vastly less energy efficient per area, the land used to produce the mandated zero carbon electric output is staggering. Wind and solar require up to 300 times the land required to produce the same electricity as a typical nuclear plant. In China, 25 square kilometres of a solar farm are required to generate 850 MW of electric power, the amount of power attained at a typical nuclear plant.

Outrage over approval of 5G

Ofcom turns Britain into 'giant airport scanner'

The rollout of 5G highintensity millimetre wave (MMW) network technology has recently been authorised by UK communications' regulator, Ofcom.

THIS is despite an abundance of high-level studies and scientists warning of eye-watering potential for harm to our health from MMW exposure.

Millimetre waves are what airport body scanners use. Britain is about to become a giant body scanner.

So, what exactly is 5G? According to senior representatives from Qualcomm Israel, the pioneers of 5G mobile comms chips, from 2017: '5G is an umbrella of various technologies that covers many spheres. The first and most common is the Internet of Things (IoT) – connecting a great many devices to the internet, such as refrigerators, lighting, garbage cans, and cameras... and the ability to achieve very high bandwidth speeds with very low latency.

'Processing, which currently takes place on the device, will take place on the cloud servers.

'Because the frequency is higher, the technology changes and takes the form of a beam between the device and the site. This enables the operator to provide services efficiently in crowded spaces, such as stadiums and airports, for example, where there's a severe problem of interference. The high-frequency operates like a laser beam between the cellular towers and the device.

Make no mistake, what 5G can do is other-worldly. But as history indicates, industries tend to cover up uncomfortable truths about their products, especially when massive amounts of money are involved. Think asbestos, DDT, tobacco, mRNA...

5G MMW will ensure we are still irradiated by the same harmful

militaries use MMW for crowd dispersal via the Active Denial System (ADS). ADS utilises MMW at high power to make the skin feel like it is burning, forcing riotous crowds to disperse. You can find videos on Youtube demonstrating this.

The proposed 5G will not operate at such high power levels as burning ADS, but it might be wise to apply the precautionary principle here, and actually carry out safety checks first, given what the scientific evidence indicates

Paul Ben Ishai, head of dielectric and THz science laboratory at Ariel University, Israel, may be the most qualified and outspoken expert on Earth in the field of interactions between MMW and the human body.

He has been shouting from the rooftops about this phenomenon for several years. He uses the word 'criminal' to describe what is occurring

In one paper, The human skin as a sub-THz receiver - Does 5G pose a danger to it or not?, he writes: 'One must consider the implications of human immersion in the electromagnetic noise, caused by devices working at the very same frequencies as those to which the sweat duct (as a helical antenna) is most attuned. We are raising a warning flag against the unrestricted use of sub-THz technologies for communication, before the possible consequences for public health are explored.'

But never mind all those serious warnings from eminent scientists, because the people responsible for setting safety standards at Ofcom, without presenting a shred of evidence that this technology can in any way be considered safe, have announced the rollout of MMW in most major UK towns and cities. Ofcom is to blame for this hellish situation. It really is time to start pulling the proverbial pitchforks out of the shed. We deserve better than this. Our overlords are using us like pieces of meat in a laboratory, and that must change.

to cause increases in cancers, neurological problems and fertility issues, with harms increasing the closer you live and work to the cell

MMW does not travel far and is blocked by just about everything, so they need clear space for millions of tightly packed network points to make it work.

Scientists such as the late Martin Blank PhD (former head of emfscientist.org) have gone on record to say they expect 5G proper to induce illness at a faster and more severe rate than previous networks.

World Economic Forum achieve its nightmarish goals of connecting and tracking and tracing everything you do, consume and touch in real time.
