The Man Who Saw the Numbers

John Beaudoin and the Global Cover-Up That Cost Millions of Lives

A lone engineer exposed a global cover-up. Governments had the data, the tools, & the duty - yet they buried the truth. How many lives were sacrificed to protect profits and power? The world must know.

In a world drowning in manipulated statistics, fraudulent death certificates, and a meticulously crafted narrative, truth becomes an endangered species. Government agencies, with their vast resources, entire departments dedicated to epidemiology, and access to real-time data, had every tool at their disposal to scrutinise the unfolding crisis. Instead, they chose to push a singular, carefully constructed message - one that ensured compliance, stoked fear, and protected powerful financial and political interests.

The media played its role, amplifying official statements while silencing those who dared to question the inconsistencies. Scientists, doctors, and data analysts who saw the red flags and raised alarms were dismissed, ridiculed, or outright banned from public discourse. Those

Amid this manufactured consensus, one man - John Beaudoin, an electrical engineer from Massachusetts - did what entire government health agencies refused to do: he looked at the raw data. With a sharp analytical mind and a determination to uncover the truth, he pored over 420,000 death certificates, cross-referenced records, and identified patterns that should have set off alarms at the highest levels. What he found wasn't just troubling - it was damning. His analysis revealed a drastic shift in mortality trends, a deliberate misclassification of deaths, and signals that pointed directly to the dangers of the COVID-19 vaccines.

These revelations should have triggered global investigations, emergency parliamentary inquiries, and criminal trials. Instead, the institutions responsible for public health and safety ignored them, the media refused to cover them, and powerful entities ensured that they

The Latest Provisional Mortality Data for Australia has Landed.

Deaths to 30th November according to @ABSStats were as follows:

Deaths to 30th November

126,974	2020
136,800	2021
174,717	2022
166,957	2023
170,875	2024

The number of deaths to the end of November jumped 27.72% in 2022 and deaths have remained high through 2023 and 2024. Population growth can not solely account for this increase. Australia's population growth was 1.2% in 2020, 0.1% in 2021, and 1.3% in 2022. COVID-19 related deaths do not account for this increase. The Senate inquiry into excess mortality was a whitewash. The ABS [Australian Bureau of Statistics] no longer compares data to a "baseline average." The wilful ignorance of legacy media, government, and those in positions of power continues...

remained buried under a mountain of censorship and disinformation. The result? Tens of thousands, if not millions, of lives lost unnecessarily. These were people who trusted their governments, believed the experts, and followed mandates that were supposed to protect them. Many were young and healthy, coerced into taking an experimental injection that may have sealed their fate. Families shattered, careers destroyed, communities left mourning their dead - casualties not of a virus, but of a system that put profit and control above human lives.

Beaudoin didn't have a research grant. He had no government backing. He didn't have a multimillion-dollar budget like the CDC [Centers for Disease Control and Prevention], NIH [National Institutes of Health], or WHO [World Health Organisation]. He had a laptop, a brain, and a relentless drive to find the truth. This wasn't just Massachusetts or the U.S. The same statistical anomalies appeared in the United Kingdom, Canada,

Australia, and New Zealand - all Five Eyes intelligence alliance nations that mysteriously enacted near-identical COVID-19 policies at the same time. Excess mortality skyrocketed post-vaccine in all Five Eyes countries. Flu and pneumonia deaths vanished from records in 2021 because hospitals stopped testing for them. Governments refused to release raw vaccine-mortality correlation data. Insurance companies in the U.S. and Germany reported a 40 percent rise in deaths among working-age people in 2021, coinciding with the vaccine rollout - not the pandemic. This wasn't a coincidence. It was coordination.

Beaudoin was able to spot massive red flags in just a few months with basic statistical tools. Governments have entire epidemiological teams with vast budgets, advanced analytics, and real-time access to medical data. Yet, instead of conducting a full forensic analysis of vaccine-related mortality, they refused to investigate post-vaccine deaths, blocked independent researchers from accessing crucial data, and de-platformed, censored, and smeared experts questioning the official narrative. Had Beaudoin's findings been seriously investigated when he first exposed them, vaccine rollouts could have been halted, and countless lives could have been saved.

The refusal to examine the vaccine mortality data is not just negligence - it is deliberate suppression. Why? Because admitting the truth would mean admitting that the vaccines - hailed as the "only way back to normal" - were not just ineffective but actively harmful. The same governments that enforced vaccine mandates, that coerced millions into taking an experimental injection, are now stonewalling any attempt to link rising excess mortality to the jab. If they had nothing to hide, why refuse transparency?

It is not too late to expose the greatest public health scandal of our time. Beaudoin's findings must be independently audited on

a global scale. The world cannot afford to look away any longer. The patterns of excess mortality, the unexplained deaths, and the shifting causes of fatality demand an honest, thorough, and transparent inquiry. Governments must release full vaccination status-linked mortality data, making it accessible to independent researchers, statisticians, and legal experts who can analyse it without bias or political pressure. Every life lost to these policies is a tragedy, and every suppressed voice represents another failure of the institutions meant to safeguard the public.

Those responsible for suppressing critical safety signals must be held accountable - not just in the court of public opinion, but in the halls of justice. The medical professionals, government officials, pharmaceutical executives, and media figures who played a role in concealing the truth must answer for their actions. Investigations must not be token gestures or limited internal reviews, but rigorous, publicly scrutinised efforts that can withstand global legal and ethical standards. If systemic negligence, coercion, or malfeasance is uncovered, those responsible must face legal consequences, whether in the form of criminal trials, financial penalties, or professional disbarment.

If one man, working alone, could see through the lies, why did every public health agency fail to do the same? The answer is as chilling as it is obvious: they knew. They had the data. They had the resources. And yet, they chose to bury the truth, allowing suffering and death to continue unchecked. This was not an oversight. It was not a mistake. It was a decision - a choice made at the highest levels to protect institutions, profits, along with political and technocratic narratives at the expense of human lives. The time for silence is over. The world deserves answers, and justice must be served.

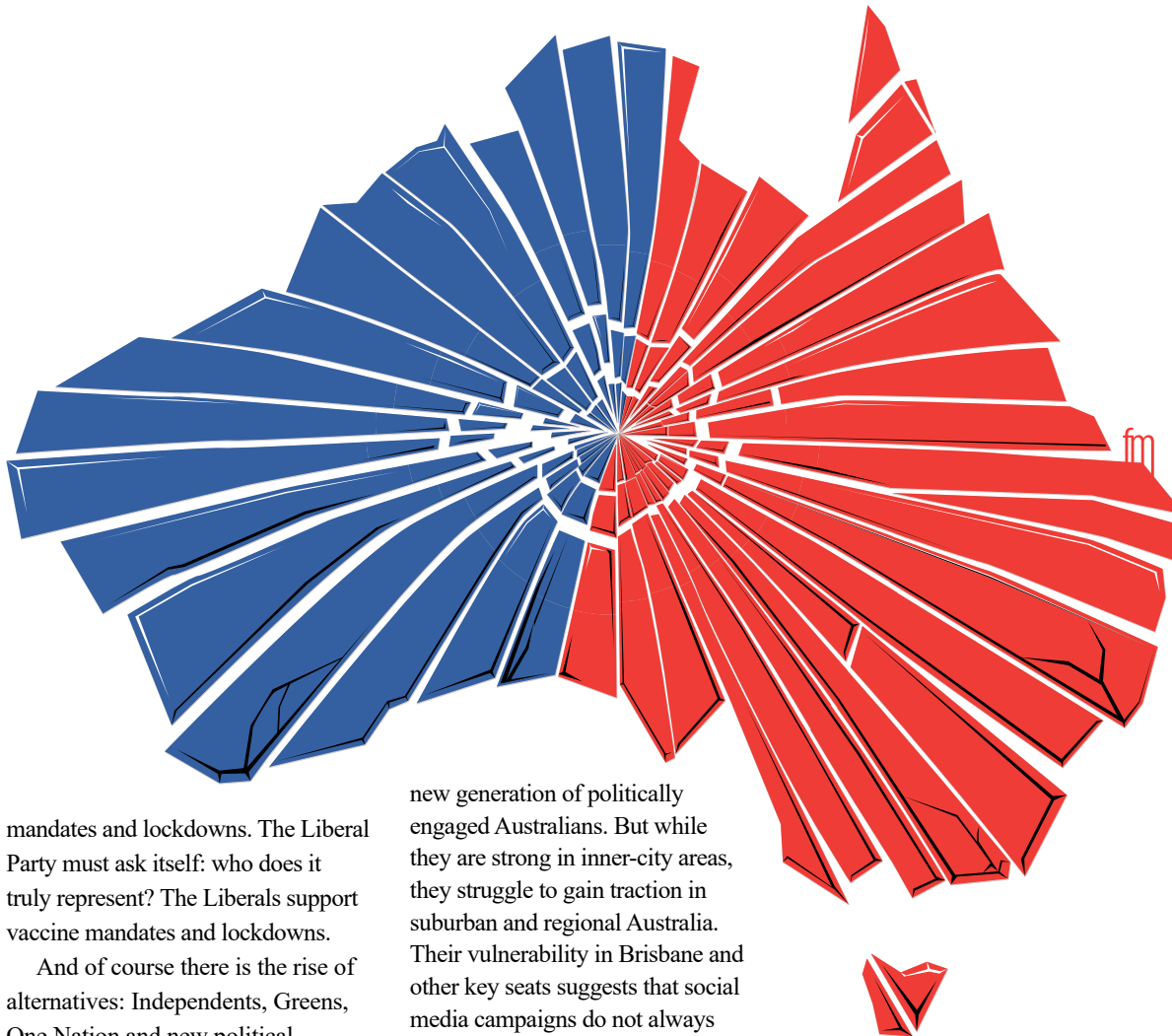

To my friends, colleagues and the people of Australia, some commentators have stated that Australia is standing at a crossroads. I disagree. We are standing on the edge of a precipice, and we don't know it. As we approach the next federal election, it is clear that our political system is undergoing a seismic shift. The traditional two-party structure is fracturing under the weight of economic uncertainty, widespread dissatisfaction, and a growing disconnect between politicians and the public. The anger among voters is undeniable, cutting across long-standing party loyalties and reshaping the battlegrounds that will determine our nation's future.

For too long, our political leaders have taken Australians for granted, assuming our loyalty while failing to address the deepening crises facing our society. But that complacency is over. The people are starting to demand real change, and it is time for politicians to listen - or face the consequences. There is a fracturing of political loyalties. The Labor and Liberal parties are both facing an unprecedented crisis of trust.

Labor was once the party of the working class, but today, many of its traditional supporters feel abandoned. Those who built this nation through hard work and sacrifice are now struggling to afford the basics - let alone own a home. Migrant communities that once saw Labor as their natural ally are reassessing their political loyalties as they face crime, housing shortages, and rising costs of living. Labor also supported Covid vaccine mandates and lockdowns. Labor is no longer the party of the working class; it has become unrecognisable to many who once saw it as their champion. Labor supports vaccine mandates and lockdowns.

The Liberal party has a serious identity crisis. It too is losing its grip on voters. Traditional conservative strongholds are crumbling as the party shifts away from the values of economic stability, personal freedoms, and family integrity that once defined it. Many Liberals now feel their party is pandering to progressive ideologies, neglecting the concerns of everyday Australians. Small businesses are struggling, interest rates are rising, and economic uncertainty is deepening. The Liberals supported Covid vaccine

The Greens have been mobilising the youth, but face limits. They are capitalising on youth discontent, using social media to mobilise a

for voters frustrated with mainstream politics. Their strong stance on national sovereignty, immigration control, and economic independence resonates with many who feel left behind by the major parties. While often dismissed by political elites, One Nation continues to attract support from those seeking a return to traditional Australian values and greater political accountability. One Nation is a party that applies common sense to issues and at the same time is across the facts, data and science.

Economic uncertainty and policy failures are at the heart of voter anger. Australia is one of the wealthiest nations on Earth, yet so many of our people are struggling. Why? Because of policy failures and political neglect. Australians who work hard and earn decent incomes are still unable

neglected, with rising crime rates and deteriorating public amenities leaving many feeling unsafe and forgotten.

Uncontrolled migration is a political weapon. Both major parties have promised to cut migration, yet they continue to use the issue as a political football. Australians want an immigration system that makes sense - one that balances economic growth with sustainable infrastructure planning. Yet too often, policy decisions are driven by the interests of academics and bureaucrats rather than the lived realities of ordinary Australians.

Politics today is unrecognisable compared to twenty years ago. Young people are engaging in new ways, largely through social media, where they are bombarded with targeted messaging. A young Muslim woman

recently stated that she supports the Greens because she believes they represent her interests. This is a powerful example of how identity politics and digital engagement are shaping voter preferences. Political parties, particularly the Greens, are investing in training young activists, influencing the way our children think about politics before they even reach voting age.

Despite the dominance of social media, online movements do not always translate into electoral victories. Australians still want policies that deliver real-world results, not just slogans and hashtags. With traditional party structures crumbling, Australia is entering a new political era. But is this shift truly a step towards democracy, or simply a reshuffling of power among the same elite interests? Australians are demanding leadership that listens, policies that address economic and social concerns, and a government that serves its people - not itself. While the decline of the two-party system is a welcome development, we must be cautious. The rise of independents and minor parties could lead to power being concentrated among those with the financial means to shape elections from behind the scenes. We must ask: is this truly a democratic awakening, or just another form of control?

This election is about more than choosing a government. It is about the future of our democracy. The frustration, the anger, the deep sense of betrayal - these emotions are real. Politicians who ignore them do so at their own peril. Australians will no longer be taken for granted. We demand a government that works for us, that prioritises our needs over ideological agendas, and that respects the values that have long defined our great nation. It is time to take back our democracy. It is time for our voices to be heard. This is not just an election - it is a turning point. And make no mistake: the stakes have never been higher - will the people's voice be heard?

At the start of this piece, I disagreed with the idea that Australia is merely standing at a crossroads. The truth is far more urgent - we are teetering on the edge of a precipice, with an unseen force pressing against our backs. We have two choices: succumb to the fall and plunge into ruin, or summon the courage to spread our wings and rise. The path we take is in our hands.

Digital ID's Historical Shadow

"We would have been at a loss if they had disappeared before being registered," said Adolf Eichmann hours before his 1962 execution. A senior Nazi official, Eichmann was answering the question: "How could the Jews have resisted?" In our digital ID age, his statement is both chilling and instructional. It reveals the dangers of centralised identification systems.

IBM's German subsidiary, Dehomag, pioneered computerised identification with punch-card technology. Originally for streamlining administration, these systems became instrumental in the regime's systematic extermination program. Officials quickly found people based on religion, age, and skills, applying government benchmarks of economic productivity and racial purity.

My grandmother survived this era and spoke of waking each morning unsure if some arbitrary trait would meet the day's criteria for arrest. Professions like law and nursing were restricted to those with "acceptable" biological attributes. Even using the title "doctor" required government

proof of Aryan identity. Anyone simply labelled "anti-social" was stripped of citizenship and suffered child confiscation, abortion, or castration. Their crime was having characteristics deemed undesirable by the elite.

This domination began with legislation. Instruments like the 1935 Marriage Health Law and the 1938 Duty to Register cumulatively created a predatory knowledge asymmetry between the government and individuals, against which we

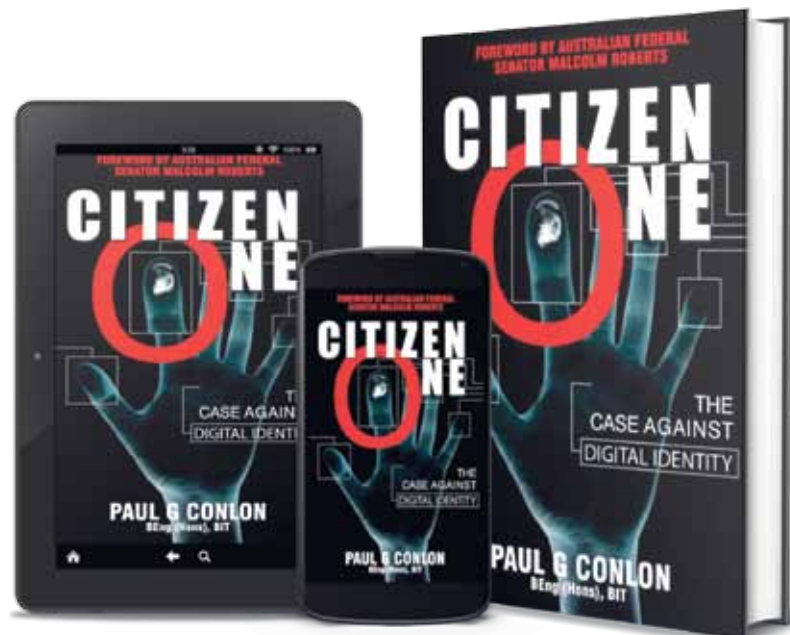

must remain vigilant.

Australia had a taste of this asymmetry in recent years. Access to everything from employment to shopping became tied to identification under altruistic pretences. Medical status determined your lifestyle, yet the enforcing technology was scattered. Today, it's being formalised through a complex Digital ID framework that it seems no one asked for.

Trust Exchange (TE_x) and

myID (formerly myGovID) operate within the so-called Trusted Digital Identity Framework (TDIF) and the Australian Government Digital Identity System (AGDIS). TE_x is sold as a "digital thumbs up from the government that you are who you say you are." Who the digital thumbs down will target, we're not told.

Given teeth by the 2024 Digital ID Act, these systems openly aim to centralise identification. They enable federal, state, and private participation in opening

bank accounts, buying phones, renting properties, and entering age-restricted venues. Digital ID requirements for welfare, electrical licenses and post office boxes are already being normalised.

History shows how once civilised people watched as selected groups were outcast, grateful their government allowed them to exist for one more day. Modern biometric ID systems far exceed what Dehomag was capable of. We need only look to India and China to see how those ahead of us on the well-trodden path to a surveillance state are suffering. Will our own datafication serve or enslave us when the next emergency arrives?

We stand at a crossroads. Digital ID makes us transparent to the government while keeping it opaque to us—a safety-critical issue treated with alarming flippancy. With an election approaching, perhaps it's time government is again "at a loss" about our identities as Eichmann suggested. Were his final words a helpful suggestion direct from the horse's mouth? "Do not comply."

Campaign Launched to Ban AI Surveillance

A new campaign, Say No Australia, has emerged to challenge the Australian Government's stance on artificial intelligence (AI) surveillance particularly facial recognition, for monitoring and tracking citizens, which officials claim is inevitable and merely requires "balance" and "regulation."

Say No Australia argues this framing is a deliberate tactic, a psychological conditioning tactic to soften public resistance rather than a genuine debate which the campaign rejects with no room for compromise.

"There is no 'safe balance' or ethical way to monitor people like slaves," Say No Australia organisers said in a statement. Their position is unequivocal: AI surveillance must

be banned outright. They dismiss talk of regulation as a distraction, labelling it a "scam" designed to lull the public into acceptance. "We're not negotiating on this," the group insists. "We say no. Ban it, end it."

The campaign warns that the technology's rise could cause an unprecedented and catastrophic shift for humanity. Far from a minor adjustment, they see it as a profound threat to freedom, predicting a future of oppressive, China-style control if AI surveillance becomes normalised. "Once it's in place, there's no turning back," they caution. "This is about our children's world."

Urging immediate action, the group calls on Australians to reject the technology and fight for liberty. "Humanity is at a crossroads, stay free." The campaign aims to rally widespread support, to defeat AI surveillance before it takes root.

Freedom of Speech in The Constitution?

On 12 February 2025 Senator Ralph Babet (UAP-Victoria) introduced a Bill to enshrine freedom of speech in the Australian Constitution. The Constitution Alteration (Right to Free Speech) 2025 seeks to insert a new Chapter IIIA and section 80A into the Commonwealth of Australia Constitution Act 1900, ensuring that no law, either state or federal can limit freedom of speech, including freedom of the press and other media.

Freedom of speech is under attack in this country and will disappear unless drastic action is taken. That is why I have introduced a bill to trigger a referendum and give the people the opportunity to vote and enshrine the right to free speech within our constitution. We will soon see whether elected officials are committed to defending our rights or whether they are more concerned with censoring and suppressing dissent. I am sad to report that the early indications are not encouraging. While freedom of speech in this country is generally assumed, it is not guaranteed, indeed it is under perilous threat right now.

Over the past decade the right of

Australians to say what they think has increasingly come under attack from glass-jawed politicians, whose sensitivity to criticism cannot be overstated. And while Australian parliaments have made no effort to protect speech, they have passed laws – at state and federal level – to restrict freedom of speech. We are now at a point in this country where it is dangerous to openly say things that most people privately believe. It's a brave person for example, who opines in public that men cannot become women. Is that really the kind of country we want to live in? A country in which stating simple biological truths puts a person in danger of being dragged before a tribunal to be interrogated for their words.

The Western world became prosperous by allowing, rather than censoring debate. Free speech is not a thing to be feared. It's a thing which should be embraced. Free speech is not something to protect people from, it's something to be encouraged. The enlightenment was built on the ability of people to say what they honestly thought, even if it went against established norms. Indeed, it was the ability to challenge norms that made progress possible. But we now risk

going backwards into a new dark age of restricted speech, where certain ideas – held sacrosanct by those in power – are beyond challenging. This bodes well for nobody.

Without speech there is no

expression of thought, it is no exaggeration to say that if people are not able to speak freely then they are not able to think clearly. And that is the key issue here. Freedom of thought supposes freedom of speech. The two are

indelibly linked. What good are all the other freedoms if people are not free to think independently of the state and to express those thoughts? Australia lacks, at a national level, entrenched protections of freedom of speech. The role of elected representatives should be to provide and sustain that right.

My bill will give the Australian people the power to vote in a referendum and determine just how important freedom of speech is to them. I believe the people will vote overwhelmingly in favour of free speech, because Australians may disagree on many issues, but we believe in a fair go and the right of everyone to voice their opinion without fear or favour.

There shouldn't be a single Australian Senator who would say they were against freedom of speech or say to their constituents, I want to make it more difficult for you and your family to express your opinions.

I went to Canberra to defend and ensure the freedoms of my constituents, not to undermine them. We will soon find out if I am alone.

All Aboard the Trump Train Will Dutton Hitch a Ride?

Trump is back and he has wasted no time in pushing his 'American First' agenda upon the United States and the World. He has moved so fast, across so many issues, that it feels like Donald Trump has achieved more in a few weeks, than Anthony Albanese has achieved since becoming Prime Minister. In fact, you may ask - what has Anthony Albanese achieved since entering Parliament in 1996?

When Donald Trump won the US Presidential election in November 2024, Albanese was trying to ram through his 'Combatting Misinformation and Disinformation' bill. It showed the clear contrast in trajectories that America and Australia are now on.

Albanese has stumbled from one disaster to another, whether it be the Voice Referendum, his \$4.3million sea-side mansion, or bringing woman's rights campaigner, Sarah Williams, to tears with his proclamation of "I am the Prime Minister".

Is it little wonder that the Albanese Government is sliding in the polls? The Coalition is beginning to consistently win two-party preferred polling and the February Newspoll showed that 53% of Australians believe that Albanese does not 'deserve' to be elected.

But the big question is - why is Peter Dutton and the Coalition not further ahead? Just imagine the mess Albanese would be in if the Coalition leader was Donald Trump. Come election time, apathetic voters and people not paying attention politically may automatically assume that Dutton is Australia's Trump. They will be mistaken.

Coalition aligned media will have you believe that Dutton is measured, careful and consistent. They argue that Dutton's temperament has led him to slowly chip away at Albanese's lead in the polls. But in the age of Trump, the times might not suit a leader of Dutton's demeanour.

Trump is undeniable. You cannot ignore him. He has completely



dominated the political space for ten years now. He is charismatic, dynamic and controversial. Coupled with this, his second Presidential term has seen him amass a cast of characters, such as Elon Musk, Robert F. Kennedy Jr., Tulsi Gabbard, et al, who are equal or close to his measure.

The speed in which Trump's team have sprung into action is unparalleled in world politics. In a handful of weeks there has been a ceasefire in Gaza, with hostages finally being released. Open dialogue has begun with Vladimir Putin regarding peace in Ukraine. Facebook sacked their fact check (censorship) team and Mark Zuckerberg is desperately seeking membership into Team Trump.

Trump boldly declared that there are only two genders, with gender neutral terminology banished from Government departments. The US borders have been secured, and deportations have begun. US membership to the World Health Organisation has been revoked. The velocity at which Trump is moving is far beyond what Dutton's demeanour can accommodate.

Recent history has taught us that bold leaders with conviction have overcome the most daunting of odds. Whether it be Trump dodging bullets and repeating phrases like 'build the wall' and 'make America great again', or Javier Milei calling

to slash Government waste by hoisting a chainsaw above his head, Dutton has fallen short of the mark.

The most disappointing aspect of Dutton has been his embrace of censorship, a stark contrast to Donald Trump and Vice-President JD Vance, who are promoting free speech. As Home Affairs Minister in 2021, Dutton introduced the 'Surveillance Legislation Amendment (Identify and Disrupt) Bill 2020', which granted federal police powers to take over online accounts and monitor activity. Critics, including the Human Rights Law Centre, argued this law encroached on privacy and free expression. Last November, under Dutton's leadership, the Coalition

supported the social media ban for under 16s, which Elon Musk described as a 'backdoor way to control access to the internet'.

Now in 2025, Dutton backed Albanese's new 'hate-speech' laws. I suppose Dutton did not read the Liberal Party founding document, Robert Menzies' 'We Believe' statement. Point 13 states: 'we believe in the great human freedoms; to worship; to think; to speak; to choose; to be ambitious; to be independent; to be industrious; to acquire skill; to seek and earn reward.'

Meanwhile, 'The Priorities of a Dutton Coalition Government' policy document is a far cry from the leadership on display in Trump's America. Rather than stating strong,

direct policy positions on issues such as mass-immigration (net overseas migration was 446,000 in 2023-24), the document instead embraces milquetoast language such as, 'a Dutton Coalition Government will rebalance our migration program to restore confidence and integrity'. The document then commits meagrely to 'reducing the permanent migration intake by 25 per cent'.

Is it little surprise that so many Australians feel they are in the political wilderness, with no party to vote for. Candidates campaigning for this year's federal election are telling me that the overwhelming focus of voters is on Trump. While they do not like him personally, they admit to liking his policies and leadership style.

On day one of his Presidency, Trump's bold leadership was on display when he pulled out of the Paris Agreement. Meanwhile Dutton's Shadow Energy Minister, Ted O'Brien, said in January, "The Coalition is absolutely committed to the Paris agreement, and we're also committed to net zero". Net Zero locks the Coalition into being anti-coal, the backbone of Australia's baseload power grid. Without coal, electricity prices will continue to rise, and blackouts will loom.

The Coalition's stance is a far cry from the boldness of Trump's inauguration address, where he declared, "we will drill, baby, drill". Trump went on to say, "we have something that no other manufacturing nation will ever have: the largest amount of oil and gas of any country on Earth, and we are going to use it".

Unfortunately, with Albanese and Dutton to choose from, Australia is stumbling down a continued path of stale, unimaginative leadership, while America has been revitalised under President Trump. The Coalition should be learning from Trump's success. Unfortunately, the current Liberal Party is not fit for purpose. They are a far cry from the 'We Believe' statement and Peter Dutton is a far cry from the conviction and leadership of Donald Trump.

Inbound - RFK Jr.

On 13 February 2025 Robert F. Kennedy Jr., was sworn in as the 26th US Secretary for Health and Human Services, coinciding with President Donald Trump's executive order establishing the Make American Healthy Again Commission (MAHA). RFK Jr. will now oversee agencies such as the Centers for Disease Control and Prevention (CDC), the Food and Drug Administration (FDA), the National Institutes of Health (NIH) and the Centers for Medicare and Medicaid Services.

For the medical industry - particularly Big Pharma - this is a major development as his controversial stances on health policy, vaccines, industrial food systems and environmental pollutants have sparked global attention. For Australia, some media outlets and academics have voiced concerns about RFK Jr.'s new role and whether his messaging could energise anti-vaccine sentiment here in



Australia. It's almost a certainty that some of his influence will hit Australia's shores sparking debate and hopefully the 'RFK Jr. Effect' will fuel some courage and common sense into Australia's medical industrial complex.

Allegations of a similar nature have long been levied against RFK Jr. and during his January 2025 confirmation hearings in the US Senate he notably retaliated against the bombastic Senator Bernie Sanders, "And by the way Bernie...you know the problem with

corruption is not just with the Federal agencies, it's in Congress too, almost all the members of this panel, are accepting, including yourself are accepting millions of dollars from the pharmaceutical industry...."

Health Authorities Hold No Evidence for Claim That Covid Vaccines Do Not Alter DNA

Last year, Australia's drug regulator, the Therapeutic Goods Administration (TGA) was unable to provide any evidence for its claim that "there is no accepted science that shows any alteration of the human genome" related to Covid vaccination when this information was requested under Freedom of Information (FOI). More recently, US-based public health watchdog Informed Consent Action Network (ICAN) reported that the Centers for Disease Control and Prevention (CDC) doesn't hold any evidence for its safety claims on this issue either. The CDC states on its website that, "COVID-19

vaccines do not change or interact with your DNA in any way."

However, when law firm Siri & Glimstad requested "all documents sufficient to support" this claim from the US health agency under Freedom of Information (FOI), the CDC advised that no records had been found. Moreover, in its response to managing partner Aaron Siri, the CDC stated, "Subject matter experts have informed us that it is not biologically possible for the vaccines to change or interact with an individual's DNA." Siri followed up with another FOI request to ascertain who exactly these subject matter experts were. The CDC went to excessive lengths to block this request.

ICAN reported on the exchange, "First, CDC sent documents that

were completely redacted. ICAN appealed and was then forced to sue when CDC did not respond. Finally, after a year of legal battles, ICAN has obtained the unredacted forms filled out by the "experts" in response to our original FOIA request." These unredacted documents revealed that the experts upon whose advice the CDC relied on were not qualified to make the claim that "it is not biologically possible for the vaccines to change or interact with an individual's DNA."

One of the experts, Dr John Su, of the CDC Immunization Safety Office (ISO) wrote that, "The requested information is outside of ISO's purview. Documents requested involve demonstration of molecular and/or atomic forces that are beyond the scope

of ISO to document." Another expert consulted on the request, a public health analyst with a master's in public health and presumably lacking specialised expertise in genetics or "molecular and/or atomic forces" wrote, without any sources or citation, "This request is not biologically possible." However, in internal emails recently released under FOI, members of the Australian drug regulator's Scientific Evaluation and Pharmacovigilance Branches were caught on record acknowledging that integration of Covid mRNA vaccine elements into the human genome is biologically possible.

Furthermore, TGA personnel acknowledged amongst themselves that the SV40 enhancer/promoter found in the Pfizer vaccine can

drag DNA into the nucleus of cells. And, TGA staffers acknowledged the speculative nature of regulators and health agencies' claims that "there is no evidence of Covid vaccines integrating into the human genome," with one admitting that, "I am unaware of studies which have tested this." In other words, there is no evidence because government agencies and pharmaceutical companies have not run any trials looking for it.

A NSW Cancer Cluster Causes Concern

What Are the Chances?

The precautionary principle is a cornerstone of medicine, prioritising patient safety by ensuring that medical decisions err on the side of caution rather than risk causing harm. History is filled with examples of government interventions that, despite good intentions, have led to unintended consequences. A prime example is the COVID-19 lockdowns imposed on healthy populations, which has been estimated to have incurred costs at least 68 times greater than the benefits they delivered.

Similarly, new therapeutics must be rigorously scrutinised and actively monitored to ensure they do more good than harm. Regulators claim that the COVID-19 mRNA vaccines are among the most closely examined medical products in history. However, surveillance systems around the globe have reported record numbers of adverse events, with scientists, doctors, and the public continuing to raise concerns.

A Troubling Discovery in NSW
In a recent interview with Russell Broadbent MP, freedom of information and data researcher Sharon Cousins shared alarming

findings regarding a cluster of 18 cancer cases occurring at a single location in New South Wales (NSW).

One particularly concerning revelation involved two nurses who developed breast cancer and had received doses from the same vaccine batch (FN0565). This batch was recently tested by Dr. David Speicher, who reported alarmingly high levels of residual DNA contamination. One of the affected nurses, Belinda, also joined the interview. 'I knew Belinda from two years ago when she attended a meeting in Wollongong, where we discussed vaccine batch numbers and the TGA's Database of Adverse Event Notifications (DAEN),' said Cousins. 'Belinda was already battling breast cancer, and it turns out she received a dose from batch FN0565 - the same batch that was later sent to Canada and found to contain DNA contamination.'

One particularly concerning revelation involved two nurses who developed breast cancer and had received doses from the same vaccine batch (FN0565).

In September 2024, Dr. Speicher's findings were sent to the Prime Minister and Health Minister in a formal letter co-signed by highly credentialed professionals and world-renowned scientists.

A Failure of Active Surveillance

These findings raise significant concerns because the COVID-19 mRNA vaccines were granted provisional approval without medium or long-term safety data. Additionally, no genotoxicity

(DNA damage) or carcinogenicity (cancer risk) testing was conducted before approval.

One would expect regulators to actively monitor for anomalies such as cancer clusters, yet there is no evidence of proactive surveillance. Instead, authorities appear to rely on a passive surveillance system, which involves long delays between adverse events and their detection.

Meanwhile, emails released under Freedom of

Information (FOI) reveal that the TGA (Therapeutic Goods Administration) is aware of the theoretical risks. Internal discussions acknowledge that:
■ "Foreign DNA can integrate into chromosomal DNA."
■ "The SV40 enhancer region can promote nuclear transport of DNA."

While these risks are officially considered low, this contradicts the TGA's earlier assertions that DNA integration is impossible. Independent research by Kevin McKernan and Phillip Buckhaults has already demonstrated DNA integration of COVID-19 vaccines into human cells in separate laboratory studies. Similarly, oncogenic (cancer-causing) and genomic (gene-altering) risks are acknowledged but dismissed as "highly unlikely."

The Need for Caution

While it is essential to recognise that correlation does not equal causation, the precautionary principle demands rigorous scrutiny of unintended consequences whenever a new medical product is introduced. Given the increasing reports of adverse events and the emerging evidence of potential risks, a thorough and independent investigation into these findings is not just warranted - it is imperative.

The Cape Byron Lighthouse Declaration

In September 2021, my 32-year career as a Senior Specialist in Anaesthesia and Critical Care came to an abrupt halt when my license to practice was suspended. The reason? Facebook posts where I challenged the government's lockdowns and mask mandates, citing a lack of evidence, while advocating for natural immunity, vitamin D, and early treatments like Zinc, Ivermectin, and Hydroxychloroquine. I also raised alarms about the dangers and inefficacy, sometimes even negative efficacy, of the synthetic gene technology.

Dissident practitioners like me faced censorship, legal harassment, bullying, and intimidation from regulators. In response, on January 22, 2023,

I joined Dr. Robert Brennan and Ros Nealon-Cook to launch the Cape Byron Lighthouse Declaration, a bold global cry of "ENOUGH!" demanding an end to censorship, the restoration of informed consent, the abolition of mandates and unethical coercion, and the return of bodily autonomy and practitioner-patient independence.

Two years later, on 22 January 2025, founders and supporters of the Declaration gathered in Byron Bay, New South Wales, to celebrate its second anniversary. As we did at its inception, we assembled at the Cape Byron Lighthouse before dawn, witnessing a stunning sunrise from Australia's easternmost point.

The movement, chronicled at lighthousedeclaration.org, has flourished since 2023. Alongside the original trio, new

"Lighthouse Keepers" from across the globe have joined, including health practitioners who risked their careers to speak out: Dr. Sally Price from Western Australia, and Dr. Peter McCullough from the USA, Dr. Rosamond Jones from the UK, Dr. Anne McCluskey from Ireland, and Fleur Borelli from the UK via video link.

Soon, "Torch Bearers" like economist Professor Gigi Foster will bolster the cause, illuminating ethical paths in broader society. What began as a defiant stand has grown into a thriving global community of courageous practitioners and supporters united in the mission to "Make Ethics Great Again".

Abandon Net Zero, Rescue the Economy

'To rescue our economy,' Trump signed day-one orders 'to end all Biden restrictions on energy production, terminate his insane electric vehicle mandate, cancel his natural gas export ban, reopen ANWR in Alaska (the biggest site potentially anywhere in the world), and declare a national energy emergency.'

Trump terminated Biden's Green New Deal, pulled out of the Paris Accord, and castigated the Davos elitists who could do nothing more than acquiesce in his triumphant procession. Among the measures is a freeze on \$280 billion for green energy (\$50 billion was already committed) said to have 'a very negative effect'.

Labor is moving in the opposite direction from Trump in announcing a further \$2 billion in green subsidies through the Clean Energy Finance Corporation. Peter Dutton, while not setting 2035 emission reduction targets, refuses to follow Trump in abandoning Net Zero. He claims that doing so would harm trade and employment. It is hard to see trade being affected when the EU is the only jurisdiction still contemplating

– and not for long – any action penalising carbon-intensive imports. As for employment, Dutton should get some better advice and be informed that any jobs in building renewables are far more than offset by jobs lost as a result of their intrinsically higher costs and lower reliability.

Labor is also providing \$2 billion to the nation's four aluminium smelters conditional on them greening their energy; this comes on top of existing subsidies for them to get cheap

coal-generated electricity. The aluminium smelter subsidy stems from Albanese's recognition that more than doubling energy costs in a business that has energy comprising a third of total costs means sudden death. He is gambling on the mirage of an unattainable breakthrough that would see wind/solar costs eventually falling below those of coal, gas and nuclear.

But the focus on aluminium also demonstrates his misunderstanding about how market capitalism works. Mr Albanese rejects compensation for steel and cement where energy costs are 10-15 per cent of total costs, judging that they can absorb the costs. And so they might, until the firms' 'fixed' capital needs replacement. When it does, the replacement decision is in the hands of the shareholder, the residual beneficiaries, who get paid only after everyone else has been recompensed. If equity shares comprise 40 per cent of a firm's capital and capital constitutes 20 per cent of total costs, shareholders who formerly got 8 per cent of the products' value make losses where energy costs are doubled. Even when energy costs are only 3 per cent of total costs, the arithmetic leaves the equity holder with 3/8ths less profit, bringing tremendous incentives to shareholders, (including superannuation funds) to find alternative locations.

The capitalist system is remorseless in pursuit of profit and it is this that drives efficiency. Mr Albanese has spent his life railing against that system and has never understood how it has driven our present living standards – and how rejecting the system for the top-down planning he favours has brought poverty to Cuba,

Venezuela, and other failed states and is seriously reducing living standards in Australia, Germany, the UK and other nations that have gone the Full Monty on replacing hydrocarbon fuels with renewables. The outcome in energy prices is indisputable.

Of course, if the whole world were to follow a decarbonisation agenda, while serious losses would follow, they would be spread across all nations. As it stands, Australia in joining the EU and UK in a climate crusade, confronts the 80 per cent of the world economy, now including the US as well as China and India, that has backed away from seriously subsidising renewables. Those nations now have a considerable comparative advantage, and it is the climate crusaders' economies that are being nailed to the cross.

Under Peter Dutton, the Liberal Party is avoiding the sort of radical deviation from the Woke dirigiste policies that had, pre-Trump, become the conventional approach of mainstream conservatives. This may be enough to win power but it would hardly justify a claim of a mandate for the change required. Other Anglosphere politicians – Poilievre in Canada and Farage (and arguably Badenoch) in the UK – like Trump, have confronted socialistic policies boldly and persuasively. This has been accompanied by both greater enthusiasm from their base support and decisive leads in public opinion.

No Shortage of Water in Australia

Dorothea Mackellar wrote it a century ago...Australia always was, and always will be, "a land of droughts and flooding rains." Just ask North Queenslanders! In late January and early February, Townsville and Ingham were drenched. Within just a few days, some areas saw 2,000 millimetres of rain. That's almost double what Sydney sees all year. But all the water went to waste! Commentator and journalist, Ben Fordham, addressed this uncomfortable fact on 2GB radio. He pointed out that on the 2 February, the Burdekin, Herbert, and Haughton Rivers discharged 852 million cubic metres of water into the

Pacific Ocean. That's enough water to fill 340,000 Olympic-sized swimming pools. It's almost two Sydney Harbours worth of freshwater dumped into the sea in just 24 hours. The worst part is that the water didn't have to go to waste. We could have captured the monsoonal flows, if we built the right infrastructure, and given it to our farmers.

John Bradfield had this idea. He was the man who built the Sydney Harbour Bridge. But his genius wasn't confined to bridges. He was also a big fan of dams. That's why in the 1930s, Bradfield fought his way through the dense mountains of far North Queensland on horseback. He was hellbent on finding water to irrigate inland Australia, and at the Burdekin River, he found it. Bradfield said that if Australia diverted

the floodwaters of the Burdekin, Johnson, Tully, Herbert and Flinders Rivers into the Thompson which flows into Lake Eyre; the arid interior of the continent would become fertile enough to sustain large-scale agriculture and large populations. He's not wrong. Many engineers have assessed the project since, and come to the same conclusion. But nothing has ever happened. Our politicians said it was all too hard. This is one of the biggest problems with Australia.

China is building massive dams and irrigation systems. The impoverished African nation of Libya has 2,800 kilometres of water pipelines and aqueducts. The Romans did it. As did the Persians, Moghuls and Egyptians. In the 1890s, Twiggy Forrest's Great-Great Uncle, built a 500-kilometre water pipeline to connect Perth to

the Kalgoorlie Gold Fields.

Why can't we do it now? At the end of the day, between 80 and 90 per cent of Australia's water falls north of the Tropic of Capricorn, in the largely unsettled Top End areas of Western Australia, the Northern Territory and Queensland. More than 50 per cent of this is lost to evaporation or runoff into the sea. The reality is there's no shortage of water in Australia. It just lands in the wrong places. It's time we put our human genius to the task, and did something about it; so that when drought inevitably comes around, we've got more than enough water to survive.

‘Jaw-dropping’ Study Finds Vaccinated Children Have 170% Higher Risk of Autism

The peer-reviewed study also found that vaccinated children had a 212% greater likelihood of developing other neurodevelopmental disorders, including ADHD, epilepsy/seizures, brain inflammation and tic and learning disorders.

Vaccinated children have a 170% higher chance of being diagnosed with autism compared to unvaccinated children, according to a new peer-reviewed study. The study also found that vaccinated children had a 212% greater likelihood of developing a range of other neurodevelopmental disorders, including attention-deficit/hyperactivity disorder (ADHD), epilepsy/seizures, brain inflammation and tic and learning disorders. According to the study, the childhood vaccination schedule is likely a significant contributor to the higher rate of autism and neurodevelopmental conditions in vaccinated children. The study of 47,155 9-year-old children enrolled in the Florida Medicaid program since birth was published on Jan. 23 in *Science, Public Health Policy and the Law*. Karl Jablonowski, Ph.D., senior research scientist for Children’s Health Defense, said the paper “is unignorable simply by the soundness of its methods.” “The sheer hazards associated with severe childhood diseases is jaw-dropping,” Jablonowski said. The paper’s authors — Anthony R. Mawson and Binu Jacob of the Mississippi-based Chalfont Research Institute — hypothesized that:

- Childhood vaccination is associated with autism and other neurodevelopmental disorders.
- Increasing numbers of vaccinations lead to a higher risk of autism.
- Vaccinated preterm babies are at greater risk of neurodevelopmental disorders than unvaccinated babies.

The study’s findings confirmed the authors’ hypotheses. Experts said the results of the study cast doubt on government claims that vaccines are not linked to autism. “The vaccine propaganda campaigns operated by our regulatory agencies, pharmaceutical companies, and legacy media continue to claim that the link between vaccines and autism has been ‘debunked,’” said

epidemiologist Nicolas Hulscher. He said the findings of this study “completely dismantle” this narrative. Jablonowski noted that the study was based solely on government data. He said: “The government has had this data for decades, professing safety while simultaneously refusing to study safety. The facade of U.S. government public health is crumbling, revealing a culprit in chronic disease in this country: willful ignorance.” The authors of the study noted that government-sponsored studies have not compared health outcomes in vaccinated versus completely unvaccinated children. Mawson and Jacob told *The Defender* they hope the government will initiate such studies.

Childhood vaccination schedule likely factor in increased autism diagnoses

The study found that, across all metrics, vaccinated children had a higher rate of neurodevelopmental disorders compared to those who remained unvaccinated. According to the findings:

- The relative risk of developing a neurodevelopmental disorder grew as the number of doctor’s visits that included vaccinations increased. Children with just one vaccination visit were 1.7 times more likely to have been diagnosed with autism compared to those who were unvaccinated.
- Children with 11 or more vaccination visits were 340% more likely to be diagnosed with autism compared to unvaccinated children and 89% more likely to be diagnosed with autism compared to children with one vaccination visit.
- Vaccinated children who were born preterm were 258% more likely to be diagnosed with at least one neurodevelopmental disorder, compared to children born preterm who remained unvaccinated. Nearly 40% of vaccinated preterm children were diagnosed with such a disorder, compared to 15.7% of those who were unvaccinated.
- Vaccinated children were 419% more likely to be diagnosed with encephalopathy (brain inflammation), 525% more likely to develop tic disorders and 581% times more likely to have a learning disability, compared to unvaccinated children.
- Among children born preterm who were subsequently vaccinated, the risk of brain inflammation and learning disabilities grew by 612% and 884%, respectively.

“While the connection between receipt of vaccines and autism has been of grave concern to many parents, this study makes it clear that even in the absence of an autism diagnosis, children’s brains are being damaged,” said biologist Christina Parks, Ph.D. Autism prevalence has grown from 1 in 1,000 children in the 1990s to 1 in 36, according to the Centers for Disease Control and Prevention (CDC). The study’s authors noted this increase is commonly attributed to greater

awareness of autism-related symptoms and higher exposure to toxic chemicals. However, the authors said their results suggest the childhood vaccination schedule may also be a key factor behind the sharp increase in autism diagnoses. “The geographically widespread increases in ASD [autism spectrum disorder] and ADHD suggests a role for an environmental factor to which virtually all children are exposed. One such factor is routine childhood vaccinations,” the study noted. The authors cited figures showing that the number of vaccines included in the CDC’s latest U.S. childhood schedule increased nearly threefold compared to the 1983 vaccination schedule. “Although vaccination is said to be safe and effective for the great majority of children, a legitimate question is whether the expanded schedule could be contributing in some way to rising rates of NDDs [neurodevelopmental disorders],” the study stated. “Any planned additions to the childhood vaccination schedule should be delayed until research to determine the safety of its impact on children’s

overall health is completed,” Mawson and Jacob said.

Results indicate childhood vaccination schedule ‘needs a complete overhaul’

According to the study, the impact of vaccination on children born preterm has not been sufficiently examined. “The possibility of adverse effects of vaccination on preterm infants may have been obscured by the primary importance placed on vaccinations for preventing neonatal infections,” the study said.

A peer-reviewed study published earlier this month found that preterm infants who received their routine 2-month vaccinations had a 170% higher incidence of apnea compared to unvaccinated babies. The study also noted that while studies have often attempted to connect rising autism rates to specific vaccines, there has been less research exploring a possible link between the cumulative childhood vaccination schedule and autism. “A link between vaccination and ASD could be due to the cumulative impact of all preceding vaccinations

rather than to a specific vaccine alone,” the study said. “ASD and other NDDs could be triggered by the last vaccination administered or by one or more of a series of vaccinations.” “There is an urgent need for research to identify biological mechanisms and potential causal relationships between individual vaccines, combinations of vaccines, and other potential factors associated with neurodevelopmental disorders,” Mawson and Jacob said. Hulscher said the study suggests that the current “CDC hyper-vaccination schedule needs a complete overhaul.” He added, “Not only is it likely contributing to the autism and chronic disease epidemics, but almost all of the vaccines were licensed without proper long-term, placebo-controlled trials.” Parks said the study’s results reinforce the importance of parental choice. “However, there were some findings that parents may find comforting,” Parks said. “While preterm infants are extremely vulnerable to encephalopathy and seizures, if parents chose not to vaccinate them, they were statistically no more likely to develop neurodevelopmental disorders than normal-term infants.” According to a September 2024 CDC report, vaccination rates among children born in 2020 and 2021 were lower than those for children born in 2018 and 2019. Hulscher said that an increasing number of Americans are becoming aware of the risks of childhood vaccination. “The American public is becoming increasingly aware of the real risks of vaccines,” Hulscher said. He attributed the growing mistrust to “the COVID-19 mRNA injection debacle that killed, injured, or permanently disabled millions of people.” Hulscher said the study’s results “warrant further study by the new U.S. administration.”

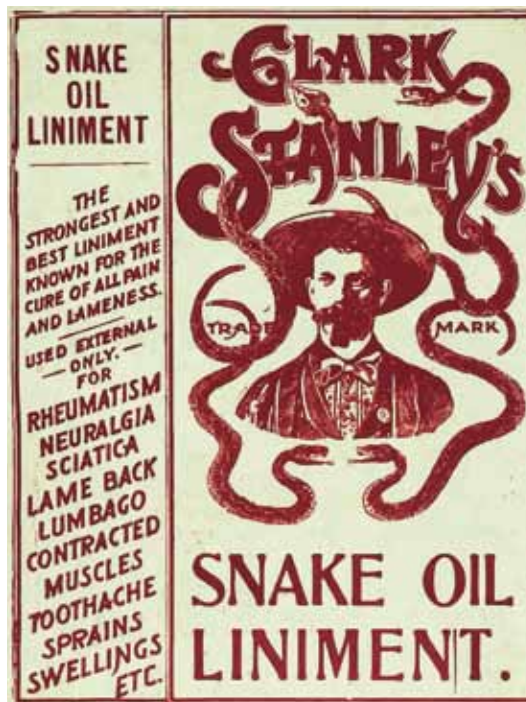
This isn't just a one-off fumble - it's a symptom of a bigger

way that police can see crimes have been committed and require investigation. Debra Leigh is a retired accountant who travelled extensively overseas in her corporate work consulting in the specialised field of managing change in the workplace.

Her Covid journey began five years ago when we started to hear reports of a dangerous new virus but there was no evidence to suggest the bug was anything to worry about. By coincidence at Perth airport, she met an infectious diseases specialist who was equally baffled by the alarmist reports and told her he and his colleagues were

Farming in Nature’s Image

Gabe Brown is such a celebrity on the regenerative agriculture lecture circuit that it is a wonder he has time for his farming and grazing operation in North Dakota. He does - and profitably - but he was struggling to find time to write a book about his lifetime adventure breaking away from mainstream industrialised agriculture.

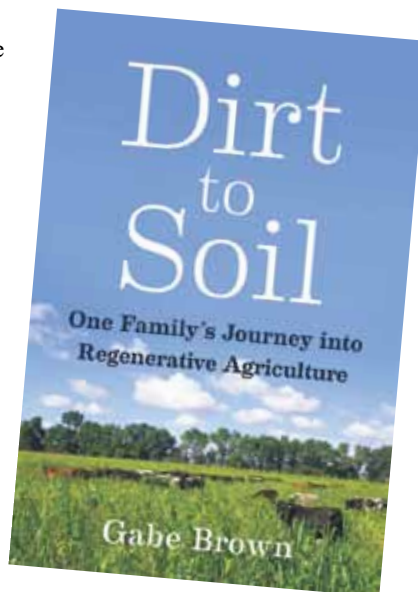
The publishers invited Courtney White to assist and the resultant book - *Dirt to Soil* - is a handbook, indeed a bible, for the serious regenerative farming fraternity and a fascinating read even for city people with no farming knowledge at all.

The book is written in two halves - the first half describing the author’s journey to radical change after four consecutive years of catastrophic crop failures due to extreme weather events of hail and drought. The second half

goes more deeply into the science of healthy soils and takes readers below the surface of the paddock into the complex underground world of bacteria and fungi.

There are lyrical passages in this book that read like hymns of praise to nature. “Diverse plant roots sending diverse signals to bacteria and fungi make diverse minerals as needed, all working together symbiotically to transfer nutrients into the body of plants and then into us in an elegant, efficient and vastly sophisticated, interdependent web of life, billions of years in the making.”

Having been faced with financial catastrophe at the outset of his farming career, the author emphasises the bottom line and provides detailed advice on costs and profits. Many of the farmers quoted in the book took the plunge to regenerative agriculture when they assessed their financial future with modern industrial chemical farming. Their yields were flat



lining while input costs of fertilizer and herbicides were rising. They were heading for a brick wall.

Animal husbandry is included in the book through its relationship to soil health. The author describes how he moved away from the conventional cattle breeding

mantra of bigger and heavier.

“We decided to stop using wormers, fly tags and the long list of vaccines. These products were band-aids treating symptoms. They were not solving the real problem which was a dysfunctional eco system.”

Holistic Planned Grazing allows for complete plant root system recovery between grazings. Livestock are used as a soil-building tool and are moved every day, sometimes twice a day. With portable electric fencing it is not as difficult as it sounds.

The five principles of soil health are listed in the first half of the book and given more scientific examination in the second. They are: 1. Limit mechanical, physical and chemical disturbance of the soil. 2. Maintain armour (plant residue) on the soil surface. Where in a health ecosystem do you find bare soil? 3. Build diversity. 4. Maintain living roots in the soil. 5. Integrate animals.

Gabe Brown comments on a feature now being noticed in Australia’s wheatbelt - the complete absence of fencing indicating no intention to run livestock. “A plant that has been grazed will pump much more liquid carbon into the soil.” Cover crops get much attention. The author prefers to call them “biological primers” improving soil structure and water retention.

Gabe Brown has rubbed shoulders with many distinguished professors and researchers, but he maintains that his best teacher is nature. Today the question is will we give nature a chance or will we surrender life on earth to mad scientists playing God in their laboratories? Will we keep pharmaceutical companies out of our bodies and away from our farm animals? Will we keep chemical cartels out of our soils? As mRNA factories emerge from the earth like mushrooms, the struggle is just beginning.

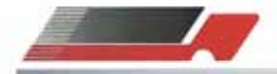
