The Death of Free Speech in the West

Preserving free speech is essential to protect democracy. Indeed, no society can be authentically democratic if only a few privileged individuals are allowed to determine how others must participate in public discourse. Unfortunately, democracy today is dying in the West because its ruling classes want to make it all about a handful of people. In our society, the right to free speech is constantly denigrated, and this practice has contributed to the emergence of troubling times.

The evidence for this is easy to find and consequences of the deleterious effects of speech-unfriendly policies and laws are clearly visible: attempts to restrict free speech with ‘disinformation’ and ‘misinformation’ law, censorship of online materials by the [Australian] e-Safety Commissioner, the adoption of ever stringent anti-discrimination laws, elimination of ‘harmful ideas’ which the ruling elites equate with domestic terrorism, discretionary use of defamation laws and practices, prohibiting

criticism of the harmful effects of sex and gender identification laws, among others.

In this context, Pavel Durov, the co-founder and CEO of social media app Telegram, has just been arbitrarily detained [24 August 2024] by the French authorities. Given the potential charges against him, Telegram’s CEO could be facing up to 20 years in prison. His arrest has been characterised as a ‘crackdown against free speech’. Indeed, the Telegram CEO told US journalist Tucker Carlson that ‘Western intelligence agencies were after him, apparently seeking to use his platform to spy on others.’ In his X account, Carlson stated a remarkable irony about this situation: ‘Pavel Durov left Russia when the government tried to control his social media company, Telegram. But in the end, it wasn’t Putin who arrested him for allowing the public to exercise free speech. It was a Western country, a Biden administration ally and enthusiastic NATO member’.

Ironically, Durov, who was born in Russia left the country after he refused to comply with state demands to shut down opposition communities on his VKontakte social media platform. His subsequent company Telegram is based in Dubai and described by Durov as ‘the best place for a neutral platform like ours to be in if we want to make sure we

can defend our users’ privacy and freedom of speech’.

In our opinion, the CEO of Telegram is now a political prisoner, and his arrest means that free speech in ‘Western democracies’ is dying. The tech entrepreneur’s arrest is clearly politically motivated as it has broad implications for other social media. Almost a billion people around the world use Telegram as a means of private communication and source of vital information.

The next in line may be the CEO of Rumble, an online video platform that focuses on free speech and content diversity, while its competition YouTube has much stricter policies. Rumble CEO, Chris Pavlovski, has vowed to make his platform entirely free speech resulting in constant attacks by the globalist left.

In 2023, for example, Rumble left communist Brazil rather than obey unconstitutional judicial orders to censor conservative voices. Now France has targeted Rumble and on August 25 [2024], Pavlovski announced on X he had to escape Europe.

‘I’ve just safely departed from Europe. France has threatened Rumble, and now they have crossed a red line by arresting Telegram’s CEO, Pavel Durov, reportedly for not censoring speech. Rumble will not stand for this behaviour and will use every

legal means available to fight for freedom of expression, a universal human right. We are currently fighting in the courts of France, and we hope for Pavel Durov's immediate release.'

In a brazen move against Elon Musk on 30 August 2024 the Brazilian courts ordered a nationwide suspension of X stating further that Brazilians illegally accessing this social media platform using VPNs would face daily fines of 50,000 Real (approx. \$8,900 USD).

The Woke ruling classes controlling the West want you to focus solely on the likes of Musk, Pavel, and Pavlovski. We can add Tulsi Gabbard, Julian Assange, Scott Ritter, and many others who have been harassed, arrested, imprisoned by state authorities in the US, UK, EU, and Canada for practicing the disappearing profession of journalism. The UK Home Secretary, Yvette Cooper,

has vowed to further crack down on people 'pushing harmful and hateful beliefs' including even what she calls 'misogyny'. The crackdown on free speech is now almost complete in the United Kingdom with Section 18 of the Public Order Act 1986 prohibiting any speech that is 'threatening, abusive, or insulting'. Labels such as 'racist', 'sexist', and 'homophobe' are routinely applied to demonise those who contest the ideological agenda of the ruling elites.

Naturally, absolute free speech under all circumstances can never be a possibility. There are easily demonstrable exceptions whereby reasonable limits to free speech can be created. Moreover, violence is never acceptable and direct attacks on the physical integrity of another person can never be tolerated.

Democracy naturally implies that both good and bad ideas ought to be allowed and encouraged in the marketplace of ideas. There

is nothing more undemocratic than preventing someone from expressing opinions. By contrast every totalitarian endeavour must restrict speech as a matter of course.

There is also a close link between moral virtue and democracy, and if the link is broken, democracy only exists in name. Moral virtue also refers to the willingness of political parties to respect the rules of democracy, especially the expectation that our leaders are directly, or indirectly, elected by the people – a problematic expectation with vote rigging practices alleged to be practiced widely.

Of course, no one pretends democracy is perfect. Indeed, it has been said that democracy is the worst form of government except for all those other forms that have been tried from time to time.

Robert F. Kennedy Jr., writing in Quadrant Online, when endorsing Trump, characterised the Democratic Party as follows:

'In the name of saving democracy, the Democratic Party set itself to dismantling it. Lacking confidence that its candidate could win at the voting booth, the DNC waged continual legal warfare against both President Trump and myself. Each time our volunteers turned in those towering boxes of signatures needed to get on the ballot, the DNC dragged us into court state by state attempting to erase their work and to subvert the will of the voters who had signed. It deployed DNC-aligned judges to throw me – and other candidates – off the ballot and to throw President Trump in jail. It ran a sham of a primary, rigged to prevent any serious challenge to President Biden.'

Unfortunately, Western governments are now actively suppressing speech that is critical of their left-globalist agendas. Their favourite narrative is that free speech (and probably Russia)

is the root of all evil behind civil unrest in the West. The notion of thought crime is making its way to the forefront of the established toolbox suggesting we are witnessing the next stage of authoritarianism – open criminalisation of speech.

The result is a remarkable totalitarian expansion of governmental power and therefore today, we no longer have free speech in the West. What we have is 'official propaganda' that supports the Woke elitist agenda and narrative of the ruling classes that control our 'democratic' societies. As economist and journalist Paul Craig Roberts points out, 'The notion that the West is free is a joke. When there is no free expression there is only tyranny. And that is what the Western world is. A tyranny.'

The Dismantling of Democracy

Research suggests that people have overestimated democracy for decades, losing sight of its true nature and core principles. People are not participating in democracy; they believe the 'system' is autonomous and safeguards their interests.

This active participation is crucial to democracy's success, as it ensures that the system remains true to its principles and serves the people's interests.

Participation creates unity; we

have seen it many times in the past hundreds of years. People of all ethnicities, religions, and skin colours learned that coming together to fight against authoritarianism formed unity.

What happens when we do not participate and take unity for granted? Over time, it creates a disconnect between the people and the government. The system will falter, and authoritarian people will rise because they see people not participating and withdrawing back into a group mentality. With it, education about unity withers. People believe nothing wrong can happen because the autonomous system will protect them. Authoritarians, both local and foreign, see this and take advantage by interfering and steering government policy ultimately to undermine unity.

Our greatest strength is education on the differences between ruling systems and how to participate in creating unity for a freedom-loving country. Conversely, a freedom-loving, unity-driven country is an authoritarian's kryptonite. They know the way to dismantle democracy is to target unity. Authoritarians will do this primarily by dividing and conquering the

population, creating anarchy groups led by authoritarians who have carved out enclaves for themselves within a population.

The notion that people forget what freedom-based systems are is valid. Otherwise, why would people stand by and do nothing when the system is attacked through policies and media rhetoric that create division? So far, it is evident participation and education are fundamental to freedom.

President Reagan said it best, "Freedom is never more than one generation away from extinction. We did not pass it on to our children

in the bloodstream. The only way they can inherit the freedom we have known is if we fight for it, protect it, defend it, and then hand it to them with the well fought lessons of how they in their lifetime must do the same. And if you and I do not do this, then you and I may well spend our sunset years telling our children and our children's children what it once was like in America when people were free."

In a freedom-based system, we should want to teach people what freedom looks like from the youngest of ages. To teach how to participate in it and, by doing

so, protect it from our adversaries (authoritarians and anarchists) to keep freedom on track and pass the torch from one generation to the next to do the same. Unfortunately, we have not been doing that at all. Even with President Reagan's and others' warnings, we must ask why these things have not been embedded in our education system. Today, the government controls education and the direction and content thereof. That must implore us to question if there are authoritarians within who are undermining our democracy.

In every group and every country, authoritarians will always want to rise and take control. As ruling systems have evolved, authoritarians have found it increasingly difficult to maintain control, let alone regain it, when lost, mainly because of population size and education. It stands to reason authoritarians would target education to slowly remove

freedom from people's minds, replacing it with distractions. As a once unified multicultural population, we seem increasingly divided through distractions.

Increasingly, we see children and women being targets in these campaigns, whether it be trans-gendering or the notion of men playing in female sporting teams. More general divisions like asking, are you a First Nations person, Muslims hating Jews and Christians, people demanding rights to work from home, now people in offices demanding rights to bring their pets to work, and one of the latest is pushing people to come out as LGBTQ that play AFL etc, to name a few distractions. By allowing these arguments to suck up all the airtime rather than focusing on inflation, cost of living, and so on, we are dividing ourselves.

Further, instead of being civilly discussed, these things get rammed through as a "right," denying, in many cases, one of the fundamental values of our system, "safety." Excommunicated by the Globalists

What is a Religious Schism? In Christianity, a schism occurs when a single religious body divides and becomes two separate religious bodies. The split can be violent or nonviolent but results in at least one of the two newly created bodies considering itself distinct from the other.

The geopolitical troubles stemming from increasing governmental control propagated by organisations like the World Economic Forum (WEF) are not solely confined to the political arena but have infiltrated all aspects of human endeavour, including that of religion.

A senior figure in the Catholic Church has recently been found guilty of schism and excommunicated by the Vatican. After years of fierce disagreement and denial of Pope Francis' legitimacy, Archbishop and former papal envoy to the U.S., Carlo Maria Vigano, was officially removed in July 2024. Archbishop Vigano has previously called on the current Pope to resign, branding him a "false prophet" and a "servant of Satan". Vigano had long railed against the current papal doctrine, alleging the Pope's involvement with globalist agendas and what he describes as anti-Christian projects led by the United Nations and groups like the WEF. He has accused the Pope of heresy, criticising his stand on immigration, climate

change, same-sex couples and publicly demanded the Pope and other church officials resign over concealment of sexual abuse within the Church.

Excommunication means a Catholic is prohibited from administering and receiving the sacraments and exercising ecclesiastical functions. Essentially it is a form of exclusion and responding to his excommunication on the social media platform, X, the 83-year-old Vigano remained unrepentant, saying he regarded the accusations against him as "an honour". "I

repudiate, reject and condemn the scandals, errors and heresies of Jorge Mario Bergoglio," he said, using the Argentinian born Pope's given name.

Archbishop Vigano remains staunchly unapologetic and has become known as an icon of resistance by many Catholics. Supporters of Vigano include movie star and director Mel Gibson who stated on social media platforms that he fully endorsed Vigano and questioned the legitimacy of Pope Francis and his supporting Bishops. Gibson questioned their motivations

describing them as "a bunch of hirelings" and goes on to ask, "who hired [Pope] Francis?" Perhaps clues to this question can be found in Vigano's open letter to President Trump.

In 2020 Vigano wrote an open letter to US President Donald Trump, warning of the globalist threat to humanity, "*A global plan called the Great Reset is underway. Its architect is a global elite that wants to subdue all of humanity, imposing coercive measures with which to drastically limit individual freedoms and those of entire populations. In several*

nations this plan has already been approved and financed; in others it is still in an early stage. Behind the world leaders who are the accomplices and executors of this infernal project, there are unscrupulous characters who finance the World Economic Forum".

It would seem at least one major impetus behind this schism is the globalist agenda including the attack upon tradition itself. One of the key features of this religious conflict is the restriction of the Tridentine Mass commonly known as the 'traditional Latin Mass'. Here the mass is conducted solely in Latin and this tradition dates back to 1570. In 2021 Pope Francis however, imposed restrictions on this practice contributing to the current schism within the Church.

Supporters of Vigano extend beyond Catholics to include protestant Christians such as a former commissioner with the Law Reform Commission of Western Australia and head of the Sheridan Institute, Professor Augusto Zimmermann. Zimmermann states, "the aim of Bergoglio [Pope Francis] and his associates is the destruction of our existing system, to be replaced with the New World Order." Zimmerman stated in blunt terms the danger of such leaders as Pope Francis, "Bergoglio [Pope Francis] himself is the one who should be excommunicated for serving a sinister globalist force of enslavement."

A Cold War Story

Johann Sebastian Bach died in Leipzig in 1750. Two hundred years later, Leipzig, the musical capital of Germany, was behind the Iron Curtain.

The Berlin Airlift, the detonation of Russia's first atomic bomb in September 1949, America's production of the hydrogen bomb and the outbreak of the Korean War in June 1950 started the East-West rivalry that dominated world affairs for the next 40 years and now returns to haunt us in Ukraine.

A brilliant diplomatic initiative on the Eastern side was the 1950 Bach Bicentennial Competition in

Leipzig where pianist contestants could play anything they liked as long as their programs included at least one of Bach's 48 Preludes and Fugues, the foundation stone of musical composition.

Tatiana Nikolayeva, a 26-year-old graduate of the Moscow Conservatory, played all 48 and won first prize. On the judging panel was the world's greatest living composer, Dimitri Shostakovich, who was inspired to emulate Bach.

Tatiana Nikolayeva recalled the time: "On his return home to Moscow from Leipzig, Shostakovich immediately began to compose his Preludes and Fugues. At his request I telephoned him every day and he asked me to come to him and listen to him play the piece he had just written."

"They are 24 masterpieces, each with its own internal world.

They can and must be compared to Bach's cycle. They are a new world in polyphony."

In 1990 in London, Tatiana Nikolayeva recorded the Shostakovich Preludes and Fugues for the Hyperion label. The three-disc set is one of

my prized possessions. When I was still at school, she gave a concert in Perth where she played Moussorgsky's Pictures at an Exhibition.

The last "picture" or variation, "The Great Gates of Kiev", closes with such massive chords that many a sturdy Steinway has needed surgery.

My disc of "Pictures" is a classic called "The Sofia Recital 1958" recorded live at a concert in the Bulgarian capital by Sviatoslav Richter before he played in America, where he was greeted like a rock star.

Sviatoslav Richter was born in the Ukraine. He did not enjoy the American crowds and preferred to play in dimly lit churches in France and Germany. His fans followed him around Europe, hoping to get to the church on time.

In my youth it was a rite of

passage to read long Russian novels, especially Tolstoy's *War and Peace*. I completed this assignment when I was a member of the Electrical Trades Union, working as a trades assistant at Dampier and we went on strike, giving me plenty of reading time.

While care-taking a wheatbelt farm I read Dostoevsky's, *The Brothers Karamazov* and loved its wild complexity.

It is a privilege of our civilisation through our symphony orchestras, libraries and ballet schools to share this wonderful cultural heritage.

Europeans endured two world wars in the 20th Century. Surely, they have no wish to begin the 21st Century with a third.

We should be building bridges, not blowing up pipelines.

Mike Benz and the US 'National Security State'

Who, really, is trying to control us?

Mike Benz, a former employee of the US State Department and an authority on internet censorship, is attracting much attention on social media with his answer to that question.

Fast talking, intense, and convinced that control of the internet is the key to wider controls, he can overwhelm his audience with the vast knowledge he acquired by ploughing through the manuals, reports, and vision statements of a myriad of organisations. But what he has to say is shocking, so it is important that it is so well based.

For Benz, the ultimate power re-shaping our lives is not, as so

many believe, the World Economic Forum – this is a lesser player on his scenario. Rather, it is the US 'national security state', consisting of the CIA, the US Department of Defence and the State Department. In alliance with NATO, these bodies operate an extensive network of government institutions, NGOs, and public private foundations – a complex and opaque arrangement he calls 'the blob'. In essence, he told a stunned Tucker Carlson, he is talking about military rule.

If that seems implausible, it becomes less so when we hear Benz out on the history of the internet and how this military establishment decided that controlling 'the narrative' was no longer a subsidiary aspect of war but a primary aim. Here, he makes much of the combined interests of the US military industrial complex and the multi-national US corporations, at times sounding, as one interviewer put it, like the Noam Chomsky of some decades ago.

The story begins in 1991, when

the US military opened the internet – its own creation – to the public. Some may remember the euphoria of that time when the 'net', a place where ordinary citizens could publish, was seen as making free speech a concrete reality for all. This was the pre-history of internet censorship, but it laid the foundations of what was to come.

What we didn't know then was that the military establishment backed internet freedom in these early years, but not for any commitment to free speech. Assisted by US intelligence agents posting pro-Western ideas, Facebook in particular had accelerated resistance to repressive regimes hostile to US interests – the 'colour revolutions' in Eastern Europe and the Arab spring being the notable instances. These 'Facebook revolutions' brought home the power of propaganda as an instrument of war for they succeeded 'without a shot being fired'.

For the 'blob', however, the point was less the democratic aspirations of the resident populations than that the overthrow of a hostile regimes enabled US multi-nationals to move in and take over previously state-owned assets. From the outset, the internet was a creature of the combined interests of the US military industrial complex and the globalised multi-nationals – just as Chomsky used to say.

In 2014, the 'blob' abandoned internet freedom, shocked by the 'loss' of the referendum in Crimea where the overwhelming majority voted to join Russia. It was now apparent that spreading pro-Western ideas on the internet was no longer, on its own, sufficient to counter pro-Russian sentiment. Suppression of anti-Western ideas became equally imperative.

So much so, that NATO not only established a whole apparatus for censoring the internet but enshrined it in a policy of 'hybrid warfare', a policy which made controlling 'the narrative' equally, if not more, important than naked military power. [NATO Secretary General] Stoltenberg summed it up

as moving 'from tanks to tweets'. The internet was now literally a site of warfare.

Until 2016, the machinery of internet censorship was confined to Eastern Europe and parts of Germany. It was the dramatic events of that year – the election of Donald Trump, Brexit and the increasing electoral power of populist parties in Spain, Italy and Greece – which ushered in the Orwellian world we now inhabit. In the name of defeating populism (which spread largely via the internet) the 'blob' turned its methods of internet censorship inward, onto the populations of Western nations themselves. (Australia is directly involved as part of the intelligence sharing 'Five Eyes' alliance.)

Readers of The Light Australia probably need no persuading about the existence of censorship and how the deletion or shadow banning of posts labelled mis-, dis-, and mal-information mostly targeted no such thing, but dissent itself. A lot more can be learned, especially about the alarming use of AI, by following Benz on X, YouTube or Rumble. Most useful to mention here are the aspects of his 'big picture' which can get lost in the detail of the 'blob's' octopus tentacles.

First, though, why was the national security state so threatened by populism? Benz maintains that it is because these movements are about restoring the power of nation states to manage national economies in the interests of citizens. This places them in direct opposition to two requirements of multinational corporations: to be able to go where labour is cheapest and to expand internationally by taking over erstwhile state assets. Putting this another way, it could be said that Benz identifies the threat of populism in its opposition to neo-liberalism.

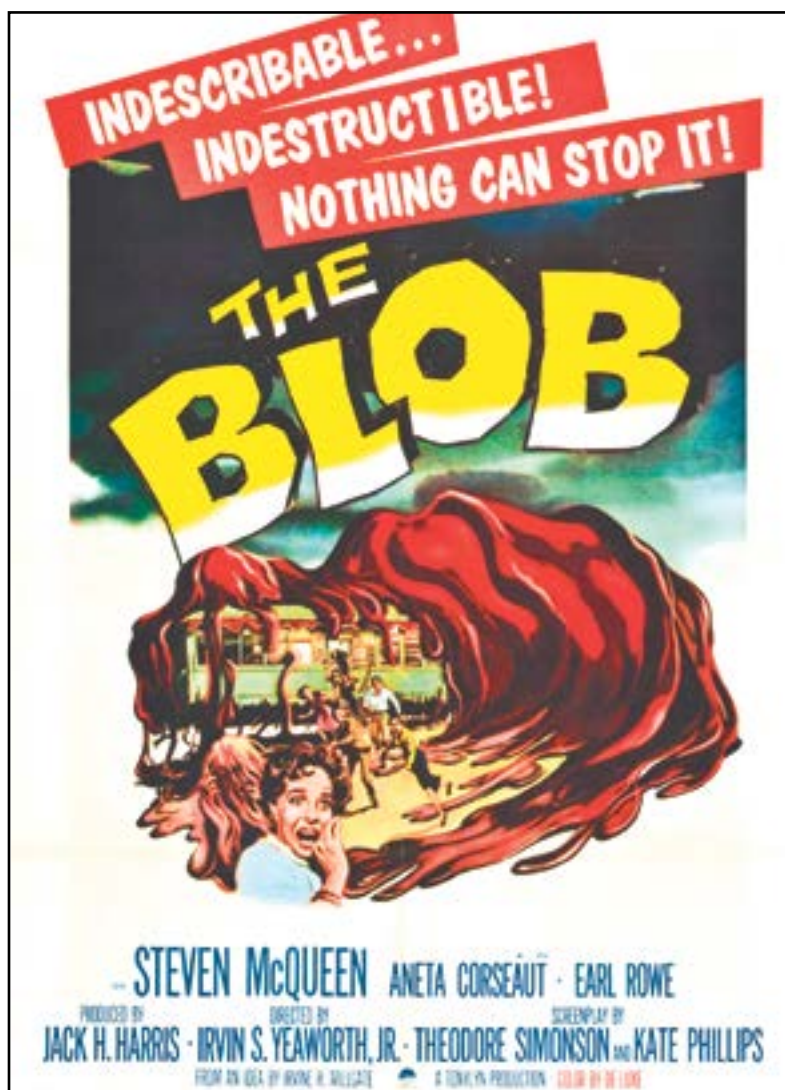
Others have suggested as much. The new insights into Benz' account concern the way the attack on populism has been managed. Populism is patently

democratic – movements 'from the people', wanting governments to work 'for the people'. This meant that presenting their repression in terms of defending democracy was a challenge. The challenge was met by an Orwellian change in language. Democracy no longer meant government 'by the people' but 'the defence of democratic institutions'. Understanding this makes sense of why so much mainstream commentary appears so self-righteous in demonising those who have lost confidence in their institutions as authoritarian, far right, extremists.

Redefining democracy, though, was not enough. Because it is unprecedented for a military defence establishment to target its own citizenry, its role had to be concealed. Benz' research reveals that the millions of dollars poured into developing censorship techniques are dispersed to universities, civil associations, the media, NGOs and other bodies. This was called a 'whole of society' approach, rendering invisible the central role of military intelligence while inducing the illusion that the move for so-called 'safety online' is from the 'bottom up', not, as it actually is, from the 'top down'.

Even more pernicious is what is implied by this 'whole of society' policy. For when a society has successfully coordinated all of its sectors to support the ruling agenda, it has moved from authoritarianism, even fascism, to full-blown totalitarianism. Or so Hannah Arendt argues in her definitive work, *The Origins of Totalitarianism*. Three features, she shows, define totalitarianism: rule by controlling the mind; the co-ordination of all sectors to the aims of the ruling body; and military and economic power working in unison. Benz does not present his account of internet censorship in these terms, but it is effectively what it demonstrates.

Food for Thought

If you asked the average person under 40 where their food comes from you are likely to get one of two answers: Coles and Woolies. As with the energy crisis, if people do not comprehend the methods and mechanisms of production, they will be unaware of impending shortages.

The availability and variety of food in the 21st Century West has lulled people into a false sense of security. People can grocery shop online or order takeaway and have it delivered to their dining table via apps like Uber Eats. Yet, we are more disconnected from our food sources than ever before.

Our food supply chain relies on a complex interacting web of technology, transportation, logistics and trade. Especially crucial is our reliance on organic fuels: coal oil and gas, without which billions of people would starve to death.

The most recent Fourth Agricultural Revolution of the mid-20th Century employed better fertilisers and plant-breeding techniques multiplying the yields of vital grain crops. American farmers increased per-acre corn yields by 500%. Other crops' yields also vastly increased while using less land, water, fuel, fertilisers and pesticides per ton of produce.

Abundant and cheap food has seen life expectancy increase and allowed us more leisure time, less stress and a corresponding increase in innovation and specialisation. Hundreds of years ago most people had to spend their waking lives planting, growing and distributing food. As this burden gradually eased, people had more time, energy and money for other pursuits: education, technology

and invention. It is no accident that the Industrial Revolution followed from the Third Agricultural Revolution, one beget the other.

Our ancestors also faced significant natural hurdles that meant food production was often severely limited. Colder periods occurred several times, often for hundreds of years. The Minoan and Roman periods of warmer climate saw civilisation flourish. Atmospheric CO₂, plant food, has increased from near starvation levels of 280 parts per million to over 400 today, largely from natural sources. This is increasing crop yields and seeing formerly arid regions greening and now able to grow food. Don't be surprised if climate alarmists launch a "Save the Deserts" campaign, complete with pictures of sad camels.

Today, farming is being assaulted from multiple angles. Climate alarmism is now focused on methane and nitrogen emissions and Globalist infiltrated Governments are enacting policies and directives to limit food production using the flimsiest excuses.

Under the guise of "biosecurity" millions of chickens are being slaughtered if one catches a cold – detected through the discredited PCR test. Bees, the pollinators,

Did the Australian Excess Mortality Inquiry follow the evidence?

Interview with Dr Jeyanthi Kunadhasan

Dr Jeyanthi Kunadhasan, previously a Consultant Anaesthetist in practice for more than 12 years, now the treasurer of Australian Medical Professionals' Society (AMPS), gave damning testimony on 13 June 2024 at the Senate Community Affairs References Committee Inquiry into Excess Mortality. Following that, Courage Is The Cure [CITC] asked Dr Kunadhasan for her comments and reflections.

Courage Is The Cure [CITC]: During the Inquiry into Excess Mortality, 13th June 2024, you stated, "As an author in the first peer reviewed data, that actually looked at the Pfizer Covid-19 vaccine data, one thing I want to actually emphasise, at no point during the trial was the intervention lifesaving." How was your explosive testimony regarding the intervention received by the Senators during the inquiry?

Dr Jeyanthi Kunadhasan [DR. KJ]: The Covid-19 vaccinations had been introduced to the whole population on the basis that they were "safe and effective". The public will be shocked to find out, that from the data in the primary trial, the vaccine was never lifesaving. This automatically makes one question the government's unprecedented coercion to get us all vaccinated, as the Therapeutic Goods Administration (TGA) would have been in receipt of this data in late 2021 as well.

This information was well received by the Senators who were already questioning the vaccine centric approach of the government. Clips of my opening statement in the excess deaths inquiry have been viewed more than 480K times on the social media platform, X.

[CITC]: Do you think Australians received a comprehensive answer to the question of why there was a significant increase in excess mortality from 2021 to 2023, considering the inquiry was confined to just one day?

[DR. KJ]: No, as highlighted in Senator Ralph Babet's dissenting report, only (26.74%) of the submissions received by the committee have been uploaded to the inquiry website for public viewing.

AMPS's own exhaustive multidisciplinary submission was

not published in full, and only a summary was published.

I corresponded with Professor Lawler, of the TGA, about the undisclosed deaths in the vaccinated arm of the Pfizer trial at the point of the vaccine approval. I referred to this in my public testimony, but those letters will not be available via the inquiry website. They are available on the AMPS website, and my correspondence is found in Chapter 7 of the submission.

So much more needed to be covered, and one day of public hearings was not enough.

[CITC]: Dr Kunadhasan, you also stated, "All doctors should not have had the unprecedented fear and coercion that was put on the medical profession in Covid. That is unforgivable. It has cost lives; it has damaged the medical profession." Do you think the Australian Government is concerned about the lives lost and damage to the medical profession, and what role did agencies like the Australian Health Practitioner Regulation Agency (AHPRA) play in the Covid-19 response?

[DR. KJ]: The quote of George Washington seems so prescient now, 'If the freedom of speech is taken away then dumb and silent we may be led, like sheep to the slaughter.' AHPRA's previous position statement issued in March 2021 was used as a tool to silence doctors and health practitioners.

The investigations continue to this day for some health practitioners, even though the original position statement has been revoked, and health emergencies and mandate requirements rescinded.

The emotional, financial and

reputational price has been made extremely high for doctors. As such, dissent is rare. However, the public suffers ultimately, as adverse events from the Covid-19 vaccination are underreported, and care delayed.

The creation of an environment where medical debate was suppressed has cost lives. The government's main concern regarding the medical profession seems to require compliance with their dictates and not being critical of their policies.

A normal reaction rooted in the precautionary principle would

Health regulatory agencies should reflect on their role in this, and ultimately answer this question: if a doctor, after study of the literature, concludes that a treatment is unsafe, and not effective, what exactly would you want that doctor to do?

[CITC]: Australians continue to demand the truth regarding excess mortality, yet there remains a reluctance to explore and provide comprehensive data in order to reveal the truth. Do you think the failed bill to establish an

throwing medical ethics and the precautionary principle under the bus.

[CITC]: What are the next steps? How do we persist in our quest for answers, truth, and justice?

[DR. KJ]: A royal commission will be a good first step. Ultimately, the public must demand it.

In Covid, we saw doctors who dissented having their clinics raided and medical licenses revoked. All for having dissenting medical opinions and wanting to "First Do No Harm". This draconian response was by and large, enforced blindly by people with no medical training (I am talking about the police, politicians etc).

The price for these doctors and other health professionals for doing the right thing has been unbelievably high. A significant proportion of the medical profession truly believed in the efficacy of the vaccines, but still condoned the silencing of their colleagues. The rest, even if they agreed with the very small number of doctors who dissented openly, chose to remain silent.

The public must decide which approach benefits their health. Currently, the price for doing, what most of us would agree to be the right thing, has been very high.

Will Anyone Admit Fault?

Two years after our health bureaucrats got together and decided it was time to call the pandemic off, we are still none the wiser about what really went on during the Covid years. The entire country was shut down, and we still can't really explain why. People's civil liberties were restricted in a way that would have made a communist dictator blush, yet we still cannot pin-point the exact reasons.

Real world evidence comparing Sweden, where lockdowns were not implemented, with nations like ours – where government panic in my home state of Victoria, for instance, led to police enforced curfews and rings of steel around Melbourne – showed that Sweden actually did better! I co-sponsored a bill with Senator Matt Canavan, and others, to establish a Commission of Inquiry into Covid-19 that would effectively have had the same powers as the Royal Commission that the Australian people deserve. I used my private Senator's time in the last sitting of August to bring the bill up for debate and force a vote. Sadly, Labor voted it down, along with the Liberal leader in the Senate, Simon Birmingham, two other Liberals (Senators Henderson and Patterson), and Senator Tyrrell from Tasmania.

It's sad to see the duopoly in action, blocking the Australian people from the accountability and answers they deserve. Several Liberals, including Senator Birmingham, also sided with Labor earlier that same week to vote against my motion in support of rendering care to babies born alive following a botched abortion.

Democracy and human rights are the real victims of the Liberal/Labor duopoly. If you believe

Green 'De-Banking' is Costing Australians a Fortune

With nearly \$10 billion in profit, CommBank has been abandoning clients that fail to align with the Paris Agreement or do not present a 'transition' plan.

They are not alone. Other banks are doing the same thing, effectively cutting off investment in the assets that make this country – and its people – wealthy.

By refusing to hand out loans to legitimate mining business, banks are 'de-banking' fossil fuel companies and forcing Australia into a 'Net Zero' transition regardless of the merit each investment presents. Meanwhile, the banks keep their eyes firmly shut to the environmental harm caused by their meddling in the energy sector.

As a result, Australia is being left with a pool of companies,

mostly foreign owned, that pursue expensive, transient energy and engage in the industrialisation of our environment under the banner of 'green'.

What banks are actually doing is 'transitioning' their lending base to secure public funds washed through 'green' businesses under the mistaken belief that the government will always cough up taxpayer cash for the loan. They have forgotten Margaret Thatcher's warning about other people's money and what happens when it runs out.

The banks justify this subversion of the economy by laying the blame on 'risk'. It would be 'risky' for banks to back fossil fuel companies, they insist, even though China is the world's largest polluter, and a sizeable chunk of that pollution is being created in pursuit of Net Zero technology. Even though no one suggested it, the banks claim they could be open to legal action if the climate apocalypse comes to pass.

Weirdly they do not want to be liable for any environmental damage created by renewable energy – or slave labour employed in the third world.

Reading the transition statements, the banks are under the impression that they will attract upwards of \$7 billion worth of

'green' investment. This wealth is taken from taxpayers. In contrast, traditional fossil fuel mining projects generate wealth out of the land, creating new money – real money – which is jointly owned by the Australian people. Mining wealth makes a country prosperous, but the banks are ensuring – via their Green Cabal – that their shareholders and customers are denied the gifts of their birth.

It's disheartening to learn how the Big Banks have abused their privileged position in society by keeping Australians locked in a financial crisis and extending their misery for no reason at all. And it is not as if the Big Banks are petitioning investors to engage with nuclear energy which might filter back through Australia's uranium mining industry.

Worse, I am yet to see any of these virtuous banks offer to be legally and financially responsible for any energy grid failures or state-wide blackouts should the fragile green grid go on the blink.

Giant Industry Superfunds, which will very soon have more money than the Four Big Banks combined, have played a similar role in artificially promoting 'green' industries by using money taken from taxpayers without their consent.

It's amazing how much money is washing around in these virtuous institutions, and how little control Australians – the people who actually earned the money and created the wealth – have over how it is spent.

Essentially, Australia's big banks have become a voting bloc with more power than the people

of Australia.

They are funded by the people, but they do not serve the people.

Then they have the nerve to claim that they are 'not profiting off misery'. One thing is for certain, they are profiting off idiocy.

As if it isn't enough to deny Australians their sovereign wealth, the banks are collaborating to end cash. Cash is the true liberator of the people, and the banks are doing everything in their power to end its distribution.

'It's too hard. It's too risky. It's too dangerous. It's too expensive.'

They'll throw away trillions on green investments and then haggle over the dollar and cents in your wallet.

In May, Macquarie Bank said it was 'days away' from going cashless in an announcement that prompted some of its customers to leave.

The Australian Bureau of Statistics (ABS) added that there has been a dramatic drop in ATM use and then conveniently neglected to point out that this is because banks have been closing ATMs, making it difficult for customers to find cash even when they want it.

If the banks can't shut down cash, they shut down branches and the ATMs, so it becomes impossible to withdraw cash. These banks are prepared to sack thousands of workers in the name of 'productivity' and then turn around and insist that they are investing in jobs. The hypocrisy is extraordinary. To them, it's about control. Control over their wealth. Control over your spending and control over profits.

Banking chiefs whisper in the ear of Parliament and send in their 'experts' out like the winged monkeys shrieking into the evening sky after being dispatched by the Wicked Witch of the West.

If the banks are bold enough to tell some of the largest mining companies in Australia to 'go jump' because they do not recite the dogma of the Paris Agreement, what are they going to do to ordinary Australians when there's no cash and no choice?

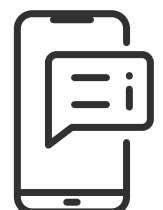

Keep the Sheep: Is there a Globalist War Against the Farmers?

Throughout 2024 there were a series of farmers' protests that erupted across Europe – in Holland, Belgium, France, Germany, Poland, Italy, Greece, Czech Republic and Spain, often with tens of thousands of protestors taking their demands to the streets.

The farmers protested in convoys of tractors conducting roadblocks, even pelting eggs at politicians and dumping truckloads of manure at government premises. The protests were in response to policies like the *European Green Deal*, an EU policy forcing Europe to become carbon neutral by 2050. The farmers were responding to overregulation and restrictions on fertilisers, land, water and fuel in what appeared to be an assault on their livelihoods by centralised control over food production.

More recently, in Australia, 10 September 2024, several thousand farmers descended on the capital including a convoy of trucks in a rally against the government's ban on the live sheep export trade.

The Keep the Sheep campaign

was sending a message to the Albanese Government with thousands of supporters gathering outside Parliament House in Canberra. Spokesman Ben Sutherland stated in a media release "It's a busy time of year for farmers, but people feel so strongly about the government ruining our livelihoods, they came out in force today."

Political commentator and host of *The Ark Podcast*, Joel Jammal, attended the rally and interviewed farmers and politicians alike.

Paul McLaughlin, a fourth-generation farmer from the Northern Territory told Jammal, "It's getting harder to farm in Australia. I've fought fires, I've fought floods, I've fought drought, I've fought banks, but government policies are getting too hard. They keep changing the goal posts and this banning of sheep, live sheep exports is just a pinnacle of what's happening to Australian agriculture."

The Honourable Bob Katter MP who was a long serving member of the National Party before becoming independent in 2001, responded to Jammal's disappointment towards opposition leader Peter Dutton MP and National Party leader David

Paul McLaughlin, a fourth-generation farmer from the Northern Territory.

Littleproud MP, both leaving the rally "five minutes after they finished" making their support speeches at the rally. Mr. Katter stated, "I'm sorry but the whole thing was shanghaied by the LNP [Liberal National Party]".

Katter a longtime supporter of farmers in Australian politics had criticism for all the major parties stating that [in the 1990s]

Labor had "destroyed the wool" industry. Recently in May 2024 Katter slammed the Labor government over its live export ban describing them as "anti-farming" and concluded in his media release with the question for the government, "So, I ask again why do you hate our farmers?"

Organisers of the Keep the Sheep campaign reported that neither Prime

Minister Anthony Albanese nor Agriculture Minister, Julie Collins (who were both invited) came to speak to the crowd.

On a positive note, however, it was reported that some 2000 people had attended the rally and the Keep the Sheep petition had reached nearly 100,000 signatures.

Agricultural Land Sacrificed for Wind & Solar

Australia has a vast landscape, as Australia's national anthem states, 'We've boundless plains to share'. At least that is what we thought.

In regional and rural Australia, there is a shift taking place. The shift to 'renewables'.

In New South Wales, agricultural and grazing land are under threat by Renewable Energy Zones (REZ).

There are five zones declared in the state, including Illawarra, Hunter-Central Coast, South West (Hay) and New England.

The first to be rolled out is the Central-West Orana Renewable Energy Zone (CWOREZ), with an area of 20,000km². The REZ will congest wind, solar, battery and high-voltage transmission line projects within the area, engulfing

the towns of Dubbo, Dunedoo, Coolah, Gilgandra, Mudgee and Wellington.

At last count, local community groups have tallied the CWOREZ to include over 1,000 wind turbines and 9,000,000 solar panels. However, the scope of these 'renewables' projects is not limited to land.

In late July, I was asked to speak at a rally in Lake Illawarra to oppose the offshore project being proposed 20km off their coastline. As I addressed the rally, I stood on stage and looked towards their pristine coastline, unable to comprehend that what is being proposed will be 1,022km². To put that into perspective, Singapore is 735km² and New York City is 790km².

Unfathomably, the Illawarra project is the smallest of six offshore wind projects proposed

by the Australian Government. Southern Ocean Victoria will be 1,030km², Hunter NSW 1,854km², Bunbury WA 7,674km², Bass Strait Tasmania 10,136km². The big kahuna will be Gippsland Victoria at 15,000km². It boggles the mind.

While media focus on concerns of views of the coastline being ruined, there are far greater environmental consequences of offshore wind. Existing American projects have seen a significant increase in whale deaths. While on July 13, a turbine caught fire in Nantucket, resulting in green fibreglass material washing up over their coast.

Why do we need offshore wind in the first place, you might ask?

A now 'removed' report by the Victorian Government admits to the rationale. Published in March 2022, the 'Offshore Wind: Policy Directions Paper' argued why the Victorian Government could not

only rely on onshore wind and solar, but also needed to embrace offshore wind. Pages 18 and 19 detailed their argument.

'Analysis indicates that to meet net-zero targets using onshore renewables could require up to 70 per cent of Victoria's agricultural land to host wind and solar farms.'

The paper goes on to say: 'achieving full energy decarbonisation with only onshore renewables is an implausible prospect'.

A figure provided in the paper states that Victoria has ~127,000km² of agricultural land, 70% of that would be 88,900km², or roughly the size of Serbia.

Of course, all these wind and solar projects rely on components that come from overseas.

Australia has abundant energy reserves, yet we are shipping those resources offshore so that other countries can benefit from the cheap

energy they provide. Meanwhile, we are importing their unreliable and expensive wind and solar components.

Worse still, we are installing these industrial-scale wind and solar projects on valuable agricultural and grazing land, off our pristine coasts, or in sensitive biodiverse areas.

Despite this, it's all 'out-of-sight and out of mind' for city people. City parliamentarians have jumped on the bandwagon. We need to 'catch the new wave' and 'champion a new economy' they claim.

Unfortunately, our valuable agricultural land is 'un-renewable'. Our food security is at threat if agricultural land is consumed by industrial scale wind, solar and high-voltage transmission line projects. Once it is gone, it is gone for good.

Australia's Misinformation Bill, Musk and Freedom of Speech

Elon Musk, the US billionaire and owner of the social media platform X, recently responded with one word to describe the proponents of Australia's laws to censor the internet – he simply called them "fascists". Australian Labor politicians hit back with retaliatory name calling, defending their proposed bill on combatting online misinformation and disinformation. These laws proposed, powers the government's communication watchdog to censor and monitor the internet and the government now is hoping to get them enacted in

parliament by the end of 2024.

Censorship, however, has always been recognised as a central tenant for totalitarian regimes whether fascist or communist in nature. In the 1930s iconic photographs of Nazi book burnings emerged, documenting clear examples of government censorship, highlighted further by references in popular culture to Orwell's 1984 novel and his warnings on Big Brother (totalitarianism).

Today, some 70 years after the end of World War II, there appears no end to the controversy of controlling public information by government. The book burnings of 1930s Germany draws parallels with this modern version of 'internet

censorship' and Musk's one word description of the Australian Labor government (fascists) may indeed be close to the truth. I am reminded of a famous quote by the German poet, Heinrich Heine, who in his 1821 play *Almansor* wrote, "That was but a prelude; where they burn books, they will ultimately burn people as well."

A more contemporary warning about this proposed bill can be found in the September 2024 parliamentary speech by Russell Broadbent MP as transcribed below. Mr. Broadbent describes Labor's misinformation bill as "unprecedented and unacceptable" and his opening words are a stark warning for Australia.

Unprecedented and Unacceptable

■ *This article is a transcript of a speech by Russell Broadbent – MP Federal Member for Monash delivered in the House of Representatives on 12 September 2024.*

Today is a dark day and one that does not bode well for the nation. The government's so-called combatting misinformation bill marks the beginning of the end of free speech and democracy in Australia. Make no mistake, this bill is another alarming example of overreach and a step towards government tyranny about what we can and cannot discuss. It gives the government unfettered power and control over Australians and their right to exchange ideas, thoughts and opinions. Do you realise what we're risking here? Free speech is the bedrock of democracy, and as Benjamin Franklin said, there is no such thing as public liberty without freedom of speech.

The bill compels digital platform providers like X and Facebook to censor content that may contribute to serious harm. But who makes that decision? Who's the arbitrator of truth? One of the bill's definitions of content that may cause serious

harm, is content that may cause serious harm to 'public health in Australia, including the efficacy of preventative health measures'. Where have I heard those words before? Why don't they just say misinformation is whatever discussion or debate goes against the narrative of the government of the day? Because it appears that anyone with a view that's contrary to the government's narrative is going to be in the firing line, just like during the pandemic, when our government, the government I was a part of, censored 4,000 social media posts as misinformation, many of which proved to be absolutely true.

I'm not alone in my concerns. In giving feedback on the original exposure draft, the Law Council rightly outlined concerns that digital platform services lack the expertise and resources to identify and distinguish misinformation and the Human Rights Commission, who were missing in action during the pandemic, said the bill didn't strike the right balance between censorship of objectively untrue content and protection for freedom of expression. It seems this final

bill hasn't adequately addressed either of these legitimate issues, so why is it being rushed through? I agree with Dr Phillip Altman, a pharmacologist with 40 years' experience as a clinical trial and drug regulatory affairs consultant, who believes the biggest pedlar of misinformation during the pandemic were the government and unelected health bureaucrats.

That's because they: falsely claimed that the experimental gene based mRNA injections were safe and effective when this was not supported by the available evidence, even from the pharmaceutical companies themselves; falsely claimed the senseless vaccine mandates would help stop transmission when they were never tested for that; falsely claimed the COVID injections would keep you from getting COVID, getting seriously ill or going to hospital; falsely claimed masks prevented transmission or infection; falsely claimed it was a pandemic of the unvaccinated; falsely claimed that early treatments were unsuitable; falsely claimed that there was no clinical evidence to support

ivermectin or hydroxychloroquine in the treatment of COVID-19 and worst of all the vilification and censorship of doctors, academics and scientists who raised the alarm about the safety of the vaccines.

But here's the rub. Professional news services – mainstream media – are excluded from this bill so they can lie or cause harm without fear of repercussions. Anyone see a big red flag here? Based on what I've observed over the last nearly five years, is deliberate suppression of information by the media that I find most sinister. For example their failure to disclose the vested interests of so-called health experts, expert committees and institutions providing public advice; failure to report on the doctors and health practitioners being deregistered and suspended for daring to disagree with the government's narrative; failure to put pressure on the government to reveal the contractual arrangements with vaccine manufacturers; failure to ask about the estimated 30,000 excess deaths since the rollout of the jabs; failure to hold the TGA [Therapeutic Goods Administration] accountable for

failing to investigate the more than 140,000 reports of adverse reactions to the jabs; failure to highlight the minimal to near zero risk of COVID-19 in the young versus the risk to the elderly; and, most heinously, the failure to cover stories of the vaccine injured, including the thousands of injured Australians who aren't even eligible for compensation because of illogically narrow eligibility criteria.

We're constantly assured that the science is settled and bombarded with propaganda to follow the science, but surely this dogma has no place in science. Surely our doctors, academics, scientists must be free to ask questions about assertions and debate issues. These are truly unprecedented times, 25 years in the parliament, I've never seen legislation like it. This is not the country I grew up in, and it's heading in a direction that I fear for future generations. Today I urge Australians to stand up and speak out on this bill while you still can.

My first recollection of seeing Aaron Malloy was at a freedom rally in Perth, Western Australia. A crowd of several thousand people had gathered outside Dumas House, the office of Mark McGowan, who was then Premier of Western Australia.

The boisterous yet peaceful crowd were protesting the Covid-19 lockdowns; the MC was Aaron Malloy who was larger than life – leading the way in a suit and brandishing a microphone.

On the sidelines was a news crew, a presenter and videographer from one of Perth’s mainstream media (MSM) outlets. In a booming voice Malloy pointed towards the news crew, “These are the spin doctors, ladies and gentlemen!”

The crowd went wild unleashing a cascade of boos and expletives directed at the MSM. The news crew stood there looking uncomfortable and this was the first time I saw the degree of contempt people had for the MSM.

It was all peaceful of course but the message of how people felt about the role the media played in

The Dumas House rally was in 2021, and Aaron would go on to host dozens of freedom rallies throughout 2021 – 2023.

Now, in September 2024 I

caught up with him at his new studio – Edge Radio Australia, located in Perth, Western Australia.

Edge Radio Australia had just acquired its FM radio licence so what better time I thought, to catch up with the man himself to congratulate him on his recent achievement.

Aaron greeted me at Edge Radio Australia studio wearing his signature Hawaiian shirt

and fedora hat, naturally we commenced our catch-up with a few whiskeys.

I had known Aaron throughout the lockdown period, we reminisced about the good times and the bad, like when the cops raided multiple venues for so-called breaches of ‘covid mandates’.

The Sixty30 Tavern in Merriwa, WA, was raided numerous times as was Topolinis Caffe in Warwick,

WA, which saw the owner and her daughter arrested for breaching so-called ‘vaccine passport orders’.

We were both there and witnessed the insanity. Aaron recalled the massive rally held in November 2021 at Forrest Chase where the police officer in charge told him there was some “57,000” people in attendance and that it was the largest rally in Perth’s history “since the Vietnam War.”

Aaron was particularly excited, however, about the expansion of his radio station. While Edge Radio Australia had always been streaming on the internet 24 hours – 7 days a week, it had recently acquired an FM public radio licence. The shows and podcasts on Edge Radio Australia continue to run 24 hours and Aaron says he finds himself working “seven days a week.”

While his station covers music and various cultural, social and political shows – he says he will always champion “free speech” and never give up being a “freedom fighter.”

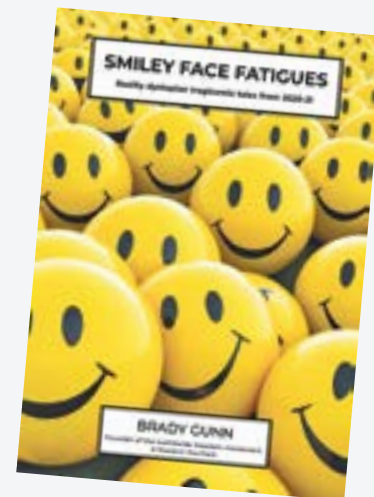
