Australian Local Government Calls for Suspension of Covid mRNA Vaccines

In a surprise move, the local government of West Australian mining town Port Hedland is calling for immediate suspension of the Moderna and Pfizer Covid vaccines pending an investigation into evidence of excessive levels of synthetic DNA in the shots. At a special meeting on Friday 11 October, Port Hedland councillors voted five-to-two in favour of notifying all of Australia's 537 local councils of the evidence of the DNA

contamination in the vaccines, and associated risks. "We are gravely concerned about the potential health risks posed by synthetic DNA contamination, including the dangers of genomic integration, cancer, hereditary defects and immune system disruption," said the letter, a copy of which was sent to councillors around the country following the vote. Letters were also sent to every health practitioner within the Port Hedland area strongly urging them to share this information with patients contemplating receiving any Pfizer or Moderna Covid modified-RNA (mod-RNA) vaccines.

The Port Hedland Council joins federal MP Russell Broadbent in calling for the suspension of the vaccines until an urgent

and thorough investigation has been carried out into the DNA contamination matter. Port Hedland Councillor Adrian McRae, who brought the motion, said that he hoped the vote "will be the ripple that creates a bigger wave across the country, and perhaps the world" on the issue of Covid vaccine safety.

The move comes after independent testing of Australian vials of Moderna and Pfizer Covid vaccines, by Canadian virologist Dr David Speicher, detected residual synthetic DNA at levels up to 145 above the regulatory limit. Independent studies in Canada, the US and Germany had previously tested the mod-RNA vaccines and found excessive levels of DNA, which is a byproduct of the production process and is allowed in amounts

of up to 10 nanograms per dose under international regulations.

In the Pfizer vaccine there is a DNA sequence called the SV40 enhancer/promoter, which is known for its utility in gene therapies to drive DNA into the nucleus of cells. The SV40 enhancer/promoter (not the same as the SV40 virus) was discovered in the Pfizer vaccine in 2023 by genomics scientist Kevin McKernan and has since been acknowledged by regulators including the Therapeutic Goods Administration (TGA) and Health Canada.

Responding to these findings, Florida Surgeon General Dr Joseph A. Ladapo petitioned the Food and Drug Administration (FDA) to halt the Covid mod-RNA vaccine program in December last year. However, both the FDA and the

TGA deny that the vaccines contain high levels of DNA or that the synthetic DNA poses any safety risks, including the SV40 enhancer/promoter. In a statement released after the Port Hedland council vote, *Continued on page 2*



The TGA said that it was aware of "misinformation" in recent reporting of the contamination issue, and that findings of high levels of residual DNA in the mod-RNA vaccines are "not robust or reliable, and are creating confusion and concern regarding the safety of vaccines."


But the TGA did not provide any evidence to support its claims or refute the work of independent scientists on this issue. At the same time, the TGA mischaracterised this work and omitted some key, but inconvenient facts from its statement. The TGA claimed that it

go to every major organ system in the body (according to Pfizer's biodistribution data) and enter the cells (according to the Office of the Gene Technology Regulator). And the regulator did not address the presence of the SV40 enhancer/promotor at all.

West Australian Premier, Roger Cook, slammed the Port Hedland Council for passing the motion to alert Australians to the DNA contamination issue, telling the press that the council had gone "off the rails" and "should stick to its knitting." But Port Hedland residents who attended the special

and prepare treatment pathways for the inevitable rise in vaccine-induced conditions," he said.

The motion to warn Australians of the DNA contamination in the mod-RNA shots was supported by Councillors Adrian McRae, Sven Arentz, Lorraine Butson, Camilo Blanco, and Deputy Mayor Ash Christensen. It was opposed by Mayor Peter Carter and Councillor Ambika Rebello. Cr Blanco, who formerly served as Port Hedland Mayor, said he was inundated with calls from other local government areas after the Port Hedland Council motion was passed. "I've been



has independently tested 27 batches of mod-RNA vaccines for residual DNA levels and found them to be compliant. However, no one can verify this, because the TGA fully redacted the results when a Freedom of Information (FOI 4558), compelled their release.

The TGA misleadingly criticised the use of a testing method called fluorometry in some studies, but ignored the evidence of excessive DNA using qPCR, which is the TGA's preferred method for testing residual DNA levels. The TGA failed to address the implications of residual DNA being encapsulated in lipid nanoparticles (LNPs), which

meeting implored the council to take action, as did internationally lauded Professor of Oncology, Angus Dalgleish, in a recorded address in support of the motion. Professor Dalgleish, who previously sat on the scientific board of mRNA technology company CureVac, said he had seen an upsurge in aggressive, fast-progressing cancers in his oncology practice amongst patients who had received Covid vaccine boosters, particularly colorectal and blood cancers. "We need our health authorities to begin monitoring these trends, develop testing protocols for those exposed to synthetic DNA contamination,

contacted by so many councils that are ready for this," he said. "They can't just ignore this. We want genuine answers."

A website has been assembled by a group of volunteers with all the Port Hedland Council motion information, and resources to equip Australians to take the matter up with their own local governments.

The Christmas Truce of 1914: Reflections “On War”

Carl Von Clausewitz famously described war in its most ‘realist’ of terms, as “War is the continuation of politics by other means.” The renowned Prussian General and military theorist began his career as a corporal and his *magnum opus*, “On War” was written in the aftermath of the Napoleonic wars, the clash of 18th Century European Empires. In 1914, World War I (then known as the Great War) would follow from this clash of empires resulting

in millions of casualties. For Australia and New Zealand, the Great War foresaw Gallipoli being etched in their history where over 11,000 Anzacs died in western Turkey where Winston Churchill would be demoted for his role in what would be a failed campaign.

During Christmas in 1914 on the Western Front however, a series of remarkable and unofficial Christmas Truce’s emerged with British, French and German troops putting down their arms and meeting in no man’s land – sharing gifts, alcohol and playing football. Reports and letters spoke of this break in warfare describing enemy

soldiers conversing in no man’s land, singing carols and lighting candles from their trenches. This ‘peace’ was short lived however, and by the end of the Great War there were 22 million dead and

20 million wounded. World War II would follow in 1939 with 70 – 80 million military and civilian casualties.

Today in 2024 some pundits are professing we are already in

the throes of World War III with geopolitical conflicts and proxy wars waging across the Middle East, Ukraine, Russia, Africa and Myanmar (Burma). The sabre rattling also continues with talk of the West and China being ‘destined for war’. It seems war is an inevitable human condition, and I can picture those troops from Christmas 1914 being ordered back to their lines by their officers, where soon the whistles would blow and over the top they would go in waves to wholesale slaughter by bullets, bombs, poison gas and bayonets. Those spontaneous truces of 1914 prove that the human spirit exists but also that the collective consciousness can override the individual. If only the geopolitical forces today could end the wars and like those men of 1914 wander over their trenches and barbed wire in peace towards their so-called enemies. Japan Rising: The International Crisis Summit 6

In September 2024 she attended the International Crisis Summit held in Japan, a global forum of medical, legal and other professionals addressing issues concerning COVID-19.*

The Japanese are very polite, respectful, obedient, family orientated people. They go to great lengths to avoid conflict and will quietly conform rather than step outside acceptable social norms. It has therefore been incredible to see images earlier this year when thousands of Japanese citizens rallied together to protest against the World Health Organization's (WHO) pandemic treaties. To me, this indicates a very real disquiet is percolating if the people of Japan are willing to break protocol and rise up to reclaim democracy.

Accordingly, there was no better place for The Grassroots Association to hold its 6th International Crisis Summit (ICS6) than at ground zero: Tokyo, Japan, on the eve of the country's rollout of the new self-replicating RNA-LNP injections for COVID-19 (called Replicon) to its senior citizens.

Regular attendees of the previous five ICS series include stalwarts such as MEP Christine Anderson, Dr Robert Malone, Dr Ryan Cole, Dr Jessica Rose, Associate Professor Byram Bridle and Dr Meryl Nass. Newcomers to this event this year included former WHO scientist Dr David Bell, viral immunologist, oncologist Dr William Makis, political commentator James Lindsey alongside Japanese expert in immunology Professor Yasufumi Murakami, historian Mr. Chikatsu Hayashi and Professor of dermatology Shingetoshi Sano (and three other Japanese doctors).

I had the privilege to be invited to the ICS6 representing both Australia and New Zealand and just one of only two lawyers, the other being US attorney, Dr Simone Gold. Presenting on the four court cases in Australia and New Zealand that I have been involved with in seeking to halt the roll out of the COVID-19 mRNA gene therapies to our healthy children and babies. I also reported on the excessive DNA contamination recently discovered in the Pfizer and Moderna vials

sourced from Australia (including in a Pfizer child's dose) in the GMO case against Pfizer and Moderna. The ISC6 was held over four jam-packed days with the 28 experts attending a number of key events.

On Day 1 a closed door think tank session was held where we discussed how to affect change and educate the public in light

of these new Replicon RNA injections for the JN.1 strain of COVID-19. The new Replicon RNA injections are concerning. They are similar to the mRNA injections previously rolled out en masse for COVID-19, however, these ones *self-reproduce*. They are designed to be 'more efficient' than traditional mRNA vaccines

by setting up a "biological factory" in the body to continually produce the 'desired protein'. Last year, Japan's Ministry of Health, Labor and Welfare approved the first Replicon vaccine, the ARCT-154, developed by American biotech firm Arcturus Therapeutics in partnership with Australian vaccine manufacturer CSL Seqirus.

It has therefore been incredible to see images earlier this year when thousands of Japanese citizens rallied together to protest against the World Health Organization's (WHO) pandemic treaties.



Day 2 saw us each having 10 minutes to present to the Japanese public. Where on Day 3 we made similar presentations to the Japanese Government. The government structure in Japan is an imperial democracy, not too dissimilar from our own. In the presentation to the Japanese House of Representatives, Dr Ryan Cole discussed the hijacking of health by regulators and Big Pharma. Canadian oncologist, Dr William Makis described the dramatic increase in turbo cancers he is witnessing in younger and younger patients since the global rollout of the COVID-19 mRNA injections began. Dr Jessica Rose provided a jam-packed presentation focused on the new Replicon RNA platform.

Day 4 was where it all came together with a 30,000 people strong rally! Who better than to open the rally on that Saturday than European Parliamentarian, Christine Anderson, with the war cry and bold reminder that democracy "is by the people, for the people". Anderson, who was a longtime opponent of the unethical COVID-19 mandates rallied the 30,000 strong crowd in Tokyo's Rinkai Park.

Also speaking at the rally was Mr Jason Christoff, who spoke on how to recognise and navigate propaganda, Dr Alejandro Diaz spoke on the importance of upholding and protecting our individual freedoms. The recent events in Japan give me immense hope that positive change is coming. Since Japan's rally against the WHO's pandemic treaties in May to those attending the ICS6 rally in September the numbers have multiplied. Japan rising is a testament to all of us the fact the Japanese like others around the globe know that democracy is theirs to reclaim.

Immoral MAD Bill Withdrawal

After significant opposition, on 25 November 2024 the Australian government withdrew the *Combating Misinformation and Disinformation [MAD] Bill 2024* which aimed to address the spread of 'harmful' misinformation and disinformation on digital platforms. The government is now seeking alternative solutions. *The Light Australia* asked The Hon. John Ruddick for his thoughts.

The Albanese government's 'Misinformation and Disinformation Bill' was the greatest threat to this nation since the Bombing of Darwin. This bill was immoral. The state should not have the power to prevent an individual speaking their mind. This bill sought to eliminate 'misinformation' by empowering a government agency to determine what misinformation is and penalise the 'spreaders of misinformation'. Dangerous!

Minister for Communications Michelle Rowland's introductory speech for the bill didn't mention a single non-government entity that had asked for this bill. Minister Rowland referred to concerns about misinformation and disinformation from the Australian Media Literacy Alliance (AMLA) and the Australian Communications Media Authority (ACMA). AMLA's membership consists of government-funded entities like the Australian Broadcasting Corporation (ABC)

and the Special Broadcasting Service (SBS).

I was concerned at the presence of AMLA in proximity to this bill for two reasons. Firstly, the ABC's own misinformation regarding the alleged war crimes of Heston Russell which were exposed by a 7NEWS Spotlight program as being doctored by ABC

sound engineers. Secondly, the bill called for mandatory media literacy requirements of social media companies, the presence of AMLA in the drafting of the bill was a conflict of interest given that their primary role is the teaching and certifying of media literacy.

ACMA are not an independent government agency, they are at the behest of the Minister. This bill would have empowered ACMA into being a de-facto Ministry of Truth. I am disturbed at this rapid, unrelenting encroachment on liberty. I remain unconvinced there had been sufficient consultation on this bill in the public arena for such significant legislation. This bill had no social license. On the 23rd of September the Australian community was given a deadline of seven days to digest all 73 pages of this bill and provide submissions if they should so choose to. Why?

I continue to question and criticise the unknown urgency of this bill. As a member of parliament, I have provided submissions to inquiries. A rushed timeline is three weeks, but the government allowed one week for submissions, this undermined interested parties in their ability to provide evidence and called into question the legitimacy of the legislation. I opposed the bill.

Australia Cancels Candace – Censorship, Digital IDs, Social Media Bans – What's Next?

On 27 October 2024 Australian Immigration Minister, Tony Burke, denied the world-famous political commentator Candace Owens a visa to enter Australia. This measure halted her November 2024 tour of Australia and New Zealand, though legal appeals were immediately launched, and the tour is now postponed until 2025. The reason given for her Australian ban by the Minister is that she has the "capacity to incite discord" and "Australia's national interest is best served when Candace Owens is somewhere else". Hopefully this selective discrimination of one person by one other person (primarily) the immigration minister will be repealed, and she will be allowed to visit the so-called Lucky Country. After

all, this popular (American born) political commentator has over 20 million followers on social media platforms.

Admittedly Owens is a controversial political commentator and is often at the forefront of discussions on cancel culture and free speech, criticising the excessive influence of liberal ideologies and the effects cancel culture has on freedom of expression. As a champion of free speech, she remains steadfast we should protect freedom of expression, even those views that might be considered offensive, controversial or heaven forbid, hurt someone's feelings. With millions of followers on worldwide social

In Australia, despite the national anthem's proclamation of unity and freedom, the resistance to her speaking tour is evidence of an ongoing assault on free speech.

On 1 December 2024 the Digital ID bill takes effect

in Australia claiming to be voluntary of course, but many suspect 'voluntary' will lead to 'compulsory'. Senator Malcolm Roberts states, "The government knows Digital ID will be compulsory by the device of preventing access to government services, banking services, air travel and major purchases for any Australian who does not have a Digital ID". Furthermore, the Australian Labor Government has announced plans to ban under-16-year-olds from using social media. How this will be done is not exactly clear, but the Albanese government stated the planning stages are under way. Implementation undoubtedly includes online bio-metric facial recognition and critics easily see this as a Chinese communist style of social credit score and internet license. These methods are hallmarks of totalitarianism and in September 2024 Elon Musk

described Australia's Labor Government's attempt to control the media in an X post with one word, he simply called these politicians "Fascists". Senator Malcolm Roberts also draws a similar analogy about this attempt at Big Brother control, "There will be no escape from the digital ID. Australians now have a digital version of 'papers please' and Australians will never be the same." Let's hope these measures leading us closer toward an Orwellian future can be defeated.

Climate Models Threaten Home Ownership

Detailed plans are in place to use worst-case scenario computer modelling of climate change to push Australians out of their homes. Our governments are creating conditions for a perfect storm, and it may look like this – *your town has a climate forecast overlay on it, costly mitigation strategies need to be implemented so your rates and levies go up.*

As climate change is a “wicked problem” – meaning no matter what measures are put in place it will never be enough – there will be trigger points where “managed retreat” needs to occur. Private home ownership will then be at the mercy of the government, their private partners and whatever climate change modelling they choose to use. The precise measures quoted here are mainly from New South Wales (NSW) government documents but some of the planning is federal and this is a global project framed under [United Nations] Agenda 2030 and Sustainable Development Goals.

Managed Relocation – Retreat

The NSW Disaster Mitigation Plan 2024 – 2026, released in February 2024, discusses large-scale managed retreat, defined as: the permanent and purposeful movement of people and existing homes and infrastructure exposed to existing or anticipated effects of natural hazards.

It is pre-emptive – before a disaster hits, and relies on extreme climate modelling. The plan uses “multi-hazard modelling.” Different models are used to come up with the most extreme rankings for different risks, such as fire and flood, then added up for a total score. The International Panel on Climate Change (IPCC) high emissions pathway of 8.5 is used for modelling, the most extreme model, and not intended to be used for climate change decision making.

Major relocations are envisaged: “These programmes aim to move a number of people and keep those people together in their community.” How about

a nice new apartment tower in a 15-minute city? Here is a new field for private investment. “There may be potential opportunities to leverage private sector funding to assist in managed relocation, for example, using potential planning mechanisms such as transferable development rights to provide incentives for intervention by the private sector.” Put simply, corporations can pay for people to be moved out of their homes, and they will receive the land in return.

The NSW Reconstruction Act 2022 allows the Minister to declare areas of the state a disaster area for primary or secondary reasons, “if the Minister is satisfied the declaration is necessary to help prevent or mitigate against potential disasters for a community.” Once an area is declared a disaster prevention area the Reconstruction Authority can compulsorily acquire properties, do what they like with the properties and sell them.

Under the guise of climate change, asset shifts (upwards) will occur incrementally, and the rights of homeowners will increasingly diminish.

Broke Governments and Privatised Infrastructure

The Disaster Mitigation Plan calls for engagement with the private sector “to prioritise and coordinate place-based infrastructure resilience intervention.” Larry Fink, BlackRock founder and CEO, spoke about local government’s financial woes when he was reported in the Financial Times article, *BlackRock to Buy Global Infrastructure Partners for \$12.5 billion*, “The global need for infrastructure combined with high deficits constraining government spending creates unprecedented opportunity for private capital to invest in infrastructure” Fink said.

Lack of funding for essential public works is a common complaint around Australia and is laid out in the report of the Local Government NSW Inquiry into the ability of local governments to fund infrastructure and services. “Most councils are reporting a deterioration in their financial

position and many fear that they are financially unsustainable or approaching unsustainability... Smaller rural and regional councils are the most vulnerable.”

The Federal National Adaption Plan Issues Paper of March 2024 states: “If private capital is shifted towards adaption and resilience, investors can secure their assets, unlock new investment opportunities” and “There is also a need for government initiatives that incentivise private investment in adaption.” In plain language, we will be paying private corporations for new and existing infrastructure and private corporations are going to have a big say in whether they want to keep up infrastructure to certain towns. This is an asset and wealth transfer and has serious implications for private home ownership.

The direction of these measures is all one-way, as it is with other areas such as insurance and energy ratings to be described in future articles. It is all leading to higher costs for homeowners and renters, and a boon for corporate entities. The government will “incentivise” private capital through “de-risking” investments and giving financial kickbacks to corporations. The government will “incentivise” the public to oblige with increasingly punitive financial obligations or just remove people from property.

Under the guise of climate change, asset shifts (upwards) will occur incrementally, and the rights of homeowners will increasingly diminish. Whatever your position on climate change, it’s imperative that the financial and climate modelling, the proposals and plans and the asset transfers (who are the winners and who are the losers) are extensively scrutinised.

Big Tech Has Called It Quits on Renewable Energy

Google, Amazon and Microsoft have concluded that weather-dependent wind and solar, and dubious energy storage solutions like pumped-hydro and batteries, are not up for the job. This is a big shift for Big Tech companies because they were on board with the renewable energy grift for years. They were all committed to net zero emissions. They were installing solar panels on their factory roofs. They were buying carbon credits to offset their emissions. They were building wind farms in all corners of the planet.

However, now Big Tech has had an AI-driven reality check. Right now, there is a global race to build AI data centres that span the United States, Russia, China and India. Without data centres, there's no Chat GPT, there's no Microsoft Azure, there's no Google Gemini, and there's no new-age internet. The problem faced by Big Tech is that the data centres they need to drive their new suite of AI products are remarkably energy intensive. A single large data centre can require the same amount of energy as 50,000 homes, and they're being rolled out at light speed. To put it another way, one

search using the AI platform ChatGPT consumes almost ten times the amount of electricity as a simple Google search.

As a result, Big Tech's demand for electricity is exploding, and Big Tech has been forced to confront the question: where is all this new energy going to come from? Big Tech have had thousands and thousands of engineers crunch the numbers. Engineers have concluded that nuclear power is the only way to produce enough cheap, stable, zero-emissions electricity to keep up with the exploding demand for electricity from AI data centres.

That's why Google has just done a deal to purchase power from seven small modular nuclear reactors that will deliver the first power by 2030. It is why Microsoft has secured the full output from the massive Three Mile Island nuclear plant in Pennsylvania which will restart in 2028. It is why Amazon has bought another nuclear-powered data centre in Pennsylvania that will come online soon. This is just the beginning. Analysts in this space predict there are many more of these nuclear power deals to come.

Just ask Sam Altman, the man who created Chat GPT. Currently, Sam Altman is spending hundreds of millions of dollars to develop small nuclear plants. He says that without

nuclear power, we have no chance of reaching net zero emissions in a new world defined by energy-intensive AI capabilities.

Wall Street agrees. According to Bloomberg, nuclear power and uranium funds are now larger than all other "clean energy" funds combined. The writing is on the wall. The smart money has already made their decision, and as per usual, the political class and their bureaucrats are lagging. Canberra still seems to think that weather-dependent wind and solar, and ridiculous energy storage solutions can power an industrial grid, even though it's all falling apart.

Right across the world, people are rallying against offshore wind because of the impact the monstrosities are having on the natural beauty of coastal areas and the marine creatures that call the waters home. People are no longer buying the idea that renewable energy is the cheapest form of energy because their power bills continue to rise as more and more renewables enter the grid. People have become more and more aware about the high-risk nature of batteries as more and more videos surface of terrifying battery fires that can't be extinguished with water.

Meanwhile, pumped hydro projects are falling over like dominoes. The

cost of the largest pumped hydro project in the country, Snowy 2.0, is now twelve times more than what Malcolm Turnbull promised. Recently, Queensland Hydro has just admitted that the Pioneer-Burdekin pumped hydro project is "not commercially viable." The government body says the project will now cost up to \$27 billion, which is double what Labor said it was originally going to cost. Queensland Hydro admits the project will "fail to recover its significant capital investment through revenue".

This is a big deal because the government touted the monstrosity as the "only option" to guarantee energy security in Queensland as the state transitions to renewables. That is why Prime Minister, Anthony Albanese, endorsed the project as "visionary".

But now it's dead in the water.

The short point? Reality has caught up with the renewable energy grift, and nuclear power has come out on top. Unfortunately, the Albanese Government has gone all-in on renewables. That means it's unlikely they will backtrack and admit they were wrong about nuclear energy. Although Peter Dutton, the Leader of the Opposition, and his inner circle have the guts to push state-owned nuclear, it's unclear whether he's able to hold the pro-renewable moderates who control his party in New South Wales at bay. Let's hope he can.

In New South Wales (NSW), dedicated local groups, Coalition Against Offshore Wind Community Forum, No Offshore Wind Farm for Illawarra and No Offshore Wind Farms Illawarra, fought hard against Australian renewable energy company, OceanEx and Norwegian Company, Equinor for the Illawarra Offshore Wind Turbine (OWT) project to be stopped. Together, they deserve a hearty congratulations for their victory.

On 15th October 2024, Equinor announced they will not proceed with the Illawarra OWT project sighting that "longstanding

community resistance" was part of their decision, indicating 'no social licence' and are now focusing on NSW Port Stephens /Newcastle 'Hunter' OWT project and Western Australian Geographe Bay / Bunbury OWT project.

Communities between Newcastle, Port Stephens, and Myall Coast are well prepared for the battle to stop what can only be described as a "Floating Industrial Experiment", as the proposed deep-water 300+ floating wind turbines will be the largest project in the world. Local groups Save Myall Coast Save Port Stephens, No Offshore Turbines Port Stephens, Port Stephens Newcastle Against Reckless Renewables and Stop the Wind Farms have been instrumental in bringing 2,000 community members together, attending meetings in Canberra with community engagements clearly showing no community support or social licence for OWT in the

Hunter zone.

This industrial experiment threatens the Australian east coast's marine environment and ecology, professional and game fishing, whale populations and coastal communities' economy. Recent blade failure off the United States' east coast has illustrated the level of widespread debris pollution and seriousness of long-term impacts from fibreglass, per- and polyfluoroalkyl substances (PFAS) and micro plastics.

Looking to Western Australia, a massive area of 4,000 km² has been proposed expanding across international tourist meccas Dunsborough, Busselton, Bunbury, Binningup and the entire Geographe Bay area. The Copenhagen Energy/ Leeuwin OWT zone is situated directly within the migratory paths, birthing, and nursing zones of threatened and endangered whale species and vital fishing habitats; no social licence is given here!

Don Punch, Minister for Fisheries

stated, "OWT are not feasible in the foreseeable future" and Copenhagen Infrastructure Partners allegedly, in a stakeholder meeting stated "OWT are not viable." The City of Mandurah publicly announced in May 2024 that it does not support Skyborns OWT project due to major environmental impact concerns. In June 2024 Deputy Mayor, Anne Ryan released a statement to the Busselton Times, saying they are standing with electors and community members with major environmental concerns, in addition to the impact on tourism and businesses. On 30 August 2024, the 'Bunbury zone' was declared by Minister for Climate Change and Energy, Chris Bowen, from behind chain mesh



fences after enormous backlash from the community including #saveourbelovedgeographebay. Furthermore, there's also the chaotic array of Green Washing projects proposed for Kalbarri (a topic for a future article). 

The TGA: Is It a Guardian of Australia's Health or Aiding Pharmaceutical Profits Over Public Safety

The Therapeutic Goods Administration (TGA), Australia's primary regulator for ensuring the safety of therapeutic goods, has come under severe criticism for its apparent failure to safeguard public health in its oversight of COVID-19 vaccines. In particular, the TGA's handling of alarming evidence regarding DNA contamination in mRNA vaccines has raised serious ethical and scientific concerns, casting doubt on whether it is truly acting in the best interest of Australians – or in the interests of pharmaceutical giants like Pfizer and Moderna.

TGA's Dismissal of DNA Contamination Claims: A Deflection of Responsibility

In its October 2024 media release, the TGA addressed widespread concerns about DNA contamination in mRNA COVID-19 vaccines, labelling these reports as "misinformation". The agency stated, "We are aware of misinformation in recent media and online reports that

claim the COVID-19 mRNA vaccines are contaminated with excessive levels of DNA. This is not the case." The TGA went on to dismiss the findings of independent laboratories that revealed dangerous levels of DNA contamination in the vaccines, claiming these studies lacked the necessary scientific rigor.

However, such an outright dismissal fails to consider the detailed and methodical research conducted by independent experts, including Dr. David Speicher, whose findings provide substantial evidence of contamination far exceeding acceptable safety thresholds. Contrary to the TGA's reassurances, Dr. Speicher's report revealed that DNA contamination in Pfizer's COVID-19 vaccines exceeded the TGA's own regulatory limit of 10 ng/dose by up to 145 times. This contamination included not only residual plasmid DNA but also the SV40 promoter, a sequence known for facilitating genomic integration – an alarming risk that the TGA has completely ignored.

Scientific Rigor vs. Regulatory Capture: The Role of the TGA

The TGA's response to these

concerns highlights a deeper issue: its close relationship with the pharmaceutical companies it is meant to regulate. Vaccine manufacturers, including Pfizer and Moderna, provide much of the data that the TGA uses to approve and monitor vaccine safety. This dependency creates an inherent conflict of interest, raising critical questions about the TGA's objectivity.

Dr. Speicher's report underscores this point by revealing how thoroughly his research was conducted, despite the TGA's claims of methodological flaws. His tests used both Qubit® fluorometry and quantitative PCR (qPCR), ensuring accuracy and repeatability. Results showed that the total DNA in Pfizer vaccine

samples ranged from 434 ng/dose to 2,803 ng/dose – far exceeding the TGA's limit of 10 ng/dose. These findings were not only consistent across multiple batches but also confirmed the presence of SV40 promoter-enhancer-ori, a sequence not disclosed to regulators and known to promote nuclear localization, increasing the risk of genomic integration.

The TGA's dismissal of such scientifically sound findings reflects a troubling pattern of regulatory capture, where the agency, rather than acting as a watchdog for public health, has become an enabler of pharmaceutical profit.

The WHO Pandemic Treaty: Defeated Again

The Pandemic Treaty is the fourth and last of the international treaty documents the United Nations and its health branch, the World Health Organization (WHO), have been working on since May 2022 in the name of pandemic prevention, preparedness and response. The reason the WHO gave for the need for a Pandemic Treaty was described in its June 2023 draft to be “in recognition of the catastrophic failure of the international community in showing solidarity and equity in response to the coronavirus disease (COVID-19) pandemic...”

Since May 2022, the Pandemic Treaty has gone through umpteen

iterations, all with the impression that the clauses and terms are being turned down to cater for member states that simply have not been able to ‘agree’. The WHO’s negotiating body that has been charged to draft the brand new treaty document has been plagued with difficulties in getting sufficient consensus amongst all 194 member states. The Pandemic Treaty was due for vote and adoption at the 77th World Health Assembly held in May 2024 but there were a couple of member states that got in the way for opposing reasons:

- the United Kingdom rejected the Pandemic Treaty over sovereignty concerns with having to freely supply to poorer nations a percentage of vaccines it manufactures;
- many African nations were not content with the lack of equality around the formula for global sharing of vaccines and



medicines during international health emergencies.

This meant the required 2/3rd majority votes of the 194 member states was unlikely. Consequently, the mandate for the negotiating body was extended for another year to May 2025. Since May 2024, the negotiating body has been feverishly working on the terms with a hope that a special assembly meeting could be held to vote on the Pandemic

Treaty in December of 2024, which was clearly associated with the then looming US elections and possible outcome that former President Donald Trump might return to office. The urgency being the uncertainty with President Trump making noises last term about leaving the United Nations and the WHO altogether. Negotiations have been fraught, and even within the seemingly content member countries, there has been great dissension from among them, namely that:

- In the United States – 49 Republican Senators wrote to President Biden asking him to withdraw the US’s support for the Pandemic Treaty Reforms. This was followed up on 8 May 2024, where 22 US Attorney Generals also wrote to President Biden to withdraw.
- The Dutch Parliament – approved a motion, which calls for the government to request a vote

postponement for the proposed Pandemic Treaty.

- In Australia – 14 members of Parliament wrote to Prime Minister Anthony Albanese calling on him to reject the WHO Pandemic Treaty Reforms.

In November 2024, the negotiating body failed to again to achieve sufficient consensus amongst member states to be able to hold the special meeting in December 2024 before the new US Government is sworn in. The coming two months will be ones to watch with the negotiating body no doubt deflated – but desperate to push on.

What is the Price of Justice?

On 31 October 2020, I was reporting on the government's restrictions around the so-called pandemic at a protest in Victoria and was arrested three times. I accused the police of unlawfully arresting me and was offered \$15,000 to walk away. I said no because I wanted my 'day in court'.

In September 2024, I represented myself against a team of government lawyers in a 13-day

trial which lasted over six weeks. On 12 September, I won my case against the government. Two out of the three arrests were found to be unlawful. The following day, I was ordered to pay over \$240,000 to cover the costs of the government to lose to an inexperienced self-represented citizen.

I got the public vindication I was seeking but was then punished for the pleasure of daring to seek justice. For me, it was always about using my voice to speak for those without a voice. Thousands of Victorians were abused during 2020-2022 and don't have the resources to pursue justice. So, you could say, the price of justice was \$240,000? I paid to win. I paid for justice!

I truly think the 'system' needed to do this to me to discourage people from pursuing public vindication. I refused to take a deal outside of court and they needed to make an example out of me. I refuse to engage in fear tactics with the authorities. I am preparing my appeal. My experience will highlight the injustice within the justice system.

So, You Want to Win in Court?

■ *Dr. William Bay, a former GP registrar, had his medical license suspended 2.3 years ago for criticising the COVID-19 vaccines and the government.*

You demand justice! And you want a fair hearing, but don't trust lawyers or cannot afford one; let alone the 10 lawyers like the Australian Health Practitioners Regulation Agency (AHPRA) and Queensland (QLD) had against me. But you've seen the success people like Monica Smit or Nick Patterson have had, and you feel inspired and want to have a go at trying to get a win for your issue too! So, what can you do?

In Australia, the legal system allows for people to self-represent whether it is in a criminal or a civil (think claims for negligence) case. As a suspended doctor with no legal training, I have

had success self-representing in several courts including; the Brisbane Magistrates Court (where I successfully fought off criminal charges from the QLD police for exercising my free speech outside AHPRA's Brisbane office), and in the Supreme Court of Queensland where I am currently suing AHPRA and the Medical Board of Australia, and have secured the preliminary ruling that AHPRA cannot prevent me from working in any job other than a doctor (like they had illegally done for the last 2.3 years), and in the High Court of Australia where I secured the right to apply for leave to appeal a decision of the full bench of the High Court – an Australian first!

Now, if you choose to represent yourself, make sure you do some research on what the risks and benefits are, how to give yourself the best chance of victory, and how to minimise your costs. In this regard, I have some general advice for you.

First the great news: if you win



your case, you have just 'stuck it to the man', you won't have to pay a large percentage of your awarded money to lawyers, and you probably won't need to pay court costs, and even better; you won't have a criminal record and can stay out of jail!

You can increase your chances of winning by reading previous cases relevant to your matter on www.jade.io (a free legal database), reading the procedural rule book for your court, giving respect to the judge and the law, and speaking slowly but confidently in court, and learning from people who have had experience self-representing.

Now for the bad news: you are going to have to pay for some court costs like filing fees, hearing fees, court transcripts etc. If you have any concession cards or are in financial hardship, you may be able to get these costs waived – keep an eye out for exemption forms or ask for one when you file. If you

lose a civil matter, you could be up for costs of the other parties (their lawyer fees) which may run into the hundreds of thousands of dollars or more. Also, the judge or jury may direct you to pay a claim of the other party which could wipe you out. And let's not forget – if you are self-representing in a criminal matter and you lose: you could go to jail, pay a fine, or be liable to whatever orders the judge imposes.

Obviously, a lot is on the line! Your very freedom and financial security may be determined by your performance. That is why it is important YOU make the decision who YOU feel is the best representative for YOU, and if YOU decide to represent yourself; YOU do the very best for your client (YOU!) by doing as much research as possible on your case to give yourself the best chance of winning. I wish you all the very best and may God be with you always!



Nations are a fiction whispered to cowering children in the dark of the night. Democracy is the last,



Soul-Searching Through History

Early in the 764 Penguin hardback pages of his book, *The Soul*, Paul Ham takes us back to Australia in ancient times. The writer, best known for his military histories such as *Kakoda* and *Passchendaele*, notes that Australian Aborigines imagined the soul as part of yet distinct from the body of a child thousands of years before the Egyptians and the Greek philosophers and before "a multitude of faiths reincarnated, redeemed damned, sold, condemned and burned it."

Of necessity, the writer's search for the soul takes him on a journey through the world's religions. His chronological, non-judgemental approach is exactly the way religion should be taught.


The book is worth reading for its cross-cultural insights alone.

For example, the author draws a parallel between Tao Te Chung's essence of the Tao – "If you are compassionate, you can be truly courageous" – and Christ's revolutionary Sermon on the Mount preached 400 years later – "Blessed are the meek for they shall inherit the earth."

For this reader, the author's quick studies of feminism, sexuality and theocracy are among the most pertinent for our times.

He quotes Egyptian author Nawal El Saadawi, best known for *The Hidden Face of Eve*. "Progress for women and an improvement in their status can never be attained unless the whole of society moves forward."

In the conventional religious attitudes to homosexuality, he sees "a profound failure of the moral imagination and compassion of humankind... Our sexual orientation does not define the context of our characters."



On theocracy: "It is important to distinguish theocrats from humble and sincere churchgoers, synagogue and mosque-goers who simply want to pray in peace and don't want to punish the Godless or impose their faith on others."

Sadly, their numbers appear to be declining."

Mattias Desmet in a recent essay on the same subject – *The De-souling of the World* – also takes us back to the ancient hunter-gatherers.



My Brother My Brother My Brother

Review: A Play by Michael Gray Griffith

The question of masculinity in the age of woke culture is a sore point for our society. Presented by The Wolves Theatre Company, Melbourne playwright, Michael Gray Griffith, in typical confrontational style, has decided to press on that nerve in his new play, *My Brother My Brother My Brother*. Michael is a local playwright with over a dozen works under his belt. Since 2021, Michael has been a significant figure in the "freedom movement."

When venues required vaccine passports for entry, he took umbrage at this segregation and founded Cafe Locked Out.

My Brother My Brother My Brother has a simple premise: three young men in their early 20s are stuck on a boat off the coast of Australia, with no land in sight and very few provisions. But there's a catch – one of the young men's grandfathers appears to have stranded them there on purpose. Grandpop has vanished; perhaps he took his own life, or perhaps not. He has left the boys a test: be men and survive or be boys and perish. The playwright is interested in the idea of "rites of passage," events young men sometimes



must endure that bring out their masculinity.

This notion is deeply offensive to today's woke cultural revolution, which views masculinity and young men as threats to diversity and inclusion. Young men today often find themselves apologising for things they did not do or crimes they did not commit. Publicly shamed as if they were living in Maoist China in the late 60s and early 70s. We frequently hear about "toxic masculinity" from the woke, but the only toxic culture I see is the woke Neo-Maoist Cultural Revolution currently unfolding.

My Brother My Brother My Brother is an excellent, Samuel

Beckett-inspired meditation on masculinity. It's an enthralling theatrical experience that handles its subjects well without being overly preachy. Themes in the anti-vax community are present, making this one of the first works of art to directly address bodily autonomy, personal liberty, and freedom – issues raised during the COVID-19 crisis. Michael tackles all this head-on in this dramatic new play.
