

**A national digital ID system will soon be foisted upon all Australians – if we let it.**





# Excess deaths: Australia's broken drug safety system

Australia has no idea how many people were killed and injured by the covid gene-vaccines as the reporting system is broken, multiple experts have said.

**DRUG regulator the Therapeutic Goods Administration (TGA) continues to claim only 14 deaths out of 1004 reports are 'linked to' the products in its safety report issued on 2 November 2023. The case alleges that there are not one, but two, GMO components in the mRNA covid vaccines.**

Experts say this is completely wrong.

The number of gene-vaccine deaths is wildly understated and the system used by the TGA to assess drug safety is so broken that it is a danger to public health, doctors say.


Regulatory expert Phillip Altman said covid gene-vaccine adverse events are under-reported by between 40 and 100 times on the TGA's Database of Adverse Event Notifications (DAEN).

completely broken as it only admits to 14 deaths being caused by the covid-19 'vaccines'. We know this is not true. Our DAEN system is not picking up important safety signals", he wrote on Substack.

Australian Medical Professionals Society (AMPS) president cardiologist Christopher Neil said the adjudication process used to determine causality is opaque.

"If we accept from those numbers that all but 14 notifications were unrelated and coincidental – with well over 900 of these death notifications being essentially spurious, despite often having been made by treating doctors – then this actually implies that the rate of true signal detection is just one in 70... an absurd claim that has never been made in the history of pharmacovigilance", he told Letters From Australia (LFA) via email.

Barrister Julian Gillespie told the Australians for Science and

Freedom conference in November he has identified roughly 30,000 dead and more than 255,000 severely injured by the covid gene-vaccines. Mr Gillespie is spearheading a class-action lawsuit against 35 central defendants including Pfizer, Moderna and AstraZeneca.

GP and adjunct professor of medicine David Richards told LFA via email that European Medicines Agency and AusVaxSafety data suggest up to 3500 deaths from 70 million vaccine doses in Australia.

NZ government data released by whistleblower Barry Young in November show up to 1 in every 1000 people injected may have died. Instead of releasing the anonymised data for public analysis the NZ government arrested Mr Young and slapped on a non-publication order to censor it.

The NZ data suggests an Australian death toll of about 26,000.

The TGA simply has no idea how many people died because its reporting system is broken.

The regulator relies on voluntary reporting. If you don't tell them, it's not in the figures.

"It is acknowledged that some adverse events may go unreported", The TGA told LFA via email.

"However, the extensive data received by the TGA, together with cooperative arrangements with international regulators, provides a high level of confidence

in our ability to rapidly identify and respond to potential covid-19 vaccine safety issues."

But most people did not report problems – so the TGA never received 'extensive data'.

Doctors were bullied by the Australian Health Practitioner Regulation Agency and the medical boards in a March 2021 directive to healthcare workers threatening disciplinary action if they criticised the gene-vaccines, which were promoted by relentless propaganda.

This discouraged reporting of side-effects both by the public who didn't know there could be a

side-effects reports.

But both the Home Affairs and Health Departments directed social media firms to censor gene-vaccine injuries, rigging the system.

The result is thousands of unreported deaths.

AMPS said excess deaths surged at rates up to 17 percent above baseline average since the gene-vaccines were released.

In December AMPS launched a comprehensive book called *Too Many Dead* showing evidence the excess deaths rates are at least partly due to the gene-vaccines.

problem, and by healthcare workers who feared retaliation, destroying the safety reporting mechanism.

Queensland GP Melissa McCann, who is spearheading a lawsuit on behalf of the vaccine injured, told how doctors were discouraged.

Previously the TGA's key reporting message was: "You don't have to be certain, just suspicious", she told the Australians for Science and Freedom conference in November.

"That's the opposite of what happened during covid, it was: 'Yes, you're obliged to report everything, but bear in mind that for almost all adverse events they're unrelated to the vaccine'."

That created an environment where patients who tried to tell their doctors what had happened to them were dismissed.

"Sometimes it was absolute ridicule and there was enormous discouragement to even draw the conclusion it was vaccine-related", she said.

Worse, in 2018 the law was changed to allow drugs onto the market before safety testing was finished via 'Provisional Registration', the category used for the gene-vaccines.

Immediate reporting of side effects establishes the safety profile and a black triangle on the packaging reminds people of this.

The TGA even directs drug-makers to scan social media for

mortality figure for 2022 was 190,394, which was 15.3 percent above the historical average, leaving 25,235 excess deaths, the Australian Bureau of Statistics (ABS) reported in its Provisional Mortality Statistics for 2022, released March 2023.

The ABS said only 10,095 of these deaths were due to covid leaving 15,140 non-covid deaths in 2022.

But the ABS changed its methodology, disappearing those non-covid excess deaths.

Journalist Clare Pain investigated the change in the new AMPS book *Too Many Dead*, finding the figures alarming enough to warrant independent investigation.

No investigation has been launched. Instead, Australia's senate voted against establishing a committee to investigate the excess deaths in March.

This is unsurprising as the government itself along with its public health officials may be to blame.

# A Stand in the Park: building unity in your community

**TURNING up to a local park to see if there's anyone else around for a chat might seem like a curious way to spend your Sunday morning but for thousands of people around the world this regular activity is helping them to connect with their community, build friendships, make sense of world events and quite frankly, stay sane.**

It's called A Stand in the Park (or ASITP) and the concept couldn't be simpler: meet in a park and chat, about anything and everything.

The first ASITP was held on 8 September 2020 in Hyde Park Sydney, organised by concept originator Brady Gunn. Brady says the fear and division he witnessed throughout that year prompted him to think about a way to bring people together, to unite them in a space "with no agenda, no religion and no leaders". Ahead of the first gathering Brady shared the details online for a 10am meet; that day he was the only one who showed up.

Not deterred by the lack of initial response Brady kept going back to Hyde Park each Sunday at 10am in a hi-vis yellow vest,

recording videos from the park and sharing them online to spread the word that he would be there if anyone needed to chat – they just needed to look for 'the guy in yellow'.

For the better part of three months he was mostly the sole attendee each week. Joined occasionally by friend Andrea, Brady persevered in the belief that "we could really be something for each other if we focused on going towards unity rather than away from division". He hoped the idea would reach people looking for a

place to be free to stand "in their own truth".

The quiet simplicity of what Brady was doing gradually began to break through all the noise. More people joined in – and not just in Hyde Park. A January 2021 post on the ASITP social media page listed eleven locations in Australia that had begun hosting ASITP weekly; a month later that list had quadrupled in size and included nine locations in New Zealand and two in Canada.

Around this time Brady was contacted by a UK-based friend,

Fifi, who had been watching his Hyde Park videos with interest; Fifi organised the first ASITP in the UK in February 2021 and it quickly caught on. By late March the same year there were 100 locations worldwide with a third of them in the UK.

More than three years on ASITP is well and truly thriving. An estimated 100,000+ people across 40 different countries gather in over 1,400 parks every Sunday. As on that first morning in Hyde Park back in 2020, they still meet from 10am and the colour yellow still

features as a landmark to look for.

There are a handful of very hardworking volunteers who manage the website and social media pages and help to facilitate new events but, true to Brady's original intentions, there are no 'leaders'. Every ASITP manages itself, there's no right or wrong way to do ASITP and no two of them look exactly alike – each one naturally becomes whatever the people attending need it to be.

The idea itself may be simple but this homegrown not-quite-movement is driven by and is fulfilling very complex human needs, such as hope and connection. Other initiatives have formed through this simple, consistent act of meeting each week and talking with like-minded people – including this very newspaper.

As Brady says "it won't ever do anything, but things will happen in it". The 'things' happening include lifelong friendships, strengthened communities, empowered individuals and warmed hearts.

## Doctors recommend radiation-free tech

**THE Santa Clara County Medical Association (SSCMA) in the US has called for precautions to protect students and staff from the harmful effects of wireless technology in schools.**

'[T]he SSCMA supports reducing exposures to radiofrequency radiation from wireless devices and encourages establishing safer school technology policies with regard to digital devices and infrastructure in order to promote the physical health, mental health and well-being of students and staff. Healthier children translate into healthier communities and a healthier society,' the Association says in its 'Recommendations for Best Practices for Safe Technology in Schools'.

The document points out a range of problems associated with the use of wireless technologies. These include:

**Effects on health:** 'Scientific literature indicates that the mechanisms of harm include oxidative injury to critical molecules such as DNA/lipids/proteins (Gerner, XIe), membrane disruption, blood brain barrier disruption, and mitochondrial

injury with much of the resultant cellular injury occurring at non-thermal levels which are well below current standards'.

**Effects on eyes:** 'There are also emerging scientific concerns with regards to eye damage and circadian rhythm disruption from blue light emitted from digital devices'.

**Social media effects:** '[T]he excessive use of digital technology and social media in children can have adverse mental health effects including internet addiction, cyberbullying, deficient

social skills, depression and lack of exercise'.

**Effects on privacy:** Many apps require the sharing of children's personal information with third parties.

The Association recommends a number of ways to improve health, safety and the learning environment for students, including:

- educating students and staff about the risks of wireless devices and how to reduce them
- educating the school nurse

about potential health effects of radiofrequency radiation (RFR) developing mobile phone-free school policies

having tech free breaks during classes

reducing blue light from devices

using hard-wired rather than wireless connections

reducing RF radiation in schools

establishing phone-free zones in schools

'using books instead of computers or tablets whenever possible for improved learning and less distraction'

keeping wireless devices away from the body

not installing smart meters on school properties

not allowing mobile phone towers on school property.

'We have become especially concerned with the dramatic increase in the use of this technology in schools resulting in exponentially higher levels of non-ionizing radiofrequency electromagnetic radiation (EMR) emitted by these wireless devices. This results in increased long-

term exposures in children who spend much of their formative years in school environments,' the SSCMA wrote.

**What can you do?** Reduce your exposure to mobile phone radiation with shielded mobile phone cases and air tube headsets. Measure the wireless radiation in your home, school and workplace with radiofrequency radiation meters. Protect your body from wireless radiation with shielding T-shirts and caps. Reduce your exposure to wireless radiation during sleep with shielding bed canopies.

# No evidence masks made any difference

Cochrane review delayed while mask mandates were imposed

**HAPPILY, since the start of 2023 when it seemed a concerted media push was in play to bring back widespread forced masking, things have improved considerably.**

Perhaps surprisingly, after three years during which the strange mask obsession had proved completely impervious to evidence and common sense, the latest version of the Cochrane review actually seems to have made a dent with ‘Team Mask’.

Indeed it must have done if even hyper-aggressive mask cheerleader the *New York Times* has given up the fight.

In a piece for the paper headlined *The Mask Mandates Did Nothing. Will Any Lessons Be Learned?* Bret Stephens writes:

“The most rigorous and comprehensive analysis of scientific studies conducted on the efficacy of masks for reducing the spread of respiratory illnesses – including covid-19 – was published late last month. Its conclusions, said Tom Jefferson,

the Oxford epidemiologist who is its lead author, were unambiguous.

“There is just no evidence that they” – masks – “make any difference,” he told the journalist Maryanne Demasi. “Full stop.”

But, wait, hold on. What about N-95 masks, as opposed to lower-quality surgical or cloth masks?

“Makes no difference – none of it,” said Jefferson.

What about the studies that initially persuaded policymakers to impose mask mandates?

“They were convinced by non-randomised studies, flawed observational studies.”

What about the utility of masks in conjunction with other preventive measures, such as hand hygiene, physical distancing or air filtration?

“There’s no evidence that any of these things make any difference.”

These observations don’t come from just anywhere. Jefferson and 11 colleagues conducted the study for Cochrane, a British nonprofit that is widely considered the gold standard for its reviews of health care data. The conclusions were based on 78 randomised controlled

trials, six of them during the covid ‘pandemic’, with a total of 610,872 participants in multiple countries. And they track what has been widely observed in the United States: states with mask mandates fared no better against covid than

those without.

Of course, that all this was known three years ago, and never needed proving all over again at possibly unrecoverable cost to the general psychological wellbeing of the public, hasn’t quite registered yet. And with a hardcore of people, it evidently never will; radical masker Professor Trish Greenhalgh quickly knocked out a paper in response, hilariously entitled: *Yes, masks reduce the risk of spreading covid, despite a review saying they don’t.*

However, the more interesting story here is not the confirmation that masks don’t work, but why this unremarkable information was so ruthlessly suppressed. This happened from very early on in the covid episode, particularly in Autumn 2020, when forced masking was getting established as policy across the world.

Smile Free’s Dr Gary Sidley has been investigating this, noting: “The previous 2020 version (of the Cochrane review), incorporating updates up until January 2020, had passed peer review and was finalised by April of the same year.

Extraordinarily, its publication was delayed until November 2020 due to ‘unexplained editorial decisions’.

According to lead author, Dr. Tom Jefferson, this extra scrutiny was “a very unexpected event in Cochrane, especially during a period in which the topic of the review and the setting of policy was of worldwide importance. It is unlikely to be coincidence that this window of delay corresponds to the period when the UK and other governments, under intense pressure from pro-mask groups, U-turned and imposed mask mandates on their populations.”

# Rigged, how networks of powerful mates rip off everyday Australians

**Rigged describes how an in-crowd has developed in Australia that dominates all areas of political decision-making and public expenditure. This is the Game of Mates where favours and paybacks are so entrenched it is considered normal. Mates move seamlessly between politics, boardrooms, lobby groups and regulatory bodies. The game goes on without pause.**

Ex-prime minister Tony Abbott was blasé about the game when he said in a public address on the retirement of resources minister Ian Macfarlane "... I hope the sector will acknowledge and demonstrate their gratitude to him in his years of retirement from this place" (Crikey, 2016). Months later Macfarlane got his reward. He was appointed as the CEO of the Queensland Resources Council lobby group.

Murray and Frijters have used the name James to signify someone who is in this exclusive and profitable club. The club runs through all major businesses including superannuation, banking, property development, higher education, infrastructure, mining and media.

Typically, James has gone to the right school, joined the right social clubs and worn the correct clothes to indicate his or her desire to be part of the game. He or she shows their intention by giving gifts which may not be directly returned. They join a web of favours and connections.

Sometimes a new member is given a risky task to test their loyalty. The Game of Mates, the authors argue, has similarities to the mafia. Knowing the dirt on each other becomes a form of insurance and keeps people silent and in the club.

The hapless working Aussie is called Sam. As the game goes on there are more Jameses in Australia wanting a slice of the pie and fewer Sams creating our national wealth. For this reason, James favours immigration. Skilled migrants have been raised and educated at no cost to James. These migrants have no strong political affiliation. They want to work and get along. They will not threaten the Game of Mates. They become more Sams who can be fleeced in tax, superannuation, home mortgages and living costs.

The authors introduce the term grey gifts. These are gifts that go to property developers, infrastructure businesses, mining companies



and other key groups at the disadvantage of the general public. While these gifts are not directly illegal, they are stealing from our common wealth. When our taxes pay for a road from a private mine to a port, this is a grey gift.

Another example comes from the Great Property Development Game. Grey gifts occur when a property developer gains a financial advantage when a piece of land is rezoned, say from single dwelling to multiple dwellings. This rezoning increases the land value and the developer has a

financial windfall. Funds that could reduce Sam's taxes or pay for new hospitals are lost to the big players in the property game.

In Queensland the authors estimate 70% of the rezoning value goes to well-connected property developers. Across Australia we lose nearly \$19 billion each year to developers when they are not charged for the gains from rezoning. A standout exception is the ACT. Here they have the betterment tax. This is charged to landowners or buyers when a piece of land is rezoned and the land value is expected to rise.

Another lucrative game in Australian cities is the Great Transportation Game. Under the name of Public Private Partnerships (PPPs) the people are burdened with the cost of new roads, light rail and tunnels that are not required and do not live up to their projected usage. Before a project starts mates are contracted to provide surveys. Of course, the survey reports are favourable. It's a closed game.

There are opportunities to loot the public after construction too. With the Cross City Tunnel (CCT) in Sydney the owners arranged with their mates for other roads to

be closed in the interest of street quietening. This funnelled more paying traffic into the tunnel. Sydneysiders woke up to the game and many of the planned street closures and road resurfacing projects were cancelled.

*Rigged* provides an in depth look at the game across different spheres but that's not all. Murray and Frijters show examples of how other countries have organised these spheres and benefitted their people. They offer positive examples about mining royalties, fair superannuation and affordable home mortgages. They also point out the myths James spins to keep the game running.

Murray and Frijters are confident the Game of Mates can be disrupted and ended by calling out the myths and removing the grey gifts that make the game so lucrative. They offer some recent examples. Uber disrupted the taxi monopoly and now fares are around 14% cheaper. Aldi broke into the supermarket duopoly and customers benefitted. When the game is challenged mates will kick and scream and play dirty to keep their powerbase. This book is a call to action. Australians in earlier times fought against inequality. Now, the authors argue, it's our turn to step up.

## Curing allergies with science and vegetables

**IN his book *On the Origin of Diseases* Dr Neil B Benson MD observes the first principle of technical writing: tell the story in everyday language that the general reader can understand while providing enough material to make the experts take notice. Indeed the author sets challenges for the next generation of doctors, researchers and entrepreneurs.**

The book's 100 pages are organised in short chapters with simplified diagrams illustrating the workings of the body and explaining the author's goal to identify and treat the causes of disease rather than simply moderate the symptoms.

This reviewer first encountered Dr Benson when he was interviewed on 23 August 2023 on Donnybrook Balingup Community Radio by Barry Green, who practises and preaches regenerative agriculture and regenerative media in that orchard and mixed farming district of Western Australia's south west.

The two men on air traded



traditional wisdom. Barry quoted his maxims of "healthy food grown in healthy soil" and "stability through diversity". Neil responded, "If you don't eat your green vegetables you are not going to be as healthy as you could be".

The doctor was speaking from experience. In his childhood he suffered from asthma, eczema and recurrent sinusitis which his mother attributed to growing up on antibiotics.

Before his medical training in Canada Dr Benson completed degrees in botany and agricultural science. He writes that this education provided knowledge of "fungal organisms, food production

methods, food chemistry, nutrition, information on botanical groupings and an ecological way of thinking".

The childhood experience and scientific background came together when he was practising medicine in New Zealand and became so well known for successful treatment of allergies that he suffered the fate of professionals ahead of their time when he encountered an obstructionist bureaucracy.

He now lives in the south-west Western Australian city of Bunbury. His soft-cover book available through book stores is modest in outward appearance but ambitious in its purpose.

In the introduction he writes,

"The problem solved here is the causative mechanism for chronic inflammatory disease which includes allergy and autoimmunity. The causation is chronic infection and this knowledge has massive implications to medicine. I have endeavoured to show how this new understanding of chronic disease has the capacity to change the health of our society and all societies".

The author writes about the key role of soluble fibre in healthy functioning of the gut and describes the studies that led to his announcement of 'the abnormal bowel cascade'. Throughout the book the doctor stresses the importance of green vegetables playing a dominant role in our daily diet. He mentions broccoli, cabbage, spinach and cauliflower.

"We should eat lots of green vegetables and a range of green and coloured vegetables. Diversity in food gives a range of nutrients and encourages diversity in the gut flora which, in turn, helps us".

The villain of the story is a pathogen called *candida albicans*, more commonly known as thrush. Here the author brings together

medical science and a holistic dietary approach, emphasising that the over-use of antibiotics and poor diet are primarily responsible for the rising rate of allergies and autoimmune disease.

"If identified early on, *candida albicans* is often treatable by diet and by a single prescription medication called nystatin. What is nystatin, you say? In my opinion it is the second most important drug of the 20th century (second to penicillin)".

He notes that this effective antifungal antibiotic is not a statin as in cholesterol treatment. The name derives from New York State Department of Health where the microbiologists who discovered the substance were working.

Throughout the book the author maintains his mixture of practical advice to the host of people suffering from allergies and other chronic diseases with specific professional advice to his colleagues in medical practice and research.

**Richard House [RH]:** There've been a number of big events held recently on 5G (see Resources section); do you sense a turning of the tide in relation to the 5G issue?

**Tanja Rebel [TR]:** I do. In fact, I believe we are nearing a boiling-point where the pot will soon boil over. and human rights.

It will be harder and harder for the mainstream media to ignore the facts being put forward by these scientists, which are based upon tens of thousands of peer-reviewed studies. Once we've reached a critical mass in the general population, who until now have not been informed of the facts, the tide will turn. Until then, we must keep on pushing! Of course, most importantly of all, we must walk our talk and relinquish all wireless gadgets for wired connections. Anything else would not be serious.

**RH: What was it that first drew your attention to there being a problem with 5G?**

**TR:** I got into this via the LED route, being an early campaigner against the (totally un-green) roll-out of LED street lights across the country – and the world – when it was obvious that these lights were not at all beneficial from a public-health perspective. However, I was met with such a level of resistance by the powers-that-be, even when confronted with the clear facts that these lights are not green at all, that I wondered what was going on. It took me a while to realise that the roll-out of LED

some of the challenges you've come up against in the process.

**TR:** A lot of people think that I'm beating a dead horse. However, I was taught early on that if you want to reach a certain goal, you need to retain focus and keep at it; I've done this with Global 5G Protest.

It started on January 25, 2020, when a Croatian woman and I got together to encourage people to rise up against the worldwide 5G roll-out, foisted upon us without any independent Health or Environmental Impact Assessments, public consultations, or free and informed consent – a right enshrined in UN Law. The first protest was big, with events in 38 countries and big crowds in Copenhagen, Amsterdam and Munich. People also came out in significant numbers in the U.S., Australia, India and South Africa. So we set another protest for March that year.

Then covid happened. The plandemic cowered people into their homes, and when they eventually emerged, many had either become too frightened or too distracted by everything going on to retain focus on stopping 5G. People rose up against lockdowns

and vaccines, with huge freedom marches worldwide. Unfortunately, these marches commonly omitted to mention the very thing being rolled out during lockdowns, threatening to take away freedom for ever. It's becoming ever more apparent that, apart from being a health and environmental threat, 5G is a surveillance grid-in-the-making, and protecting freedom necessitates stopping it. If not, we'll find ourselves locked into an electronic prison.

So we've called subsequent protests (there've been many) 'Global 5G Protest for Freedom'. Since 2020, we've organised a protest every season to coincide with equinoxes and solstices. Numbers haven't been as large as for our first protest, but there have been thousands of brilliant events worldwide, with amazing pictures which we've made into collages and distributed in press releases

across social and mainstream media. However, apart from once in January 2020, they have been ignored, and even the alternative media hasn't been particularly receptive. Maybe this interview will mark a turning point?

**RH: Let's hope so! Very briefly – what would victory look like for the 5G movement?**

**TR:** An immediate halt to the 5G roll-out and the dismantling of all masts. But this is only the beginning. We need the total dismantling of all wireless radiation equipment in favour of wired connections, which are more safe, effective and secure.

Moreover, we need a complete re-evaluation of electromagnetic radiation and its effect on humans and wildlife, with far lower exposure levels – International Commission on Non-Ionising Radiation Protection (ICNIRP) 'safe' levels are ridiculously high,

but what authorities invariably refer to when dismissing the serious potential health problems of 5G.

The only safe level is the Earth's natural background radiation. Humans don't need ever more connectivity; we urgently need to reconnect to the Earth and each other.

# The three distractions of the Voice

## A POSTSCRIPT to a divisive political campaign

Military analysts tell us that we are now in the era of fifth generation warfare. In this strategy countries are brought to their knees through the creation of internal division to the point where they can no longer summon the social and economic cohesion needed to maintain a viable nation state.

In recent military history, the move to this fifth generation followed the failure of America's 'hearts and minds' project in the Vietnam War. For Americans and Australians today, the question is – why are we using these tactics against ourselves and tearing our own countries to pieces?

During Australia's debate on The Voice Graham Hood and John Larter on Club Grubbery interviewed Aboriginal elder Richard Shillingsworth and civil rights lawyer Peter Fam.

The following is a transcript of Peter Fam's analysis, taken directly from the Club Grubbery show of September 11, 2023.

"In my lived experience and my experience as a human rights lawyer, the Government here in Australia has never cared about the well-being of Aboriginal and Torres Strait Islander people so history suggests that the Voice is not about that. In the past few years, I think those of us who

did not already know it realised that the government does not care about us either. So, we have something in common.

"Everybody knows the mainstream media are bought and sold. We know as well that their main tactic is distraction. Try and make us look in one direction so we don't look at what's going on over there (in the other direction). Like the magic trick of misdirection.

"What are they trying to distract us from? I suggest three things.

"The first is what they are actually doing. The central bank digital currency (CBDC), digital surveillance, censorship and misinformation bill, World Health Organisation, World Economic Forum, health regulations they are trying to pass, tidal waves of vaccine injuries and death all around the world, the mitigation of our civil liberties for the benefit of the globalist technocratic system where the few who know best try to control the many who can't be trusted with their own liberty.

"The second thing - and this may be even more important, especially where there is so much division and in-fighting even within the freedom movement – is from ourselves and from our own well-being. What we focus on is where our energy goes and they know that. If we are focusing on external fighting, especially arguing about things, we are not being the best version of ourselves.

"The best version of ourselves would not stand for any of this stuff that has gone on. We wouldn't stand for the high rates of illness and death in our kids. We wouldn't stand for the issues that are literally killing us – the

toxicity in our environment. We would not stand for what is happening to the land we live on, for what is happening to our communities.

"So, the question is how are we doing? Is there work we could be doing on ourselves but we are not because we are too busy arguing with people?

"Thirdly, it is about division. Divide and conquer. The more inflammatory debates and polarising topics they can throw into the community, the more likely we are to spend all of our

time fighting each other instead of realising that we have a common enemy. The bodies and organisations that are throwing these polarising topics into the community over and over again are our common enemy.

"So, if we just work together as a community, we can ignore them completely, we can create a life that is worth living together. We have to do this because the systems we are living in are crumbling and actually trying to harm us.

"We don't have a choice but to come together and create

alternatives for ourselves".



## Asset confiscations must stop

### THEY destroy trust, they destroy free democracies and they destroy capitalism.

The United States (US) has reportedly confiscated US \$58 Billion of Russian citizen's assets over the last year in retaliation for the Ukraine conflict. 3. Ensure your doctor/health professionals join the Australian Medical Professional Society (AMPS) to bring ethics back into medicine.



## Where the real power and control lies

### THE roots of the public-private partnership in health go back at least a century to the capture of medicine as described by E. Richard Brown in Rockefeller Medicine Men: Medicine and Capitalism in America.

The kerosene king had started out selling counterfeit snake oil, but once the technology of cracking petroleum arrived, the ingenuity of his fellow Germans led to petrochemical-based pharmaceuticals.

Rockefeller became the biggest name in U.S. pharmaceuticals by using the power of his endowments to gain control of medical schools. He promptly banned traditional medicine. Simultaneously he

became a force in the media.

It is not just a curious parallel that today we see Big Pharma, the medical profession and the corporate media in cahoots – they are largely the same interests.

The vast profits to be made set off a rivalry between the U.S. and Britain on the one hand, and Germany on the other. That quest for wealth was to shape the 20th century.

Government, for all its big budgets and burden on taxpayers, cannot compete with private foundations. These are the playthings of families and wealthy individuals. Through think tanks, the big four auditors and their consultancies, and the banks and private equity, corporate forces make government policy.

Examples include George Soros’s well documented and lavish funding of selected

U.S. district attorneys, having realised how the political machine – and electoral process – can be controlled through the judicial system.

There is Bill Gates’s development of Common Core and successful effort through the teachers’ unions, academics and politicians to foist it upon the U.S.

The powerful influence of billionaire families like the Pritzkers set the gender debate, as explored by Jennifer Bilek.

It goes much deeper than the revolving door between government and the private sector. Catherine Austin-Fitts explains how defence contractors control computing and IT systems, including information and payments. Private banks run the financial systems.

Democratically-elected governments are no longer sovereign: their information and payment systems are now run

by banks and corporations and they restrict what they allow politicians to see.

When Austin-Fitts was number two in charge of the Department of Housing and Urban Development in the 1990s, contractors flat out denied her access to information. It is worth quoting her at length:

“Sovereign government no longer controls the information and payment systems. They are run by the defence contractors who report to a shadow government. The NY Federal Reserve and member banks operate as depositors. So they run the bank accounts and financial systems and the defence contractors run the information and payment systems. Between them they report to the shadow government or themselves.

If the middle class is going to reassert authority, that means

control of the digital systems – the sovereign government, the president, the officials do not control them. They control the appropriations”.

There is one deeper and more troubling feature of heist by organised crime. Unlike Lucky Luciano and Meyer Lansky, today’s dons have absorbed the lessons of Freud and Bernays. They employ the skills of Marc Bernays Randolph, founder and CEO of Netflix. Whether Randolph knows it or not, he helps to sculpt the cranium that accepts the Great Lockdown.

In summary, the degree of mind control that accompanies Event Covid, the Lockdown and the momentous transfer of wealth that is taking place in its shadow, makes the propaganda machine of the Third Reich look like playtime.

# Coining in on future currency

CBDCs, cash and Bitcoin vying for position in our wallets

**IN an era where the mainstream narrative often dictates public opinion and actions, I have chosen a less-travelled path: doing the opposite of what is generally advised.**

This approach has been surprisingly effective. From questioning untested pharmaceutical treatments, doubting the traditional food pyramid, and navigating the complex world of higher education and its associated financial burdens, I've embraced a path of scepticism and self-reliance.

Within traditional finance, this philosophy extends to the use of cash. Contrary to mainstream advice, which favours digital transactions for convenience, cash offers distinct advantages.

It offers control, privacy, and immunity from censorship.

These values might seem insignificant until they become crucial, as vividly illustrated by the plight of Canadian truckers. Yet, there's a growing sense that the era of cash might be nearing its end. As cash is issued by central banks, its existence could come to an end if they choose to discontinue its issuance.

Most people don't realise that their money is essentially just numbers on a screen and doesn't really exist in a tangible form. The funds displayed in your online banking app are, in a technical sense, not entirely under your ownership either, as banks have the authority to lend out and use your deposits.

Holding onto cash as a long-term strategy also poses challenges. The diminishing purchasing power of cash, a result of government overspending and increasing debt, is a harsh reality. A depressing amount of our tax money goes on war and interest debt. We are forced to pay our hard-earned money on mismanaged

finances and forever wars.

The historical example of Weimar Germany, where hyperinflation rendered cash worthless, is a cautionary tale. The financial crisis of 2008 and the economic disruptions during the covid-19 pandemic further illustrate how government policies can favour large corporations over small businesses, leading to what some describe as crony capitalism.

Gold has traditionally been a refuge against currency devaluation, but it is with limitations, especially regarding mobility and ease of transaction. Enter Central Bank Digital Currencies (CBDCs), a modern solution that leverages blockchain technology.

However, the efficacy of CBDCs is still a matter of debate, as evidenced by the failed projects in countries like Nigeria and China.

They also offer programmability into our money, a feature that has not existed before in money. This will allow the government to close the loop on our growing surveillance state.

Looking ahead, it appears increasingly likely that cash will become obsolete in the UK, to be replaced by CBDCs. CBDCs will

be pitched as a solution to inflation and the cost-of-living crisis. However, this will be another government mistruth designed to confuse and distract.

A CBDC is essentially a digital version of our current, weakening currency, but with the added feature of programmability – controlling where and what you can spend on, and even setting expiry dates.

This represents a fundamental change to the nature of money, which is being introduced by stealth to avoid public uproar.

In this context, the mainstream media's stance on Bitcoin is noteworthy. Often portrayed negatively, Bitcoin is dismissed as a tool for illegal activities or an environmental threat.

However, these criticisms are not true and overlook the fundamental attributes of Bitcoin as a decentralised, peer-to-peer electronic cash system. Money that has a connection to real work and energy, like gold, and is not created from thin air.

What, then, would constitute ideal money? Consider a currency with a capped supply to prevent debasement, like Bitcoin, which is limited to 21 million coins, yet

highly divisible by 100,000,000 'Satoshis'. Bitcoin's design makes it censorship-resistant, enabling transactions without intermediaries.

It's also permissionless, allowing free access to anyone in the world, further democratised by innovations like sending Bitcoin via SMS, a boon for those without smartphones.

Bitcoin banks the unbanked, and provides a solution for those distrusting their governments, or who have been debanked for having non-mainstream views.

Bitcoin's open-source nature ensures transparency and ongoing improvements in transaction costs, speed, and privacy.

This represents a new form of money that aligns with the principles of freedom and autonomy. It challenges us to rethink our approach to currency and financial sovereignty. It is a global money outside of governmental control.

Alongside traditional assets like gold and cash, Bitcoin offers an alternative worth considering. Its resistance to debasement and growing acceptance makes it an appealing option for transactions and savings.

However, it is important

to differentiate Bitcoin from the broader category of cryptocurrencies, as this article specifically advocates for Bitcoin. Bitcoin and crypto are not the same.

The best thing about Bitcoin is you don't need to ask permission. Transactions are confirmed, not approved.





# The paperclip of freedom

Binding together with war-time symbol of defiance and unity

**A FRIEND turned up at a recent Stand in the Park meeting [see page 4 of this paper] with a three-inch paperclip attached to his shirt pocket. Being the curious type and not usually missing a trick, I asked him why he was wearing it.**

He told me that during World War II, Norwegians who were passively resisting the German occupation took to wearing a paperclip as a token of their resistance. I had heard of the White Rose movement in Nazi Germany, which produced underground pamphlets and literature at great risk to those involved, with some members sacrificing their lives in the process. White Rose is active again today (and in the UK too), but the paperclip movement was a new one to me.

My friend had brought with him a supply of clips that he generously gave out to the assembled 'standers'. In return, I gave him a Stand In The Park badge that says: 'We stand for freedom'.

Norway was seen by Hitler as an important strategic country

because of its coastline. He knew that to break the Allied blockade of Germany, he needed a relatively safe route for transport of supplies to maintain his war effort. Norway had declared its neutrality, but this was not going to stop him from getting what he wanted, so in April 1940, Germany invaded and occupied the country.

It didn't take long for the Germans to become established, and they set about trying to Nazify the country. The King and Crown Prince of Norway had decamped to England, and the Crown Princess had sought sanctuary in America, where she became a guest of F. D. Roosevelt in the White House.

The Norwegian population lived under German rule. Teachers were told to join the Nazi party and teach Nazism in classrooms, and the church was told to obey Hitler and the state. Anti-Jewish legislation was passed. In a population of four million, some 400,000 German troops were operating in Norway by 1945. With such a high ratio of occupation forces, any acts of rebellion, resistance and defiance were perilous. However, it kept many soldiers away from more active areas of conflict, thereby

reducing the German ability to counter the Allied invasions from both East and West.

In 1940, students at Oslo University started wearing paperclips on their lapels as a visual, non-violent symbol of unity, resistance and national pride. Other symbols relating to Norwegian nationality had been banned and these young people wanted a way of displaying their rejection of Nazi ideology.

Why did they choose the paperclip? While there is no definite answer, it is thought that the 'binding together' function of the clip symbolised exactly what they wanted to display: We may be under German rule but we are united in our condemnation of it. Also it was thought, mistakenly as it turned out, that the paperclip had been invented by a Norwegian by the name of Johan Vaaler.

In time, the Germans cottoned on to the symbolism of the clip and it became a crime to wear one, but by then the Norwegians had found more practical ways to annoy their occupiers. Teachers went on strike and although some were sent to prison camps, it didn't deter the vast majority, and eventually the Germans had to give up on force-

feeding their ideology through the education system.

Every bishop in Norway resigned, along with 90 per cent of the clergy, and here too the Nazis had to admit defeat with regard to their edict that the church must submit to 'obedience to the leader and the state'. German was a widely spoken language pre-war, but after the occupation, the majority of the population refused to speak it.

On public transport, Germans were shunned, so it was made a crime to stand if there was a vacant seat next to a German. It must have been difficult for soldiers in a foreign country trying to find directions from a population refusing to speak their language and giving them wrong directions whenever they could.

All of us who frequent our Stand in the Park meetings are under no illusions that in 2023 we are under an occupying force that, while not stomping around in jackboots and carrying guns, are nonetheless attempting to stamp their unholy, inhuman Agenda 2030 policies on the world. Behind the summer sunshine and the distracting rubbish that passes for mainstream news,

there is no doubt that we are in the fight of our lives, if life as we know it is to survive.

I've been wearing my paperclip whenever I'm out and about and have not yet seen any more being worn. I've been asked about it a couple of times, and I take great pleasure in telling the story of its Norwegian origins.

And how does it relate to the present day I'm asked? It doesn't take much to get inquisitive souls nodding in agreement when they realise and acknowledge the huge transfer of wealth that has been taking place these last three years, because they are suffering along with everyone else.

Not to mention the fact that more people are becoming aware that governments are not acting in our best interests. Five jabs plus boosters has opened a lot of eyes, although in some cases it is too late.

I shall continue to wear my paperclip as my new-found symbol of resistance. If it was good enough for the brave souls of occupied Norway, it is good enough for me.

# Parallels of manipulation

**THE tidal wave of tyranny in the name of science has unmasked evil as a palpable force and actual presence.**

Sound familiar?

Cecil Rhodes, initiator of the ‘Jesuit-like secret society’ (a church for the extension of the British Empire), looks upon men as ‘machines’ and is ‘quite unscrupulous as to the means he employs’.

Apart from enormous wealth, those in the secret society’s inner circle were highly influential people. The self-made man and gifted academic, Alfred Lord

Milner, took over the position of leading the ‘men behind the curtain’ after Cecil Rhodes’ death.

The following sounds eerily synchronistic to what is happening today too: the death of Queen Victoria in 1901 ‘came as no surprise, since her health had been deteriorating for some time. ## The new imperialism

is neither neo nor new and it is not liberal. All these terms don’t mean anything anymore.

“What we are living under is raw power and imperialism with a progressively smaller number of people on top calling the shots and trying to take over the resources, the money and everything else in the world.

“It is a raw power grab and is as old as the hills.”






